SUBJECT: Designated Off-Limits Areas and Establishments

1. References.

2. The following establishments have been designated as off-limits establishments for all Soldiers assigned to the National Training Center and Fort Irwin. In addition, this order applies to Marines and Sailors assigned to Marine Corps Logistic Base-Barstow.

3. The following are off limits areas and prohibited activities at times specified due to violent criminal gang activity or recurrent misconduct by military members that is prejudicial to good order and discipline and service discrediting:

Area known as "Shit Creek"	1 Mile radius surrounding the confluence of the Gila and Colorado Rivers: 1500 ft. North of the bend on East Levee Rd, East of South Avenue 4E and West of South Ave 4 ½. (Sunrise to Sunset)	Yuma, AZ
Trolley Stations	Palomar Street & San Ysidro Caution Area (after hours of operation)	San Diego, CA
Burger King and McDonalds (Parking lot)	28 th Street (0001-0400)	Chula Vista, CA
Denny's (Parking lot)	692 E. Street (0001-0400)	Chula Vista, CA

4. PROHIBITED ACTIVITIES:

a. IAW DoDI 1325-06, Military personnel must reject active participation in criminal gangs and in other organizations that advocate supremacist, extremist, or criminal gang doctrine, ideology, or causes; including those that attempt to create illegal discrimination based on race, creed, color, sex, religion, ethnicity, or national origin; advocate the use of force, violence, or criminal activity; or otherwise engage in efforts to deprive individuals of their civil rights. Active participation in such gangs or organizations is prohibited. Active participation includes, but is not limited to, fundraising; demonstrating or rallying; recruiting, training, organizing, or leading members; distributing material (including posting on-line); knowingly wearing gang colors or clothing; having tattoos or body markings associated with such gangs or organizations; or otherwise engaging in activities in furtherance of the objective of such gangs or organizations that are detrimental to good order, discipline, or mission accomplishment or are incompatible with military service.

b. Military personnel are prohibited from participation in any activity of, or membership in, a group or organization associated with an Outlaw Motorcycle Gang (OMG) or Criminal Street Gang, including any meeting locations, events and/or activities that are known for the presence of Outlaw Motorcycle Gangs or Criminal Street Gangs. 5. Synthetic Cannabis (otherwise known as "spice" or "mamba") is often advertised and sold by retailers or manufacturers as "herbal incense" or "herbal smoking blends" and is considered a Schedule 1 controlled substance by the U.S. government. They are known to be sold in head shops, smoke shops, or other businesses that sell cannabis and tobacco paraphernalia, including, but not limited to truck stops or food-marts. If any Soldiers, Sailors, Airmen, or Marines encounter an establishment that they suspect, or become aware stocks such items, they should immediately leave or avoid entering such establishments and report it to their chain of command. Service members will bear in mind that regardless of what substances or intoxicants that state or local jurisdictions may have de-criminalized, they are still subject to federal law and military regulations surrounding these drugs and any violations can and will incur disciplinary action under the UCMJ or other appropriate authorities.

6. All establishments that are reported to stock such items may be investigated for possible designation as an off-limit establishment and carry the same prohibitions as those in paragraph 2 above. Any reports of such establishments should be brought to the attention of the chain of command and the AFDCB which may result in being added to the list in paragraph 2 above.
