If the certificate was not issued in one of the four languages indicated, it is necessary which is accompanied by a sworn translation.

The validity of vaccination certificates is the same as for the COVID-19 green certification (EU digital COVID certificate) issued by the Italian State.

For the above uses, the vaccines currently accepted in Italy and authorized by EMA are:

- Comirnaty (Pfizer-BioNtech);
- Spikevax (Modern);
- Vaxzevria (AstraZeneca);
- Janssen (Johnson & Johnson).

The healing certifications must contain at least the following contents:

- identification data of the owner (name, surname, date of birth);
- information on the holder's previous SARS-CoV-2 infection, following a test positive (date of first positive swab);

- identification data of the person who issued the certificate (State, Health Authority).

All healing certifications, in paper and / or digital format, must be accompanied from a sworn translation.

The validity of the healing certificates is the same as for the COVID-19 green certification (EU digital COVID certificate) issued by the Italian State.
