SUBJECT: Personnel Authorized to Subsist in U.S. Army Garrison (USAG) Italy
Warrior Restaurants

1. Reference: Army Regulation 30-22 (paragraph 3-38), The Army Food Program, 17 July 2019
2. Purpose: To establish an exception to policy procedures and guidelines governing the subsisting of patrons in appropriated funded Warrior restaurant facilities.
3. Due to commercial food establishments limited operating hours, I authorize the use of the Warrior Restaurant facilities to support DoD-affiliated personnel on a continuing basis.
4. This authorization provides food service support in the best interests of the Government, the installation, and all categories of personnel. The ability of non-Subsistence in Kind (SIK) personnel (i.e. non-meal card holders) to subsist in the Warrior Restaurant facility is a privilege and convenience, not an entitlement.
5. The following personnel are authorized to subsist in the Warrior Restaurant facilities:
 - a. Army Enlisted and Officers
 - b. Members of other military services
 - c. Foreign military
 - d. Department of Defense Civilian employees
 - e. Family members and dependents
 - f. Members of Army Senior and Junior Reserve Officers' Training Corps
 - g. Scouts and youth groups sponsored at either the local or national level

- h. Guests at holiday meals
 - i. Retired military personnel
 - j. Other Installation Access Pass Holders
 - k. Visiting individuals escorted by DoD personnel, including Entertainment groups and Civilian dignitaries
6. The following guidelines will apply:
- a. Subsisting non-SIK personnel will not adversely affect subsisting SIK personnel.
 - b. Personnel purchasing meals will adhere to the established times to enter the facility, dress code, and policies.
 - c. No increase in resources will be made available to subsist non-SIK personnel. This includes preparing special meals for non-SIK, saving food for non-SIK; purchasing additional food service equipment to subsist non-SIK; or amending operating hours to accommodate non-SIK.
7. Non-Sik personnel consuming any meals inside the Warrior Restaurants will not have priority over SIK Soldiers; the SIK Soldiers are the priority first and will be allowed to go to the front of the line if others are waiting first.
8. To comply with Italian and U.S. Army regulations, direct and indirect Host Nation employees may only purchase subsistence during their tour of duty. Host Nation employees may not bring guests. The term "Host Nation employee" does not include routine delivery, service repair personnel, or others who merely possess a government contract.
9. This authorization will remain on file at the Warrior Restaurant facilities and with the LRC Italy, Food Program Manager.
