MEMORANDUM FOR U.S. Army Garrison (USAG) Italy and All Supported Units

SUBJECT: U.S. Army Garrison (USAG) Italy Safety Policy

1. References:

2. Purpose: Promote a proactive safety culture within USAG Italy and its workforce.

3. Applicability: This policy applies to all Service Members, civilians, mission partners, and contractor activities at USAG Italy.

4. Policy: As the Commander of USAG Italy, the safety, health, and well-being of all personnel within our two Military Communities are of utmost importance. My priority is the protection of the safety and health of every Service Member (SM), Family Member, and employee within this community. I am responsible for the overall implementation and oversight of the Army Safety and Occupational Health Management System (ASOHMS) which will deliver a safer and healthier work environment and living space within USAG Italy, free from unacceptable risk and uncontrolled hazards, increasing mission readiness and capability.

5. Procedures:

- a. Leadership engagement is fundamental to a safe working/living environment. Leaders throughout the installation will implement and emphasize applicable aspects of the Safety and Occupational Health (SOH) program within their respective areas of responsibility.

- (1) Leadership engagement and personnel participation
- (2) Mishap incident, illness reporting, and investigation
- (3) Safety training and promotion
- (4) Safety inspection and assessments
- (5) Hazard analysis and control development
- (6) Health protection and readiness

b. Employees and Service Members will actively participate, both formally and informally, by intervening when they see unsafe behavior and/or conditions to protect all members of our community and through the identification and reporting of unsafe conditions, near misses, mishaps, and occupational illnesses via ASMIS 2.0.

c. The Garrison Safety Office will manage the SOH programs and assist all leaders, employees, SM, and members of the community in maintaining and improving the safety and health of our living and working spaces.

6. Proponent: The proponent and responsible agency for this policy is the USAG Italy Safety Directorate.
