SUBJECT: USAG Policy Memorandum #30 - Driving on Closed Routes during Physical Training (PT) Hours

- 1. Reference: AR 190-5 (Motor Vehicle Traffic Supervision), 22 May 2006.
- 2. Applicability. Soldiers, Army Civilian Employees, and their Families.
- 3. Policy:

a. Soldiers, Army Civilians, and their Families will not drive on the following designated physical training (PT) routes during the hours of 0600-0700, Monday through Saturday (including Federal Holidays).

- (1) Jackson Boulevard and Forest Drive
- (2) Kemper Street, Kershaw Street, Pickens Street, and Manigault Street
- (3) Hardee Street, Gregg Street, Forney Street, and Early Street
- (4) Dixie Road in front of building 11,000
- (5) Marion Avenue and Johnson Street
- (6) Daniel Circle, Dearing Circle, and Cleburne Street
- (7) Jackson Boulevard, Magruder Avenue, and all intersecting roads
- (8) Golden Arrow Road

b. If a Soldier, Army Civilian or Family member is stopped by Fort Jackson Law Enforcement during designated PT hours on any of the above listed roads and intersections, the following actions will be taken:

SUBJECT: USAG Policy Memorandum #30 - Driving on Closed Routes During Physical Training (PT) Hours

(1) First Offense: The offender will receive an Armed Forces Ticket (AFT)/DD Form 1408 (military only), or a United States District Court Violation Notice (USDCVN) (all others). The AFT/DD Form 1408 will be annotated in the Defense Biometric Identification System (DBIDS) and forwarded to the chain of command for action. Anyone receiving a USDCVN will receive a monetary fine, which they can contest in United States District Court. First offenders do not have the right to request an administrative hearing IAW (c) below.

(2) Second Offense: The offender will receive an AFT or USDCVN, which will be annotated in DBIDS. Further, the offender's installation driving privileges will be temporarily suspended for seven days.

(3) Third Offense: The offender will receive an AFT or USDCVN, which will be annotated in DBIDS. Further, the offender's installation driving privileges will be temporarily suspended for 14 days.

(4) Fourth Offense: The offender will receive an AFT or USDCVN, which will be annotated in DBIDS. Further, the offender's installation driving privileges will be temporarily suspended for 30 days.

c. IAW AR 190-5, paragraph 2-6(b), any suspension will not become effective until 14 days after the installation commander or designee notifies the affected person and offers that person an administrative hearing. The offender's failure to request an administrative hearing within 14 calendar days will constitute a waiver of this right.
