2. Chairman Molosso called the meeting to order at 1800 and thanked all present for their attendance and what they do every day to support Retirees and their Families. Minutes from the 9 May 2019 meeting were approved.

3. Garrison Update:

- a. Full Scale Exercise: Exercise will be conducted 23-27 September 2019. Gate closures will occur 26 and 27 September which may cause access delays.
- b. CG Bowling Tournament: Bowling tournament will be held 27 September at 1330.
 - c. A Gold Star Mother event will be held on 29 September 2019.
- d. Golf Membership Drive: The membership drive is 4 October 2019. Currently, there are 23 active duty members. Membership needs command support.
 - e. Fall Flea Market at the Solomon Center is 19 October 2019.
 - f. Gate Hours: Installation is trying to balance need versus budgetary constraints.
- g. Speed limits on Boyden Arbor are confusing. Installation will check and correct if needed.
- 4. Old Business: Ms. Edgerton, SJA, discussed the impact limited staffing has on Retirees. Currently there is one full-time attorney. Walk-in is available for Power of Attorney and Notary. Mr. Frisby works for the South Carolina Attorney General, Mr. Alan Wilson. Their office is reaching out to every county in the state to offer legal services.
- 5. New Business: None.
- 6. RSO: Retiree Appreciation Days (RAD) held 16–18 May 2019 had 727 attendees for the Expo, 30 attendees for the graduation with 20 Passing in Review, 157 golfers, 35 attendees had breakfast, and 67 played Bingo for a total of 1036 attendees. The 2019 guest speaker was SMA (Ret) Raymond F. Chandler III. Attendees commented on the positive atmosphere, information available, lunch, service quality improvements each year, and Expo vendors being sincere and courteous. Events held this year will be continued in 2020. If more bowlers do not participate, the event will probably be eliminated. Council wants to see more senior leader presence. There is very little advertising done by print, radio, and television. The 2020 Retiree Appreciation Days Operation Order will be prepared in early November 2019.
