SUBJECT: Fort Knox Policy Memo 02 – Fort Knox Warrior Restaurants Dress Code

1. REFERENCES:

a. Army Regulation (AR) 670-1 (Wear and Appearance of Army Uniforms and Insignia), 26 Jan 21.

b. Army Civilian Personnel On-Line, PERMISS (Dress and Appearance), DOD 1400.25

c. AR 30-22 (Army Food Program), 17 Jul 19.

2. PURPOSE: To establish standards of dress and appearance for all the Fort Knox Warrior Restaurants.

3. APPLICABILITY: This policy applies to all Military and DOD Civilian personnel who are dining, working, or visiting the Fort Knox Warrior Restaurants.

4. POLICY: Personnel entering or utilizing the Fort Knox Warrior Restaurants will be dressed in good taste and maintain a respectable standard of appearance. To maintain reputable standards, the Fort Knox Warrior Restaurants have established the following dress code:

a. Shoes and shirts will be worn at all times. No slides or shower shoes are allowed. Flip flops and sandals can be worn.

b. Clothing that is soiled and presents an unhealthy or unclean appearance will not be allowed.

c. Shirts intended to be worn as undergarments will not be worn as outer garments. Blouses without bras or see-through shirts will not be worn.

d. Clothing that is not of an appropriate length revealing the backside and/ or undergarments will not be worn. No belly will be shown for men and women.

e. Military issued head gear will not be worn in the Warrior Restaurants, except for the following authorized personnel identified as food service personnel, food inspectors, Law Enforcement under arms, and personnel wearing religious headgear while in civilian attire or in military uniform in accordance with AR 670-1 and 10 USC 774.

f. Clothing with slogans or patches, which are of a sexual nature, contain profanity, or are in bad taste, will not be allowed.

g. Tattoos that are extremist, indecent, sexist, racist, or otherwise offensive will be covered.

h. Soldiers may wear unsoiled summer/winter Improved Physical Fitness Uniforms (IPFU) when dining, working, or visiting the Fort Knox Warrior Restaurants, during on/ off duty hours and/ or unless otherwise directed by the Commander.

i. No mixed uniforms or any part of a uniform will be worn with civilian attire, including motor pool coveralls, or OCP tee-shirts (excluding the IPFU jacket) in accordance with AR 670-1, unless otherwise directed by the Commander.

j. Weapons are not authorized in the Warrior Restaurants except for Law Enforcement personnel while on duty.

3. All personnel entering the Fort Knox Warrior Restaurants will adhere to these guidelines or will be directed to leave the Warrior Restaurant or provided the option to acquire a meal to go (carry-out container).
