MEMORANDUM FOR All Military Personnel, Department of Defense (DOD) Civilians, Contractors and Family Members assigned to, living, or working in the United States Army Garrison, Kwajalein Atoll (USAG-KA)

SUBJECT: Policy Memorandum 190-13-1, Photography and Video Recording Restrictions on USAG-KA Installations

1. In accordance with Paragraph 6-4 and 6-5 of Army Regulation (AR) 190-13, photography in restricted areas of USAG-KA is prohibited, with the exception of photographs taken for official purposes and commercial imaging surveillance by photography or video recording, is prohibited at Army locations. For this location no photographs should be taken south of 9th Street and of restricted areas. Restricted areas include the airfield, Echo Pier, and fenced areas. PMO has a complete list of restricted area facility numbers. Photography, in restricted areas, for unofficial purposes must be authorized by the Commander or designated representative in advance.

2. Examples of official photography are as follows:

a. Safety personnel obtaining photographs of the airfield, flight line activities, and conditions for the sole purpose of documenting unsafe practices, deviations from established procedures, and reporting facility conditions. Photographs will be used as training tools to identify and correct unsafe practices, or document the conditions of facilities, personnel and runways.

b. All ceremonies, unexploded ordnance detonation, discovery of marine mammals, construction and phases of construction by authorized government personnel or contractors in conjunction with the performance of their official duties.

3. The following Government and Contracting personnel are authorized to perform official photography in the restricted areas of Bucholz and Dyess Army Airfields, flight lines, and airfield facilities. These photographs will be taken for the sole purposes listed in 2.a., above.

a. Aviation/Airfield Flight & Safety Officials.

b. Public Works Engineers.

c. Environmental Engineers.

d. Health & Safety Representatives.

4. The personnel listed above will prominently display, at all times while taking photographs, a brightly colored badge issued by the Security Access Control Contractor. This badge will meet all standards listed in AR 190-13, Army Physical Security Program and state the position of the individual and contain the statement "Airfield Photography Authorized."

5. Public release, dissemination or use of official photographs for any purpose other than an official purpose is prohibited. Public release, dissemination or use of unofficial photographs taken in restricted areas for purposes other than those approved by the USAG-KA Commander, are likewise prohibited. Appropriate administrative actions, to include loss of photography privileges, confiscation of photographs and all equipment and punishment under 18 USC 795 may result from the unauthorized use of official and unofficial photographs.

6. Entities requiring the placement of Closed-Circuit Television (CCTV) must receive approval and register all equipment with the Provost Marshal Office. Ensuring the placement of CCTV recording devices will not capture any restricted areas. Restricted areas include the airfield, Echo Pier, and fenced areas. PMO has a complete list of restricted area facility numbers. Appropriate administrative actions, to include confiscation of all CCTV equipment and punishment under 18 USC 795 may result from the unauthorized placement of CCTV equipment.
