SUBJECT: Off-Limits Establishments

1. References.

- a. AR 190-24, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, 27 July 06.
- b. Uniform Code of Military Justice, 2019 Edition.

2. PURPOSE. To eliminate conditions which adversely affect the health, safety, welfare, morale, and discipline of Service Members assigned to Fort Lee.

3. SCOPE. This Policy is effective immediately and will remain in effect until further notice in accordance with AR 190-24. Civilians and Family Members should be aware of these off-limits restrictions. Failure to obey this policy constitutes a violation of Article 93 of the Uniform Code of Military Justice (UCMJ). This policy applies to:

- a. All Armed Forces personnel assigned or attached to Fort Lee.
- b. All Armed Forces personnel for whom the U.S. Army Combined Arms Support Command (CASCOM) Commander is the General Court-Martial Convening Authority.
- c. All Armed Forces personnel in Temporary Duty (TDY) status whose TDY orders specifically state that they are attached to Fort Lee for UCMJ purposes.


