Why YOU should participate in Deployment Diversion:

The average person generates about 4.5 lbs of trash per day. Deployments and PCS moves can amplify that number.

Help us achieve JBLM's Sustainability goal:

- Achieve zero net waste by 2025
- Comply with the JBLM mandatory recycling policy
- Reduce costs for JBLM incurred from disposal of waste
- Increase revenue for JBLM from sale of recyclables goes towards MWR programs

Many items generated in quarters can be reused. If it is in good shape consider donating to local missions or thrift stores. Items that are unsalvageable may have value as a recyclable item.

Some items generated in quarters are considered hazardous material.

- Refrigerators contain ozone depleting chemicals. They are not allowed to be placed in a dumpster.
- MRE's with heaters still intact are not allowed in the dumpsters. They are considered household hazardous waste
- Aerosol cans (fragrance sprays, etc)
- Household cleaners
- Light bulbs
- Batteries

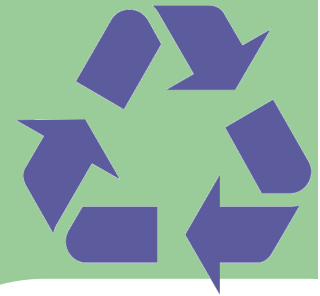

What is deployment diversion?

As deploying Servicemembers clear the barracks, there is a spike in waste generation, an increased cost in disposal of waste, and improper disposal of hazardous material.

Improper disposal could result in fines from the EPA.

Deployment Diversion encourages JBLM tenant units to decrease overall waste through proper segregation of hazardous materials, reusable items, and recyclable items. This will reduce fines, comply with mandatory recycling policies, reduce dumpster overflow, and increase revenue from recyclables. The money generated in the Qualified Recycling Program (QRP) is used for MWR activities and facilities on JBLM.
