- Working knowledge of the SIGINT Enterprise and NGA
- At a minimum, must have expertise on the following equipment:

 - DRT
 - H-Pack
 - PRD-13
 - SIGINT Terminal Guidance (STG)
- Must be a U.S. Citizen.
