SUBJECT: USAG FHL Policy # 3-6, Updated COVID-19 Mask Guidance for Fort Hunter Liggett

1. REFERENCES:

a. Updated Mask Guidance for all DoD Installations and Other Facilities from the Under Secretary of Defense, dated 1 March 2022

b. Headquarters Department of the Army (HQDA) Fragmentary Order (FRAGO) 19 to Execution Order (EXORD) 225-21

c. Secretary of Defense Memorandum, "Guidance for Commanders' Risk-Based Responses and Implementation of Health Protection Condition (HPCON) Framework during the Coronavirus Disease 2019 Pandemic," April 29, 2021

2. PURPOSE. To provide guidance to Fort Hunter Liggett (FHL) Tenants, Department of Defense (DoD) Civilians, DoD contractors, Family members, and other agencies on FHL's COVID-19 mask requirements.

3. APPLICABILITY. This policy applies to all Service members, DoD Civilians, DoD contractors and Family members who live, work or conduct business on FHL. Commanders at all levels, are responsible for the complete implementation of this policy and will ensure all personnel are in compliance. Units permanently assigned to FHL are to include this policy in their unit safety program and will display it on unit safety boards. Unit commanders or Officers in Charge, temporarily assigned to the installation for training purposes, shall ensure their personnel are briefed on the requirements of this policy. All individuals subject to this policy have the individual duty to know and understand this policy. Personnel who are uncertain about any aspect of this policy should raise their questions to their supervisors or their chain of command.

4. USAG FHL Policy #1-8, Updated COVID-19 Mask Guidance for Fort Hunter Liggett, is hereby rescinded. In accordance with HQDA FRAGO 19 to EXORD 225-21, all personnel shall follow and comply with the Under Secretary of Defense Memorandum, "Updated Guidance for Mask and Screening Testing for all Department of Defense Installations and Other Facilities, dated 1 March 2022.

5. POLICY. Effective 10 March 2022, Tenants, DoD Civilians, DoD contractors, Service members, Family members, Visitors, and other agencies on FHL, are recommended to

wear masks but not required. This guidance may be subject to change pending CDC, HQDA guidance, and COVID-19 community transmission levels.
