

U.S. Army Garrison Fort Hunter Liggett & Parks Reserve Forces Training Area March 27, 2020





There are no confirmed cases of COVID-19 at FHL or PRFTA. Both installations have COVID-19 webpages with HPCON levels, commanders' messages and links to resources. People are advised to follow CDC guidelines to practice good hygiene, stay away from sick people. Staff at both installations have been reduced to mission essential and most employees are teleworking or taking leave.

Highlights for FHL: Installation is at HPCON Bravo+ with most employees teleworking. DES executed Team Clean to sanitize the fire station and dispatch center. Staff working on post are using social distancing to reduce risks, and continue to support military training as needed. The Hunting & Fishing Program continues with some restrictions.

Highlights for PRFTA: Installation is at HPCON Charlie with most employees teleworking. Parks Commander was the guest speaker at the Los Positas College 8th Annual Women Veterans Luncheon on March 11.

FHL and Parks Reserve Forces Training Area provides base operations support enabling total force readiness while providing for the well-being and security of Soldiers, Family members and Civilians on post. It is the seventh largest Army installation and the largest Army Reserve installation in the country. GARRISON READINESS COVID-19 Response Process





Fort Hunter Liggett is ready to respond to suspected COVID-19 cases. Once a suspected case is reported, the installation response process begins TEAM TRACE. This team researches all locations and individuals the person may have come into contact with. Then TEAM CLEAN activates to disinfect all identified areas. Pictured are Directorate of Emergency Services staff donning on appropriate protective equipment and cleaning and disinfecting the Dispatch Center and work-out area. Crews ensure cleaning material are disposed in strict compliance with national standards. TEAM SUPPORT concurrently checks in with exposed individuals to provide support as needed. Quarantined individuals are asked to self-monitor and contact medical providers for advice and service. GARRISON READINESS Emergency Operations




