

### How Do I Change My Mailing Address for HONORS?

Mailing addresses for HONORS are obtained from the same sources as those used for mailing of Army Echoes. Please refer to the following if you need to change your address:

- Retirees entitled to retired pay should mail changes to: DFAS, U.S. Military Retirement Pay, 8899 E 56th Street, Indianapolis, IN 46249-1200; call 800-321-1080; or fax 800-469-6559.
- Surviving spouses in receipt of survivor benefit pay should mail changes to: DFAS, U.S. Military Annuitant Pay, 8899 E 56th Street, Indianapolis, IN, 46249-1300; call 800-321-1080; or fax 800-982-8459.
- Retirees entitled to retired pay and survivor annuitants can also access and make changes to their accounts online at www.dfas.mil and selecting the icon "My Pay." If you have a PIN, you can access your account and make the appropriate change. If you do not have a PIN, request one, and a temporary PIN will be mailed to you. The temporary PIN is good for initial access, and you will be prompted to establish a permanent pin. For those who have computer access this is the suggested means.
- Retired Reservists not yet age 60 should mail changes to: U.S. Army Human Resources Command, ATTN: AHRC-PDP-TR, 1600 Spearhead Division Ave. Dept. 482, Fort Knox, KY 40122-5402 or call 888-276-9472.

Since its launch in 2002, the Federal Long Term Care Insurance Program (FLTCIP) has offered active and retired members of the uniformed services and their Families, the opportunity to take control of their future long-term care needs. Designed to be both flexible and affordable for a range of budgets, the program has grown to be the largest of its kind in the nation, with more than 300,000 enrollees. When enrollees are asked why they value the FLTCIP, the following reasons typically top the list.

# Flexibility: A choice of care settings and providers

The FLTCIP can give enrollees confidence that, if a long-term care event occurs, their insurance will help reimburse for care in the setting of their choice, whether at home, in an assisted living facility, or in a nursing home. Both formal care from licensed professionals and informal care provided by friends and Family members are covered. Benefits for informal caregivers who are Family members are limited to 500 days in your lifetime. To be eligible for reimbursement as an informal caregiver, a Family member must not have been living in your home at the time you became eligible for benefits.

In fact, coverage for informal care has been a hallmark of the program from the start. By reimbursing friends and Family members who serve as caregivers, the FLTCIP makes it possible for enrollees to remain at home and avoid or postpone entering a facility. The importance of what's called "aging in place" (and receiving care from a familiar individual) is evident in the FLT-CIP's claim history. The program can be especially attractive to individuals who value their independence and who may worry about relying on a spouse or children should they need care. Having such coverage helps spouses maintain their current lifestyle and minimizes the financial and emotional sacrifices adult children are often asked to make when a long-term care event occurs.

# Protection: Helping to safeguard retirement savings and assets

Another key to the program's success is its ability to help protect retirement income and savings from the high cost of care. Families who have experienced a long-term care event know that services can be expensive, and that costs continue to escalate. For instance, three years of care at home with a health aide, in an assisted living facility, or in a nursing home can range from \$88,920 to more than \$248,000.

## **TRICARE** For Life

### **TRICARE** For Life

TRICARE For Life is Medicare-wraparound coverage for TRICARE-eligible beneficiaries who have Medicare Part A and B.

- Enrollment not required
  - o Coverage is automatic if you have Medicare Part A and B
  - o You must pay Medicare Part B premiums
- Available worldwide:
  - o TRICARE pays after Medicare in the U.S. and U.S. Territories
  - o TRICARE is the first payer in all other overseas areas

### Who Can Participate?

TRICARE-eligible beneficiaries who have both Medicare Part A and B can use TRICARE For Life. Not sure if you're eligible? Check out the Eligibility Page for details.

### How it Works

You may visit any authorized provider. >>Find a Doctor

- Your provider files your claims with Medicare.
- Medicare pays its portion and sends the claim to the TRICARE For Life claims processor. >>View what Medicare pays
- TRICARE For Life then pays the provider directly for TRICARE-covered services.
- You won't receive a TRICARE wallet card, all you need is your Medicare card and military ID as proof of coverage.

You can get care at military hospitals and clinics, but only if space is available. >>Find a Military Hospital or Clinic

### What You Pay

You don't pay any enrollment fees, but you must pay Medicare Part B monthly premiums. Your Part B premium is based on your income.

# 2022 Cost of Living Adjustment COLA

Based on the increase in the Consumer Price Index, there will be a 5.9 percent Cost of Living Adjustment (COLA) for most retired pay and Survivor Benefit Plan annuities, and the Special Survivor Indemnity Allowance (SSIA), effective Dec. 1, 2021.

With the COLA applied, the maximum amount of SSIA payable will be \$346.

Retirees will see the change in their Dec. 30, 2021 payment. Annuitants will see the change in their Jan. 3, 2022 payment.

#### **TRICARE For Life Contractors**

The TRICARE For Life contractors assist with claims and provide customer service to all beneficiaries using TRICARE For Life.

- In the U.S. and U.S. Territories: Wisconsin Physicians Service (WPS)
- All other overseas areas: International SOS

#### Is TRICARE For Life Right for You?

TRICARE For Life is the plan for you if:

- You're eligible for TRICARE
- You have both Medicare Part A and B

Coverage is available worldwide and you can see any provider you want. However, you'll pay more if you get care from Veteran's Administration providers or providers who opt-out of Medicare, because they're not allowed to bill Medicare.

When retired Service members and their families become eligible for TRICARE For Life, typically at 65, they are no longer able to enroll in TRICARE Prime.

#### Individuals with COVID-19 type symptoms should not attend these events and remain home for the safety of themselves and others.

COVID-19 Vaccinations and appropriate boosters are highly recommended prior to attending.

Appropriate masks should be worn consistently and correctly (over mouth and nose).

Appropriate masks should be worn in any common areas or shared workspaces (including open floorplan office space, cubicle embankments, and conference rooms). Maximum numbers may be enforced

In general, people do not need to wear masks when outdoors.

However, consistent with CDC guidance, those who are not fully vaccinated should wear a mask in crowded outdoor settings or during outdoor activities that involve sustained close contact with other people who are not fully vaccinated.

While serving in the military, the Service member does not need to look far to find answers to most any questions regarding benefits, assistance and entitlements. Upon retiring however, many Service members and families are unsure of where to go or who to call for information or assistance. Obtaining a DS Logon:

As a Department of Defense (DoD) Retiree you have several options available to you to obtain a DS Logon. These options are listed in order to provide you with the highest level of access as quickly and securely as possible. You must be enrolled in Defense Enrollment Eligibility Reporting System (DEERS) to obtain a DS Logon.

#### 1. Defense Financial Account Service (DFAS) Registration

As a DFAS myPay account holder, you are able to quickly obtain a DS Logon account by authenticating with your DFAS myPay account. Select Register and select DFAS as your registration method and then enter your DFAS myPay Username and Password.

#### 2. E-mail Registration

You may use your current DoD Beneficiary ID card to quickly obtain a DS Logon Premium account by using your e-mail on file in DEERS. Select Register to enter the registration process and select "I have an active DoD ID card and an e-mail on file in the Defense Enrollment Eligibility Reporting System (DEERS)". In order to use this method to register you must have a valid e-mail on file in DEERS.

#### 3. Online Remote Proofing

Select Register to enter the registration process. A series of questions will be asked in order to provide you with the highest level of access as quickly as possible. If you do not have a CAC or DFAS myPay and do not know if you have an e-mail on file in DEERS select the last option, I have none of the above. Next you will be asked to enter your personal information so we can locate your record in DEERS. You must be enrolled in DEERS to obtain a DS Logon. Once your record is located you may continue the registration process by personalizing your account settings (setting your password and selecting challenge questions). You



will be provided your username once your basic account is created. You will then be prompted to upgrade your account immediately through our online remote proofing process.

#### 4. RAPIDS

You may request a DS Logon while getting a DoD ID card issued. You must notify the Verifying Official of your request while processing the issuance of your DoD ID card. You can locate the nearest RAPIDS facility at: RAPIDS Site Locator. You must provide an e-mail address not used by anyone else in your family and a personal identification number (PIN) that will be used to register for your DS Logon account. Once you have requested a DS Logon account, you will receive a DS Logon activation e-mail within 24 hours. After receiving the activation e-mail follow the instructions and return to this website to activate your account using your activation code and the PIN you created. Keep in mind the activation code is only good for 7 days.

# 5. In-person Proofing at a VA Regional Office (VARO)

This process is used to verify your identity in person with the VA. You can visit one of the 50+ VA Regional Offices throughout the country. To locate your nearest VARO, visit the VA website and search the VA Regional Benefits Offices.

- o Before visiting a VARO, please locate your two I-9 Identity Documents.
- o While at the VARO, please make sure the Operator has your current address on file.
- o Once your DS Logon request is completed, you will receive a DS Logon activation letter via U.S. mail in 7-12 business days. After receiving the activation letter simply return to this website to activate your account.

# Cyber Scams and Cyber Awareness By U.S. Army Office of the Provost Marshal General, Antiterrorism Division WASHINGTON

— With the global COVID-19 pandemic forcing many to telework, we've become more dependent on virtual information exchanges and information technology systems. And as we become more reliant on technology, we become more vulnerable to cyberattacks. But how much do you know about the risk associated with the cyber domain? Two cybersecurity topics that everyone should be mindful of are (1) the risk from cyber scams and (2) the fundamentals of protecting yourself from cyberattacks.

**1. Cyber Scams**: Cyber scams are on the rise, and so are the creative tactics that criminals use to exploit victims. A brief introduction to some of the common cyber scams is provided below. To learn more about these scams and other cybercrime threats, visit the U.S. Army Criminal Investigation Division's Cybercrime Prevention Flyers website (https://www.cid.army.mil/mcu-advisories.html), where you will find more than 30 products to strengthen your cybersecurity posture and prevent cybercrime before it occurs.

- Social Media Scam: Scammers are using social media sites like Instagram, Snapchat, and Facebook to run ads or send private messages to military members, trying to scam them out of their hard-earned money. Scammers pose as former or current military members, bank officials, day traders, financial consultants, or debt relief agents offering ways for you to make thousands of dollars fast.
- Phishing Scam: A phishing email is an email designed to convince the recipient to divulge personal information, banking or credit card information, or the password to a personal account.
- Internet Email/Blackmail Scam: A blackmail email arrives in your inbox and lists your password, or at least a password you've used before. The sender explains they have recorded video of you watching online pornography, cheating on your spouse, or some other personally embarrassing behavior. The sender threatens to send the video to your

family and friends if you fail to pay them "hush money."

- Employment Scam: An employment scam is an attempt to defraud job seekers through the use of deception with the intention of personal or financial gain.
- Government Impersonator Scam: This scam involves someone pretending to be a government official who tries to convince you to send money or share your sensitive personally identifiable information (PII).
- Housing Rent Scam: Housing rental scams are increasing worldwide, especially during the pandemic. There are millions of fake listings for apartments and houses listed in classified ads and on supposedly reputable rental sites. Scammers advertise rentals that do not exist, are no longer available, or are actually homes for sale.
- Telephone Fraud Scam: A scammer calls claiming to be from a government entity, a court, the IRS, an insurance company, or a debt collection company. The caller forcefully and aggressively states that you are delinquent on a debt, or overdue on paying your taxes, and your credit score will be ruined if you don't settle the bill immediately.

Protect the Army and Yourself from 2. Cyberattacks: In May 2021, Secretary of the Army Christine Wormuth stated at her confirmation hearing: "I am greatly concerned, frankly, by the threats that we face in the cyber domain." The Secretary's concerns were largely directed at the potential for cyber infrastructure attacks impacting Army readiness. However, the risks from cyberattacks span the entire Army community, including individuals such as Retired Soldiers. Recently, in support of the Army Antiterrorism FY22 focus areas, TRADOC's Signal School developed a cyber-security awareness product (pictured here) to remind community members to #DoYourPart to prevent cybercrime by being cyber aware.

## VA Offers Airborne Hazards, Burn Pit Registry:

FALLS CHURCH, Va. -- Department of Veterans Affairs officials developed the Airborne Hazards and Open Burn Pit Registry to help Service members and veterans document potential exposure to airborne hazards while serving overseas. The registry is a secure database of health information voluntarily provided by Service members and veterans that helps VA collect, analyze, and report on health conditions that may be related to environmental exposures experienced during deployment. As part of the registry, Service members and veterans can participate in an optional medical exam to discuss their health with a care provider. Participation in the registry will not affect access to health care or benefits, and it is not related to the VA disability compensation claims process. "In addition to encouraging eligible Service members and veterans to register, we are working across the Military Health System and in collaboration with VA to make it easier for health care providers to access patients' environmental exposure data and assess their health concerns," said Steve Jones, Force Readiness and Health Assurance Policy director and a retired Army environmental science and engineering officer. "Through all these efforts, we'll continue to collect critical data and gain a better understanding of how airborne hazards impact our troops' short and long-term health." Eligibility VA staff determine eligibility for the registry based on deployment information from the Department of Defense. Service members and veterans who deployed to the Southwest Asia theater of operations on or after Aug. 2, 1990, or in Afghanistan or Djibouti on or after Sept. 11, 2001, may be eligible to sign up for the Airborne Hazards and Open Burn Pit Registry. These regions include the following countries, bodies of water and the airspace above these locations: Afghanistan; Bahrain; Djibouti; Gulf of Aden; Gulf of Oman; Iraq; Kuwait; Oman; Qatar; Saudi Arabia; United Arab Emirates; and waters of the Arabian Sea, Persian Gulf, and Red Sea. Disability claims processing begins for some particulate matter conditions: WASHINGTON --The Department of Veterans Affairs began processing disability claims Aug. 2 for asthma, rhini-

tis and sinusitis on a presumptive basis based on presumed particulate matter exposures during

military service in Southwest Asia and certain other areas if these conditions manifested within 10 years of a qualifying period of military service. VA conducted the first iteration of a newly formed internal process to review scientific evidence to support rulemaking, resulting in the recommendation to consider creation of new presumptions of service connection for respiratory conditions based on its evaluation of a National Academies of Science, Engineering and Medicine report and other evidence. The process concluded that particulate matter pollution is associated with chronic asthma, rhinitis and sinusitis for veterans who served in the Southwest Asia theater of operations beginning Aug. 2, 1990 to the present, or Afghanistan, Uzbekistan, Syria or Djibouti beginning Sept. 19, 2001 to the present. VA's review also concluded that there was sufficient evidence to presume that these veterans have been exposed to particulate matter. VA will conduct outreach to impacted veterans and survivors to inform them about their eligibility and will provide information on how to apply. Veterans and survivors who believe they may be eligible for the newly established presumptive conditions are encouraged to apply. They should file a VA Form 21-526EZ if applying for the first time or a VA Form 20-0995 if they are reapplying for these conditions. # 6 in 10 Retirees Have Incorrect Information in DEERS:

When TRICARE officials tried reaching a group of retirees with critical information recently, more than 6 out of 10 had incorrect information in DEERS. To maintain medical benefits and receive crucial health care and benefit communications, retirees and surviving spouses must maintain accurate information in the Defense Enrollment Eligibility Reporting System. Beneficiaries need to update their information in DEERS so that health care teams can contact people with critical healthcare and appointment information; vital authorizations; claims; and enrollment information. Retirees and surviving spouses enrolled in any TRICARE plan need to update DEERS as soon as possible anytime they move, change contact information, or experience a qualifying life event such as:

- Change in sponsor's status
- Having a baby or adopting
- There is a change in a student's full-time enrollment status
- Becoming eligible for Medicare
- Death of sponsor or family member
- Marriage or divorce

# **DFAS Announces Status** Notification System:

CLEVELAND – Defense Finance and Accounting Service officials recently announced an improvement for retirees and Survivor Benefit Plan annuitants. DFAS is rolling out the use of status notifications to keep customers in the loop as forms or documents they submit move through the retired pay or annuitant pay processing cycles. Status notifications are a three-step process that updates customers when DFAS receives forms or documents for processing by mail or fax, or in some specific cases, through AskDFAS. Customers will receive separate status notifications when their form or document is:

1. Received and queued in the DFAS work system

- 2. Assigned to be worked
- 3. Completed, with either a notification that processing is complete or a notification that DFAS is sending a request for additional information.

To be eligible to receive status notifications, customers should ensure their email address is available and updated in myPay. To add or ensure an email address is up-to-date, visit myPay. The first rollout of status notifications involved submissions related to the Survivor Benefit Plan, including the DD 2656-6 for SBP changes and the DD 2656-7 SBP annuity startup form, as well as school certifications, the direct deposit form-SF 1199, and change of address requests. These were followed by requests related to federal tax changes (for retirees or annuitants), state tax changes (for retirees) and the designation of beneficiary for arrears of pay. Status notifications for additional categories of requests will be added throughout the coming year. ### Start a Survivor Benefit Plan Annuity

If you are the designated beneficiary of a deceased military Service member's Survivor Benefit Plan, there are several documents we need to begin your SBP annuity account:

Use the DD 2656-7 Form Wizard to fill in your form The DD 2656-7 Form Wizard https://www.dfas.mil/ RetiredMilitary/survivors/ApplySBP/ will help you fill out the DD 2656-7 - Verification for Survivor Annuity form. The form wizard will ask you a series of questions and fill in your answers in the appropriate areas of the form. When you have finished answering the questions, you can click a button to generate a ready-to-print PDF with your answers.

Please remember you will need to sign and date this form, and then submit it to DFAS, along with the appropriate supporting documentation.

#### How to use the Form Wizard

You can download the entire DD 2656-7 Form Wizard (right click and choose "Save As") to your Windows or MAC computer. You will need compatible PDF software, such as the free Adobe Acrobat DC software, available at adobe.com. We do not recommend saving the Form Wizard to a shared computer, because it contains personally-identifiable information. When using Chrome, Edge, Firefox or Safari to access an Adobe form wizard, the user may initially receive a pop-up attached message. The user must download the pdf (by clicking the download icon in the upper right-hand corner of the page), then double-click on downloaded file. It is suggested to use the form wizard on a personal device. Using the form wizard on a DFAS computer may not have the same functionality as a personal device.

Alternatively, you can complete and send the following documents:

#### Verification for Survivors Annuity

DD2656-7 - PDF form to print and fill out, OR DD2656-7 Form Wizard for Spouses, Former Spouses and Child Annuitants Withholding Certificate for Pension or Annuity (IRS W-4P) - To have federal taxes withheld from the annuity

**Fast Start Direct Deposit Form** (FMS 2231) - To have payments directly deposited to your bank account, OR Direct Deposit Enrollment Form (SF 1199A), OR International Direct Deposit Enrollment Form (SF 1199-I)

If any of the following circumstances apply to you, please also send the relevant document(s):

If you have not already sent to DFAS: a copy of the retiree's death certificate showing cause of death or a Service member's DD 1300 Report of Casualty Citizenship Affidavit - Only needed if the claimant lives outside of the United States and is anyone other than the retiree's child

**IRS Form W8-BEN** - Only needed if the claimant is a nonresident alien and their country of citizenship has a tax treaty with the United States

**DD Form 2790** (Custodianship Certificate of Minor Child) - Only needed if a claimant is a minor (under age 18). Click this link for a helpful checklist to complete this form. Click this link for a helpful how-to video to complete this form.

DD 2788 (Child Annuitant's School Certification) -Only needed if the claimant is over age 18 but under age 22 and attends school full-time

Legal Representative Documentation - Only needed if someone signs on behalf of the claimant; a copy of supporting documentation such as a Power of Attorney, Guardianship, or Representative Payee is required. # FEDVIP/BENEFEDS

#### Eligibility

The Federal Employees Dental and Vision Insurance Program (FEDVIP) is available to eligible Federal and U.S. Postal Service (USPS) employees, annuitants, survivor annuitants, and compensationers. FEDVIP eligibility has also expanded to include certain retired uniformed Service members, active duty family members, and survivors.

You can't make FSAFEDS enrollment or demographic changes through BENEFEDS, even if you made those same demographic changes to your BENEFEDS account—you must do so through www.fsafeds.com. It's important to make any demographic changes with both BENEFEDS and FSAFEDS as each entity administers different parts of FSAFEDS. VA issues the Notice of Funding Opportunity in the Federal Register to foster competition among technology developers, funding innovation that will best serve the needs of certain seriously disabled Service members and Veterans.

Since 2016, when VA awarded its first SAHAT grant, VA has awarded 22 grants. To date, these grants have resulted in the introduction of new products to the accessibility industry used to improve the lives of Veterans, including: bed or chair. "Awarding up to \$200,000 per grant to develop technology will ultimately help make homes more livable for seriously disabled Service members and Veterans," said Principal Deputy Under-Secretary for Benefits Mike Frueh.
