#### Some News Notes of Interest:

- On Monday, May 17, Kimbrough Ambulatory Care Center began offering COVID-19 vaccinations to all DoD eligible beneficiaries 12 years of age and older at McGill Training Center. COVID-19 vaccinations are available on a walk-in basis or by appointment via the <a href="https://informatics-stage.health.mil/COVAX/">https://informatics-stage.health.mil/COVAX/</a>. Please note: All vaccinations are provided at McGill Training Center Mondays, Wednesdays and Fridays from 8 a.m. 3:30 p.m.
- There have been a lot of questions regarding the scope of the installation's mask policy. Here's the Garrison's current policy (**Outdoor or Indoor**):
  - 100% Vaccinated (2 Shots +14 days) = NO MASK Requirement; Not 100% Vaccinated = MASK
  - Kids not vaccinated = MASK (Includes kids under 12 who are not able to be vaccinated)
  - Working or attending CDC / CYS = MASK (No Exception)

- Working or attending medical services (KACC or DENTAC) = MASK (No Exception) This guidance is good for all service areas not mentioned above to include PX and COMMISSARY and other community areas.

**\*Please note:** Individual commands and non-garrison organizations can implement their own specific mask policies based on their requirements.)

• Fort Meade Fingerprinting Operations are conducted on Tuesdays and Thursdays from 10 a.m. – noon, and all appointments should be scheduled in advance on the FGGM SharePoint. If an

## New Motorcycle Training Range for Fort Meade

Motorcycle training at Fort Meade is revving up! With the completion of a new training range, mandatory Basic Rider Course (BRC), Experienced Rider Course (ERC) and Military Sports Bike Rider Course (MSRC) training will be provided at no-cost to all tenant military personnel stationed here at Fort Meade, and for all active duty army personnel Army wide. An approved MSF course is mandatory in accordance with Army Regulation 385-10, and Department of Defense Instruction 6055.4, DoD Traffic Safety Program, for all military personnel who ride.
