The Army Community Service (ACS) Family Support EFMP can assist you with systems navigation, advocacy for special housing modifications, respite care, recreational events, monthly special needs support groups, special needs resources, information about your rights and responsibilities, and much more. Our office hours are Monday through Friday, 0730-1600. We welcome you to contact us!

For example, if you want to know about your rights and responsibilities under the Individuals with Disabilities Education Act, just click on the first listing under "Extended Resources".

A few other important in-processing reminders:

-Visit the Corvias Military Housing website for housing information at <http://meade.corviasmilitaryliving.com/>. You can notify Corvias of your specific housing needs and get on the waiting list prior to your arrival. For our EFMP Families seeking to live on base that are seeking housing modifications and/or accommodations for their EFM's please complete the Corvias Reasonable accommodation and Modification Request Form – and have your EFM's medical provider complete the Corvias Medical Verification Memo. Some EFMP facts:

-The EFMP is a mandatory enrollment program that is based on public law and Department of Defense mandates. The program works with other military and civilian agencies to provide comprehensive assistance, coordination, medical, educational, housing, community support and personnel services to military Families with special needs.

-Three groups of Soldiers with Exceptional Family Members (EFMs) are required to enroll in the program: active duty Army; U.S. Army Reserve (USAR) Soldiers in the USAR-Active Guard Reserve (AGR) Program; and Army National Guard AGR personnel serving under the authority of title 10, United States Code and title 32, United States Code.

-Soldiers are responsible for keeping their EFM's medical and/or special education documentation updated every **three** years or when the **condition changes, whichever comes first**. Soldiers are enrolled permanently in the program unless medical or special education needs warrant closure or the Soldier is separated from the Army. Screening occurs during in-processing, readiness processing, and out-processing if Soldiers indicate they have or suspect they have an EFM. For more information about your rights and responsibilities under the EFMP, please refer to AR 608-75.

Emergency Information Sheet for Special Needs Family Members Living on the Installation

The following information can be utilized by our Fort Meade Police Department to better provide emergency services to our Family Members with special needs. The information is voluntary but highly encouraged for safety. Examples of special needs may include physical disability that makes rapid and easy mobility difficult, allergies, difficulty communicating, blind or deaf, and autism or an intellectual or developmental delay. As well as various health conditions which makes them medically fragile. Other beneficial information for them to have would be any behavioral special needs for the purpose of potential child elopement or actions that may exacerbate stress response.
