MEMORANDUM FOR Presidio of Monterey Installation

SUBJECT: United States Army Garrison (USAG) Presidio of Monterey (PoM),  
Command Policy #24 - Appropriated Fund Dining Facility (DFAC) Rules and Dress  
Code

1. References:

- a. AR 30-22, The Army Food Program.
- b. DA PAM 30-22, Operating Procedures for the Army Food Program.
- c. TB MED 530, Tri-Service Food Code.

2. Purpose. To prescribe the conditions under which authorized personnel are permitted to dine in the PoM Appropriated Fund DFACs.

3. Applicability. This policy applies to all personnel who are given approval to dine in PoM's Appropriated Fund DFACs.

4. The following rules apply to all patrons of the DFACs:

a. Food or drink served in the DFACs will not be taken out of the DFACs. Exceptions are DFAC and Grab-n-Go issued food and beverage containers for Service Members only, during all meal periods. Service Members that receive a to-go container are not authorized to dine in either DFAC during that meal period.

b. Condiments, dinnerware, glassware, and silverware will not be removed from the DFACs.

c. Food spillage, broken containers, or defective dinnerware will be brought to the attention of a DFAC Manager.

d. Abusive language, loud talking, or yelling are not authorized.

e. Public displays of affection (kissing, holding hands, hugging) are not authorized.

5. The following items and activities are prohibited:

- a. Backpacks, book bags, large purses, non-DFAC and non-Grab-n-Go containers, etc.
- b. The use of cellular phones or any other sound producing devices while in the serving lines.
- c. Crowding or socializing around the cashier stations and exit routes.
- d. Dirty, torn, ragged, or hazardous smelling clothing.
- e. Sleeping attire, bathrobes, and open toe slippers or sandals.
- f. Shirts or blouses that expose the midriff, do not cover the armpits, or are made of see-through material.
- g. Obscene themed shirts or patches or clothing that is placed obscenely.
- h. Short shorts or cut-offs of any kind.
- i. Head coverings will not be worn indoors, unless for religious accommodation, in an official capacity, under arms, Drill Sergeants, or when directed by the Commander, such as for indoor ceremonial activities.

6. Service Members with sweat stained, wet, or dirty Military Physical Fitness Training (PT) uniforms from any branch of service are not authorized to dine in the DFACs. To-go containers are available upon request at both Chay Hall and Belas Hall DFACs, and at the Chay Grab-n-Go during meal periods.

7. Televisions will be set to news channels or sports channels and operated by the DFAC staff only.

8. Failure to comply with established rules and/or dress code may be cause for denied entry or removal from the DFAC.
