SUBJECT: Command Policy Memorandum # 46, Alcoholic Beverages

1. References:

a. AR 215-1, Chapter 10, Military Morale, Welfare and Recreation Programs and Non-Appropriated Fund (NAF) Instrumentalities, 24 September 2010.

b. AR 600-85, The Army Substance Abuse Program, 23 July 2020

c. TRADOC Regulation 350-6, Enlisted Initial Entry Training Policies and Administration, 9 August 2019

2. Purpose: Reference b. above (AR 600-85) requires Commanders to conduct and make available to personnel under their command, programs that discourage irresponsible use of alcoholic beverages, reduce or eliminate alcohol-related incidences, and promote responsible social behavior, such as the Designated Driver or Dial-A-Ride Programs.

3. Policy:

a. Scope. This policy applies to all Department of Defense (DoD) Military, Civilians and Families, their guests, and visitors who are on the Presidio of Monterey (POM), to include Ord Military Community (OMC), La Mesa Village, and USASA POM Enclave at Camp Roberts.

b. This policy supplements AR 215-1 and TRADOC 350-6. It does not supersede or substitute any provisions of any individual service regulation, directive, or policy. Should individual service regulations, directives, or policies include more restrictions concerning alcohol, the more restrictive document shall govern those service members.

c. All serving alcoholic beverages shall comply with AR 215-1, paras. 10-5 & 10-8.

d. Consistent with the laws of California and AR 215-1, only individuals who are at least 21 years old are permitted to purchase, consume, possess, serve, or transport alcoholic beverages, to include low-content alcoholic beverages (beverages with 7% alcohol content or less).

e. In accordance with AR 215-1, paragraph 10-3, individuals who are authorized by state law and applicable DOD regulations to consume alcohol are permitted to consume alcohol at the below listed locations. I further restrict permitted alcohol consumption to individuals who are permitted to gather at the locations, and whose consumption is responsible. Boisterous or combative behavior associated with alcohol consumption is contrary to this policy. Consuming alcohol or carrying open alcohol containers (seal broken) at other locations on POM is not permitted.

- (1) In on-post family residential housing units and yards;
- (2) At unaccompanied personnel housing, e.g. permanent party barracks;
- (3) At outdoor intramural sporting games at MWR fields;
- (4) At military lodging facilities; and
- (5) At locations at which alcohol is served, IAW paragraph 3.d.

f. The following locations are authorized to serve alcohol, subject to the conditions in AR 215-1, paras. 10-2; 10-3; and 10-4:

- (1) Hobson Recreation Center on POM;
- (2) General Stillwell Community Center Ballroom on OMC;
- (3) The Weckerling Center on POM (for special occasions catered by MWR);
- (4) Hayes Park Community Center on OMC (for special occasions catered by MWR);
- (5) La Mesa Community Center (for special occasions catered by MWR).

g. In accordance with AR 215-1, para. 10-2, alcoholic beverages shall not be consumed in, on, or at any of the following: skill development facilities; child and youth services facilities or functions; libraries; and advanced individual training barracks.

h. Requests to serve and consume alcohol at locations not specified above must be made to the Deputy Garrison Commander no later than 14 days before the requested event. The request must include the type of alcohol intended to be served and/or consumed, the location, the intended start and end times of the event, the anticipated number of participants, if service member-trainees or anyone under the age of 21 will be

present. If the event includes service members or under age 21 participants, a risk safety assessment must be included.

i. This policy does not apply to locations which are within the direct command and control of a tenant commander or director in the grade of O-6 or GS-15 or above.

j. This policy is not intended to affect the ability of any concessionaire, licensee or franchisee to employ individuals to lawfully serve and sell alcoholic beverages.

4. Commanders and supervisors at all levels are responsible for educating and informing their service members and civilian employees about this policy, the dangers of alcohol and its effect on military readiness and the penalties related to violation of civil and military law regarding the use of alcohol. Responsibility includes establishing programs to discourage and eliminate irresponsible use of alcoholic beverages and alcohol-related incidents.
