

**Appendix A to JRTC & FORT POLK SUPP AR 27-10**  
**UCMJ Jurisdiction**

This Appendix A outlines and establishes the jurisdiction of the Special Court-Martial Convening Authorities (SPCMCA) that fall under my General Court-Martial Convening Authority (GCMCA) and the respective Summary Court-Martial Convening Authorities (SCMCA) that fall under each SPCMCA. Unless otherwise noted below, units under each SCMCA exercise company grade UCMJ authority, and fall under the listed SCMCA for exercise of summary court-martial jurisdiction and non-judicial punishment jurisdiction.
