MEMORANDUM FOR ALL US ARMY GARRISON RHEINLAND-PFALZ (USAG RP) PERSONNEL

SUBJECT: Policy Memorandum #13, Installation Perimeter Fence and Access Control Areas.

- 2. PURPOSE. To provide the local policy for identifying, managing, and maintaining command and control for keys for all access points on the perimeter fence lines and installation security.
- 3. APPLICABILITY. This policy is applicable to all persons located on or operating under the control of the USAG RP Commander.
- POLICY. All personnel utilizing facilities or perimeter fence lines in the USAG RP area of operation will comply with this policy to sustain forces readiness.
- 5. PROCEDURES. The Commander is responsible for the safety and security of all installations with the USAG RP footprint. It is imperative that the perimeter fence access points are not tampered with or utilized by unauthorized personnel in an unauthorized manor. The process to ensuring the perimeter is secured it identifying access points not in control of the Garrison by conducting random checks of all access points. All locks and keys to perimeter fence line access points will be centralized with the Physical Security office as the primary key custodian.

SUBJECT: Policy Memorandum #13, Installation Perimeter Fence and Access Control Areas.

- a. Access to any access point not manned by Ponds security along a perimeter fence line can be coordinated with the USAG RP DES Physical Security office. Any emergency access considerations where Physical Security may not be reached or time is of the essence, contact the Military Police Desk for assistance.
- b. Only on case by case basis will keys be issued to a unit/tenet with access to a perimeter fence line access point. Such request must be made with the USAG RP DES Physical Security office in writing with justification for key issuance. All key issuances are subject to inspections and revocation by the USAG RP Physical Security Office if used in violation of its intended purpose. Proper documentation must be maintained and is inspectable for 90 days.
- c. Emplacing or cutting of any lock or chain along the perimeter installation fence line is strictly prohibited without the consent of the Garrison Commander or written consent of the USAG RP DES Physical Security office. Violations will be elevated to the Garrison Commander for disciplinary action. All locks and chains found on fence lines access points will be cut and replaced by the physical security office.
- 6. PROPONENT. USAG RP Directorate of Emergency Services is the proponent for this policy.
