MEMORANDUM FOR All Patrons of the Warrior Restaurants/Dining Facilities (DFAC) in United States Army Garrison Rheinland-Pfalz. (USAG RP)

SUBJECT: Dining Facility Procedures and Dress Code Policy (Cmd Memo 2022-015)

## 1. References:

- a. AR 30-22, Army Food Program, 17 July 2019
- b. DA PAM 30-22, Operating Procedures for the Army Food Program, 17 July 2019
- c. TB MED 530, Tri-Service Food Code, 1 March 2019
- d. AR 670-1, Wear and Appearance of Army Uniforms and Insignia, 26 January 2021
- 2. Applicability: All military and civilian personnel utilizing the Warrior Restaurants/DFACS in the Kaiserslautern and Baumholder military communities will adhere to the dress code and conduct themselves as outlined in this memorandum.
- 3. Personnel authorized to use the Dining Facilities:
  - a. Active-Duty Service Members.
- b. Family members, NATO Allies, DOD employees, Local National Employees, Department of the Army contract personnel (with escort only) as indicated in subsisting personnel policy memorandum.
- c. Reserve Component Service Members conducting annual training, while conducting active-duty training, or are on active-duty orders.
- d. Military Personnel, in a permanent change of station (PCS) status with a copy of the PCS orders for identification.
  - e. Military Personnel on a temporary duty (TDY) status with a copy of the TDY orders.
- f. Distinguished civilian guests or VIPs conducting official military business accompanied by the Commander, Deputy to the Garrison Commander or authorized designee. An advance written or verbal notification to the Food Service administrative office is required to provide the necessary support.

## 4. Standards of conduct:

- a. All personnel will conduct themselves in a professional manner.
- b. Personnel will not engage in loud or boisterous outbursts or conversation.
- c. The use of profanity or obscene gestures is strictly prohibited and will not be tolerated.
- d. Removal of dining facility property is prohibited. Unless specifically selecting a carry out meal/box which includes but is not limited to one piece of fruit, one yogurt, and/or one pre-packaged pastry.
- e. The filling of any beverage container not owned by the dining facility from any of the beverage dispensers is prohibited. This includes but is not limited to canteens or personal water bottles.

## 5. Standards of dress:

- a. Military and civilian clothing will not be mixed. Military uniforms will be worn in accordance with the appropriate Service's regulation.
  - b. Physical fitness uniforms are allowed only during breakfast hours; 0700 to 0830.
- c. Excessively soiled uniforms are not authorized for dining in, however a carry out meal/box will be offered.
- d. Military and DoD personnel are not authorized to wear headgear of any type (to include stocking caps and wave cap) unless they are Military Police under arms or working in the kitchen or serving line.
  - e. Religious headgear is authorized according to service-specific regulations.
- f. Clothing that is soiled or that presents an unhealthy or unclean appearance is prohibited.
  - a. Items in the hair that could possibly fall out such as bobby pins are prohibited.
- h. The use of any electronic device is <u>not allowed</u> while receiving food in the serving line. This includes wearing headphones in or on the ears, Bluetooth devices, cell phones, tablets, and any other electronic devices of this nature.
- i. Shoes must be worn at all times. Open toe shoes are unauthorized including sandals of any kind due to safety concerns.

- j. Clothing which allows the armpits to be exposed is prohibited.
- k. Shirts must be worn at all times. They must cover the underarms and body torso at all times. Tank-tops are prohibited. Shirts must not display profanity or obscene sketches, pictures, or remarks
  - I. Sleeveless, spaghetti strap, and strapless dresses are prohibited.
- m. Trouser and/or shorts cannot sag below the hipline or be short enough to expose inner pocket linings.
- n. Weapons are not authorized in the dining facility. The facilities specific to this policy do not have the proper equipment to allow weapons to safely enter. Military Police (MP) under arms are the only exception.
- o. Backpacks or bags of any type are to be placed by the coat rack storage areas in the front of the facility. This is due to physical security and safety concerns.
- 6. All personnel utilizing the USAG RP Warrior Restaurants/DFACs will comply with these guidelines. In addition to maintaining good order and discipline, this guidance helps to ensure the health and welfare of all patrons. Individuals failing to comply with these standards will be asked to leave the facility until all requirements are met.
- 7. Customer service cards are located near the entrance/exit of the Warrior Restaurants/DFACS for your convenience. All comments and suggestions are encouraged and welcomed, to include input through the Interactive Customer Evaluation system.
