26 February 2021

General Order Update #9

As a result of the diligence, discipline, and responsibility displayed by our Soldiers, Civilians, and Family members, the prevalence and transmission of the COVID-19 virus has declined in the local area. Although the virus remains and there are possibilities of increased spread from new variants, the COVID-19 General Order Update #9 removes many of the restrictions and control measures previously in place to control the spread of the virus. To ensure each of these changes do not result in a resurgence of the virus, it is essential that the entire Fort Riley community continue to exercise sound judgement, individual discipline, and prudent precaution.

- 1. **Restaurants and Bars (Including Aggieville).** Service members are now permitted to dinein at restaurants and bars between **0500–2100**. Service members will wear masks in restaurants and bars unless actively eating or drinking. This includes entering and exiting the facility, sitting at tables and bar tops, using the restroom, and during all movement in and around the establishment.
- 2. **Off-Post Gyms.** Soldiers are **authorized** to use off-post gym facilities. Soldiers will wear masks while in off post gyms, even if not required by the individual gym's policy.
- 3. **Leave and Travel.** Service member leave and pass may be approved by unit commanders and other leave approval authorities under AR 600-8-10. Service members who travel to a CDC or Kansas Department of Health and Environment high risk area incur a 14-day quarantine. https://www.coronavirus.kdheks.gov/DocumentCenter/View/135/Travel-Related-Quarantine-Table-PDF---Updated-12-1-20
- 4. **Home and Barracks Visitation.** The maximum number of visitors in any residence, regardless of size, is ten. The visitor limit in a barracks room is three. When hosting visitors indoors, ensure the size, layout, and configuration of the home supports physical distancing. Service members are required to limit the number of visitors based on their home's ability to maintain physical distancing. During any home or barracks visit, individuals will maintain a distance of six feet from one another, abide by sanitation requirements, and wear face coverings/masks at all times. O-6 Commanders are the approval authority for granting ETPs for home visitation with more than ten personnel. All home visitation ETP requests will require a description of mitigation/prevention measures that will be in place for the visit.
- 5. **Curfew.** There is no longer a curfew for service members on Fort Riley, KS.
- Q. If I am in a restaurant finishing my meal past 2100, will I get in trouble?
- A. Yes. Off post dine-in is only authorized between 0500-2100. You must be leaving the dine-in area by 2100.

Q: Can I have drink at a bar or go to a club?

A: Yes, as long it is between the hours of 0500-2100 and has not been identified by Fort Riley as an "off-limits establishment." Aggieville is no longer an off-limits location.

Q: If I travel outside of the 150 mile radius, do I need to guarantine?

A: No, unless you travel to a specified "high risk" location from the CDC or KDHE. If you do travel to one of these "high risk" locations, you will incur a 14-day quarantine.

Additional Information

All individuals on the Fort Riley military installation and all individuals performing official duties on behalf of the Department of Defense from any location other than the individual's home will wear masks in accordance with the most current CDC guidance. Individuals must wear masks continuously while on military installations, except: (1) when an individual is alone in an office with floor-to-ceiling walls with a closed door; (2) for brief periods of time when eating and drinking while maintaining distancing; (3) when the mask is required to be lowered briefly for identification/security purposes; and (4) when necessary to reasonably accommodate an individual with a disability.

On-post gatherings of greater than 50 people are prohibited. Exceptions to this policy may be granted by an O-6 after an inspection by the 1ID Division Surgeon's Office and notification to the 1ID Command Group. Service members will follow state and local guidance regarding off-post mass gatherings. During any mass gathering, individuals will abide by sanitation requirements, maintain a social distance of six feet, and wear a face covering.

All Service members are prohibited from engaging in outside employment as a taxi driver, Uber driver, Lyft driver, or any similar rideshare services. All Service members are also prohibited from engaging in outside employment as a driver for a food delivery service such as Uber Eats, DoorDash, EatStreet, etc.

Service Members who began working for a rideshare or food delivery service prior to 29 June 2020 may obtain and exception to policy from an O-6 in the chain of command.

FORT RILEY COMMISSARY AND POST EXCHANGE

All persons entering these facilities will adhere to FRKS COVID mitigation measures including the wearing of face coverings when required, sanitation protocols to include hand washing and physical distancing requirements, as well as temperature screening by a Soldier at the entrance. Hand sanitizing is proven effective at killing viruses and bacteria and minimizes touching potentially infected surfaces.

- Service members who may be experiencing COVID-19 type symptoms should call the clinic prior to arrival. A provider will speak with the service member about possible exposure current symptoms, and potential treatment needs.
- When dental patients arrive for their appointment, wash or sanitize hands, be screened (including temperature check) and wear facemasks at all times inside the clinic unless instructed to remove by dental providers.

Effective Sept. 12, Outdoor Pavilions/Parks/Playgrounds opened with visitor compliance with all the General Order mandated wearing of masks, physical distancing, and group size limits and hand sanitizing/healthy practices. RILEY COUNTY HEALTH DEPARTMENT HEALTH ORDER NO. 20

All personnel must comply with state and local restrictions when off-Fort Riley and in Riley County. Effective 1 March, 2021, the order expires on 1 April, 2021 and includes:

Any City of Manhattan face mask or face covering requirement applies within the boundary of the City of Manhattan, according to the terms of any City of Manhattan Ordinance in effect. All individuals present within the city limits of Manhattan must comply with any such City of Manhattan ordinance in effect and remain subject to its penalties for noncompliance. Based upon data, Order No. 20 continues to require a face mask or face covering in any public space for persons located within Riley County but outside the boundary of the City of Manhattan.

GEARY COUNTY PUBLIC HEALTH ORDER CO. RESOLUTION 12-28-2020A

Effective 28 December, 2020, until amended, superseded, or rescinded: all personnel must comply with state and local restrictions when off-Fort Riley and in Geary County. The order includes:

- All persons over two years old must wear a mask indoors or outdoors where 6-foot distancing cannot be maintained, in line to enter an indoor public space, obtaining healthcare, on public transportation.
- All businesses, organizations, and non-profits must require masks.
- Gatherings of more than 100 people are prohibited. Large venues shall remain closed.
- Dance floors shall be closed.

• All seated parties must be placed at least 6 feet apart.
