

# What is the **EXCEPTIONAL FAMILY MEMBER PROGRAM? (EFMP)**



The EFMP is a mandatory enrollment program for Service Members with DEERS dependents that have chronic medical conditions or special education needs; EFMP enrollment ensures that Service Members receive PCS options to installations that have the specific doctors, therapists, & services their Family Members need.

# ***Do you need to enroll in the Exceptional Family Member Program?***

## ***Do any of your Dependents:***

(NOT A COMPLETE LIST)

- Take multiple medications or have an IEP at school for ADD/ADHD?
- Have a diagnosis of cancer in the last 5 years?
- Regularly see a specialty doctor at least once a year?
- Carry an Epi Pen for a reaction causing loss of consciousness or difficulty breathing?
- Have sleep apnea & use a CPAP/BIPAP machine?
- Regularly see a behavior health provider or therapist over the last 6 months?
- Have a diagnosed heart condition or blood disorder?
- Have Autism Spectrum Disorder or Sensory Processing Disorder?
- Take asthma medication daily or have ER or clinic visits for asthma attack?
- Regularly see a pain manager at least quarterly?
- Take depression or anxiety medication?
- Receive infant toddler services & have an IFSP?
- Receive speech, occupational, or physical therapy?
- Have insulin dependent diabetes?
- Have epilepsy or other seizure disorder?

***Per Army Regulation 608-75, you need to enroll!***

“Commanders will take appropriate action against Soldiers who knowingly provide false information, who knowingly fail or refuse to initially enroll in EFMP, and who knowingly and willfully disregard the 3 year anniversary to update review of the EFM condition.”
