

## ✓ In Person OIC/RSO Range Certification Course (3ID and Tenant Units)

- As of 2 SEP 25, OIC/RSO Certification training is held at BLDG 7905. (Class capacity 40 PAX)
- Classes are scheduled for Tuesdays and Thursdays during the first and third weeks of each month.
- Doors open at 0900, sign-in until 0945, class starts 1000.
