

MEMORANDUM FOR All Personnel Performing Duties on Fort Stewart, Hunter Army Airfield, and Wright Army Airfield


SUBJECT: Intent for the 3<sup>rd</sup> Infantry Division and Fort Stewart, GA Blue Book

1. Purpose: This Blue Book is the foundation upon which we build warriors. It codifies the unyielding standards of discipline, appearance, and conduct that define us as Soldiers of the 3<sup>rd</sup> Infantry Division, the Mame Division, the hammer of the XVIIIth Airborne Corps and our Nation. Our Division's reputation lies not just in our courage, but in the disciplined formations that forge an unstoppable force against our enemies. These standards outlined within this Blue Book are not new; they represent the legacy we inherited from those who came before us. They apply to every Soldier, from the Commanding General to the newest Private in our ranks. This is the shared code we will live by and we must hold each other accountable to these standards.
2. General: Our Foundation is disciplined Soldiers, NCOs, and Officers. Discipline is the soul of an army, and for the Mame Division, it is the bedrock of our lethality. Discipline is not an attribute we demonstrate when others are watching; it is a standard that we ruthlessly enforce when no one is watching. The standards within this book are the sharpening stones for our bayonets. They ensure we are fitter, more disciplined, and more lethal than any enemy we will ever face on the battlefield. We do not simply follow and enforce these standards; we embody them.
3. Specific: The Standard for this Division is Lethality. Let there be no ambiguity: our adherence to standards is directly linked to our ability to fight, survive, and win. A Soldier who masters the small details of their uniform and conduct is a Soldier who can be trusted to confidently execute and orchestrate the small details of a firefight. A unit that holds itself accountable in garrison will hold the line under fire because there is mutually supported trust. We enforce these standards upon ourselves and each other because it forges the comradery and cohesion necessary to dominate our enemies. We are the 3<sup>rd</sup> Infantry Division: Not Fancy, Just Tough. We are proud of that fact, and our disciplined conduct will prove it in every action we take.
4. CSM Durgin and I are immensely proud to train and fight alongside the legendary Dog Faced Soldiers of the 3<sup>rd</sup> Infantry Division.

## PART ONE

a. **General Guidance and Army Values.** All Soldiers will follow the Army Values and apply them to everything they do, on and off duty. 3<sup>rd</sup> Infantry Division Soldiers will live and operate within the Army Values: ***Loyalty, Duty, Respect, Selfless Service, Honor, Integrity, and Personal Courage.***

b. **US Army General Orders.** The purpose of the U.S. Army's three General Orders is to instill fundamental discipline, responsibility, and readiness in soldiers, providing a bedrock for conduct beyond specific duties, ensuring vigilance, accountability, professionalism, and effective security of posts, property, and information, forming the basis for integrity and mission success. They teach soldiers to be alert, obey orders, intervene in emergencies, and report issues that affect the life, health, and welfare of our Soldiers and Families.

**1. I will guard everything within the limits of my post and quit my post only when properly relieved.**

**2. I will obey my special orders and perform all my duties in a military manner.**

**3. I will report violations of my special orders, emergencies, and anything not covered in my instructions to the commander of the relief.**

c. **NCO Support Channel.** The NCO Corps is the backbone of this Division, and our NCOs must be empowered to run the day-to-day operations of this Division with minimal oversight. NCOs are ready, willing, and able to hold the line or will be held accountable for their failure to act. The NCO Support Channel (leadership chain) parallels and complements the Chain of Command. It is a channel of communications and supervision from the Command Sergeant Major (CSM), to 1SGs, and then to other NCOs and enlisted personnel of the unit. Its goal is to solve concerns at the lowest level. This NCO support channel will assist the chain of command in accomplishing the following, but not limited to:

**Tier 1: The Core Imperatives.** These two responsibilities are the absolute, intertwined priorities from which all other duties are derived. The Army NCO Strategy emphasizes that "People are the Army's greatest strength" and that NCOs must build "cohesive teams that are highly trained, disciplined, and fit that are ready to fight and win."

- **Caring for our Soldiers and their Families.** Caring for our Soldiers and their Families, on and off duty, is an NCO's sacred commitment. For the Soldier, this means rigorous, realistic training that forges experts capable of executing their combat mission to standard under any condition and in any environment, every time. We must ensure they are always prepared for the rigors of Large-Scale Combat Operations. For their Families, this means ensuring they are resilient and ready for the challenges of their Soldier's absence from the home. Our Soldier and Family Readiness Groups (SFRGs) are the vital link, providing the continuity and unwavering support that binds the Soldier, the family, and the unit.
- **Training your Soldiers and Formations for Combat.** We must train enlisted Soldiers to be lethal professionals by relentlessly developing their mastery of both their specific Military Occupational Specialty (MOS) and the fundamental skills of a warfighter. This ensures they are not just experts in their craft, but adaptable and resilient warfighters capable of dominating and winning in any situation they may find themselves in.

**Tier 2: Direct Enablers of the Core Imperatives.** These duties are the direct actions NCOs take to build ready, disciplined teams and execute the mission. They provide the purpose, direction, and motivation essential for leadership.

- Planning and conducting day-to-day unit operations within prescribed policies and directives.
- Communicating, instilling, and ensuring the efficacy of the professional Army ethic.
- Leading and supervising physical training, aligned with H2F and Apex Path, and ensuring Soldiers follow the

prescribed Body Composition Standards outlined in AR 600-9.

- Leveraging the NCO Support Channel to build cohesive teams, founded on trust and respect, through professional development and quality of life program initiatives.
- Training Soldiers, crews, and teams on the unit's mission to instill a sense of purpose, driving commitment beyond simple compliance.

**Tier 3: Supporting and Sustaining Activities.** These responsibilities are crucial for the long-term functioning, professionalism, and capability of the unit and the Army. They are the essential administrative and logistical functions that support direct leadership and training tasks.

- Maintain accountability for and ensure the serviceability of all assigned individual and unit equipment.
- Administer and monitor the NCO Development Program (NCOPD) and professional additional duties.
- Teach Soldiers the history of the Army, to include military customs, courtesies, and traditions; build and foster Esprit De Corps within the organization.

**d. Battle Buddy.** The battle buddy team ensures Soldiers look out for one another. Leaders will ensure all newly assigned Soldiers are paired with an experienced Soldier from the individual's team, squad, or section. Soldiers should always operate as a two-person team, on or off duty. The battle buddy does not replace newly assigned Soldier sponsors they met at the Marne Reception Center. The Battle Buddy system will be utilized by Soldiers of all ranks, from the most senior to the most junior; we will take care of our own.

**e. Daily Uniform.** Company/Troop/Battery and Detachment commanders and 1SGs will set the daily Duty Uniform and command teams will ensure it is known throughout their formation. Commanders and 1SGs will ensure they select the appropriate uniform based on the day's tasks while mitigating risks associated with work and weather.

**f. Judgement.** All leaders are expected to exercise sound judgement throughout the execution of all their duties. If a Commander's decision veers from a known standard, the Commander should communicate the reasons based on risk to force and risk to mission.

**g. Daily Formation / Pre-Combat Inspections (PCIs).** Every Company/Troop/Battery and Detachment will conduct daily formations to facilitate accountability, inspect their troops, reinforce discipline, instill attention to detail, and enhance NCO professionalism. Leaders are required to conduct daily in person accountability, which consists of a form of inspection (uniform, grooming standard, or piece of equipment) throughout the duty week. The primary categories of routine inspections are morning parade (In-Ranks Inspections), PCCs / PCIs, crew/squad/section drills, and the dissemination of information. To honor and protect the off-duty time of every Soldier, leaders will reserve after-hours communication for urgent, time-sensitive matters that cannot wait until the next day of duty.

**h. Open Door Policy.** If you have a problem your first-line supervisor cannot solve, go see the next higher leader or commander. Every commander from the Commanding General (CG) down to Company/Battery/Troop/Detachment commander has an open-door policy. All Soldiers are free to use the open-door policy at any level, after first notifying their chain of command of their intent to do so. Within FSGA/HAAF, the CG highly recommends that all enlisted open-door issues be directed to the Division Command Sergeant Major first to allow for the solving of problems/concerns through the NCO Support Channel. Putting your concerns and complaints on social media without allowing your chain of command the opportunity to fix the issue is discourteous and unprofessional.

**i. Inspector General Access.** Soldiers are authorized, and encouraged to use, the Inspector General Office (571-801-5093) for assistance. The Inspector General Office is for Soldiers, Family Members, or Civilians who feel that they have exhausted all other options and resources to solve a problem or issue outside their span of control.

**j. Cellular Phone Use.** Commanders are authorized to restrict cellular phone use when there is an increased risk to Operational Security (OPSEC) and in training environments. Commanders will publish SFRG and Emergency Points of Contact (POC) rosters while in cellular phone restricted environments.

## PART TWO

**1. Personal Appearance Policies.** All Soldiers will abide by AR 670-1, DA PAM 670-1, and Army Directive 2025-18. Soldiers will present a professional image, both on and off duty. Pride in appearance includes physical fitness and adherence to acceptable weight standards in accordance with AR 600-9. **Portions of Army Directive 2025-18, excerpted below, may be the basis of adverse administrative and/or punitive action under the UCMJ.**

**a. Grooming.** Soldiers will abide by AR 670-1, DA PAM 670-1 grooming standards and Army Directive 2025-18. Soldiers that are off duty are not required to shave. Soldiers are not required to carry a copy of their temporary shaving profile or Religious Exemption MFR on their person. However, Leaders conducting an on-the-spot correction may ask a Soldier if they have a profile or a valid Religious Exemption and may also request to view their Verification Memo signed by their BN CDR.

**Medical Profiles (Beards).** If appropriate medical authority prescribes beard growth, the length required for medical treatment must be specified. For example, "The length of the beard will not exceed 1/4 in." (Refer to TB MED 287). Soldiers with approved religious accommodation will adhere to the specifications of their waiver.

**Religious Accommodations (Beards).** The following grooming standards apply to Soldiers with a religious accommodation request, approved by a Commanding General, in accordance with AR 600-20. Beards for religious accommodation (which include facial and neck hair) must be maintained to a length not to exceed 2 inches when measured from the bottom of the chin as outlined in AR 670-1. Beards exceeding 2 inches will be rolled or tied to achieve the 2-inch maximum length. Beards must be worn in a neat and conservative manner that presents a professional appearance.

**Facial hair:** Males will keep their face clean-shaven when in uniform, or in civilian clothes on duty. Mustaches are permitted. If worn, males will keep mustaches neatly trimmed, tapered, and tidy. Mustaches will not present a chopped off or bushy appearance, and no portion of the mustache will cover the upper lip line, extend sideways beyond a vertical line drawn upward from the corners of the mouth, or extend above a parallel line at the lowest portion of the nose. Handlebar mustaches and goatees are not authorized. Beards are not authorized without an approved Religious Exception to Policy or a Medical shaving profile. Soldiers will keep the growth trimmed to the level specified by the appropriate medical authority but are not authorized to shape the hair growth.

**b. Male Haircut Standards:** Hair will be tapered or faded starting at zero length (skin fade) or at 1/4-inch length at the sideburns and hair around the ears (low, mid, and high fades). Hair must blend evenly around the sides and back and will not fall over the ears. The bulk (defined as the distance the hair protrudes from the scalp) of the hair at the top of the scalp will not exceed 2 inches, and the bulk of the hair at the sides of the head will not exceed 1 inch. Only shaved or closely cut hair on the back of the neck may touch the collar of the uniform. Male Soldiers are authorized to shave or trim their heads (whole scalp). Edged or outlined cuts are authorized if they are natural to the Soldier's hairline. If the hair does not part naturally, the male Soldier may cut a part in the area where the Soldier would normally part the hair (no wider than 1/8-inch width). The part will be one straight line, or if slanted or curved, align with the natural hairline. Male Soldiers are not authorized to wear locs, braids, or twists. Male Soldiers will not shape or cut designs into their hair or scalp. Leaders will judge the appropriateness of a particular hairstyle based on the guidelines found within this directive and the ability to wear all types of headgear (such as beret, garrison cap, patrol cap, or service cap/hat) and any protective equipment (such as a protective mask or combat helmet) properly.

**Sideburns:** Sideburns are hair grown in front of the ear and below the point where the top portion of the ear attaches to the head. Sideburns will not extend below the bottom of the opening of the ear. Sideburns will not be styled to taper, flair, or come to a point. The length of the individual hairs of the sideburn will not exceed 1/8 inch when fully extended.

**c. Female Haircut Standards.** There is no minimum hair length and shaving the head is permitted. Bangs must stay above the eyebrows. Hair color is restricted to natural shades applied in a blended, subtle manner without extreme contrasts. Multiple braids, locs, twists, or cornrows can be gathered into a single ponytail that conforms to length and width regulations, though ponytails are not allowed with any dress uniform. Hairstyles with shorter sides and back are authorized if the top does not exceed 2 inches and blends smoothly, but these styles cannot be combined with buns or braids. Asymmetrical cuts are prohibited, but tapered or faded styles, including skin fades, are allowed if the hair blends evenly and does not fall over the ears, with bulk not exceeding 2 inches on top and 1 inch on the sides. A straight or naturally curved part, no wider than 1/8 inch, may be cut. However, tapered or

faded haircuts cannot be combined with other authorized hairstyles. The general bulk of the hair, measured from the scalp, cannot exceed 2 inches, except for buns, braids, and ponytails. Designs are not to be cut into the hair or scalp. Ultimately, leaders will determine the appropriateness of a hairstyle based on these guidelines and the ability to properly wear all required headgear.

**Buns.** Buns will be worn on the back of the head and may extend a maximum of 3 inches from the scalp and no wider than the width of the head. Buns will be centered at the back of the head, positioned horizontally in line with the top of the ears when viewed from the side. The bottom portion of the bun may fall at or above the collar.

**Ponytails.** Female Soldiers are authorized to wear their hair in a single braided or a single unbraided ponytail while in the Army Combat Uniform (ACU, OCP) or the Army Physical Fitness Uniform (APFU). Hair must be neatly fastened and secured in a single ponytail. The bulk of the ponytail must not exceed the width of the head. The ponytail length must not exceed 6 inches from the top of the collar. The minimum length is at least 1 inch, measured from the base of the ponytail holder. The ponytail will be centered at the back of the head and positioned horizontally in line with the top of the ears when viewed from the side. Female Soldiers are not allowed to wear ponytails when in any variation of the dress uniform.

Hair holding devices are authorized only for the purpose of securing the hair. Soldiers will not place hair holding devices in their hair for decorative purposes. All hair holding devices must be plain and of a color as close to the Soldier's hair as is possible or clear. Authorized devices include, but are not limited to, small plain scrunchies (elastic hair bands covered with material), barrettes, combs, pins, clips, rubber bands, and hair or head bands. Some examples of prohibited devices include, but are not limited to large, lacy scrunchies; beads, bows, or claw or alligator clips; clips, pins, or barrettes with butterflies, flowers, sparkles, gems, or scalloped edges; and bows made from hairpieces. Foreign material (for example, beads and decorative items) will not be used in the hair.

All headgear will fit snugly and comfortably around the largest part of the head without bulging or distortion from the intended shape of the headgear and without excessive gaps. When headgear is worn, hair should not protrude at distinct angles from under the edges. Hairstyles that do not allow headgear to be worn in this manner are prohibited.

**d. Tactical Uniform.** Leaders will use the below base line uniform configurations during field training exercises or combat operations. This standard ensures that units are optimally prepared for combat. Standards on wear, uniformity, and maintenance of our tactical uniforms depend on leader involvement and inspections. The three configurations are the **Marne DUTY Uniform**, **Marne LIGHT Uniform**, and the **Marne STANDARD Uniform**.

- No unauthorized patches will be worn on any part of the uniform or on any item of equipment.
- All uniform guidelines are open to Commanders and 1SG modification based on appropriate Risk Assessment and Leader Judgement.
- Unit leadership, based on tactical requirements will determine the use of facial camouflage. Skin camouflage will not be worn when the temperature (ambient or wind-chill) is 32° F and below. Skin camouflage will not be worn in any facility outside of the unit footprint.

**e. Personal Protective Equipment (PPE).** All Soldiers must have on their person or wear the following protective gear when wearing the Marne LIGHT uniform and above:

- Ballistic Eye Protection (APEL approved only).
- Hearing Protection, ID card, ID Tags, and note taking material.
- Fire-retardant gloves with a leather palm.
- Knee Pad on the knees or combat pants with knee inserts. (Discretion of the Commander)

- Combat Application Tourniquet. Every Soldier will have two tourniquets while wearing the Marne STANDARD Uniform.
- PPE should be accessible and worn based on leader analysis of METT-TC.

**f. Ballistic Protection.** All Soldiers will wear the **Marne STANDARD uniform** that includes front, back, and side ballistic plates during live fire training events. **Commercial, personally bought, body armor and plate carriers are not authorized for wear at any time.**

**g. Body Armor.** Body armor will be worn closed with all buckles and hook and loop fastened, nametape, and rank. Leaders will ensure all Soldiers have the Individual First Aid Kit (IFAK) attached to their body armor, FLC/TAP system, duty belt, or sub belt system on the shooter's nondominant side.

**h. Combat Helmet.** The ACH/ECH helmet will be complete with ACU (OCP) cover, NVG mount (if designated as a vehicle operator), and helmet band with sewn-on last name. Soldiers who have been issued the Integrated Head Protection System (IHPS) helmet do not require a helmet band. The 3ID patch will be worn on both sides of either style of helmet. **Lowcut or Ops-Core helmets are NOT authorized unless assigned to 1/75 Ranger Regiment or 3/160<sup>th</sup> Special Operations Aviation Regiment (SOAR) if issued.**

**i. Marne Uniform Configurations.** The following uniform configurations are the 3ID baseline. Leaders may modify these configurations to fit their daily training, and operational needs regarding risk and safety mitigation:

**1. Marne DUTY Uniform.** The uniform will be a clean and serviceable ACU (OCP) uniform with name tape, US Army tape, rank, subdued cloth flag, and subdued SSI; Clean approved, authorized, or issued boots; Clean, serviceable patrol cap with rank and name tape; Brown T-Shirt, brown belt, ID card, ID tags, paper, and writing instrument. Commanders at company level and above may authorize their entire formation to roll sleeves above the elbow IAW AR 670-1; this is not an individual Soldier decision. In garrison, Soldiers will **NOT** cuff sleeves IAW AR 670-1. However, while in range or field conditions, the sleeves may be down and cuffed inside the coat.

**2. Marne LIGHT Uniform.** Same as the Marne DUTY Uniform with the following additions: no skill badges will be worn in the Marne LIGHT Uniform unless sewn on; combat helmet, approved eye protection, hearing protection, and gloves, FLC/TAP worn IAW DIV/BDE/BN SOPs, knee and elbow pads (when applicable and at the Commander's discretion), personal hydration system, subdued cloth or Infrared (IR) flag, issued tourniquets, and IFAK.

**3. Marne STANDARD Uniform.** Same as Marne LIGHT Uniform with body armor with ESAPI ballistic plates. FLC/TAP is not required to be worn with body armor if the Soldier has appropriate pouches attached to their body armor. Tourniquets and IFAK must be worn with the Marne STANDARD Uniform on the nondominant side. Soldiers must be able to carry Unit Basic Load of ammunition (7x 30 round magazines = 210 rounds for M4 and 3x 17 round magazines = 51 Rounds for M17) for their individual assigned weapon system.

**j. Electronic Devices.** Soldiers WILL NOT walk and talk / text while in uniform. This applies to the use of a hands-free device or when the cell phone is in speaker mode. ***Leaders will limit the use of electronic devices while training.*** Local unit level Commands will always enforce/reinforce this guidance. During physical training, the following rules apply:

- Soldiers may use headphones, including wireless or non-wireless devices and earpieces, in uniform only while performing individual physical readiness training in indoor gyms or fitness centers IAW Army Directive 2016-20. Ear pads will not exceed 1-1/2 inches in diameter at the widest point IAW AR 670-1 and The Army Blue Book.
- Soldiers may also wear a solid black armband for electronic devices in the gym or fitness center.
- Soldiers will **NOT** wear headphones or armbands while in uniform and outdoors.
- Leaders may allow their formations to play music from a media device **during static organized physical readiness**

training. Music may also be played in unit gyms, which includes the area around beaver fit gyms and gyms in a box. Music will be played at a volume that does not interfere with other formations and will not contain profanity, degrading, or distasteful content.

- Soldiers will **NOT** play music during outdoor runs or foot marches at any time.

**k. Hearing Protection.** All Soldiers will wear fitted, non-linear hearing protection during all military training/operations involving high-frequency impulse noise that can cause injury to a Soldier's hearing.

**l. Eyewear.** The following rules apply to eyewear and contact lenses:

- Conservative civilian eyeglasses and sunglasses are authorized for wear with all uniforms. Lenses will not have a mirrored finish to them and will be black in color.
- In field environments, Soldiers are only authorized to wear Authorized Protective Eyewear List (APEL) ballistic eye protection issued with Smoke/Tinted/Clear lenses. (Refer to the PEO Soldier Qualified products list at <https://www.peosoldier.army.mil/Equipment/Approved-Eyewear-QPL/>)
- Contact lenses that change the natural color of the eyes are prohibited while on duty. **Contact lenses are NOT authorized in field conditions.**

**m. Colored Shoulder Sleeve Insignia.** BDE / BN Commanders may authorize the wear of full-color Shoulder Sleeve Insignia (SSI) and special skills tabs on the ACU (OCP) and IHWCU for special occasions such as, but not limited to, commemoration ceremonies or changes of command / responsibility. The full-color SSI will NOT be worn outside of the area where the ceremony or special event is being conducted. Full color SSI- Military Operations in Hostile Conditions (MOHC) will NOT be worn on the right sleeve at any time. The Full Color SSI will NOT be the standard to wear on the last duty day of the week. Subdued United States Flags will be the standard wear on the ACU (OCP) for the 3<sup>rd</sup> Infantry Division in field, range, and deployed environments; Dog Faced Soldiers are not fancy, just tough and we are a combat Division.

**Utility Uniforms (Class C).** All military uniforms will be worn IAW AR 670-1 and DA PAM 670-1 standards. Leaders must understand the Georgia weather/environment and that temperatures may change 20-30 degrees in a 12-hour period and must plan for the changing weather conditions. If worn off post, utility uniforms will be clean and serviceable. Soldiers will not wear utility uniforms off post in any establishment which primarily serves alcohol.

**n. Flight Suit.** The Army Aviation Combat Uniform (A2CU) is worn on duty when flying, on standby awaiting flight, or as directed by the commander. A2CUs are not authorized for everyday wear in garrison or office environments. Sleeves will not be pushed or rolled. Personnel wearing the A2CU outside of the flight line will blouse the trousers.

**o. Combat Vehicle Crewman (CVC) Uniform.** Soldiers may wear the combat vehicle crewman uniform on duty when prescribed by the commander for combat vehicle operations IAW CTA 50-900 and unit SOPs. The combat vehicle crewman uniform is not intended for wear as an all-purpose uniform when other uniforms are more appropriate.

**p. Army Combat Shirt.** The Army Combat Shirt is authorized only during training events and must be worn with name tape, rank, unit patch, and subdued US Flag. The Army Combat Shirt will NOT be worn around or off post, in Warrior Restaurants, at Shoppettes (AAFES Express), the PX, the Commissary, or in any other business on the installation.

**q. Headgear.** Soldiers in uniform will wear appropriate headgear when outdoors except when it interferes with safety. When headgear is stored, it will not create a bulky appearance or protrude from any pocket. Durags, stocking caps, hair nets, etc. are NOT authorized for wear underneath any headgear.

**1. Patrol Cap.** The patrol cap will be worn straight on the head so that the cap band creates a straight line around the head, parallel to the ground. No alterations to the cap are authorized. The cap is worn so that no hair is visible on the forehead

beneath the cap. If the name tape is sewn on the patrol cap, the rank must be sewn on.

**2. Beret.** At the Commander's discretion, the beret may be worn with the Army Service Uniform and utility uniform during all ceremonies or special duties. If assigned to 1/75 Ranger Regiment or 3/160<sup>th</sup> SOAR, personnel will wear the distinct beret associated with their organization.

**3. ACU (OCP) Sun "Boonie" Hat.** The "boonie" hat may be worn at the discretion of the Commander or 1SG for training on FSGA or while deployed. Soldiers will **NOT** wear the "boonie" outside of the unit or training areas; it will not be worn in the Garrison environment. Name tape and subdued rank will be affixed on the ACU (OCP) Sun Hat when worn.

**4. Black/Coyote Brown Fleece Cap.** The fleece cap may be worn with ACU (OCP) or the APFU in garrison, field, flight line, or on static guard duty when the ambient temperature, to include wind chill, is 32 degrees and below. Soldiers will wear the fleece cap snugly on their head; Soldiers will not roll the cap but can have one-fold. Personnel wear the microfleece cap pulled down snugly on their head with the bottom edge covering the ears but not covering the eyebrows. The fleece cap will not be worn at any off-post area. **The Black Fleece Cap will be the only authorized headgear worn during Physical Training.**

\*\*\*\*Military Police, while on official duties, may wear the Fleece Cap off the installation, when responding to emergencies, if the weather conditions are 32 degrees and below.

**5. Neck Gaiter.** The neck gaiter is authorized and may be worn with the APFU and tactical uniforms when temperatures are 32 degrees. It may be worn as a neck warmer, hood, or balaclava/mask. Neck gaiters will be removed when indoors.

**6. Organizational Headgear (Stetson).** Battalion Commanders may substitute headgear with distinctive unit Organizational Headgear within the following guidelines: Individual purchase of Organizational Headgear must be voluntary and is authorized for units no smaller than Battalion or Squadron. Organizational Headgear will be worn only in the unit's immediate area. The Cavalry Stetson will be black in color. A braided cord, rank, regimental or ordinary cavalry brass, and **THE CURRENT** Distinguished Unit Insignia will be worn on the Stetson.

**7. Unit Baseball Caps.** No baseball style headgear will be worn, while in the duty uniform, outside of a unit's immediate Headquarters.

r. **Cavalry Spurs.** Spurs will be worn only in the unit's immediate area or for special functions like organizational headgear use such as last day of the duty week, unit dining-ins/outs, formal events, professional gatherings, and other events in line with cavalry traditions designated by the Squadron Commander. **Under no circumstances will they be worn in AAFES facilities, Commissaries, or support agency facilities.**

s. **Cadre T-Shirts.** Professional programs (e.g. Marne Reception Center (MRC), FSGA NCOA Academy, E3B Cadre, and Spur Ride Cadre) may wear a Cadre T-shirt approved by their Commander. The T-shirt will only be worn in the immediate area of that program or during official program training, instruction, or duty. At no time will Cadre wear the approved T-Shirt at the Commissary, AAFES facilities, or other areas outside the program area. Cadre will not place their ACU (OCP) blouse over their Cadre T-Shirt when entering these facilities; they must replace it with the brown T-shirt.

t. **Extended Cold Weather Clothing System Generation III (ECWCS GEN III).** ECWCS is a breathable multi-layered, versatile, insulating system that allows the soldier to adapt to varying mission requirements and environmental conditions. The system is designed to maintain adequate environmental protection between 40F and -60F (4C and -51C).



- **Level I** is a base layer that is worn next to the skin and other shell layers are worn over the base layer. Level I consists of the light-weight undershirt and drawers.
- **Level II** is another base layer that is worn next to the skin and other shell layers are worn over the base layer. Level II consists of the mid-weight shirt and drawers.
- **Level III** is the primary insulation layer that is worn underneath shell layers or worn as an outer garment in cool conditions. Level III consists of the high-loft fleece jacket. **The brown fleece jacket will not be worn as a stand-alone jacket at temperatures above 50 degrees or in the presence of rain or snow.**
- **Level IV** is a shell layer designed to be worn with base and insulative levels in transitional environments to provide wind and sand protection. Level IV consists of the wind jacket.
- **Level V** is a shell layer designed to be worn with base and insulative levels for use in moderate to cold conditions. Level V consists of the soft-shell cold weather jacket and trousers.
- **Level VI** is a shell layer that is a waterproof barrier designed to be worn over other levels in moderate to cold wet conditions alternating between freezing and thawing. Level VI consists of the extreme wet/cold weather jacket and trousers.
- **Level VII** is a soft shell insulative layer and is designed to be the outermost layer. Level VII is used during static operations in extreme cold and dry conditions.

## 2. Physical Readiness Training (H2F and Apex Path).

**a. General.** All 3<sup>rd</sup> Infantry Division and Fort Stewart Soldiers will conduct a minimum of one hour of Physical Readiness Training (PRT) Monday through Friday from 0630-0800. If Soldiers' duties prevent them from conducting PRT during these hours, commanders will establish PRT at an alternate time during the duty day to better facilitate unit operations.

1. PRT will be conducted as Teams, Squads, Platoons, or higher.
2. Leaders will conduct PRT as a group and with their respective formations. There will be no PRT activities at the individual level from 0630-0800.
3. The Battalion Commander is the approval authority for off installation PRT events.
4. Sports PT, while an authorized PT event and an excellent team cohesion event, will not be repetitive physical training events for units and must have approval from the Battalion Commander.
5. Leaders must allow for adequate Soldier recovery time following PRT for personal hygiene and nutrition.
6. Commanders are required to have a **Remedial, Pregnancy and Post-Partum (P3T)**, and **Profile PT Program** within their organizations.
7. All PRT sessions, either H2F or APEX PATH oriented, are organized unit level activities and will be planned and led by NCOs accordingly.
8. **Outside of medical appointments, there will be no activities conducted prior to 0800 without the prior approval of Battalion Commanders.** This includes, but is not limited to, ceremony rehearsals, ceremonies, training rehearsals, motor pool operations, etc.

**b. Uniform.** The APFU or ACUs (OCP) are the only authorized uniforms for physical readiness training. The Army Physical Fitness Uniform (APFU), when clean and serviceable, is authorized for wear on and off duty and on and off the installation, unless restricted by the commander. The APFU is not intended for wear as an all-purpose uniform and will not be worn after 0900 for the normal duty day unless otherwise authorized by the Commander for events such as Marine Hero Days and Physical Therapy appointments that require the APFU wear. APFU is not authorized for wear in the PX, Commissary, or other facilities as posted by facility managers. Soldiers may visit the AAFES Shoppette (AAFES Express) in AFPU while in transit to and from their workplace and homes. IAW DA PAM 670-1, Para. 10-6, pregnant Soldiers will wear the APFU until the uniform becomes too small or uncomfortable. Pregnant Soldiers are authorized to wear the t-shirt outside the trunks. Commanders or Senior Enlisted Leaders will not require pregnant Soldiers to purchase a larger APFU to accommodate the pregnancy. When the uniform becomes too small or uncomfortable, pregnant Soldiers may wear equivalent civilian workout clothes while conducting physical fitness in the FSGA and HAAF Fitness Facilities from 0630-0800. Female Soldiers are NOT authorized to wear earrings while in the Army Physical Fitness Uniform or when conducting Combat Focused PT.

**c. Unit T-Shirts and Sweatshirts.** Commanders may substitute a distinctive Battalion and above t-shirt or sweatshirt for the APFU T-shirt or jacket within the following guidelines:

- Individual purchase must be voluntary.
- Logos must be in good taste, with no profanity or lewd images.
- Unit T-shirts and crew or hooded sweatshirts are authorized for wear; however, the hood and pockets will not be used when in the APFU.
- 1/4 Zip collared shirts are NOT authorized for wear during Physical Fitness as part of the APFU.

**d. APFU Weather Conditions Guidance.** For temperatures above 50° F, the summer APFU will be the uniform. Between the temperatures of 50° F and 33° F the APFU will be determined by the Company/Battery/Troop Command (CDR and/or 1SG). At 32° F or below the APFU will be winters with the option of removing the pants with the approval of the Company/Battery/ Troop Command (CDR and/or 1SG). Organizational formations will be in the same uniform, regardless of the temperature; uniformity will be maintained throughout the formations.

**e. Foot March.** IAW ATP 3-21.18, Foot Marches (Dated: July 2025), foot marching will remain an important component in our conditioning and combat readiness. Leaders must take a thoughtful and progressive approach to prevent needless injuries and ensure sustainable combat readiness for mission accomplishment. The authorized conditioning foot march uniforms are either the APFU with boots or the Marne Light uniform with either combat helmet or patrol cap; **removing all patches from the uniform is not authorized.** Commanders are authorized to eliminate the headgear requirement based on current weather conditions in the summer months to prevent heat injuries. **All tactical foot marches will be conducted in the complete Marne Light Uniform.** Soldiers will **NOT** wear ear buds or play music from any device while foot marching. Soft sole shoes will **NEVER** be worn during organized unit foot marches. **Every Soldier in the Division will complete a 12-mile foot march, in the Marne Light uniform with a 35lb. pack (dry), in less than 3 hours annually.**

**f. The Marne Mile.** The Marne Mile is designed to be used as a “run-on, run-off” training event. There is no need for a reservation, it is a first come, first serve resource. This course is designed to familiarize squads and sections with tactical movements used in combat and to test Marne Soldiers on their agility, strength, and endurance. The Marne Mile is classified as a Combat Focused PT event that is managed and maintained by the Fort Stewart Garrison Team, Directorate of Plans, Training, Aviation, Mobilization, and Security (DPTAMS), and Department of Public Works (DPW).

**g. PT Road Guard Uniform Requirements.** The duty uniform for all PT Road Guards is the **Marne DUTY** uniform. Additionally, all personnel conducting Road Guard operations from 1 April – 30 September will have their issued assault pack with wet weather top and bottoms. From 01 October – 31 March, Soldiers will have all the above, in addition to appropriate cold weather ECWCS GEN III clothing items and gloves to protect themselves from cold and wet weather conditions throughout their tour of duty.

**\*\*\*At no time will PT Road Guards be performing their duties from inside their privately owned vehicles.**

**3. On and Off-Duty Appearance.** High standards of appearance should carry over into your selection of civilian attire. Wear of appropriate attire avoids public embarrassment and promotes a sense of community.

**a. Civilian Clothing.** On occasion, we conduct unit events where civilian clothing serves as the prescribed uniform. We will use the following guidelines (unisex):

**1. Marne Business Casual.** For Male personnel, slacks with collared shirt tucked, dress shoes, and a sport coat. A tie is optional. No denim or cargo pants. Hats will not be worn. For Female personnel, slacks, dress or skirt and blouse with dress shoes.

**2. Marne Casual.** Casual slacks, denim jeans, or field pants with button-down collared shirt, Polo shirt, or blouse and activity-appropriate street or hiking/trail style shoes. Sport coat is optional. Hats are optional.

**3. Coastal Casual.** Pants, shorts, skirt, or dress (mid-thigh or lower), tasteful shirt, and shoes/sandals based on temperature. No midriiffs, tube, skin-tight, cut-off tops or tank tops. Hats are acceptable.

**b. Official Travel (TDY).** While traveling on official orders, Soldiers will travel in the **Marne Duty Uniform** or in **Marne casual**. Marne Duty Uniform (ACU, OCP) is only authorized on military charter aircraft for mass transit to deployment locations or training rotations, for security reasons.

**c. Warrior Restaurants and Kiosks.** Soldiers and visitors will not wear hats or sleeveless shirts in the Warrior Restaurants and Kiosks. Headphones will be removed in the serving line while ordering meals as a sign of respect for others. For hygiene purposes, closed toe shoes are the only authorized footwear in Warrior Restaurants or Kiosks.

**d. On-Post Facilities.** While visiting on-post support activities, agencies, work areas, and public areas, Soldiers will wear attire that is congruent with a military family friendly atmosphere and our Army Values.

1. Clothes with obscene, slanderous, vulgar words or drawings, or items which make disparaging comments are not authorized on Fort Stewart, Hunter Army Airfield, or Wright Army Airfield.
2. Cut off jeans or garments which expose any part of the buttocks, or any see-through garments normally worn as undergarments are prohibited.
3. Except where footwear is not appropriate (e.g., swimming pools), bare feet are not authorized in any facility on the installation.
4. Soldiers are required to always carry their Military ID Card on the installation, whether on or off duty.
5. Earring wear while on duty in uniform, on duty in civilians, and off duty is restricted to AR 670-1 guidelines for males and females.

## PART THREE

**1. 3<sup>rd</sup> Infantry Division, FSGA, HAAF, and WAAF Conduct.** You are expected to carry out your duties and to conduct yourself properly on and off duty by living the Army Values, the Soldiers' Creed, and representing the Marne Division with pride. There are civil laws which pertain to all citizens, Soldiers included, and you must obey these laws. You will use professional language in public and common areas on and off the installation. Profanity and inappropriate language are prohibited in common areas that are frequented by our Families and children. Soldiers will demonstrate appropriate respect for all civilian authorities on and off the installation. Leaders are also expected to discuss Army and Division standards and ongoing life events with their subordinates to remain engaged and relevant in their life and wellbeing.

**a. Intra-Unit Intimate Relationships.** Soldiers of different ranks are prohibited from engaging in certain relationships. Such relationships are outlined in AR 600-32. Soldiers are discouraged from engaging in intimate relationships that may cause real or perceived issues with good order and discipline. Such relationships include any behaviors that compromise, or appear to compromise, the integrity of supervisory authority or the chain of command; cause actual or perceived partiality or unfairness; involve, or appear to involve, the improper use of grade or rank or position for personal gain; are, or are perceived to be, exploitative or coercive in nature; or create an actual or clearly predictable adverse impact on discipline, authority, morale, or the ability of the command to accomplish its mission. Conduct Between Soldiers of Different Grades may be punished under the UCMJ.

**b. Drugs.** Possession or use of any controlled substance without a valid prescription or use of prescription drugs intended for another person is illegal. This directive applies to Family members of Soldiers who live or work on the installations, as well as guests visiting the installations.

**c. Smoking / Vaping / Dipping.** Tobacco use, to include smokeless tobacco, whether in loose or pouch form, is prohibited in all government buildings. Smoking and vaping are prohibited in all government buildings, Unaccompanied Soldier Housing, unit motor pools/parks, military tentage, and government-owned vehicles. Smoking and vaping are prohibited during the physical training hours of 0630 and 0800. Unit commanders are encouraged to establish "smoking areas" inside of their unit footprints.

**d. Secondary Off Duty Employment.** All active-duty personnel are prohibited from engaging in off-duty employment without their Battalion Commander's prior approval IAW AR 600-63, Army Health Promotion.

**2. Off-Limits Establishments.** Individuals will not enter off limits or restricted areas without authority. A list can be found on the 3<sup>rd</sup> Infantry Division and Fort Stewart website: <https://home.army.mil/stewart/my-fort/soldiers/limit-information>.

**3. Military Courtesy.** All Soldiers will render salutes to superior officers, stand at the position of Attention or Parade Rest when speaking with officers / NCOs, and greet officers and NCOs with the Division / Unit greeting of the day.

**a. Greeting Officers and Noncommissioned Officers.** All Soldiers render the salute unless it is impractical (e.g., arms full of packages) and exchange verbal greetings with either the unit motto or the division motto such as "Rock of the Marne" followed by "Sir" / "Ma'am" or "CSM / 1SG" as appropriate. The return greeting is the "Top of the Rock" or the unit motto response.

**b. Reveille, Retreat, and National Anthem.** Soldiers (on or off duty, in or out of uniform) are expected to render proper honors during Reveille, Retreat, and the National Anthem IAW AR 600-25, Salutes, Honors, and Courtesy. If traveling in a government or privately owned vehicle (car, motorcycle, bicycle), Soldiers will stop, exit their vehicle, and render appropriate honors. If the location or situation is unsafe to exit vehicles, at a minimum Soldiers will stop their vehicle.

**c. Child Development Centers (CDC).** All Child Development Centers located on Fort Stewart and Hunter Army Airfield are designated as No Hat, No Salute areas to better assist parents with maintaining the safety of their children to and from the buildings and their mode of transportation. While no salutes will be rendered in these areas, the greeting of the day will be given if encountering an Officer or NCO. CDCs will have signage posted by the FSGA and HAAF Garrison stating the immediate areas around the CDC are designated No Hat, No Salute areas when picking up or dropping off children.

**4. Unaccompanied Soldier Housing.** Leaders, at all echelons, will ensure that our Soldiers that reside in Unaccompanied Soldier Housing are treated with the same dignity and respect as their married counterparts. The Army Barracks Management Program (ABMP) and unit policies are designed to balance a Soldier's need for a 'home-like' atmosphere with the requirement to maintain a safe, healthy, and secure living environment for all. Balancing these goals is chain of command business but a Soldier should not feel as though their living space is simply a place to rest their head between work shifts, it is their home, and they will be granted freedom, within accepted parameters, to make it their home without causing temporary or permanent damage to the dwelling. Each Soldier has a personal responsibility to maintain their living areas, just as married Soldiers are accountable for their quarters under Fort Stewart Family Housing and Balfour Beatty Communities policies.

**a. Firearms.** Soldiers residing within Unaccompanied Soldier Housing must store all privately owned firearms in your unit's arms room or with a registered off-post firearms dealer. **Storage or possession of privately owned firearms in Unaccompanied Soldier Housing is strictly prohibited.**

**b. Alcohol.** There is not a limit on the amount of alcohol a Soldier may possess while residing in Unaccompanied Soldier Housing. However, Commanders may revoke or limit this privilege due to behavior, standards, or general indiscipline or misconduct problems within their formations.

**c. Quiet Hours.** Quiet hours in Unaccompanied Soldier Housing are from 2200 to 0600. No excessively loud music or sounds are allowed during that period. Excessively loud is defined as loud enough to be heard from the hallway or another room with the door closed or if it impedes one roommate's reasonable ability to sleep. If a resident fails to be quiet after CQ/SD correction, the matter will be referred to the SDO and the offender's leadership.

**d. Daytime Visitation.** Soldiers may have visitors in their Unaccompanied Soldier Housing from 1700 to 2359 on duty days and from 0800 to 2359 on a non-duty day. Staff Duty (SD) or Charge of Quarters (CQ) will review the visitor log and remaining ID cards beginning at 2345 each night and escort all remaining visitors, not on a valid overnight visitation plan, from the building NLT 2359.

**e. Overnight Visitation.** Soldiers residing in Unaccompanied Soldier Housing are not authorized overnight visitation on **Duty Days**. A Soldier residing in Unaccompanied Soldier Housing may request to have a visitor, of either sex, remain overnight on non-duty days. To host a visitor overnight, Soldiers will submit a Visitation Plan to their C/B/T Chain of Command. Soldiers may submit a request for Pass or Leave ICW a Visitation Plan for approval on non-duty days. Soldiers may not have a visitor on a permanent basis (continuous cohabitation). No visitors below the age of 18 will be allowed in Unaccompanied Soldier housing without a parent or guardian that is over the age of 18, in conjunction with prior knowledge, coordination, and approval of the Soldier's Chain of Command.

**f. Pets.** No pets are allowed in Unaccompanied Soldier Housing, including caged and aquatic animals.

**g. Command Housing Visitation Policy.** Leaders are responsible for engaging Soldiers and Family Members to ensure they are provided quality on and off-post housing, that property owners and property managers fulfill their legal obligations, and that Soldiers understand their housing rights and responsibilities.

**Command Visits.** Our Soldiers, and their Families, quality of life is our top priority. Command visits are essential to protection of the force and our Families. Informed consent is required to view or enter the privatized quarters (on or off post) for the purpose of assessing safety, health, and overall housing quality. An Occupant (Soldier or another occupant) may limit or completely revoke consent at any time, to include during the visit, to any area of the residence. If this occurs, the Command visitors will only access areas to which they have consent and will depart the residence immediately upon revocation of consent. There shall be no reprisal against a Soldier or Family Member for not giving consent or revoking consent.

**Visit Content.** Visits will include discussion of housing, maintenance, or landlord/property manager concerns, Soldier rights and responsibilities regarding housing, unit training, deployment plans, upcoming events, and Family Readiness Services. Leaders will address and offer solutions to family stressors (finances, childcare, marital tension, or similar issues)

and assess housing quality while verifying that landlords/property managers are fulfilling their obligations. The visit will be documented in MFR style format, including issues to be addressed by the applicable party to enable follow-up and ensure resolution with property managers and Soldiers. Life, health, and safety issues will be immediately addressed with the Soldier and/or landlord/property manager.

## PART FOUR

**1. Safety and Protecting the Force.** Every Soldier is a safety officer; this is not a motto; it is a duty. We are all obligated to intervene to protect life, limb, and eyesight regardless of the situation. A failure to do so is a failure in leadership and will be treated as dereliction of duty under Article 92, UCMJ.

**a. Privately Owned Weapons.** All Fort Stewart, Hunter Army Airfield, Wright Army Airfield and DoD personnel, including their dependents, and any person entering Fort Stewart and Hunter Army Airfield will register their weapon(s) within 24 hrs., IAW AR 190-11, (Physical Security of Arms, Ammunition, and Explosives). Servicemembers and dependents must register all privately owned firearms (any cartridge firing or muzzle loading rifle, shotgun, handgun (pistol or revolver), pellet firing rifle or handgun with a muzzle velocity of 600 feet per second (FPS) or higher and crossbows. Violators are subject to punitive measures by the Commanding General. Servicemembers are also advised that the State of Georgia constitutional carry law does not apply on the installations of Fort Stewart or Hunter Army Airfield. Firearms registration is conducted online by emailing a FS Form 2027 to [usarmy.stewart.usag.list.des-weapons-registration@army.mil](mailto:usarmy.stewart.usag.list.des-weapons-registration@army.mil) or in person at Building 101, FSGA; Hours of operation: 0600-1600, Monday – Friday. More information on Privately Owned Weapons can be found at <https://home.army.mil/stewart/about/Garrison/DES/privately-owned-weapons>.

**b. Privately Owned Vehicles.** Soldiers and Department of the Army civilians will not display obscene, racist, or offensive messages prejudicial to good order and discipline in or on their vehicles. Additionally, Soldiers, dependents, and DA Civilians will ensure that all registrations and insurance remain in compliance with established State regulations and standards. Soldiers, dependents, and DA Civilians will operate vehicles safely and in accordance with all installation regulations; speeding and driving while under the influence of alcohol or drugs may result in loss of on post driving privileges and UCMJ actions. Soldiers will not play music at excessive levels, if the sound system can be heard at 25 feet or more from the vehicle with all the vehicle's windows closed, it is considered at an excessive volume and must be turned down. Fort Stewart quiet hours are between 2200-0630 daily.

**c. Motorcycle Operations.** All Soldiers operating a Motorcycle on or off post will abide by Department of Defense and local Commander guidance. All Soldiers that operate, or are passengers on a motorcycle, will wear a properly fastened Department of Transportation (DOT) approved helmet, eye protection, long sleeve shirt/jacket, long pants, full fingered gloves, and over the ankle style footwear. IAW Army Regulation 385-10, The Army Safety and Occupational Health Program, Chapter 13-17 and the Army Progressive Motorcycle Program, it is mandatory for all Soldiers operating a privately-owned motorcycle to complete all motorcycle safety training before operating a motorcycle.

**d. Tactical Vehicles.** Soldiers will wear required PPE when riding in tactical vehicles including helmet, eye protection, and gloves. **All occupants will wear the provided vehicle restraints (seat belt, harnesses, safety tether, etc.).** Soldiers riding in the back of a troop carrier will utilize the troop strap. Tactical vehicles are prohibited in Shoppette (AAFES Express), PX, Commissary, Commercial Food Providers, or similar parking lots regardless of length of time.

**2. Online Conduct.** Soldiers are expected to conduct themselves professionally while online and the same rules and regulations that govern other aspects of a Servicemember's conduct apply to online behavior. Inappropriate or unlawful conduct online can have real consequences. Think, Type, Post is the Army's core social media policy. Think about our values before you type and think again before you post. Inappropriate online conduct can and will negatively impact a Soldier's career IAW AR 600-20, Army Command Policy, and AR 360-1, The Army Public Affairs Program. Maintaining a social media profile or presence for the purpose of generating income is a form of off duty employment and requires prior approval.

**3. Political Endorsement / Activities.** Soldiers will abstain from partisan/political endorsement while on duty. Political displays (e.g., signs, flags) are forbidden on Fort Stewart, Hunter Army Airfield, and Wright Army Airfield, the only exception being one bumper sticker per vehicle for official candidates running for elected office. Soldiers are prohibited from attending political rallies or activities in uniform and have a responsibility to avoid engaging in activities that associate the Department of War with any partisan political campaign, election, candidate, cause or issue. Soldiers are individually responsible for understanding the restrictions imposed by DoD Directive 1344.10.





## THE 3<sup>rd</sup> INFANTRY DIVISION PATCH



The 3rd Infantry Division shoulder sleeve insignia consists of three diagonal white stripes,  $\frac{5}{16}$ " wide and  $\frac{5}{16}$ " apart, superimposed diagonally upon a dark blue field  $2 \frac{1}{4}$ " square. When worn on the left sleeve, the three stripes should run from the upper, rear corner downward to the front, lower corner. The clear field of blue stands for the loyalty, steadfastness and undying devotion to the principles of right and justice by the American Soldier. The three clear-cut, white stripes stand dually for the three operations up to the signing of the Armistice of 11 November 1918, of which the 3rd Division took part (Marne, St. Mihiel and Meuse-Argonne), and for the numerical designation of the Division. One of the basic facts considered in the design was the striking appearance of any design that embodied the use of equal stripes as shown to the world by the flag of our country.

## [The 3rd Infantry Division: A Legacy of Service](#)

### World War I

Activated on November 21, 1917, the 3rd Division quickly deployed to France as part of the American Expeditionary Force. The division earned its nickname, the "Marne Division," during the pivotal Battle of Château-Thierry, where it successfully repelled a German offensive, preventing their advance on Paris. By the end of the war, the division had fought for 99 days on the front line, earning six campaign clasps and its first two Medals of Honor.

### World War II

The 3rd Infantry Division holds the distinction of being the only U.S. division to fight the German Third Reich on every front in the European Theater, from North Africa and Sicily to Italy, France, Germany, and finally Austria. With 536 days in combat and four amphibious assault landings, it was one of the most combat-experienced divisions in Europe. The division's valor earned it ten battle streamers, a Presidential Unit Citation, and the French Croix de Guerre. A remarkable forty-four soldiers received the Medal of Honor, including Audie Murphy, the most decorated American soldier in the Army's history.

### Korean War

Called upon for its extensive combat experience, the 3rd Infantry Division arrived in Korea in November 1950. It played a crucial role in the massive Hungnam beachhead evacuation, saving over 100,000 troops and 125,000 refugees. The division famously defended Outpost Harry against determined Chinese assaults. During the "Forgotten War," the unit earned thirteen Medals of Honor, eight campaign streamers, and two Republic of Korea Presidential Unit Citations.

***Medal of Honor Recipients: 13***

### Cold War & Post-Cold War

From 1958 to 1996, the division was a key component of NATO's defense in Germany against potential Soviet aggression. Following the Cold War, a brigade from the division participated in Operations Desert Shield/Desert Storm in 1991, leading the 1st Armored Division to a swift victory. Throughout the 1990s, the division also served as a multinational peacekeeping force in the Balkans.

### Global War on Terrorism & Beyond

In response to the 9/11 attacks, the 3rd Infantry Division led the lightning-fast ground assault from Kuwait to Baghdad during Operation Iraqi Freedom in 2003, highlighted by the famous "Thunder Runs." SFC Paul R. Smith was posthumously awarded the Medal of Honor for his actions in Baghdad. In 2021, SFC Alwyn Cashe was posthumously awarded the Medal of Honor for his heroism in Iraq. 3<sup>rd</sup> ID was the only Division to serve four combat tours in Iraq and later deployed multiple times to Afghanistan. More recently, the division has deployed in support of Operation Atlantic Resolve in Europe.
