SUBJECT: U.S. Army Garrison Fort Stewart and Hunter Army Airfield, Policy #25, Installation Parking Areas, and Transportation Storage Policy

1. References.

- a. AR 420-1. (Army Facilities).

2. PURPOSE. This policy establishes guidelines on activities permitted on installation parking lots and public areas, transportation vehicle storage and long-term parking.

3. APPLICABILITY. This policy applies to DoD Service Members, Department of the U.S. Army Civilians, and Family members residing and visiting Fort Stewart and Hunter Army Airfield areas of responsibility.

4. POLICY. This policy prohibits the following: long term parking (more than 96 hours) of transportation vehicles on a parking lot or public area; vehicle maintenance on within barrack-parking lot or privatized housing common areas; vehicle storage (in excess of 96 hours).

- a. Long-term parking is defined as not moving for 96 hours or more.
- b. Public Areas are defined as any area outside of curtilage. Curtilage is defined as the area, usually enclosed, encompassing the grounds and buildings immediately surrounding a home/barracks that is used in the daily activities of domestic life.
- c. Transportation vehicles are defined as boats, trailers, privately owned vehicles, motorcycles, recreational vehicles (RVs) and all-terrain vehicles.

d. Maintenance is defined as routine or emergency repairs. Hazardous materials will not be stored in/around barracks, and parking lots.

e. Offenses include but are not limited to: illegal parking on atop of seeded areas, sidewalk blocking, parking against traffic flow, driving and parking a transportation with expired registration and insurance coverage.
