



Valor remembered: three U.S. Soldiers to receive military's top honor

WASHINGTON —The President of the United States will present Medals of Honor to two Soldiers who gave their lives for their comrades and another who fearlessly defended a forward-operating base during actions in Iraq and Afghanistan.

President Joe Biden will recognize the bravery of three U.S. Soldiers during a White House ceremony, Thursday.

Sgt. 1st Class Alwyn Cashe will receive the award for rescuing teammates from a burning vehicle while ignoring his own injuries in October 2005 near Samarra, Iraq.

Sgt. 1st Class Christopher Celiz will receive the medal for using his body to shield his team and an injured ally from enemy gunfire in the Paktia Province, Afghanistan, in July 2018.

Master Sgt. Earl Plumlee will receive the military's highest honor for engaging invading insurgents at a U.S. base near Ghazni, Afghanistan, in August 2013.

Plumlee

Plumlee served as a weapons sergeant assigned to Charlie Company, 4th Battalion, 1st Special Forces Group (Airborne), at Forward Operating Base Ghazni when enemy forces attacked the complex. Plumlee instantly responded to a massive explosion that caused a 60-foot breach in the base's perimeter wall.

Ten heavily armed insurgents wearing suicide vests entered the base perimeter through the opening. Plumlee and five other Special Forces Soldiers climbed into trucks and headed to the attack point.

Plumlee's driver maneuvered the vehicle to provide cover for three injured U.S. Soldiers. With their truck exposed to enemy fire, Plumlee then used his own body to shield his driver from attack.

Plumlee, outnumbered and armed with only a pistol, engaged the enemy fighters. After finding cover behind a plastic water tank, he quickly killed one insurgent with a well-placed grenade. As enemy bullets cracked past his head, he killed another insurgent by firing into another's suicide vest which detonated.

Still outmanned, Plumlee advanced on the enemy forces again, exposing himself to gunfire as another suicide vest detonated only seven meters from his position. The enemy fighters then unloaded heavy fire upon Plumlee, including several grenades.

The onslaught forced Plumlee to take cover behind a junction panel. Plumlee and another Soldier then mounted a counterattack. The Soldier made his way toward a wounded insurgent, who ignited his suicide vest and the force of the blast sent Plumlee flying backward against a wall.

With his back injured, Plumlee once again found his bearings and engaged the enemy fighters yet another time. This time, after intense enemy fire forced him to retreat, he joined a group of U.S. and Polish Soldiers. Insurgents tossed hand grenades towards the U.S. troops. Then another insurgent began attacking the U.S. Soldiers from the rear, prompting Plumlee to fire his last two rounds. As the insurgent fell, he then detonated his suicide vest, mortally wounding a U.S. Soldier.

"It was one of the worst gun fights I've ever seen," he said. "And it was happening right where I sleep."

Several times, Plumlee said, he stood inches from a bullet striking him during the battle. Plumlee did receive wounds when an insurgent suicide-vest attack injured his back.

"It was a crazy day," he said. "It doesn't make any sense. How I didn't get shot, I don't know. My best guess was because I kept moving. [The insurgents] were always one or two feet behind me."

Finally, with enemies still within striking distance, he ran amid insurgent fire to aid a wounded Soldier and carried him to safety.

When asked about being awarded the Medal of Honor, Plumlee said the Medal should recognize the efforts of the group.

"It's just my nature," Plumlee said. "I'm not used to being singled out for anything positive or negative. Generally the team you're involved in gets those kinds of accolades. I'm still fairly uncomfortable with it."

Unmanned Aircraft Systems operator passes bar exam, joins JAG Corps

Dedication is often described as being devoted to a task or purpose. For some, it's dedication to sports. For others, it's dedication to serving their country. For Cpl. Jordan Robertson, her dedication is to joining the Army Judge Advocate General's Corps.

Robertson, a native of Salt Lake City, Utah, is not the first person in her Family to take an interest in law. Her mother, Judge Shauna Graves-Robertson, is the presiding judge in the Salt Lake County Justice Court.

Prior to enlisting in the Army, Robertson attended the Thomas Jefferson School of Law, where she earned her Juris Doctor degree in 2019. During her final semester of law school, she applied to the JAG Corps, where she could be accepted under one condition: she must pass the bar examination.

The bar exam is offered twice per year, once in February and once in July.

"I graduated in May 2019, and immediately started studying to take the bar exam in July," Robertson said. "The results came out in September and I didn't pass, which caused me to lose the opportunity to commission."

Robertson knew that she still wanted to be in the military, so she enlisted in the Army in October 2019.

"My recruiter asked me if I wanted to be a paralegal specialist and I said 'no,'" Robertson explained. "I was really upset and disenchanted with the idea of law and decided to become an Unmanned Aircraft Systems Operator."

Upon completion of basic and advanced individual training in September 2020, Robertson was stationed at Hunter Army Airfield, Georgia, where she currently serves with Fox Troop, 3rd Squadron, 17th Cavalry Regiment, 3rd Combat Aviation Brigade, 3rd Infantry Division.

Robertson said her leadership knew that she recently graduated from law school so they did everything they could to help her prepare for the next bar exam. After five months of rigorous studying, February rolled around and it was time to take the bar examination again. Robertson said she was prepared and had never felt more ready.

After completing the bar exam, it takes about 3 months for the results to come out, so all Robertson could do was wait.

On May 1, the day Robertson had been waiting for finally arrived. The exam results were in.

"Around 8 a.m., I got the notification, so I took a deep breath, opened the email, and found out that I passed the bar exam," Robertson said. "I screamed, cried, and immediately made a group video call to my parents and sister."

Robertson said that there was no other word to describe her feelings other than relief.

"I felt relieved because it felt like I was finally putting the pieces of my life together to get where I wanted to go," she explained. "The culmination of years of effort finally felt like it was paying off."

On Oct. 19, Robertson was virtually sworn into the Minnesota State Bar Administration.

After she was sworn in by the Minnesota Supreme Court Judge, she had all the credentials to apply for the JAG Corps again.

"With the support from my chain of command, I put in another application for the JAG Corps," Robertson said. "I was recently accepted and now I'm hoping for a class date in early 2022."

According to Robertson, entry into the JAG Corps is extremely competitive. The U.S. Army is currently accepting only the top legal talent and academic standards are very strict. In addition to academics, applicants are expected to exhibit the leadership qualities befitting an officer in service to their country.

The next step for Robertson is beginning the Direct Commissioned Course, a rigorous, six-week course in leadership and tactics on Fort Benning. DCC is designed to challenge new Army officers mentally and physically in the classroom and field.

The second step is a ten-and-a-half week academic course at the Judge Advocate General's Legal Center and School in Charlottesville, Virginia. Judge Advocates receive classroom instruction on the organization, function, and mission of the Judge Advocate General's Corps, as well as an overview of the practice of law in the Army. The course is designed to prepare judge advocates for their first three years of practice in the JAG Corps.

Judge Advocates are responsible for offering legal support that involves military operations. They primarily focus on the areas of criminal law, legal assistance, civil/administrative law, labor/employment law, international/operational law, intelligence law, and contract/fiscal law.

"I'm excited for the next adventure," Robertson said. "I'm looking forward to standing up for the people who can't stand up for themselves and really making a difference in their lives."

Robertson's mom, Graves-Robertson, said that this is only the beginning of the road for her daughter.

"My daughter is an individual whose vocabulary does not include the term 'give up,'" said Graves-Robertson. "Not only are her father and I proud, but she has a whole village that has supported her over the years that is beaming with pride as well."

Face masks required in on-post facilities

Effective immediately, 3rd Infantry Division, Fort Stewart and Hunter Army Airfield GO1 requires ALL individuals to wear a mask inside ANY on-post facility at Fort Stewart or Hunter Army Airfield. Service members are also required to wear a mask inside off-post public buildings/ facilities (i.e. barber shops, religious services, grocery stores, etc.). Mask mandate exceptions

Vehicle parking safety reminder

Changes to speeding violations issued

The commanding general recently authorized the Fort Stewart Military Police to issue DD Form 1408 for traffic violations when a Soldier is pulled over for speeding 10mph or over above the speed limit. The DD 1408 is effectively a military speeding ticket that allows a Soldier's brigade commander to issue administrative reprimands, non-judicial punishment, suspension of on post driving privileges, corrective training, and/or other appropriate remedial measures. Cashe

Cashe gave his life to save six Soldiers from a burning vehicle while under enemy fire in Iraq on Oct. 17, 2005.

While assigned to Company A, 1st Battalion, 15th Infantry Regiment, 3rd Brigade, 3rd Infantry Division, Cashe was in command of the lead Bradley Fighting Vehicle during a night-time mounted patrol in Samarra, Iraq. The enemy attacked his vehicle with an improvised explosive device and small-arms fire.

The explosion ignited the Bradley's fuel cell, causing flames to engulf the disabled vehicle. Cashe forced the gunner's hatch open to evacuate, and immediately shifted his attention to the driver still trapped inside.

With the help of another Soldier, Cashe opened the driver's hatch and extracted the Soldier, who was on fire. As they extinguished the flames on the driver's body, Cashe's fuel-soaked uniform ignited, resulting in severe burns across his body.

Ignoring his painful wounds, Cashe, pulled the driver to a position of safety before returning to the rear of the vehicle to extract personnel trapped inside the troop compartment. Flames continued to engulf the vehicle and could be seen coming out of every portal.

Shortly after, the enemy started to open fire on Cashe's position. Soldiers on the patrol exchanged gunfire to defend their position, while Cashe opened the troop door to extract additional personnel.

Upon gaining entry, Cashe pushed through the flames to pull four Soldiers from the burning wreckage.

With two Soldiers still missing, Cashe reentered the burning troop compartment to retrieve them. He also recovered the body of an interpreter who had been killed in the explosion.

"Again and again, he continues to go back, soaked in

fuel [and] on fire, with no regard for his own safety to get everybody out," said Maj. Jimmy Hathaway, Cashe's former company commander, during an interview in 2014.

Reinforcements then arrived to suppress the enemy and establish a casualty collection point.

With second- and third-degree burns covering more than 70 percent of his body, Cashe pushed through the pain and encouraged his Soldiers to receive medical care or be evacuated before himself.

"As we were fighting the fight and clearing the scene, he wouldn't leave," Hathaway added. "He wanted to make sure all of his guys were out first even though he was burned over most of his body. He was still more concerned about his guys getting out than he was."

In the end, 10 Soldiers were wounded, with seven of them sustaining serious wounds.

Cashe died of his wounds on Nov. 8, 2005, at Brooke Army Medical Center in San Antonio, Texas. He was posthumously awarded the Silver Star for his heroic actions.

Cashe's widow, Tamara, will attend the White House ceremony to accept the Medal of Honor for his extraordinary heroism and selflessness above and beyond the call of duty. Their daughter, Alexis, will also attend the ceremony.

Celiz

Celiz had been nearing the end of his fifth deployment when tragedy struck during a mission in the Paktia Province of Afghanistan.

A well-respected Army Ranger, Celiz earned the admiration of his peers with his selfless attitude. Celiz bonded with his fellow Soldiers both on duty and during family dinners and trips into the wilderness. He also mentored and challenged fellow Soldiers to become better at their duties.

"He didn't feel like he could do his job without his Soldiers ready and able by his side," said his widow, Katie. "He always pushed them and he wanted them to push him. He couldn't be a better person if they didn't challenge him."

Then on July 12, Celiz led a special-purpose unit comprised of allies and members of the 1st Battalion, 75th Ranger Regiment, to clear an area of enemy forces. As the team's mission neared completion, a large contingent of enemy forces unleashed a wave of bullets toward the unit.

The onslaught injured a partnered force member. Celiz, knowing the danger before him, exposed himself to enemy fire as he secured a heavy weapon system, enabling his unit time to reach cover.

As the unit's leader, Celiz decided to use his body to shield his team as they carried the wounded member to a medical evacuation helicopter.

Even as the enemy machine-gun fire continued to rain upon him, he stood between the medical aircraft and never wavered, even as the onslaught injured him.

In a final, selfless act, he motioned the helicopter to leave rather than attempt to rescue him.

Shortly after, a medical team treated and evacuated Celiz to the nearest medical treatment facility where he died of his wounds.

Celiz's actions that July day left a lasting impact on friends and family.

The impact of his mentorship became more apparent at Celiz's funeral, when hundreds of his former teammates, Soldiers and friends filled the synagogue Congregation Mickve Israel in Savannah, Georgia. Celiz had found the Jewish faith later in life and it invigorated him, his wife, Katie, said.

Katie also said that friends and family remembered Celiz for his embrace of others.

"He was always very accepting of everybody," she said. "In high school, he was friends with everybody; he didn't discriminate because of your race, creed or who you were. As long as you were a good person, that was all he cared about."

Celiz is survived by Katie and their daughter.



Providers strengthen skills during sling load training

Soldiers assigned to Bravo Company, 87th Division Sustainment Support Battalion, 3rd Division Sustainment Brigade, 3rd Infantry Division, honed their skills during sling load training, Dec. 9 on Fort Stewart.

"The purpose of sling load training is to rig up equipment and to rapidly take it by helicopter from one point to another using sling sets, cargo nets and other specially designed equipment," said Cpl. Justin Rogers a radio and communications security repairer assigned to Bravo Co.

Leading up to the sling load training, Soldiers participated in additional training to prepare.

"The platoons and squad leaders have all done platoon field training which led up to our culminating company base defense training," said 1st Sgt. Thomas Johns, the senior enlisted advisor of Bravo Co. "We also sent Soldiers to sling load training and air assault training."

Sling loading equipment allows units to avoid surface obstacles that may hinder them from reaching their destination in a timely manner. It is also used to reach outlying areas where the use of convoys is impractical or impossible. These procedures may be used during a deployment by the unit for both humanitarian assistance, or in support of contingency operations.

"We're not exactly preparing to deploy," said Capt. Jessica Richardson the commander or Bravo Co. "We are currently on prepare to deploy orders so we must maintain a high state of readiness at all times for our mission."

The training allowed Provider Soldiers to get under the helicopters, familiarize themselves with sling load operations to include how to properly attach and secure equipment.

"This training has tested our readiness stature and showed us where we need to improve upon," Richardson said. "The training is important because it creates a realistic picture for the command of where our unit stands while helping the Soldiers develop skills which are integral to our success as a maintenance unit."

Sling load training is important because it allows Soldiers and leaders to identify areas that could use more training to strengthen areas of weakness outside of daily operations.

"The training and maintenance that we are [hosting] at Camp Oliver is helping us hone in on our basic skills while also testing our ability to perform and accomplish maintenance tasks in an austere work environment," Richardson said. "It takes Soldiers out of their element in the motor pool and helps them to face the reality of our assigned mission."

An expectation from the leaders of Bravo Co. is for Soldiers to work together efficiently in order to accomplish the mission.

"I am hoping the Soldiers learn how to come together as a team, often these field elements are where we strengthen the company's bond," Richardson said. "I know that the Soldiers will feel more confident in their skill levels since this training will reinforce the skills they have previously learned during earlier field exercises."

Training is beneficial to Soldiers in order to become proficient and enhance their skills to better prepare them for adverse situations.

"This is my first time officially certifying with a load to be lifted," Rogers said. "It's always important to be well versed regardless of your military occupational specialty or rank because you never know what can happen down range or any given situation. It's also good to teach and work together as a team doing something we don't do every day."

Soldiers that prepared for the training gained additional skills by completing the hands-on portion

"From this training I learned to be more prepared and electrostatic discharge that keeps the static from the helicopter from electrocuting Soldiers as they hook up the sling-arms," Rogers said. "I feel like we did pretty well because we even had a lower enlisted Soldier in the helicopter to experience the entire process."

Along with the importance of transportation equipment by helicopter from one point to another, Soldiers were also able to learn the importance of each individual tasks while safely attaching equipment to the helicopter.

"Being in the helicopter is a bit nerve-wrecking, but the most important part is to maintain your composure, stay calm and confident especially being the static discharge person," Rogers said. "It's very important to maintain contact with the hook otherwise somebody could get electrocuted, but once you do it becomes muscle memory."

As Bravo Co. continues to provide support to the 3rd DSB and the Division stateside daily, they continue to prepare to provide the same support if they deploy overseas.

"Our unit is continuously supporting the mission and Division whether we are operating out of a field or garrison environment," Richardson said. "I couldn't be prouder of my Soldiers for their initiative and drive to always accomplish the mission."

Dogface Soldier becomes first female to earn Ranger and Sapper tabs

Second Lt. Amanda Atkinson, assigned to the "Gila Battalion," 9th Brigade Engineer Battalion, 2nd Armored Brigade Combat Team, 3rd Infantry Division, graduated from Army Ranger School, Dec. 10 on Fort Benning. She is the first female Soldier in 3rd ID and fifth in the Army to earn both the Ranger and Sapper tab.

Atkinson had already graduated the Sapper Leader Course on July 2, 2019, at Fort Leonard Wood, Missouri, but now became the 94th female to graduate Ranger School, earning the right to wear both tabs – known as "double-tabbed."

She graduated alongside 1st Lt. Rafael Eirea-Lamberto, a fellow Soldier from her unit, who earned the "double-tabbed" status as well.

"Lieutenants Atkinson and Eirea-Lamberto represent the fighting spirit of the Gila Battalion," said Lt. Col. Brian T. Looney, commander of the 9th BEB, 2nd ABCT, 3rd ID. "I am extremely proud of these two leaders and their dedication to excellence."

Ranger School was developed during the Korean War and designed to build the combat skills of selected officers and enlisted personnel, requiring them to perform effectively as small-unit leaders in a realistic, tactical environment. The school is one of the toughest training courses in the Army and consists of 61 days of training and comprises three phases: Benning, Mountain and Florida. Candidates must successfully complete each phase.

When asked why Atkinson wanted to attend Ranger School after she had already graduated from SLC she said "I wanted to attend to better myself and improve my leadership skills before taking a platoon."

Atkinson spoke highly of her experience during the course.

"Being a female did not affect how I was treated at the school," she said. "My instructors and peers held me to the same standard as all the other ranger students."

Atkinson, a native of Harbeson, Delaware, and Eirea-Lamberto, a native of Miami, Florida, both started and graduated on the same date and crossed paths many times while in training.

"The fact that I went with my peer Amanda Atkinson was awesome," Eirea-Lamberto said. "We were in the same squad during Mountain phase and the same platoon during Florida phase. We pushed each other and watched each other's backs."

Both Soldiers worked with the same mentor and trainer, Master Sgt. Joshua Spaulding, a former operations noncommissioned officer in 9th BEB, 2nd ABCT, 3rd ID, who also trained them prior to the 14th Annual Best Sapper Competition this past May.

"It is always an honor to train other leaders and see them succeed and then see them pay it forward," Spaulding said. "Lieutenants Atkinson and Eirea-Lamberto have accomplished a lot this year, but their biggest achievement is probably all the other Sappers they have trained and helped graduate SLC."

As a trailblazer, Atkinson offers advice to any female Soldier aspiring to achieve the same goal: "I would tell them if they put in the hard work, then they will be able to succeed at both schools."



A Dogface Soldier through and through: Memories of Alwyn Cashe

"He loved 3rd ID; he loved Kelley Hill; he loved the organization," remembers Lt. Col. Leon Matthias of Sgt. 1st Class Alwyn Cashe. "He bled it through and through."

With the upcoming ceremony to present the Medal of Honor to Cashe's family, former and current 3rd Infantry Division Soldiers remember him as a true Dogface Soldier who embodied the division's values.

While serving as a platoon sergeant in the 1st Battalion, 15th Infantry Regiment, Cashe's vehicle was struck by a roadside bomb near Samarra, Iraq, on Oct. 17, 2005. Dazed and wounded, Cashe retrieved seven Soldiers and an Iraqi interpreter one-by-one from the burning vehicle, receiving burns himself on nearly 72% of his body. Three of those rescued ultimately perished days later at Brooke Army Medical Center in San Antonio, Texas. Alwyn Cashe was the last, succumbing to his wounds on Nov. 8. He posthumously received the Silver Star Medal for his heroic actions.

Although it has been 16 years since his death, stories of Cashe and his legacy live on with those who knew him.

While most stories about Cashe focus on his heroism in the face of danger, Matthias, his former platoon leader and witness to the events of that day, fondly recalls a funny and telling moment he had with his then-platoon sergeant.

The 1st Bn. 15th Inf. Rgmt., 3rd Brigade, 3rd ID, was stationed at Kelley Hill on Fort Benning, Georgia, while the rest of the division was headquartered four hours away on Fort Stewart. While deployed, the brigade was

assigned to support Task Force Liberty and received a different combat patch than the familiar blue and white-striped 3rd ID insignia.

Matthias, then a young lieutenant, was excited to sew a combat patch on his uniform after months in Iraq. He chose to wear the Task Force Liberty patch instead of that of 3rd ID. The decision to wear the patch of another organization did not sit well with Cashe.

"Well, I think I earned this combat patch, and they said we could wear it," Matthias retorted to his platoon sergeant.

"He's like 'sir, you're not coming on patrol wearing that patch; we are wearing a 3rd ID patch," Matthias remembers. Matthias continued to protest, but it fell on deaf ears.

The next thing he knew, Matthias heard Cashe say "get him" and suddenly the Soldiers of the platoon piled on Matthias and ripped off the Task Force Liberty patch.

"This is the unit you deployed with, this is the patch you're going to wear for your deployment, and he was truly adamant about it," said Matthias of Cashe.

Command Sgt. Maj. Quentin Fenderson, the 3rd ID senior enlisted advisor, said Cashe's pride in his unit was well earned.

"Third Brigade was different," said Fenderson, who served in the brigade alongside Cashe. "We felt like we were the underdogs. Every other year we were deploying."

"So, everybody on Kelley Hill knew each other, and I think that was one of the things that separated us," Fenderson continued. "It was a family. We shared failures. We shared success."

One memory of Cashe still resonates and guides

Fenderson to this day.

Fenderson said the brigade went to the Joint Readiness Training Center together prior to their deployment to Iraq. He recalls Cashe's company forgot to bring antennas for their vehicles.

"Here is Sgt. 1st Class Cashe—at the time the platoon sergeant—he's walking around because he's got all these relationships throughout the brigade," said Fenderson. "He's walking around borrowing antennas from people to make sure that his entire company got these antennas."

"Some leaders today would have sent somebody else to do that," said Fenderson. "But he took it upon himself."

Fenderson remembers laughing at him at the time and asking, "What are you doing out here?"

"He's just like, 'hey, gotta make it happen,'" said Fenderson. "That's the type of person he was."


For Fenderson, this story highlights how much Cashe cared about ensuring that his Soldiers could accomplish their mission.

When 3rd Brigade deployed to Iraq, parts of the unit were separated out across the country, so news of the attack on Cashe's vehicle took some time to reach everyone

"I just remember that when the information came out, they didn't talk about who it was," Fenderson continued.

After the family was notified, an information blackout was lifted and Soldiers throughout the brigade found out it was Cashe's team, said Fenderson.

"Everybody, I think, just felt it," he said. "When Cashe passed away, it hit us hard because that really was a brother."

Fenderson said that no one was surprised when they found out Cashe performed heroically in combat.

"Nobody expected anything different," said Fenderson. "That's just how he was."

"This well-deserved level of recognition for his courage and sacrifice has been highly anticipated by Soldiers of the 3rd Infantry Division-both past and present," said Maj. Gen. Charles D. Costanza, the commanding general of the 3rd ID.

Costanza previously commanded the 3rd Brigade, 3rd ID in which Cashe served and worked alongside many Army officials and the Cashe family to make this event a reality.

"Sgt 1st Class Cashe is an example of what being a Dogface Soldier is all about – selfless service. The special relationship we developed with the Cashe family while preserving his memory and telling his story is truly remarkable. I am incredibly proud that this time has finally arrived; for him, our Army and his family," he said.

For the Soldiers who were with Cashe when his vehicle was struck, his legacy as a consummate professional and caring leader was established long before that day.

Douglas Dodge, who has since retired from the Army, served as a squad leader under Cashe and was rescued by him during the attack that lead to Cashe's

death.

Dodge said that prior to the attack, their platoon worked long hours and had few days off. The team was worn out and on edge with each other.

Dodge remembers having a strong disagreement with Cashe while in Iraq, although the specific details are fuzzy years later.

Following the argument, Dodge went to see their first sergeant, who sat him and another squad leader down and explained how much Cashe protected his Soldiers from unnecessary work, even if they didn't know it.

"You guys don't understand what he does every day to try to give you guys time just to even have an hour for yourselves," Dodge remembers his first sergeant saying. Hearing this from someone above their platoon resonated with Dodge.

"It showed me how much he really did do for us and took care of us without us even knowing," Dodge said. "It wasn't in our faces. It wasn't like 'look what I did for you guys.' It was just unspoken. He just did it because he cared."

"I wish I had known that sooner. I think I would have matured faster if I had really realized and understood the responsibilities he had been undertaking and the things he did for us," Dodge continued.

Dodge carried this lesson from Cashe forward with him throughout his career as a noncommissioned officer.

"I took care of my Soldiers before, but I don't think that I had the level of compassion at that point in my career that Sergeant Cashe did," Dodge said. "Afterwards, I really gave my Soldiers every little bit of what I had."

Dodge said the effectiveness of his leadership style was apparent as many of his Soldiers later reached out to thank him for his mentorship and guidance.

"That was only because I started investing myself into my Soldiers as much as [Cashe] did," he said.

These memories, and so many others, live on with the Soldiers who knew Cashe. A crape myrtle tree grows in memorial of Cashe amidst 468 others at the Warriors Walk on Fort Stewart. The trees mark the exceptional valor and honor of each of the unit's fallen Dogface Soldiers.

"On my run days I walk through those trees," said Fenderson. "I go to see those who died that day and make sure their trees aren't overgrown."

The pain of the loss of his brothers-in-arms remain with him to this day.

"When I walk by those trees, it's personal because me and the ones who are left from 3rd Brigade are the ones who knew them," said Fenderson.

The memory of Cashe continues as a beacon for the Soldiers of 3rd ID, who honored him last year by dedicating the unit's most prominent memorial garden and event space in his name. Previously known as Marne Garden, a ceremony involving numerous Cashe family members, Army leaders and veterans took place May 20, 2021, and the garden officially became known as Sgt. 1st Class Alwyn C. Cashe Garden.

It has been five years since 3rd Brigade deactivated during an Army drawdown of personnel, but the unit's motto still faithfully represents Soldiers like Cashe, said Fenderson. "Not Too Fancy, Just Tough."

Clinical Skills Fair keeps healthcare professionals sharp

U.S. Army Medical Department Activity Fort Stewart-Hunter Army Airfield, held its annual Clinical Skills Fair, Dec. 6-8 at Winn Army Community Hospital to help healthcare professionals stay attuned to modern medical practices.

Licensed Practical Nurse instructor Loresa Crawford from the hospital's education team organized this year's fair.

Crawford, who has 21 years' experience in nursing, said the skills fair is important because as nurses, they need to keep up with the basic skills to help out where they can.

"As the times change, the skills are improved and the devices that we use are updated," Crawford said.

The classes included hand washing, nasogastric tube insertion, how to obtain arterial blood

gas, PCA pump setup, pressure ulcer identification and care, medication reconciliation, catheter insertion, bed transfer, and cardiac rhythm identification.

Crawford noted that several of the classes are critical to ensure healthcare providers remain ready to support Soldiers and Families.

More than 250 people attended the skills fair. Clarissa Wise, a board certified Registered Nurse with a Master's in Nursing, said that this was the first time she attended and assisted at the Winn ACH Clinical Skills Fair.

"It was a wonderful learning experience, she said. I enjoyed all of the classes but especially the arterial blood gas class; which was taught by Dr. [Christopher] Ott. The class was hands on and you could tell that he enjoys teaching."

Wise said it is important for all nurses to have a commitment to lifelong learning as nursing continues to change based on evidence-based practice. She said that some of the stations addressed basic skills that they use every day, such as hand washing.

"Proper hand washing remains the most effective way to prevent the spread of infection," she said. "With COVID-19 still a major concern, we must also remain competent with nursing skills that we do not use on a daily basis."

Scholarships for Military Children applications open

FORT LEE, Va. — Applications are now open for the Scholarships for Military Children Program for academic year 2022 – 2023.

The program, now entering its 22nd year, recognizes the contributions of military families to the readiness of the fighting force and celebrates the commissary's role in enhancing military quality of life. It's administered by Fisher House Foundation, a nonprofit organization dedicated to helping service members, veterans and their Families. Thus far, the program has awarded more than \$21 million to 12,312 students, selected from a pool of nearly 109,000 applicants.

"For the 22nd year in a row, commissaries are honored to be a part of a program that provides the children of military service members with this valuable financial boost to their higher education goals," said Marine Corps Sgt. Maj. Michael R. Saucedo, senior enlisted advisor to the DeCA director. "We at the Defense Commissary Agency again extend our thanks to the Fisher House Foundation as well as the generous industry partner donors and others that make these scholarships possible for so many deserving families each year."

Funding for the program comes from commissary business partners and other contributions to Fisher House Foundation designated specifically for the scholarship programs.

"Fisher House Foundation is grateful for our longstanding partnership with the Defense Commissary Agency providing scholarships to these very deserving military kids," said Chairman and CEO of Fisher House Foundation, Ken Fisher. "We are also fortunate to have incredible donors that are committed to helping military families through our scholarship program."

Selection qualifications are straightforward. Requirements

include completing the application; submission of the student's official transcript indicating a minimum cumulative GPA of 3.0 or above on a 4.0 scale for high school applicants, or college transcript indicating a cumulative minimum GPA of 2.5 or above on a 4.0 scale for students already enrolled in college; and a 500 word essay. The subject of the essay is listed at the *militaryscholar.org* website under "Scholarships for Military Children."

Eligibility for the program is determined using the Defense Enrollment Eligibility Reporting System database. Applicants should ensure that they, as well as their sponsor, are enrolled in the DEERS database and have a current military dependent ID card. The applicant must also be planning to attend or already be attending an accredited college or university, full time, in the fall of 2022 or be enrolled in a program of studies designed to transfer directly into a four-year program.

Applicants who are awarded a full scholarship to attend a college or university or receive an appointment to one of the service academies or affiliated preparatory schools are not eligible to receive funds from this program. A full scholarship is usually defined as one that provides for payment of tuition, books, lab fees and other expenses.

For scholarship year 2022-23, Fisher House Foundation will award 500 scholarship grants of \$2,000 each. The selection process will begin immediately following the application deadline of February 17, at 11:59 p.m. PST.

All rules and requirements for the Scholarships for Military Children program, as well as links to frequently asked questions are available at *militaryscholar.org*.

Fisher House Foundation also has a free, easy to use custom scholarship search engine tailored to military families called "Scholarships for Service." It's available on both mobile devices and desktop computers at *militaryscholar.org*.
