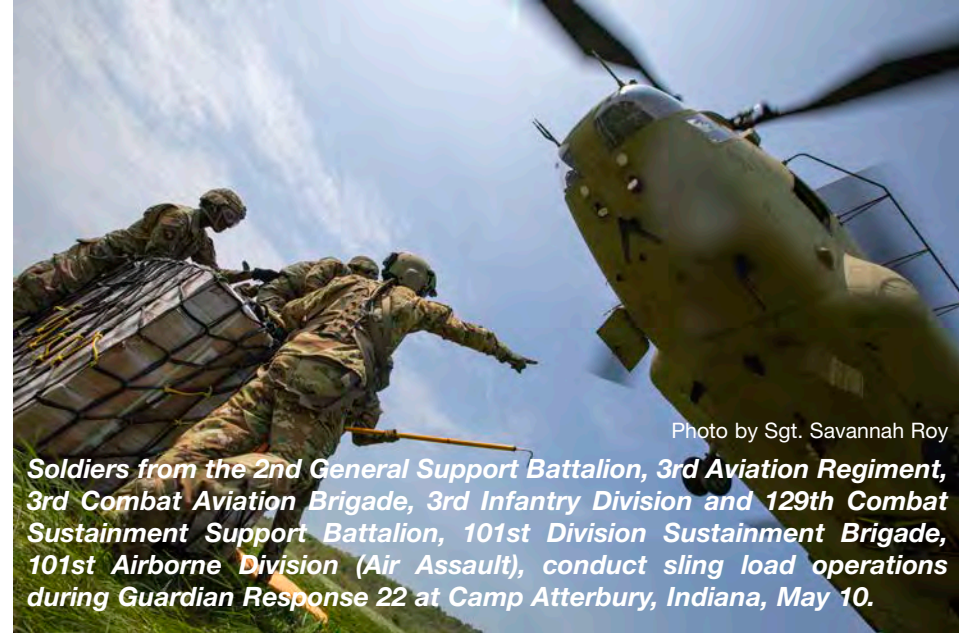

# Army network builds on Europe lessons, looks to industry for data-centric future

Russian aggression in Ukraine has reinforced the need for resilient military communications and robust information-sharing with coalition partners, Army leaders said during a network modernization-focused industry exchange meeting held May 9 and 10.

“We must invest in modernization to secure networks, platforms, and data, which will create cyberspace advantage that enriches operations across all domains,” said Brig. Gen. Joseph A. Papenfus, deputy chief of staff, G-6, U.S. Army Europe and Africa, who joined the event virtually from Europe. “Interoperability is the ability to act together, [and] the efforts being discussed at this technical exchange are a great example of how we are stronger together.”

The experiences of U.S. Army units executing support operations in Europe are accelerating the Army’s transition to data-centric operations. These operations see warfighters and technologies working together to synthesize large volumes of data and securely deliver information to support effects at all echelons. As they leverage a combination of military and commercial communications technologies and common operating picture applications and tools, units deployed today are providing real-time feedback on new concepts and capabilities to share data and interact with partners and allies.

“We’re not waiting for the Army of 2030,” said Dr. Raj Iyer, Army Chief Information Officer. “It’s about operationalizing data for today’s fight. If we do that, then we have the confidence to build and scale across the Army for the future.”

Observations from Europe — coupled with outcomes from Project Convergence, other experiments and unit operational exercises in additional theaters such as the Pacific — are feeding the Army’s implementation of a unified network across the full spectrum of doctrine, organization, training, materiel, leadership and education, personnel, facilities and policy, said Lt. Gen. John Morrison Jr., deputy chief of staff, G-6, U.S. Army. The unified network will enable operational units deployed around the world to plug into available network infrastructure, reach back to the enterprise and apply strategic and operational effects such as long-range fires,

cyber and electronic warfare, he said.

“Think of the power of that construct,” Morrison said, noting the role of industry in staying ahead of evolving threats as communications technology advances. “Our competitors are watching everything that we do, and they are learning rapidly from us, and jumping ahead in some areas. We can stop that, together.”

Featuring warfighter perspectives from the corps to battalion levels and special operations community alongside senior leader remarks, the Philadelphia technical exchange meeting was the eighth in the Army’s semi-annual series of network modernization-focused industry events.

With more than 350 members of industry attending in person and 400 online, the forum also provided in-depth technical discussions on future network design goals and offered targeted opportunities for industry to submit white papers for potential prototyping contracts. Focus topics included data centrality and data fabric; warfighter feedback across echelons and formations; standards implementation; command post modernization; Unified Network Operations; and aerial tier networking.

For example, during a panel discussion focused on how the Army can implement data-centric operations, Lt. Col. Randall Linnemann, the G-6 for the 101st Airborne Division (Air Assault), described how his unit is experimenting with emerging cloud capabilities to operate command posts in a much more mobile, agile and dispersed construct than if the command posts were dependent on constant connections to other deployed command posts’ networks.

“If the data goes up to the cloud, when the command post goes offline — whether it’s maneuvering or jumping — we have continuity of operations,” he said.

This approach not only increases resiliency against a potential near-peer adversary aiming to interfere with communications, but also allows users to focus on the specific data required for a mission, and tailor the network accordingly, Linnemann said.

Data centrality also relies on multi-layered security including tailored access controls, data tagging and authentication, which provide the foundation for securely sharing data with mission partners, said Brig. Gen. Jeth Rey, director of the Army Futures Command

Network Cross-Functional Team.

“We need industry to bake in cybersecurity into everything we establish or create in the future,” he said. The challenge to industry is how we create the data and tag it at the attribute level.”

The technical exchange meeting zeroed in on Capability Sets, or CS, 25 and 27, which will be the third and fourth in the Army’s iterative series of integrated tactical communications packages for delivery to Soldiers supporting Joint All Domain Command and Control. CS 21 focuses on expeditionary and intuitive capabilities and is now fielding to infantry units, while CS 23 focuses on capacity, resiliency and convergence and extends network modernization to mounted units and the Division level.

With the Army recently locking the design for CS 23 and preparing for final operational demos supporting fielding decisions, now is the time to continue to push for advancements in automation, protection and data centrality to be delivered in CS 25 and CS 27, leaders said.

“We have a tremendous amount of momentum and progress,” said Maj. Gen. Robert Collins, Program Executive Officer for Command, Control and Communications-Tactical, which hosted the event along with the Network Cross-Functional Team and the Combat Capabilities Development Command Command, Control, Computers, Communications, Cyber, Intelligence, Surveillance and Reconnaissance, or C5ISR, Center. “We in the government cannot do this alone — this is to articulate and be transparent about where we are going.”

The next step will be for industry to submit white papers on specific topics with proposed solutions for Army experts to review. Based on that analysis, the service can then issue select invitations for vendors to execute technology demonstrations prior to down-selecting for potential contract awards.

The strategy will continue to be informed by events in Europe, which have underscored the imperative for “secure and reliable communications, multiple pathways, encryption and securing our data,” said Joseph Welch, C5ISR Center director. “It just drives home the importance of the different sets of technology that will be required when we look at the whole global scale.”

## State carry act does not apply on post

The recently passed Georgia Constitutional Carry Act does not apply to Fort Stewart-Hunter Army Airfield or any Army installation in Georgia. Per Army Regulation 190-11, the carrying of privately owned weapons and ammunition is prohibited on post unless authorized by the Senior Commander. Also, the carrying of a concealed weapon on the installation is prohibited regardless of whether a state or county permit has been obtained. # Provider Soldiers conduct port to fort operations

Soldiers with the 3rd Division Sustainment Brigade mobility section and the 258th Movement Control Team, Division Sustainment Troops Battalion, 3 DSB, conducted port to fort operations May 6-20 at the Joint Base Charleston Naval Weapons Station in Charleston, South Carolina and the Fort Stewart rail marshalling area.

The operation focused on the return of the DSTB and 414th Signal Company, DSTB equipment from the Central Command area of operations following the unit's nine-month deployment providing logistic oversight for the region.

"Currently, we're conducting port operations in support of the redeployment operations for CENTCOM AoR of moving equipment and making sure we're collaborating with 841st Transportation

Battalion to ensure efficiency, making sure we're meeting the commander's intent and building combat power," said Chief Warrant Officer Kevin Coleman, the 3rd DSB mobility officer. "The good thing about it though is it's not a difficult issue when the commander lays out the commander's intent. When it's very clear, you have the guidance and you're synchronized with working with your S3 operations and understanding operations drives logistics, it's not difficult."

To ensure the success of the mission, the DSB Mobility team began planning efforts in early April with the 841st, who conduct surface deployment and redeployment operations and water terminal operations to support and sustain the warfighter.

"In order to conduct this operation we had to make sure we had synchronization and that involves a lot of communication as far as the commander and also from the support enablers as far as 841st to ensure we're meeting the timeline so Soldiers could be able to have their equipment, be able to take ownership of their equipment and then to be ready to prepare, train and fight," said Coleman. "The way we were able to do this is we had to make sure that we continued planning efforts and

planning working groups to make sure we are all synchronized with the plan/timeline."

Another key for the operation's success was the addition of the 258th MCT to the enablers. The 258th is comprised of transportation management coordinators (88Ns) responsible for overseeing and facilitating the movement of personnel and cargo by air, sea and land.

"88N's are involved with the staging of equipment once it comes off the boat," said Staff Sgt. Destiny Crews, the noncommissioned officer in charge for the DSB mobility section. "They're involved with the assessment of all the equipment whether it's damaged or things we need to send to G8 so we can get our equipment back to the ready and our combat power back to 100 percent. 88N's are critical in just making sure that we keep full accountability of all of our stuff from port to port."

The operation gave the MCT, who's mission typically sees them supporting air operations at Hunter Army Airfield in Savannah, Georgia, an opportunity to conduct a mission outside of their normal scope.

"This is very unique for our unit specifically," said 2nd Lt. Colin Lynch, a movement officer with 258th MCT. "For a movement control team in general this may not be so unique, but for our unit specifically it's unique. We focus heavily on air operations at the ADACG (Arrival/Departure Airfield Control Group). We sprinkle in a little line haul and rail ops through the RMA and the ADACG as well, but we rarely get to do port operations however we recognize that if we're deployed then port operations will be part of our mission. So this is a unique experience but very important so that we can be prepared in an event that we deploy we may have to use a port operation."

In addition to incorporating the movement control team to oversee and coordinate the download of equipment, each unit with equipment provided a unit movement officer tasked with accounting for their unit's equipment.

"As UMO, usually I keep the company's equipment in my best interest,

maintain bumper numbers, TCNs (control number for the vehicle) and make sure this equipment is continuously in visibility so it's not forgotten that we can track it all the way back to our home station," said 1st Lt. Rucker Pierce, the UMO and executive officer for 414th. "Overall this has been a good exciting experience. It's something you can see you have a direct impact on. A lot of stuff we do is planning and now we're finally in the execution phase and you can see the impact from your planning and you can see the importance of to see the logistician side of things and have a better understanding and be well rounded as a Soldier or a leader."

Following the port operations, the equipment was moved via line haul to Fort Stewart where the unit's facilitated the download and transfer of the equipment back to their organization's motorpools.

The completed operation gave all parties involved the opportunity to plan and execute a mission that the DSB routinely conducts in support of other organizations in the division and

refine their operational plans for conducting transportation and movement operations.

"This helps us get our combat readiness back so we can get ready for exercises and other deployments, but at the end of the day it all comes down to readiness," said Crews. "The more efficient we do this, the more efficient our MCT's are for deployment and redeployment activities, the more efficient our brigade is, the more knowledgeable our UMOs are it sets the standard as the sustainment brigade because we are the standard for the division."

Marne Justice is a reoccurring report of Uniformed Code of Military Justice violations under the jurisdiction of 3rd Infantry Division, Fort Stewart and Hunter Army Airfield. This is to maintain transparency, inform the community of military justice trends and to deter future misconduct by Soldiers. The following are from Feb. 1 - March 31.

#### Justice in Action

A Cpl. was derelict in the performance of his duties and improperly maintained his equipment. The Cpl. was also found to have wrongfully used cocaine.

The Result: Criminal charges were preferred, Reduced to E1, separated from the Army with an Other than Honorable Discharge.

A Capt. got into a verbal altercation with his spouse, which turned physical when he punched her in the face in front of their children.

The Result: Received a General Officer Memorandum of Reprimand, which was placed in his permanent file.

A private strangled, kidnapped, pushed, punched, and threw an object his wife; restrained, threw an object, and pulled the hair of his girlfriend; strangled, pushed, and punched another girlfriend in the stomach while she was pregnant with his child. The offenses committed against these three women occurred over a 2 year period.

The Result: Prosecuted at a General Court Martial, convicted of 23 offenses, forfeited all pay and allowances, sentenced to 10yrs 15 days of confinement, and dishonorably discharged from the Army.

A staff sergeant openly disrespected and disobeyed the orders of his company and battalion commanders and went AWOL. The staff sergeant was also found to have unlawfully used cocaine and fentanyl.

The Result: Spent one month in Pretrial Confinement, Criminal charges were preferred, Reduced to E1, Separated from the Army, with an Other than Honorable Discharge.

A private first class laid on top of and grabbed the buttocks of a female Soldier without her consent. The Pfc. then lied to law enforcement.

The Result: Criminal charges were preferred, Reduced to E1, separated from the Army, with an Other than Honorable Discharge.

A private inappropriately touched the genitalia of and had sexual intercourse with a female Soldier without her consent.

The Result: Reduced to E1, Separated from the Army, with an Other than Honorable Discharge.

A sergeant sent sexually explicit images of his genitals to a minor and solicited child pornography from a minor.

The Result: Confined by civilian authorities pending a civilian prosecution. Reduced to E1, separated from the Army, with an Other than Honorable Discharge.

The maximum punishments for a Field Grade Article 15 include 45 days of extra duty, 60 days of restriction, the loss of ½ month of pay for up to two months, and a reduction in rank. Soldiers in the rank of E1 to E4 may be reduced multiple ranks. Soldiers in the rank of E5 or E6 may be reduced one grade. Lastly, the Officer issuing the Article 15 may elect to file a reprimand in the performance section of the Soldier's Army Military Human Resource Record (AMHRR).

What is a GOMOR?

A GOMOR, or General Officer Memorandum of Reprimand, is an administrative reprimand issued in the form of a memorandum. A GOMOR may be issued for any type of misconduct and may be issued in addition to any other punitive actions taken by the Chain of Command without creating any Double Jeopardy concerns. GOMORs may be filed in a Soldier's local file or in a Soldier's AMHRR. If placed in the Soldier's local file, the GOMOR will remain in the Soldiers file at 3ID for 18 months, or until the Soldier changes duty locations, whichever comes first. If placed in the Soldiers AMHRR, the GOMOR will remain in the Soldiers permanent, military record.

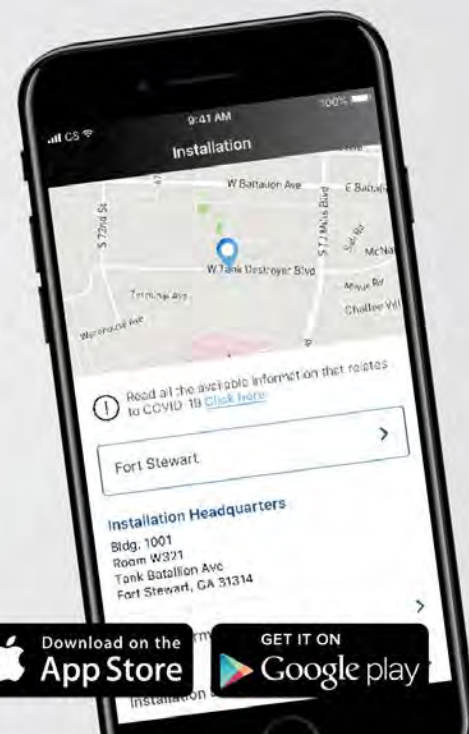

# 3rd Inf. Div. Soldier's remains

ERMINE, Ky. – Soldiers, family members and friends paid their final respects to Cpl. Donald L. Menken, a U.S. Army Korean War casualty who served in Company K, 3rd Battalion, 15th Infantry Regiment, 3rd Infantry Division, who was laid to rest on May 14 during a ceremony at Green Acres Cemetery in Ermine. At the age of 21, Menken was reported missing in action after being wounded by artillery shell fragments June 10, 1953, while guarding Outpost Harry, a position on the main road to Seoul in what is now the Demilitarized Zone in the Republic of Korea. The young Soldier was then declared killed in action June 11, 1954, and non-recoverable in 1956.

Following the Korean War, the American Graves Registration Service Group found remains in Korea that were designated as Unknown X-6039 after they could not be identified.

Unknown X-6039 was transported with other unidentified Korean War remains and buried at the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu.

In July 2018, the Defense POW/MIA Accounting Agency proposed a plan to identify the 652 Korean War unknown remains from the Punchbowl. On Jan. 28, 2019, X-6039 remains were disinterred and transferred to the DPAA Laboratory at Joint Base Pearl Harbor Hickam, Hawaii. Menken's remains were identified on Feb. 2, 2022, using dental and anthropological analysis along with some other circumstantial evidence.

"It felt like we finally got the closure we had been needing," said Fulton Combs, a nephew of Menken. "Although many years have passed, he has never left our hearts."

Soldiers assigned to the present-day 3rd Bn., 15th IR, in the 2nd Armored Brigade Combat Team, 3rd ID, at Fort Stewart, Georgia, traveled to Ermine to render honors to their fallen brother during his funeral.

"He is one of our Soldiers," said Lt. Col. Brian Montgomery, commander of the 3rd Bn., 15th IR. "It is an honor and a privilege to bring him home."

The funeral began at the First Baptist Church of Whitesburg for a eulogy before Menken's casket was transported to Green Acres Cemetery where attendees were able to pay tribute to the fallen Soldier.

"For Donny's brothers in arms to have shown up and pay their respects has been the greatest thing that could have possibly happened," Combs said. "The love that this family has been shown by the military has been something we will always appreciate."

On display at Menken's funeral was a letter written by the Korean president sent to the family in 2000 thanking them for Menken's noble sacrifice during the war.

"It was the ultimate sacrifice," Combs said. "He knew

that he could die and still chose to fight for the people and country he loves."

Although nearly 70 years have passed since his death, Combs remembers that Menken was always the apple of his mother's eye. Combs said Menken's mother never gave up hope that one day he would return home, and although she passed before he did, the family chose Green Acres Cemetery so that Menken could be laid to rest beside her.

"She never accepted Donny's death and always hoped he would come back home," said Marie Hinerman, the sister of Menken. "I know that if she were here, she would've thought this was all amazing."

During the ceremony, Soldiers currently serving in Menken's former regiment honored their fellow brother in arms with a 21-gun salute and presented the family with the folding of the American flag.

"I'm humbled to be part of this ceremony and happy to have been of service to the family," said Command Sgt. Maj. Nicholas Paske, the senior enlisted advisor for the 3rd Bn., 15th IR, 2nd ABCT, 3rd ID. "He was our brother and it's important that he is laid to rest by his brothers."

During the ceremony, as the solemn echoes of Taps filled the air, Montgomery knelt down and placed the American flag in Hinerman's hands while thanking her for her brother's sacrifice.

"They brought his remains back and now he will get to lay beside his mother," Hinerman said. "I can never thank them enough."

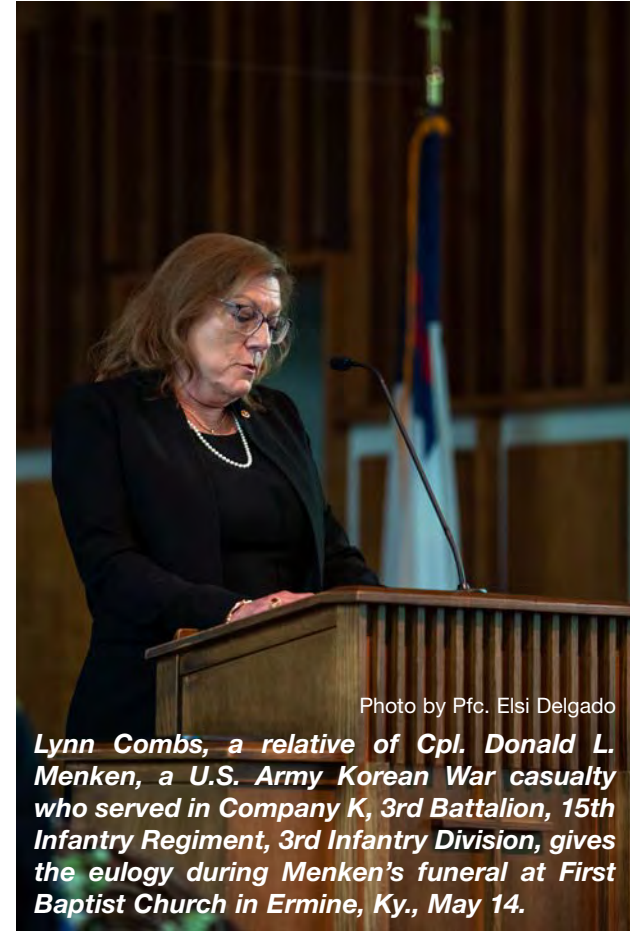

## New medical records system begins June 11

The 3rd Infantry Division will begin modernizing their healthcare records system to the new Military Health System GENESIS starting on June 11.

The MHS GENESIS has been making its way across Department of Defense installations and will replace Tricare Online in the coming months.

"MHS GENESIS is the new electronic health record for the Military Health System and the Department of Defense, and will replace our existing outpatient and inpatient electronic health and dental record systems," said Maj. Karen Long, senior aeromedical physician assistant at 3rd Combat Aviation Brigade, Hunter Army Airfield, Georgia.

The new system offers multiple upgrades that will help Soldiers and their Families receive the best care possible by offering direct communication with primary care teams and online appointment scheduling.

"A lot of functions within the MHS Genesis Patient Portal will be similar to Tricare Online, but there are a variety of improvements with the new system," explained Long. "The secure messaging piece of the Patient Portal allows for direct communication with your primary care team, as well as specialty clinics. Through the Patient Portal, you can schedule appointments, review or download clinical notes, labs results and radiology reports from any visit you've had within the MHS. There's also a health library available to look up information on medical conditions and medications."

While system modernization will benefit service members and their Families in the long run, the transition period will cause some delays. From June 11 until July 1, 2022, beneficiaries will not be able to make online appointments. Instead, 3rd Combat Aviation Soldiers should make appointments at the Falcon Clinic front desk and Family members should utilize the central appointment line.

"Appointment availability after June 11 will be affected for several weeks and appointment wait times will increase as our medics, nursing staff and providers adjust to the new system and workflows," said Long. "Everyone can help ease the

transition by ensuring their Defense Enrollment Eligibility Reporting System, DEERS, is up to date, downloading copies of referrals and vaccination records for school-aged children and taking advantage of early prescription refill services offered at Winn and Tuttle."

Soldiers and their Families are encouraged to complete school physicals and appointments before June 11. Prescriptions should be refilled through July 2022, early refills of most prescriptions have been authorized starting May 15.

"The most important thing for Soldiers and all beneficiaries to do is to ensure they can access their MHS GENESIS Patient Portal," explained Long. "This requires either a DS Login or CAC Login."

To create a DS Login and update personal contact information, visit the MilConnect website.

Despite the transition, Soldiers and their Families don't need to rush onto Tricare Online to download their information.

"You won't lose TRICARE Online access immediately," said Long. "Soldiers and beneficiaries will still be able to go into TRICARE Online and retrieve any information that's there. Once we're completely transitioned to MHS GENESIS, the old system will eventually phase out. After this, legacy patient records remain available to beneficiaries through their providers."

For Soldiers, Families and medical teams DoD-wide, the transition to a standardized system will make life transitions a smoother process.

"Our Soldiers and Families move often in comparison to our civilian counterparts, as do our providers and the medical staff," explained Long. "MHS Genesis will make for an easier transition when these moves occur. Once MHS Genesis is in use at all DoD facilities, an individual's medical documentation will happen on the same electronic health record system from in-processing at basic training to separation or retirement and beyond."

# Engineer Soldiers face fears during Guardian Response

Soldiers of the 526th Engineer Construction Company out of Fort Stewart faced one of the American people's worst fears, a nuclear explosion at home.

This is exactly what the unit faced during Guardian Response 22 at the Muscatatuck Urban Training Center, Indiana. The multicomponent homeland emergency exercise boosts capabilities, hones skills at urban search and rescue, and improves readiness of the Army units assigned to the Department of Defense's Chemical, Biological, Radiological and Nuclear Response Enterprise (DCRF).

"Allowing all of us to work together and share what's in our tool kits allows us to all work together on the same page and understand the assets the military offers," said Lee Given, an observer, controller and trainer. "This allows us to understand how things work and operate as a whole whether you're wearing green or local firefighters."

The engineers company was one of 15 units that joined to face the exercise that simulated nuclear explosion within a major city in Pennsylvania. In the scenario, millions of lives were lost in the initial blast, thousands were injured and many more are missing or trapped in collapsed buildings and transportation hubs.

Wearing full body, protective chemical suits made of thick plastic, the Soldiers rotated through the various scenes to breach obstacles of wood and concrete to reach and retrieve the injured. The work is tedious and physically strenuous.

"They are on a 45 minute, 15 minute work and rest cycle," said Sgt. 1st Class Daniel Gibson, operations sergeant for the 526 ECC. "The temperature outside is 60 degrees but closer to 101 degrees inside their suits. It's tough work."

Battling against time to save lives, the Soldiers worked through long hours of hauling equipment to their needed locations and employing them. Chain saws, steel pry bars, blocks of wood, generators, and hydraulic spreaders commonly called jaws of life were among the equipment used throughout the mission.

"It's pretty tough," Gibbons said. "They are constantly hydrating and resting so

they're performance is outstanding. We can't rescue if we are hurting ourselves."

The exercise has had the engineers and other units working around the clock for six days to evaluate their performance to successfully meet their mission requirements. Each step of the way is overseen by the observer, controller, trainers and senior U.S. Army North leaders.

Maj. Gen. Jeffrey Van, the commanding general of the Joint Task Force-Civil Command that oversees DCRF, said the exercise ensures the next units assigned to the no notice response force are prepared to respond as needed to any kind of chemical, biological, radiological or nuclear attack on U.S. soil.

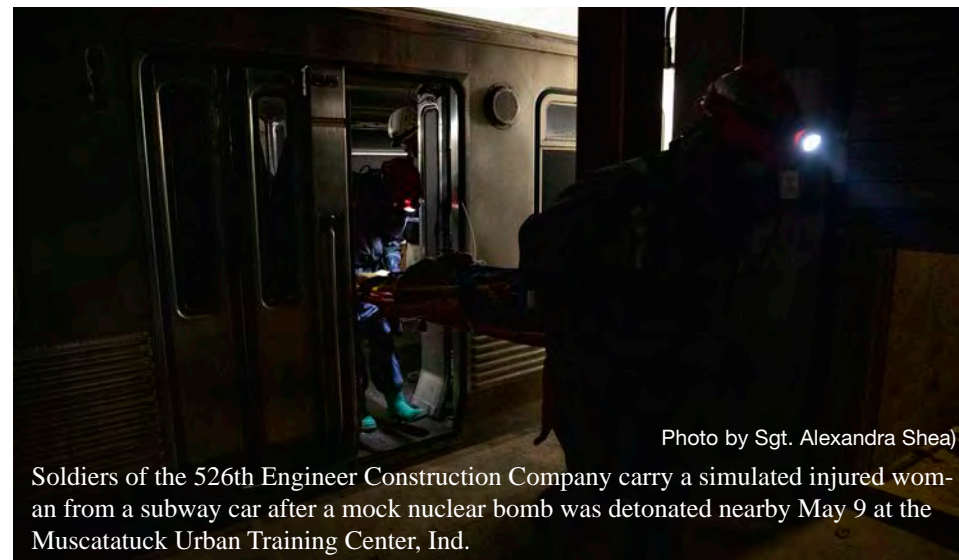

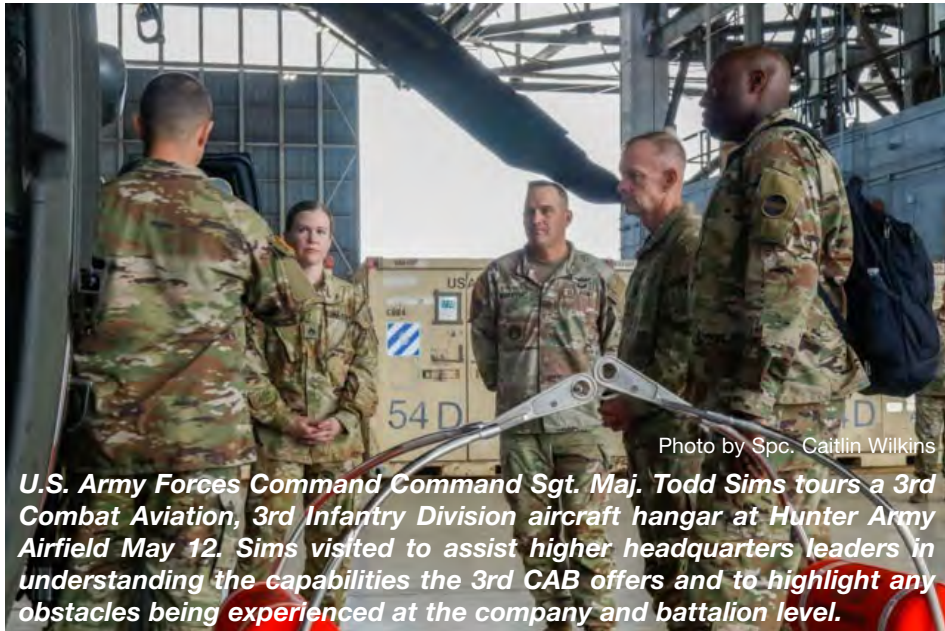
