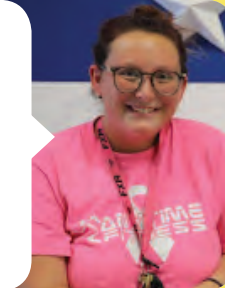

Inspector General NCO of the year

U.S. Army Sgt. 1st Class Andrew Sholtz, a noncommissioned officer in the Office of the Division Inspector General assigned to the 3rd Infantry Division, Fort Stewart, Georgia, earned the title of Department of the Army Inspector General Noncommissioned Officer of the Year, which was announced April 20.

Throughout the Army, NCOs compete amongst themselves to determine who is the best in their particular field and this competition determined exactly that for Inspector General NCOs.

“We submitted three letters of recommendation and a memo for Sholtz,” said Joel Smith, the deputy command IG for 3rd ID. “Sholtz displayed all the qualities of an outstanding IG NCO.”

In the competition for Inspector General NCO of the year, nominees from across the Army competed in the Department of the Army-level competition in Washington, D.C.

“Sholtz has constantly demonstrated the complete dedication and overall excellence needed as the IG NCO of the year,” Smith said.

After a challenging board competition, Sholtz was named the winner. He had the honor of receiving his award at the Hall of Heroes inside the Pentagon.

“It’s a huge accomplishment for me,” said Sholtz. “The IG of the year NCO title is the first time in my career that I have been acknowledged as the best of something across the entire Army enterprise.”

Winning this award is a long way from where Sholtz began his Army career. Before joining the Army, he worked in retail making less than the minimum wage.

“I woke up one day realizing that I was tired of living from paycheck to paycheck,” said Sholtz. “I felt the need for something bigger than myself and the Army was that for me.”

Soon after, Sholtz joined the Army to be a cannon crewmember within the artillery field.

In this job, Sholtz served a vital role helping his fellow Soldiers by providing timely and accurate fires that supported warfighters on the front lines. After years of hard work, Sholtz was handpicked by leadership within the field artillery branch to become an inspector general NCO.

The Office of the Inspector General provides Soldiers with impartial and unbiased advice and with oversight through relevant and timely inspections, investigations and training to promote stewardship, accountability, integrity, efficiency, good order & discipline to enhance total Army readiness.

These Soldiers serve in a position of trust, bound by the Army regulations and the information gathered is confidential. Confidentiality allows Soldiers and leaders to feel comfortable in contacting the Office of the Inspector General without risk of judgment or reprisal.

Since beginning this new career path, Sholtz has handled cases relating to injuries, death, sexual harassment complaints and other forms of misconduct.

“I love my job because it is one of the most impactful roles I’ve had in the Army,” Sholtz said. “I have the ability to change someone’s life for the better.”

During his time in the military, Scholtz was also able to acquire a bachelor’s degree in homeland security, an associate degree in counterterrorism and is currently working on his master’s degree in business administration. As a husband and a father, Sholtz has always kept his family close to help with the daily stresses he faces.

“My wife has always done an amazing job of taking care of things at home so I can focus on what I’m doing at work,” Sholtz said. “They have definitely been a driving factor in who I am as an NCO and a leader.”

Sholtz is scheduled to move to Oklahoma where he hopes to serve as a first sergeant. After his time in the Army ends, he plans to work as an IG Department of the Army civilian, where the experience he has gained as Inspector General NCO of the year will likely be invaluable.

“He’s a dedicated Soldier, a quality individual, great husband and father,” said Smith. “I’m sure when and wherever he goes, he will do an outstanding job for the United States Army.”

Trusted Traveler reinstated

Trusted Traveler resumed today at Fort Stewart and Hunter Army Airfield. Trusted Traveler allows all DOD ID card holders to vouch for all occupants in their vehicle. The DOD ID card holder must be the driver unless observed medical conditions prevents vehicle operation. Trusted Traveler hours are 6 a.m. to 9 p.m. daily, Monday through Sunday at all gates. After 9 p.m. all occupants of the vehicle will be subject to 100% ID card check at open gates except Rio gate at Hunter. After 9 p.m. use Montgomery Gate at Hunter. Contractors and AIE card holders are not authorized Trusted Traveler. Visitor Control Center hours remain 6 a.m. to 6 p.m. at Stewart and Hunter.

State carry act does not apply on post

The recently passed Georgia Constitutional Carry Act does not apply to Fort Stewart-Hunter Army Airfield or any Army installation in Georgia. Per Army Regulation 190-11, the carrying of privately owned weapons and ammunition is prohibited on post unless authorized by the Senior Commander. Also, the carrying of a concealed weapon on the installation is prohibited regardless of whether a state or county permit has been obtained. 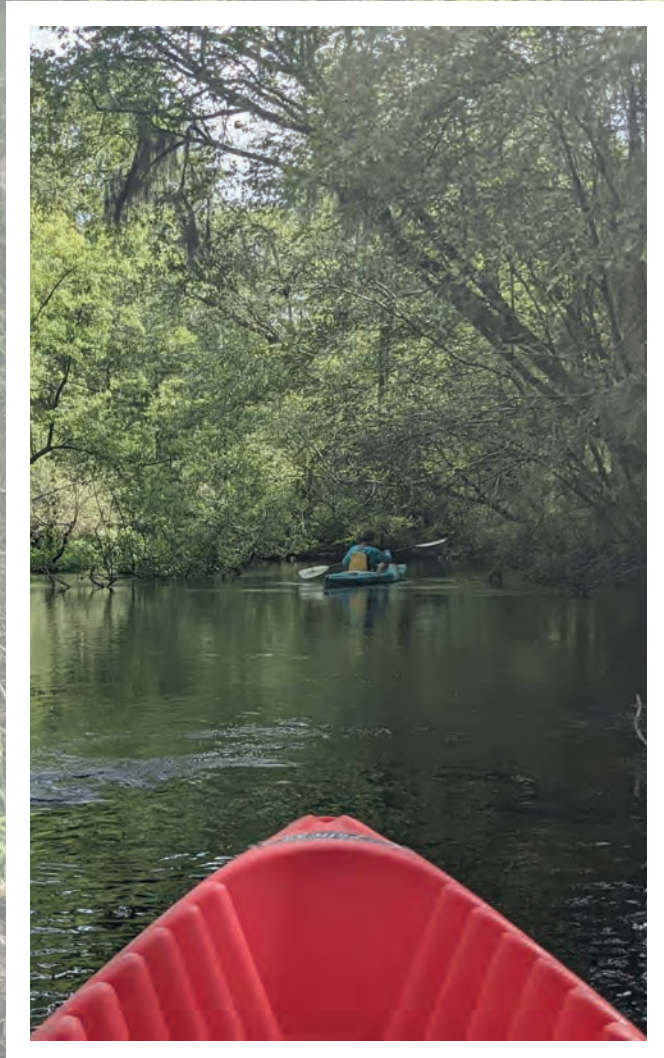

Explosive ordnance disposal NCOs lead from front for 80 years

U.S. Army Explosive Ordnance Disposal noncommissioned officers have defeated dangerous explosive devices and molded EOD teams since the Army EOD profession began more than 80 years ago at the Bomb Disposal School on Aberdeen Proving Ground, Maryland.

The U.S. Army began training the first enlisted Bomb Disposal Soldiers, the predecessors to today's EOD technicians, in April 1942 following the establishment of the British Bomb Squad to defeat time-delayed bombs dropped during World War II.

Aberdeen Proving Ground, Maryland, is the former home to the U.S. Army Ordnance Corps, which moved to Fort Lee, Virginia, in 2008. Today, it is the home base for the 20th Chemical, Biological, Radiological, Nuclear, Explosives (CBRNE) Command, the U.S. Department of Defense's premier all hazards formation.

The 20th CBRNE Command is home to 75 percent of the Active Duty U.S. Army's EOD technicians and Chemical, Biological, Radiological, Nuclear specialists, as well as the 1st Area Medical Laboratory, CBRNE Analytical and Remediation Activity, five Weapons of Mass Destruction Coordination Teams and three Nuclear Disablement Teams.

Soldiers and civilians from 20th CBRNE Command deploy from 19 bases in 16 states to confront and defeat the world's most dangerous hazards and threats in support of joint, interagency and allied operations.

Army EOD noncommissioned officers ensure EOD technicians are ready to safeguard U.S. forces and enable military operations around the world.

According to 1st Sgt. Roger D. Rich, the senior enlisted leader of the 18th Ordnance Company (EOD), Explosive Ordnance Disposal Soldiers have to be ready to respond at any minute to a wide variety of missions, from Immediate Response Force deployments to supporting the Defense POW/MIA Accounting Agency's efforts to locate prisoner of war and missing in action service members from past conflicts in explosive-ridden areas.

"What makes the U.S. Army EOD technician special is our ability to develop creative solutions to complex problems and accomplish the mission regardless of the situation," said Rich, a Madison, North Carolina, native and Master EOD technician who has deployed to Iraq and Afghanistan. "Although the EOD community often finds itself confronted with a multitude of obstacles, in garrison and while deployed, we are able to band together and help one another achieve success."

"The 18th Ordnance Company (EOD) is unique because of the culture that we have," said Rich. "Every Soldier has a voice and their opinion matters. Everyone is involved in every aspect of what the company does."

A former combat engineer, Rich saw firsthand the importance of strong NCO leadership to keep Soldiers ready for the crucible of combat. He decided to

become an Army EOD technician after serving on route clearance missions.

The 18th EOD Company recently returned home to Fort Bragg, North Carolina, after serving as the sole Explosive Ordnance Disposal company in Iraq for six months in support of Special Operations Joint Task Force-Levant.

The company completed hundreds of missions in Iraq focused on partner force development while also supporting Special Operations Forces and defeating a wide variety of different explosives. They also confronted enemy fixed wing and rotary wing Unmanned Aerial Systems designed to target U.S. and coalition forces during the deployment.

The 18th EOD Company "Voodoo" is part of the 192nd EOD Battalion, 52nd EOD Group and 20th CBRNE Command.

EOD forces have rendered safe over 100,000 improvised explosive devices in Iraq and Afghanistan since 2006 and they have also trained thousands of host nation forces.

Command Sgt. Maj. Benjamin O. Brinkmeyer served at Forward Operating Base Danger in Iraq from 2004 – 2005. A former National Guardsman who went on Active Duty in 2001, Brinkmeyer had served as an infantry Soldier and construction equipment repairer. He was ready to leave the Army during his Iraq deployment before a 55mm rocket nosed in right next

to his front door. His platoon sergeant asked him to get EOD technicians to take care of it.

"I didn't even know who they were. When I knocked on the front door, their first sergeant answered it," said Brinkmeyer, a native of Hubbard, Iowa. "He was hard on me and made me question everything I thought that video games and movies had taught me. He made me fill sand bags and knock on every door and clear the area. After he destroyed the rocket, he asked me if I wanted to do the job."

The EOD first sergeant invited Brinkmeyer to stop by the following day. He walked Brinkmeyer through their quarters and introduced him to their mission.

"I don't think I was what he was looking for or maybe he was just planting a seed," said Brinkmeyer. "He told me I couldn't do (on the job EOD training) and that I probably wasn't smart enough to do it anyway. I left there confused and angry."

Later during the deployment, when his reenlistment window opened, Brinkmeyer knew exactly what he wanted.

Today, 17 years later, Brinkmeyer is a Master EOD Technician and the senior enlisted leader for the Fort Bragg, North Carolina-based 192nd Ordnance Disposal Battalion (EOD) "Renegades."

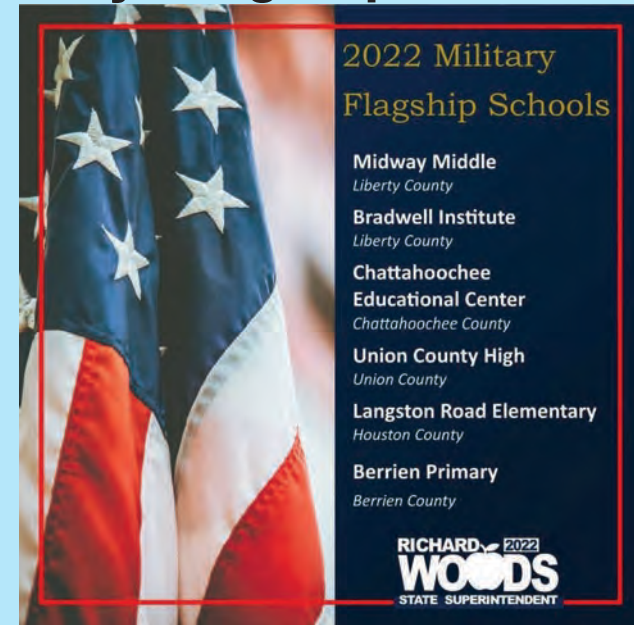

New students at both schools are partnered with Student Ambassadors who are trained through a joint venture with Fort Stewart's School Liaison. These ambassadors provide tours and introduce teachers to help new-

comers acclimate to their new school culture. Both schools also have Military Family Life Counselors (MFLC) who help with school adjustment, behavioral and emotional concerns, deployment adjustments, and communication.

Additionally, the district level Military Coordinator and School Social Workers assist families with unusual circumstances or more complex needs.

"Military students and families are an integral part of our school district and it is our mission to reach every student," stated Dr. Franklin Perry, Superintendent of Liberty County Schools. "The addition of these two schools brings our total to four Military Flagship schools out of only 19 total Flagship schools named in the state of Georgia. We are very proud of these newly named schools and everything they do to help their military students and families." Both schools will receive a special visit from Georgia State School Superintendent, Richard Woods, along with other officials and will receive a banner to display in their school advertising their status as Military Flagship Schools.

The 192nd EOD Battalion commands seven high demand Army EOD companies, including the Fort Bragg, North Carolina-based 28th EOD Company that supports Special Forces missions and the 18th, 722nd and 767th EOD companies that deploy for airborne Immediate Response Force missions, as well as the Fort Belvoir, Virginia-based 55th EOD Company that supports domestic response missions and the Fort Drum, New York-based 754th and 760th EOD companies that support military operations and civil authorities.

He credits his success to many retired Army EOD NCOs who helped him develop into the leader and technician he is today, including 1st Sgt. Mike Cassin, Master Sgt. Garrick Hipskin, Sgt. 1st Class Brad Borgelt, Sgt. 1st Class Mark Palmer and Sgt. 1st Class Tony Gant.

Brinkmeyer recalls his first response to an improvised explosive device and working through defeating it with his team leader, Sgt. 1st Class Josh Kurk.

"At that moment I realized, you either gave them enough or you didn't," said Brinkmeyer. "For me that moment was prolific and is something I still think about regularly."

Brinkmeyer said EOD technicians have to think critically to solve complex and dangerous problems when defeating explosive devices.

"EOD technicians aren't special ... not any more than any other Soldier serving in uniform. But what does separate them is their ability to critically think and apply a cognitive thought process to tackle complex problems for a wide array of issues," said Brinkmeyer.

"Soldiers who volunteer for EOD don't do it for the

glory, the title or the bragging rights. They do it to protect others and keep people safe," said Brinkmeyer. "There isn't a technician currently serving or from the past that doesn't have a lingering nightmare or afterthought of, 'if I don't know everything or do things correctly, the death of others will be from a decision I made.' That alone drives them to become aggressive and question everything."

Command Sgt. Maj. Dave Silva became an Army EOD technician after serving as a cannon crewmember on Fort Bragg, North Carolina.

He said he was drawn to the uniqueness of the mission.

"Once I spent some time with the unit, it became clear this is who I want to work beside," said Silva. "They were incredibly intelligent when it came to ordnance and explosives and still maintained a very relaxed and fun environment that anyone would want to be a part of."

Today, Silva is the command sergeant major for the 71st Ordnance Group (EOD), the group that commands all EOD Soldiers west of the Mississippi River. The Fort Carson, Colorado-based EOD group commands three EOD battalions and 18 EOD companies on 11 military installations.

Silva said NCO leadership is critical to the success of EOD operations around the world.

"A tremendous amount of trust must be earned to be an NCO in this career field," said Silva. "In EOD, the team leader is a staff sergeant. The team leader is the hub in which the entirety of the EOD community revolves around and supports. These NCOs are empowered to make critical decisions, while their team operates autonomously, in very austere environments. The EOD center of gravity is the team, led by the team leader."

Silva said it is not unusual for a staff sergeant and a specialist to operate in a foreign country, advising a partner nation, without any additional supervision.

The Master EOD technician said every EOD technician on a team determines how to tackle different explosives.

"On an EOD team, every voice has equal value," said Silva, who has deployed seven times and served in both Iraq and Afghanistan. "A team member who graduated yesterday will question a Master Badge team leader with years of experience and that is welcomed. Our teams have one chance to get it right, there are no redos when it comes to unexploded ordnance and improvised explosive devices."

With the EOD motto of "initial success or total failure," Silva said the trust and camaraderie in Army EOD teams extends to joint, interagency and allied EOD teams.

Silva said the EOD community has given him the opportunity to defeat explosive hazards, travel the world and protect the nation's senior most leaders.

"Twenty-five years of EOD later, I'm having as much fun as I've ever had and feel even more strongly that this is the family in which I belong," said Silva, a native of Long Beach, California. "I've seen all 50 states, five of seven continents, the absolute best and worst of dozens of countries, spent Christmas at the White House, protected the Pope as well as presidents, and fast roped onto the USS Abraham Lincoln in the Persian Gulf."

"I've had so many incredible experiences but the highlight of my career isn't the experiences, it's the relationships, it's the people, it's the EOD family that I'll take with me long after the experiences end," said Silva.

MARNE AIR, SUSTAINERS HEAT UP SKIES

Soldiers assigned to the 258th Movement Control Team, Division Sustainment Troops Battalion, 3rd Division Sustainment Brigade, 3rd Infantry Division, provided support to the 3rd Combat Aviation Brigade, 3rd ID, during an Emergency Deployment Readiness Exercise April 25-27, 2022, at Hunter Army Airfield, Savannah, Georgia.

“The 258th MCT personnel will be helping perform inspections of vehicles and containers in addition to ensuring that documentation is properly prepared,” said 2nd Lt. Colin Lynch, the movement control officer of 258th MCT. “This will ensure that 3rd CAB is prepared for their movement to Camp Atterbury and future deployments.”

The training helps keep Soldiers on their toes by training hands-on and preparing for the possibility of any upcoming missions.

“Operations such as these help keep our Soldiers trained on 88N (transportation management coordinator) skills involved in unit movement in a real world setting,” said Lynch. “Our counterpart unit is working diligently over in Europe and their success with their mission is helping us back here in the States with ours.”

The training ties into the 258th MCT’s mission with day-to-day operations and missions conducted overseas.

“The upcoming port ops will provide the Soldiers an opportunity to expand their knowledge base beyond just A/DACG (Arrival/Departure Airfield Control Group) and RMA (Rail Marshalling Area) operations, on which we typically focus,” said Staff Sgt. Robert Woolsey, a transportation management coordinator assigned to the 258th MCT. “The EDRE is providing us with the chance to refine and refresh our skills before we take part in the port operations.”

This type of training not only provides Soldiers with additional skills, but gives the Soldiers a chance to work with other units in supporting their missions.

“The opportunity to support the EDRE is important because it not only allows us to train our Soldiers, but it allows us to provide Division level support,” said Woolsey. “Working with 3CAB allows us to help them be prepared for any future movements while providing A/DACG civilians and 258MCT Soldiers practice for line-haul operations for any unit in the future.”

By supporting the EDRE training now, Soldiers will be better prepared to support future missions.

“The mission provides Soldiers the opportunity to learn and refine their skills for use here at 258MCT and to bring to their future units,” said Lynch. “We expect them to utilize this opportunity as much as they can and use their leaning experiences to teach other Soldiers in the unit. We also expect them to take charge and help ensure that 3CAB and any outside unit is always properly prepared for movement.”

Some Soldiers previously participated in 258th MCT’s EDRE or line-haul operations, but for others it will be their first experience.

“This is my first time doing this operation,” said Pfc. Jonathan Presley, a transportation management coordinator assigned to the 258th MCT. “After this training I expect to proficiently learn how to categorize equipment as it comes into the yard.”

In order to prepare for the training, the Soldiers used the skills gained from 1st Armored Brigade Combat Team, 3rd Infantry Division’s deployment, taught classes to the 3rd CAB on various movement skills, assigned roles to each Soldier and conducted walkthroughs with the A/DACG civilians in order to ensure success.

“We also plan to perform AAR’s (After Action Review) at the end of each day of the operation to ensure that any improvements can be implemented going forward,” said Lynch. “We have verified Soldiers have all the necessary skills to help 3CAB as necessary throughout the operation. Additionally, there is a pride in helping units support real world missions. The Soldiers also take pride in being able to help units across the entire Division.”

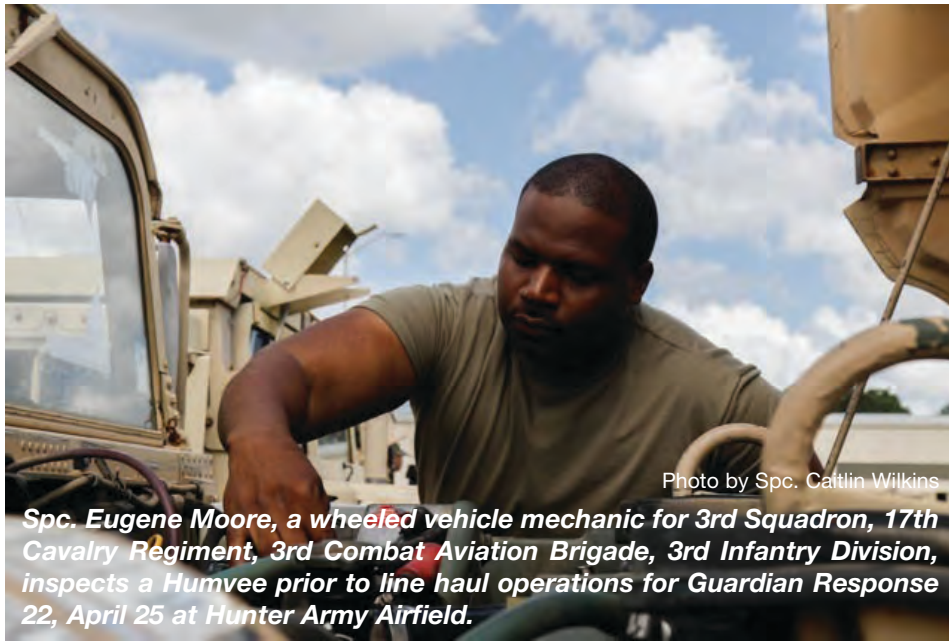

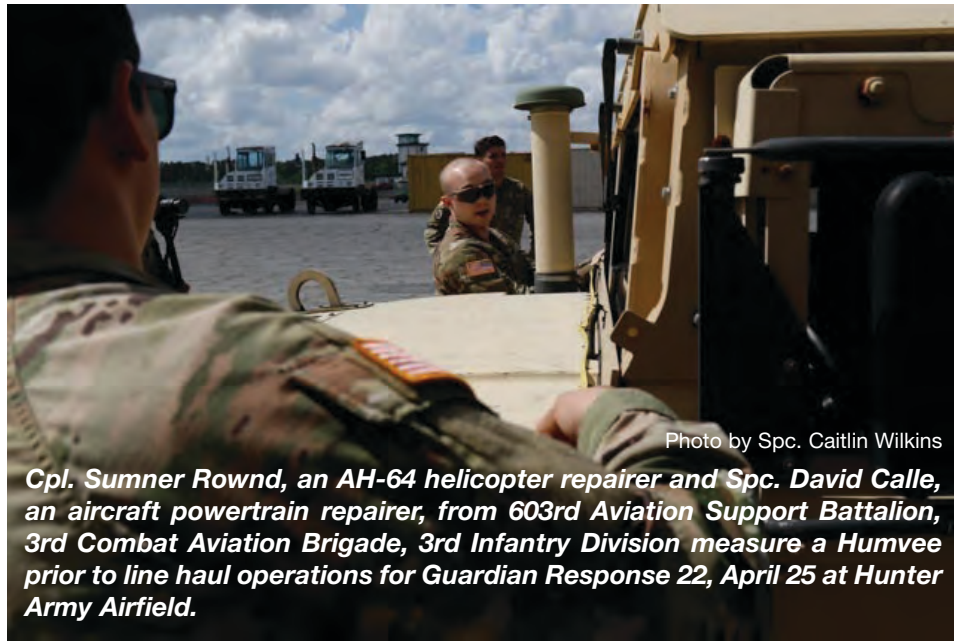

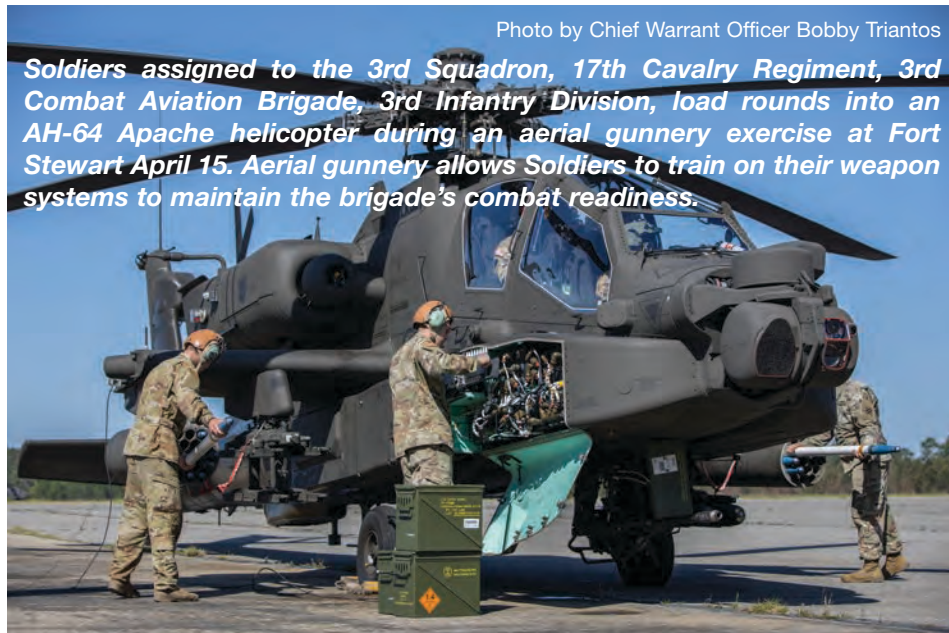

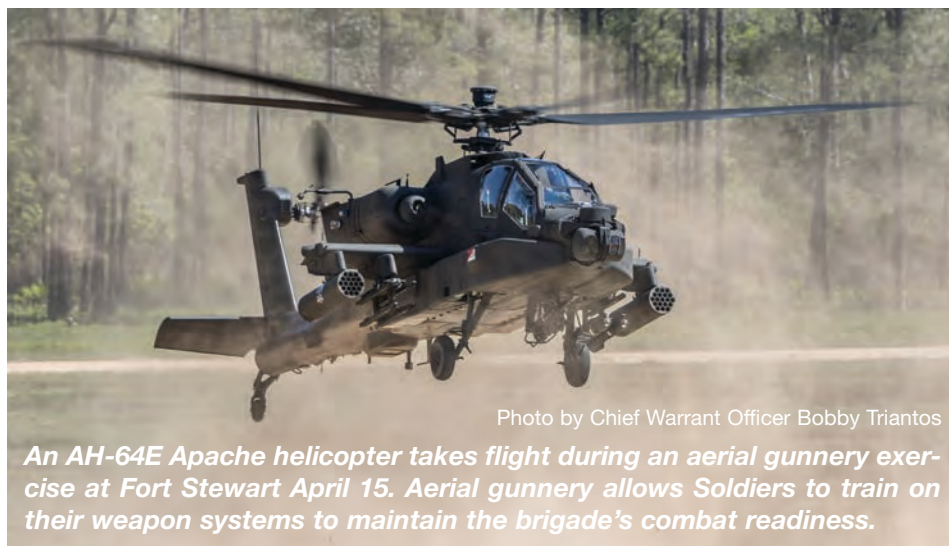

PCS season approaches, prepare now

Soldiers, civilians, and their Families preparing for a permanent change of station (PCS) move during June, July and August (potentially into September) should anticipate unexpected delays in scheduling of their household goods move. Soldiers, civilians, and their Families should not move or store their household goods prior to receiving PCS orders. Soldiers and civilians need to contact the local transportation office as soon as orders are received and keep their Chain of Command informed on progress or challenges. Upon receipt of PCS orders, any delay in contacting the local transportation office (e.g. waiting 30 days or less for a desired pickup date) may result in non-availability of DoD moving companies.

Fallout from the COVID-19 pandemic has led to DoD moving companies experiencing continued labor constraints, port congestions, shortage of warehouses, trucks, equipment and supplies as well as increases in material costs. These shortfalls will continue to limit industry capacity, increase missed required delivery dates (RDD) and extend lead times for shipment pickups and deliveries up to 4 to 6 weeks during the summer peak season.

As of March 15, 2022, Human Resources Command (HRC) provided the total number of Soldiers (36,984) with 2022 PCS orders that have report dates during the 2022 summer peak moving season months of June, July, and August. In comparison to 2021, this is an increase of 2,897 more

PCS orders issued with report dates during the 2022 summer peak moving season months of June, July, and August. Unless industry labor availability improves significantly, the 2022 summer peak season will be even more challenging than 2021 for the movement of household good shipments.

Army Senior Leaders are aware of these challenges and actively exploring mitigation actions for Soldier, civilian, and their Family relocation issues. Headquarters Department of Army G4 recently published a Household Goods Quality of Life (QOL) link on the HQDA G4 News page with great resources and information.

Some advice from the Fort Detrick Logistics Readiness Center Personal Property Team includes:

P - Plan your move. Pay attention to the Personal Property Team during levy briefings, ask questions, take notes. Know your maximum Household Goods weight allowance and what items you are authorized to ship. Decide what to ship, store, and or donate or recycle.

C - Coordinate your move. Immediately upon receipt of orders, log in to <https://www.military-onesource.mil/moving-housing/moving/pcs>, input your information, and select shipping dates.

S - Stay flexible regarding selected dates and remain in contact with your Transportation Service Provider (Moving Company). The goal is to assist you in making a successful move but you must take an active part in the process. Relocating can be stressful but early coordination and planning can reduce the stress and help you to stay on schedule.

Ryncarz said the healthcare providers and staff supporting the Fort Stewart–Hunter Army Airfield community started in training in February and will continue through time MHS GENESIS goes active – June 11, 2022.

“In order to accomplish our mission to implement a new electronic health record, we have worked with the Defense Health Agency (DHA) and MHS Genesis team,” Ryncarz said. “This transition team encompasses over 10 different organizations from the private and public sector, they have all come together to help us improve our healthcare delivery system.”

MHS GENESIS will standardize records keeping across the DoD and military services. It will benefit beneficiaries and medical personnel too.

Ryncarz said MHS GENESIS will be a continuous medical record for beneficiaries as they transition between duty stations, manage prescriptions, and offer a communication portal between staff and patients.

If you have a current TRICARE Online account, it will automatically migrate to MHS GENESIS on June 11.

One of the highlights of the new records system is the MHS GENESIS Patient Portal; which provides a secure website available 24/7; which gives you access to:

- View health information
- Schedule appointments
- Communicate securely with providers
- Request prescription refills

There will be a brief overlap between the MHS GENESIS Patient Portal and the TRICARE Patient portal that may impact beneficiaries; where online appointments, referrals and online prescription refills come online.

Beneficiaries can help ease the transition by ensuring their DEERs system is up to date, downloading paper copies of referrals and taking advantage of early prescription refill services, utilizing ScriptCenter, <https://winn.tricare.mil/Health-Services/Pharmacy>; and Express Scripts, <https://militaryrx.express-scripts.com>.

Maj. Raquel L. Giunta, Winn's pharmacy chief said the transition may cause additional delays in the pharmacy wait times of up to two to three hours.

“To reduce the wait time for prescription refill pick up during this transition, the pharmacy will offer early refill processing for all non-controlled prescriptions,” Giunta said. “If you have a prescription refill that is due to be filled from now through July 15, we encourage you to call your refill in prior to June 11 to one of our refill pharmacy pick up sites at the Post Exchange, the Main Outpatient Pharmacy, Script Center, or the pharmacies at Tuttle and Richmond Hill Medical Home – if you are enrolled as a patient there.”

When MHS GENESIS goes live across the Department of Defense in 2023, it is expected to support the availability of electronic health records for more than 9.6 million beneficiaries and over 200,000 MHS personnel globally.

WINN BRIEFS

On June 11, Winn Army Community Hospital and our outlying Pharmacies will transition to a new electronic health record system --- known as MHS GENESIS. The transition is expected to cause delays in the pharmacy wait times up to 2-3 hours. To reduce the impact, Winn ACH authorizes early refills for non-controlled prescriptions between May 13 and July 15. We strongly encourage you to call your refill prior to June 11. You can use the refill pharmacy pick-up sites at the PX, the Main

Outpatient Pharmacy, Script Center, or the pharmacies at Tuttle or the Richmond Hill

Medical Home -- If enrolled as a patient there. Other ways to reduce the impact of the transition are to ensure your DEERS information is up to date; download paper copies of referrals; and take advantage of prescription refill services like ScriptCenter, <https://winn.tricare.mil/Health-Services/Pharmacy>; and Express Scripts, <https://militaryrx.express-scripts.com>.

Spiritual and Physical Fitness are paired in a life of a Soldier

Picture yourself as a bird with an injured wing. You cannot fly because you lost your sense of balance. Apply this same image to your military life in context. We can see how we can correlate the two together, which I will explain in detail. Looking at the importance of physical and spiritual fitness in the life of a Soldier, they need to keep their balance between physical and spiritual fitness in order to successfully and effectively accomplish a mission. In other words, every Soldier must be fueled by physical and spiritual energy.

In the military, there is common acceptance for physical fitness. Every Soldier knows this if they want to be successful on their APFT/ACFT; if the Soldier is not in shape, he or she will definitely not be a success. Therefore, to avoid failure, Soldiers push themselves to “the limits” to improve on pushups, sit-ups, and running time during an early morning PRT. What is more, some of them go on special diets or use supplements to boost their body. The goal is to build up strength and perseverance.

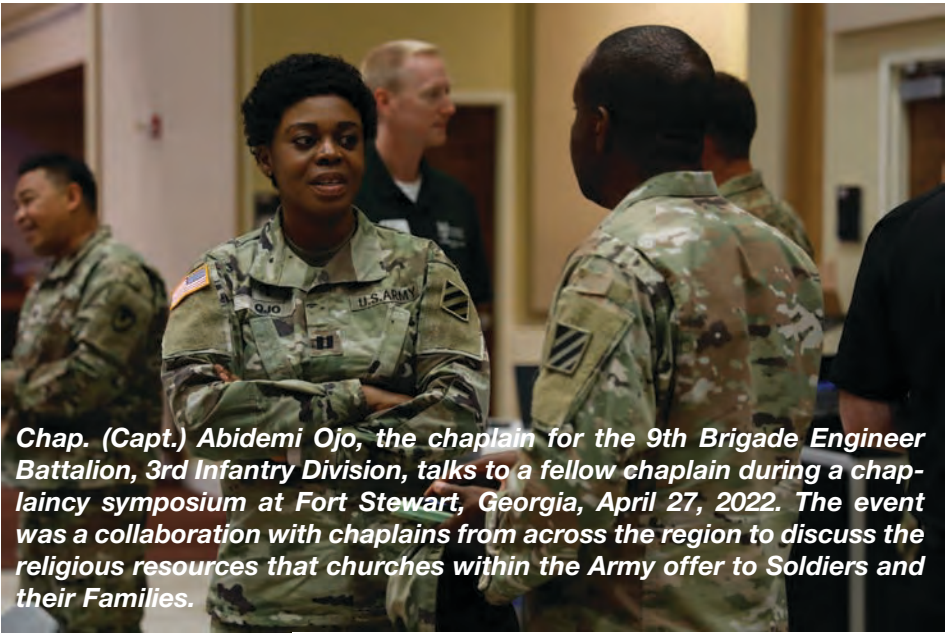
Preparation for physical fitness sounds obvious and intuitive: the better shape you are, the better results. However, sometimes we forget the significance of spiritual fitness. Soldiers may wonder how spiritual fitness may be beneficial for them and how it may contribute to their well-being and improve their performance. Some deny, directly or indirectly, the purpose of talking about spirituality in the Military settings. Some may have their own arguments supporting their own opinions but it is not the goal of this short article to address it. Let us rather stick to the statement that spiritual fitness has a strong positive mental and physical addition to quality of life. Let us define what spiritual fitness is and why practicing it is important in a life of every Service Member.

According to the U.S. Army Medical Department Spirituality is often “defined as a sense of connection that gives meaning and purpose to a person’s life. Spirituality is unique to each individual, and refers to the deepest part of you. Your spirit provides you with the revealing sense of who you are, why you are here and what your purpose for living is. It is that innermost part of you that allows you to gain strength and hope”.

State Required Monitoring Frequencies

Only EPA approved laboratory methods are used to analyze your drinking water. Our personnel take water samples from numerous locations throughout the distribution system and residential taps; samples are then delivered to an accredited laboratory where water quality analyses are performed. At a minimum, samples are analyzed as follows:

The Georgia Environmental Protection Division (EPD) issued Fort Stewart/Hunter Army Airfield an SDG monitoring waiver until Q4 2022 because EPD studies have shown that the drinking water is not vulnerable to contamination from SDG as other installations.

Conserving our Water Supply

Everyday throughout the world, nations are facing water problems in terms of both quantity and quality. According to a report from the Organisation for Economic Co-Operation and Development, by 2050 water demands are expected to increase by 400 percent from manufacturing and by 130 percent from household use (from a baseline year of 2012). Although 75 percent of the earth is covered by water, only 1 percent is available as renewable fresh water, and only about one-third of all precipitation that falls on the land goes back to the oceans by rivers and runoff. We are a nation whose water needs are rapidly rising while available supplies are shrinking, regional water crises are becoming increasingly frequent as water tables are falling and stream flow is decreasing. We can no longer take our drinking water for granted. This means that individuals, municipalities, industries, and governments must be proactive in conserving and protecting our water supplies. The consequences of recurring long duration droughts are far-reaching, affecting wildlife, vegetation, and humans. Additionally, drought impacts on society are often exacerbated by the demand that people place on the water supply. Water is one of the most precious commodities we have on this planet; we ought not to treat it as if it were an unlimited resource. By shifting our priorities for water usage, we can prevent water scarcity. The well has run dry in many places—let's not make our community next!

Health Effects of Lead in Water



If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Water Systems are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. 2021 Water Quality Report

Where does my water come from?
Fort Stewart's main water supply comes from six municipal groundwater wells that are no less than 500 feet deep, while Hunter Army Airfield residents are serviced by two 500-foot deep wells and one 1,100-foot deep well. Groundwater is stored in permeable rock layers called aquifers, which are like underground lakes. Our groundwater is supplied by the Floridan Aquifer. Before the water is delivered, the water is chlorinated to kill disease-causing organisms and fluorinated to promote dental health.

Our water is SAFE to drink; however, some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as those with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care provider. Protecting your Water Source



The Electricals of Public Works (DPW) is pleased to present Fort Stewart and Hunter Army Airfield's Annual Water Quality Report (Water System Identification CG1790024 and CG0510107, respectively). Our water is SAFE to drink! This report provides you with a detailed account of all water monitoring and testing results gathered in 2021 confirming the

Installation's good water quality. As always, we've met our goal to provide our patrons with safe and dependable drinking water. Additional copies of this report are available at the Installation's Environmental Office: Fort Stewart Building 1137 and Hunter Army Airfield Building 615.

The sources of drinking water (both tap and bottled) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the land or through the ground, it can dissolve naturally-occurring minerals. Therefore, water can pick up substances as by-products from both the presence of animals and human activities. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial and domestic wastewater discharges, oil and gas production, or mining and farming activities.
- Pesticides or herbicides, which may come from a variety of sources such as agriculture, urban runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals (VOCs), which are by-products of industrial processes and petroleum production, and they can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be either naturally-occurring or the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which provide the same public health protection. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk.
