**GENERAL ORDER NUMBER 1 (GO-1)**

**TITLE:** Prevention of COVID within the Authority of the Commander, 3d Infantry Division.

**PURPOSE.** Due to the elevated risk of the Delta variant and the continued Coronavirus Disease-2019 (COVID-19) risk to unit readiness and the welfare of our community, prevention and mitigation measures continue to be necessary to reduce the transmission of the disease. In continued alignment with CDC, federal, state, and local health protection guidelines, the following adjustments to GO1 remains in effect in order to maintain the health and safety of our community and ensure the readiness of the force.

**AUTHORITY.** 10 United States Code Chapter 47 (Uniform Code of Military Justice); HQDA General Order 10-81, Court-Martial Convening Authority, 01 May 1981.

**APPLICABILITY.** This General Order applies to all Servicemembers (SMs) who are assigned, attached, or performing duties at Fort Stewart (FSGA) or Hunter Army Airfield (HAAF). Paragraph 1 applies to all individuals who enter FSGA/HAAF.

**PUNITIVE ORDER.** Paragraphs 1 and 2 are punitive. This order remains in effect while Soldiers are off-duty, on leave, or on pass. Violations may be punished under the UCMJ.

**1. WEAR OF MASKS.**

a. All individuals, regardless of vaccination status, must wear face coverings/masks when inside any on-post facility at FSGA or HAAF.

b. All SMs, regardless of vaccination status, must wear face coverings/masks when inside off-post public buildings/facilities (e.g., barber shops, religious services, grocery stores).

c. Unvaccinated individuals at FSGA or HAAF must also wear a mask in outdoor public spaces in accordance with DoD and 3ID guidance. Service members and Civilian employees who misrepresent their vaccination status may be subject to appropriate adverse administrative or punitive actions.

d. Fully vaccinated individuals who are at least two weeks past their final dose of an authorized COVID-19 vaccine are not required to wear a mask in outdoor public spaces

at FSGA or HAAF, but should exercise appropriate social distancing. SMs shall maintain a copy of their COVID-19 Vaccination Record Card in either hard copy or as a photo or document on their phone.

e. All individuals, regardless of vaccination status, are required to wear a mask on public conveyances (i.e. planes, water transport, buses, trains, taxis, ride-shares) traveling into, within, or out of the United States, and in U.S. transportation hubs such as airports and stations. This requirement extends to DoD transportation assets (including Government vehicles) and hubs, including those outside the United States.

f. Regardless of vaccination status, exceptions to mask wear outlined in the Secretary of Defense Memorandum, (Use of Masks and Other Public Health Measures), 4 February 2021 still apply: (1) when an individual is alone in an office with floor-to-ceiling walls with a closed door; (2) for brief periods of time when eating and drinking while maintain distancing in accordance with CDC guidelines and instructions from commander's and supervisors; (3) when the mask is required to be lowered briefly for identification or security purpose; and (4) when necessary to reasonably accommodate an individual with a disability.

g. Additionally, under the authority granted to me by the Secretary of the Army memorandum (Use of Masks and Delegation of Authority to Grant Exceptions), 24 February 2021, I grant the following categorical exceptions to the wear of masks on FSGA/HAAF:

(1) Public Outdoor Spaces: Service Members may take off their masks while in outdoor public spaces if they are able to maintain proper social distancing.

(2) Physical Training (outdoors): Service Members may take off their masks while conducting physical training outdoors, and must attempt to maintain proper social distancing, 6 feet.

(3) Physical Training (indoors): Service Members may take off their masks only when they are able to maintain proper social distancing, 6 feet, while conducting physical training indoors (i.e. gymnasiums).

(4) Private residences/barracks: Personnel do not need to wear a mask when inside their residences (housing and barracks rooms).

(5) Children: Children under 2 years of age should not wear masks.

h. Commanders at all levels are responsible for the enforcement of mask wear within all indoor and outdoor facilities within their command footprint. Commanders may ask subordinates whether they have been vaccinated in order to enforce this policy.

Commanders may utilize Army systems of record on vaccination status to ensure appropriate application of mask measures in paragraph 1.

I. Fully vaccinated SMs shall maintain a copy of their COVID-19 Vaccination Record Card in either hard copy or as a photo or document on their phone.

### 2. PROHIBITED ACTIVITIES.

a. **Local Community Orders.** State and local authorities have issued various orders to protect against the spread of the virus throughout their communities. All SMs will read, understand, and follow these orders. In cases where one order is more restrictive than another, SMs must adhere to the more restrictive provisions.

b. **Restrictions relating to off-post business, venues, and similar locations:**

(1) **NO SM, regardless of vaccination status, may visit a bar, nightclub, or danceclub.** Bars, nightclubs, or danceclubs are defined as a drinking establishment whose primary purpose is the sale of alcoholic beverages and primarily serves to provide social interaction, and limited (popcorn, pretzels) or no food.

(2) Despite businesses' marked or actual mitigation measures, **unvaccinated SMs may not go to** the following: off-post dine-in restaurants, unless dining outdoors and adhering to social distancing; live performance venues (such as professional or amateur sporting events and concerts, but not including local recreational or children's sporting events); off-post indoor movie theaters; amusement parks (e.g., water parks, carnivals, theme parks, circuses, and trampoline parks); and tattoo parlors.

(3) **Unvaccinated SMs may go to** any other establishments while social distancing, including barber shops, beaches, parks, carry-out restaurants, dine-in restaurants if dining outdoors, drive-in theaters, outdoor recreation, outdoor pools, religious services, and indoor recreation/fitness centers (e.g., bowling alleys, gyms).

(4) Nothing prohibits the use of on-post services.

c. **Barracks.** If unvaccinated no more than (3) persons are allowed in a barracks room.

d. **Travel and Leave guidance.**

(1) For the purpose of leave and pass, the local area is defined as the counties within 150-miles of FSGA. Battalion-level commanders may approve or disapprove local and non-local leave and pass to areas identified as high risk. This may be delegated to Company-level commanders.

(2) Company-level commanders may approve local and non-local leave and pass to areas not identified as high risk.

(3) A fully vaccinated SM is not required to be placed in a Restriction of Movement (ROM) status upon return from leave/pass. Fully vaccinated means the SM is at least two weeks beyond their final dose of an approved vaccine.

(4) For unvaccinated SMs, Commanders at echelon shall consider impact on readiness and mission requirements prior to approval of leave/pass.

(5) The approval authority for high risk leave/pass must assess whether a travel ROM is required for unvaccinated SMs upon return to duty based on an assessment of 1) leave/pass location; 2) leave activities (low v. high risk activities, including attendance at gatherings of more than 10 people; and 3) mode of travel.

(6) If a travel ROM is required, the SM shall ROM for 10 days, authorized to be reduced to 7 days with a negative COVID-19 test.

(7) Brigade Commanders are both the exemption and release authority from a travel ROM.

### 3. CIVILIAN WORKFORCE.

ALL DoD and DA Civilians will wear face coverings/masks when inside on-post public buildings/facilities and in outdoor shared spaces at FSGA/HAAF. DoD and DA Civilian employees may staff an exception to this requirement through their immediate supervisor to the SMC.

### 4. GUIDANCE AND EXCEPTIONS TO POLICY.

a. Commanders and supervisors may make recommendations or request in writing to me exceptions to this general order to ensure a safe and ready workforce.

b. All SMs may depart from these restrictions for emergency purposes. Justifiable emergencies should be non-recurring events involving serious medical or financial concerns requiring immediate action. SMs will immediately notify their chain of command in such event.

c. I highly discourage **everyone** in our community from attending **indoor social** gatherings of more than ten (10) persons. I also highly discourage **everyone** from attending **outdoor social** gatherings of more than fifteen (15) persons. Everyone attending gatherings, regardless of size, should wear masks, practice social distancing, and act responsibly.

d. In addition to masks, it is important to continue practicing non-pharmaceutical intervention, including but not limited to: social distancing, where it is prudent for health and safety; frequent handwashing, staying home when sick, and routine daily cleaning of high-touch surfaces.

**5. UNIT COMMANDERS RESPONSIBILITY.** Unit commanders will ensure their personnel are briefed on the prohibitions and requirements of this order.

**6. EFFECTIVE DATE.** Previous versions are rescinded. This General Order is effective immediately and will remain in effect until rescinded.

# Revised General Order 1



## Activities

- **NO SM, regardless of vaccination status, may go to bars, nightclubs, or dance clubs.** Bars, nightclubs, or dance clubs are defined as a drinking establishment whose primary purpose is the sale of alcoholic beverages and primarily serves to provide social interaction, and limited (popcorn, pretzels) or no food.
- **Additionally, unvaccinated SMs may not go to the following businesses/activities:**
  - Indoor dining at off-post restaurants, live performance venues, indoor/outdoor sporting events (not including local recreational/children's sporting events), indoor movie theaters, amusements parks, and tattoo parlors
  - All other businesses/activities are permitted while social distancing and wearing a mask.
- Indoor social gatherings of more than 10 persons are highly discouraged.
- Outdoor social gatherings of more than 15 persons are highly discouraged.

## Mask Policy

- **All individuals shall wear a mask inside any on-post facility at FSGA or HAAF.**
- **All SMs, regardless of vaccination status, shall wear a mask inside off-post public buildings/facilities** (i.e. barber shops, religious services, grocery stores, etc.) and on public transportation.
- **Not fully vaccinated** individuals at FSGA or HAAF must also wear a mask in outdoor public spaces IAW DoD and 3ID guidance.
- All previous exceptions to policy for mask wear remain in place. (i.e. physical training outdoors or indoors **only when you are able to maintain social distancing**, private residences/barracks, children under 2).
- Additionally, all SMs may take off their masks while in outdoor public spaces if they are able to maintain proper social distancing, 6 feet.
- Fully **vaccinated** shall maintain a copy of their vaccine card (hard copy or on phone)

## Travel Policy

- Vaccinated SMs are not required to be placed in Travel RoM upon return from leave/pass.
- Unvaccinated SMs high risk leave/pass will be assessed to determine whether a Travel RoM is required.
