MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Temporary Off-Limits Business Addition - FROZEN PARADISE BAR AND GRILL LLC, 818 E G Miles Park Way, Hinesville GA 31313

1. Members of the Armed Forces are temporarily prohibited from entering FROZEN PARADISE BAR AND GRILL LLC, 818 E G Miles Park Way, Hinesville GA 31313 and/or engaging in any business with this establishment as long as this order is in effect. This action is being taken because it has been determined that FROZEN PARADISE BAR AND GRILL, an establishment frequented by Armed Forces personnel, presents conditions, which adversely affects Soldiers' health, safety, and welfare.
2. This temporary restriction will remain in effect on FROZEN PARADISE BAR AND GRILL LLC until either rescinded in writing or the establishment is permanently added to the off-limits list. The Armed Forces Disciplinary Control Board will review this temporary restriction and make a recommendation to either continue the temporary restriction, permanently add the business to the off-limits list, or remove the restriction.
3. Active Duty Armed Forces personnel assigned and attached to Fort Stewart and Hunter Army Airfield are prohibited from using, visiting, or entering the business establishments listed above. Family members of service personnel and others associated with the service or installation should be aware of the off-limits restrictions. Military personnel assigned and attached to Fort Stewart and Hunter Army Airfield who violate AR 190-24/ OPNAVINST 1620.2A/AFI 31-213/MCO 1620.2D/COMDINST 1620.1E by using, visiting, or entering these business establishments are subject to disciplinary action under the Uniform Code of Military Justice (UCMJ).
4. An off-limits area is defined as any vehicle, conveyance, place, structure, building, or area in which Active Duty Armed Forces personnel are prohibited to use, ride, visit, enter, or conduct business with during the period in which it is declared off-limits. Commanders will ensure all members of their command are aware of this list.

SUBJECT: Off-Limits Business Establishments

1. Under the provisions of Army Regulation (AR) 190-24/OPNAVINST 1620.2A/AFI 31-213/MCO 1620.2D/COMDINST 1620.1E (Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations), dated 27 July 2006, Armed Forces Disciplinary Control Board and Off-Installation Liaison and Operations, the following establishments are officially declared off-limits to personnel of the Armed Forces assigned and attached to Fort Stewart and Hunter Army Airfield:

c. BIG APPLE ADULT ENTERTAINMENT CLUB: 715 East Oglethorpe Hwy, Hinesville, GA 31313.


