Marne 6 sends: Modifying Defender-Europe 20

In response to the ongoing COVID-19 pandemic, a decision was recently made to modify the Defender-Europe 20 exercise. This decision was made after a careful review of the current situation and with direct coordination between the Department of Defense and our Allied partners.

As a result of this decision, there are changes that will have a direct impact on 2nd Armored Brigade Combat Team, 3rd Infantry Division, and their deployment timeline. The 2nd Armored Brigade Combat Team will remain in Europe, supporting the remaining Defender-Europe 20 training events before assuming the Operation Atlantic Resolve Regionally Aligned Force mission. Soldiers who remained at home station for Defender-Europe 20 may be forward deployed to join the rest of the brigade in order to meet manning requirements. Upon completion of this mission, late this year, 2ABCT will redeploy to Fort Stewart.

The decision was largely based on the timing of the next regionally aligned brigade's arrival versus the spread of COVID-19 in Europe. Since 2/3 ABCT was already in place in Europe prior to travel restrictions into and out of Europe, and the next brigade had not arrived, the

decision was made for 2/3ABCT to assume their mission as the Europeanbased brigade combat team. This new mission allows the Spartan Brigade to showcase its readiness and lethality and they are postured and ready to support NATO and our Nation.

I understand this decision and change of mission

directly impacts our Soldiers and Families. Please know that we are working diligently with our higher headquarters, United States Army Human Resources Command and the Department of the Army to sort through the ensuing change and get you the answers you need. Please be patient, and as soon as we have more information it will be made available.

I want to personally thank each and every one of you for the sacrifices you make on a daily basis; it is your support and dedication that makes this great division what it is and gives us the strength we need during times like these. Please continue to be strong and take care of each other and trust in us to take care of your Soldiers.

3ID, garrison lead COVID-19 town hall

Fort Stewart and Hunter Army Airfield leaders, both uniformed and non-uniformed, gathered for a town hall community live stream to address the growing concerns over the novel Coronavirus, or COVID-19, at the main post chapel March 19 on Fort Stewart.

Maj. Gen. Tony Aguto, 3rd Infantry Division commander, Col. Bryan Logan, Fort Stewart garrison commander, and Col. Michelle Munroe, WINN Army Community Hospital commander, as well as representatives from different civilian-led departments discussed what precautions they are implementing in their sections and how this affects services and the health of the community.

"I want to stress how serious this is and how seriously we're taking it," Aguto said. "My first priority is the readiness of the force; our most precious resource is our people."

Striking the balance between readiness and the health and safety of all Dogface Soldiers, Family members and civilian counterparts has been challenging, but measures have been put in place in accordance with Center for Disease Control and Prevention guidelines.

"The first thing you can do to prevent COVID-19 in your household is to regularly clean common surface areas like doorknobs, counter tops, computer keyboards, light switches and even your phone," Munroe said.

Soldiers and civilians also increased the cleaning of its office buildings and common facilities, such as the commissary and gyms on post.

"Our cleaning schedule implemented across [all installation] buildings is twice a day," Munroe said.

Caution is advised when using various cleaning solutions, said Monroe. Using diluted household bleach solutions and alcohol solutions with at least 70 percent alcohol within it are just some of the effective ways to keep a clean environment.

According to Aguto, as of March 19 approximately 95 cases have since come up in the local area and those individuals have been restricted to their residence.

The CDC recommends social distancing, keeping an estimated six feet apart from others, especially those with notable symptoms. Staying home if non-essential, coughing into your elbow and sneezing into it aids the fight against COVID-19. More information is available on *cdc.gov*.

But what about the 3rd Infantry Division? What about the Soldiers abroad and their Families dealing with a rapidly changing environment, what are they to do? The leadership present at the town-hall stream addressed those concerned with the information available.

"Every Soldier that is currently overseas is fulfilling a mission requirement," Aguto said. "They are out in the field but have instituted a number of safety and protective measures against COVID-19."

Maj. Gen. Aguto assured the Marne communities that when a proper timeline for Soldier redeployment back to the states is established, that he will disseminate that information.

Official travel has currently been stopped stated Aguto, according to Department of Defense policy. Permanent change of station and official travel are stopped until May 11th.

"We will move mountains, [that is to say] work within our bureaucracy to help any hardship cases that are out there," Aguto said in regard to Soldiers and their Families affected while in the middle of moving to their next location.

"Expiration – term of service (ETS) and retirement, those moves have not stopped," Aguto said. "If you're retiring or ETS'ing, you may continue on that path and our Soldier Service Center is prepared to continue that process."

Access to the commissary has changed slightly. Early-bird shopping has been established, running from 8 a.m. to 9 a.m. at Fort Stewart Monday through Friday and 9 a.m. to 10 a.m. at Hunter. These hours have been designated to our retirees ages 60 and over.

The commissary will continue to operate their normal hours and all Marne post exchanges will run from 9 a.m. to 6 p.m. Monday through Saturday and 10 a.m. to 6 p.m. Sundays.

"If stricter restrictions are put in place, mission essential personnel may be granted special permissions for on- and off-post travel," said Maj. Peter Bogart, the 3rd Infantry Division deputy public affairs officer.

More information regarding the installations and their guidance in the fight against COVID-19, as well as maintaining the health and safety of the 3rd ID community is available on the Fort Stewart app, which can be downloaded through the iOS app store and Google Play store and its website: *home.army. mil/stewart*.

"We continue to work with our local, state and federal authorities and within the guidelines of the CDC to proactively respond to this threat," Aguto said. "My number one priority is taking every possible measure we can to prevent the spread of the Coronavirus not just on Fort Stewart and Hunter Army Airfield, but to our local communities as well."

DOD TRAVEL RESTRICTIONS DUE TO COVID-19

Who does the domestic travel restriction apply to?



All Soldiers and their Family members will stop all official travel – such as Permanent Change of Station or Temporary Duty – through May 11.

Winn Army Community Hospital prepares to assist

In order to ensure maximal safety of patients from the spread of COVID-19, Winn Army Community Hospital has implemented a pre-screening measure at the four operational entrances of the hospital.

"These measures will more rapidly identify those individuals most at risk," said Capt. Patrick Pead, Army Public Health Officer in Charge, Winn ACH. "We then expeditiously route those who need immediate attention to the emergency room, before unnecessary exposure throughout the hospital could happen."

The screening stations are looking specifically for individuals who may have been to a high-risk area or been exposed to a person identified positive for COVID-19. They are also checking to see if the patient has exhibited a temperature of more than 100.4, trouble breathing or a recurrent cough.

Spc. Ange Kanghan and Sgt. Shaun Mohr were on-hand in front of the Winn ACH emergency room March 19. They met each patient with courtesy and professionalism wearing gloves and mask. "It's an honor for us to be doing the screening, because we need to step up and help stop the spread," Kanghan said. "We can help control the problem before it takes root."

Spc. Elsy Hernandez, who was Winn ACH Soldier of the Quarter for 4th Quarter 2019, also helped out with screening at the west entrance to the hospital.

"I hope the screening helps make people more comfortable," Hernadez said, adding she didn't mind the duty as it helped ensure the safety of Soldiers, hospital staff and other patients.

Additional steps the installation and the Medical Department Activity are using to help stop the spread is through use of common sense with social distancing, good personal hygiene, quarantine and isolation.

According to the Centers for Disease Control, *cdc.gov/coronavirus/2019-ncov/ prepare/prevention*, the best way to prevent illness is to avoid being exposed to this virus.

Through the use of social distancing – avoiding crowds of 10 or more and keeping about three feet between individuals – is a good way to reduce the threat of spreading an infectious disease.

CDC prevention tips:

• Wash your hands often with soap and water for at least 20 seconds.

• If soap and water are not readily available, use a hand sanitizer with at least 60% alcohol.

• Avoid touching your eyes, nose and mouth.

• If you must sneeze or cough, cover your mouth and nose with a cloth or the inside of your elbow. After disposing of the tissue, wash your hands.

• If you feel sick, avoid being around people and wear a mask when you are.

• Disinfect all surfaces like counters, tabletops and doorknobs.

If you feel sick but are not exhibiting one of the three primary symptoms – self monitor. It is also influenza and allergy season.

If you don't exhibit symptoms but were exposed to a person who tested positive as a case of COVID-19, you may be quarantined. The CDC notes quarantine separates and restricts the movement of people who have been exposed to a contagious disease to see if they become sick. It lasts long enough to ensure the person has not contracted an infectious disease.

In the case of COVID-19, quarantine is

14 days. Monitoring includes taking your temperature twice daily. Individuals in quarantine are called to get rest, stay hydrated and exercise and to avoid contact with others. If a person doesn't exhibit symptoms within that time, then the person is assumed not to have been infected.

If you exhibit COVID-19 symptoms, a request for a COVID-19 test will be requested by healthcare providers to the Georgia State Public Health approval and you will be isolated.

What is isolation?

Isolation prevents the spread of an infectious disease by separating people who are sick from those who are not. It lasts as long as the disease is contagious. In case of isolation, you will not have contact with anyone, including Family members – unless they are in isolation, too. Care providers will be called to ensure extra diligence –using a face, eye and hand protection, use of disinfectants to clean dishes and contact surfaces.

Soldiers on PCS orders can now request to stay extra year at duty station

WASHINGTON – Soldiers preparing for a permanent change-of-station move can now request to stay at their current duty station for up to a year, as the Army adapts how it moves people during the COVID-19 crisis.

New Army guidance says Soldiers can request to defer an assignment and return to their losing unit if they expect to face hardship as a result of a PCS move.

"People remain our No. 1 priority, our center of gravity in all we do," Lt. Gen. Thomas Seamands, the Army's G-1, said at a press briefing last week. "We're working really hard to take care of our Soldiers, civilians and Families around the globe."

On March 16, the Defense Department began to temporarily halt all domestic travel, including PCS and temporary duty travel, for servicemembers, DOD civilians and their families assigned to DOD installations in the U.S. or its territories.

The domestic travel ban lasts until May 11 and follows other restrictions last week that stopped movement for 60 days to overseas locations with a Level 3 travel health notice, such as South Korea and much of Europe, where there has been widespread transmissions of the virus.

STABILIZING FAMILIES

The latest guidance comes after Army Chief of Staff Gen. James McConville suggested last year that Soldiers be given the opportunity to stay put if it increases their quality of life and eases the peak PCS season in the summer.

While the Army plans to liberally approve requests, Seamands said that not all will be granted, particularly for mission-essential personnel.

"Absent any mission-essential nature of their assignment, then they should be allowed to stay in place," he said.

Soldiers assigned to Patriot missile units, for instance, may not qualify for the delayed movement since they have a high operational tempo and can only go to certain places.

For most Soldiers, Seamands said they should have a say in the decision, especially if they choose to reenlist in order to stabilize or go someplace else.

"We'll stabilize the Family likely for a year and then see what the inventory and the readiness demands are across the force at that point," he said.

The Army also plans to address possible shortages in units caused by the moves, or the lack of them.

"We are constantly balancing readiness and looking at the numbers across the board to make sure we have the right Soldier with the right skill in the right place," he said. "But there would potentially be a second-order effect and that's our job to mitigate that and to be able to maintain readiness across our Army."

HOUSEHOLD GOODS

Shipment of household goods, including personal vehicles, for those scheduled to move will also be delayed until at least May 15, unless there is an approved exception to policy.

In a nutshell, if a household goods shipment has been awarded to a moving company but no physical action has been taken, then the items will not move until the DOD stop-movement order changes, said Lt. Gen. Duane Gamble, the Army's G-4.

But "if a Soldier is permitted to continue with their PCS move, then their household goods will be moved accordingly," Gamble said at the briefing.

Exceptions may only be granted for compelling cases deemed mission essential, necessary for humanitarian reasons or warranted due to extreme hardship.

U.S. Transportation Command continues to have daily calls with moving companies to share information on travel restrictions and any movements. "Like any sector, this is hitting them really hard and they're anxious to know when traffic will resume," said Rick Marsh, director of the Defense Personal Property Program.

Soldiers who decide to stay in place for a significant amount of time will get their orders amended so their household goods and POV are returned to them, if they haven't been shipped yet, Gamble said.

The Army Human Resources Command has set up an emergency hotline to assist Soldiers and Families with PCS or TDY questions at 1-800-582-5552.

Soldiers can also contact the telephone number on their orders, or reach back to their old unit or arriving unit for additional guidance.





Soldiers take aim at new marksman qualification course

Soldiers assigned to Headquarters and Headquarters Battalion, 3rd Infantry Division, conducted the Army's new marksmanship qualification during their scheduled M-4 range week March 9-12 at Fort Stewart.

HHBN's Soldiers are part of the beginning phasing in stages of the new qualifications range, according to 1st Lt. Shawn Sims, a signal officer assigned to Signal Intelligence Sustainment Company, HHBN, 3rd ID.

The new marksmanship qualification course has been designed to replace the Cold War-era marksmanship qualification course, requiring Soldiers to engage targets faster in a variety of firing positions that they may be required to take during an enemy engagement.

"This new test is an actual measurement of Soldiers' marksmanship skills and how they would apply it to the real world," said Sgt. David Fernandez, a nodal network fication lanes and three zeroing systems operator assigned to SIS Co., HHBN, 3rd ID.

The new required firing positions include prone unsupported, prone supported, kneeling supported and standing supported.

Staff Sgt. Aaron Terry, a multichannel transmission systems operator assigned to SIS Co., HHBN, 3rd ID, said Soldiers are now given instructions prior to engaging the targets, and then they must change magazines and positions on their own during a prescribed amount of time.

"We had to ensure preliminary marksmanship instruction within the sections was completed, so that everybody was familiar with the new qualification standard," Sims said. "We had to work with range control to get the new targets and make sure the barriers for the standing portion were taken care of."

Terry said his job as noncommissioned officer in charge of the range encompassed coordinating and executing the range with 16 qualilanes.

"It is a little more involving and keeps you on your toes," said Sgt. 1st Class Rashawn Brown, a telecommunications operations chief assigned to 3rd ID. "It's going to take time for Soldiers to get used to it."

Sims said the Army won't officially move to the new standard until this fall and the old standard can still be administered until that time.

"It's easy if you apply your shot process, which falls back on applying what you learned during engagement skills trainer and primary marksmanship instruction," Fernandez said. "The hardest thing is transitioning between the positions and reloading."

The PMI portion, and EST training will be significant when preparing to qualify for the new standard, Terry said.

"Go into qualifying with an open mind and take PMI seriously, especially before going to the range,' said Terry. "Although it is a requirement, have fun with it and you'll be successful."

New allowances for Soldiers, Families affected by virus

WASHINGTON - The Army has rolled out new allowances for Soldiers and Families facing official travel delays or in guarantine amid the COVID-19 virus outbreak.

A hardship duty pay for restriction of movement now provides Soldiers who are not currently in a travel status \$100 per day - not to exceed \$1,500 - to defray the cost of additional lodging if a commander restricts them to a self-monitoring period.

HDP-ROM may also be available to other Soldiers who have been ordered to stay isolated, such as individuals returning from a deployment or temporary duty.

The hardship duty pay is a taxable, lump sum payment for each day in self-monitoring or isolation.

New isolation allowances are being given to Soldiers and Families ordered to stay isolated after completing a permanent change-of-station move.

The allowance is based on local per diem rates and starts after the Soldier reports to a new duty station and before eligible for temporary lodging allowance or temporary lodging expense. The Soldier must also incur a cost and not already be provided lodging or meals to earn the allowance.

Once their new command tells them they can start to in-process, Soldiers will then be eligible for their regular PCS allowances.

Soldiers and Families ordered to self-isolate or quarantine while proceeding to their next duty station will be placed on temporary duty and authorized per diem if lodging or meals are not provided.

In addition, Soldiers currently on TDY status may be eligible to extend their orders to cover costs incurred during their self-monitoring period.

The Army currently has a 14-day mandatory quarantine for Soldiers and a recommended self-quarantine for DOD civilians and Family members returning from countries with a travel health notice of Alert Level 2 and above.

"We will ensure that every Soldier gets properly compensated for their PCS or TDY being delayed at no fault of their own," said Angie Rodriguez-Torres, military compensation and entitlements analyst at the Army's G-1 office.

Trusted Traveler takes effect on Stewart, Hunter

Trusted Traveler is now in effect on Fort Stewart and Hunter Army Airfield.

Trusted Traveler is an Army program implemented to expedite installation access and maintain vehicle throughput to lessen traffic congestion.

Trusted travelers are valid Common Access Card holders or in possession of a validated DOD affiliated ID card. Service members, Family members, DOD employees and retirees are allowed to enter the installation as trusted travelers and vouch for all vehicle occupants. This includes non-affiliated personnel. The trusted traveler assumes all responsibilities for those he or she has in their car and their actions while on the installation.

Trusted travelers are responsible to ensure vehicle occupants possess a valid picture ID such as a REAL ID-compliant state driver's license, state ID, DD Form 1173 (Uniform Services ID Card), DD Form 2 series, or a U.S. passport for ready identification. Trusted travelers are also responsible to ensure vehicle occupants do not have a foreign passport as their only means of identification, are not the subject of a criminal investigations, do not have active warrants and are not barred from the installation. Vehicle occupants under the age of 18 without a picture ID may be sponsored by a trusted traveler.

"The trusted traveler program is a great way for the installation to support its community by allowing a simple process for Soldiers and Family Members to sponsor their friends and Family on the installation," said Maj. Dayna Urbank, Directorate of Emergency Services Operations Officer. "It alleviates long lines at the visitor control center, while still providing a level of security for our installation."

Trusted traveler does not apply to transportation or ride share companies. All occupants of transportation or ride share vehicles are required to present identification at all times.

Trusted traveler hours are 5 a.m. to 10 p.m. After hours between 10 p.m. and 5 a.m. trusted traveler is not in effect and all vehicle occupants must present proper identification in order to access the installation. Trusted traveler status will be removed from any ID card holder deemed to be engaged in conduct that is detrimental to the good order and discipline on the installation.

Department of the Army Security Guards, military police or any personnel conducting access control duties may initiate 100% ID check at any time at their discretion.

Soldiers can now apply for AER assistance electronically

WASHINGTON – The Army Emergency Relief program has implemented changes to assist Soldiers and Families impacted by the spread of COVID-19.

The new guidelines ensure that Soldiers and Families can process assistance applications on time, while under quarantine or observing limited face-toface interaction, said retired Command Sgt. Maj. Charles Durr Jr., chief of assistance.

Soldiers and Families must first inform their chain of command of their current financial hardship. They will then need to fill out an AER application and supporting documentation and route it up to their chain of command for approval.

Any documents containing personally identifiable information must be transmitted securely, officials said. Soldiers and Families can request a SERV-U link from an AER officer to safely transfer their application, or use the DOD Safe website. The electronic request for assistance must include:

• AER Form 101, Application for Financial Assistance

• AER Form 57, AER Budget Planning Sheet

• AER Form 575, AER Electronic Funds

Transfer Authorization

• Supporting documents validating financial need

Once a Soldier's chain of command has approved an application, it must be sent to an AER official for final review.

"The AER special assistance application processing guidelines have been well received by unit leadership," Durr said.

Unit leadership has "been effectively processing assistance cases electronically via secure portal transmission, and Headquarters AER has been electronically depositing funds into Soldier's bank accounts successfully," he added.

As of Friday, AER has processed 14 cases totaling more than \$15,000, Durr said. Out of the total number, four cases supported personnel under quarantine, five provided financial assistance due to loss of pay, and five aided personnel impacted by the recent travel ban.

"After 34-years of service, I have seen the benefits of the AER program to our Soldiers," said Army Vice Chief Staff Gen. Joseph M. Martin. "I encourage leaders to educate themselves about the program and join the campaign by sharing what they learned about the benefits of AER and invite their Soldiers to voluntarily join the legacy of Soldiers helping Soldiers."

Army makes exceptions to enlisted promotion policy

WASHINGTON – In response to the COVID-19 outbreak, the Army has initiated several policy exceptions that will impact enlisted promotion cycles scheduled until the end of this fiscal year, unless terminated sooner, G-1 officials announced Tuesday.

Due to the recent restrictions placed on travel and training, the Army is altering its approach to semi-centralized promotion boards, along with changing the training requirements required for promotion eligibility, said Sgt. Maj. Mark A. Clark, the Army G-1 directorate of military personnel management sergeant major.

The exception will impact the active-duty and Army Reserve force, with many of the alterations taking effect during the May promotion month, Clark said. The National Guard will produce additional guidance at a later date.

"The overall impact is to protect the force and preserve readiness," Clark said. "We are trying to get ahead and be proactive and creative. We want commanders and Soldiers to understand that we're thinking about what's best for them and what's best for the Army - all at the same time."

As the COVID-19 environment continues to evolve, the Army will continue to review its policy exceptions every 30 days and make any necessary changes. The modifications will be in place until Sept. 30.

VIRTUAL BOARDS

Commanders are now authorized an alternative means to evaluate personnel during a monthly unit promotion board, Clark said.

With the exception to policy, commanders can conduct a promotion board within a virtual environment. It will be up to the command team to determine their proper means of communication, he added.

"We gave some latitude to the command teams, allowing them to be creative on how they want to assess their Soldiers," Clark said. "With all of the different virtual options that command teams will access to... it gives the commander the option to do [their promotion boards] via the internet or in an environment that supports social distancing."

In addition to the virtual boards, leaders can also rely on their battalion command sergeant major to make promotion recommendations based on their "one-on-one interactions with an eligible Soldier," Clark added.

Battalion CSMs can obtain input from their chain of command or through the noncommissioned officer support channel to make an informed decision about an eligible Soldier.

MILITARY EDUCATION

Starting in May, the Army will temporarily suspend its PME course requirements for staff sergeants and sergeants first class who need to complete the Advanced Leader Course or Senior Leader Course, respectively, Clark said.

The temporary suspension of PME will not waive the PME requirement, Clark said.

Soldiers will still be required to complete the course at a later date and will be prioritized first in the training pipeline to ensure they meet this training requirement.

"Soldiers who have always been doing the right thing ... by already completing their requisite level of professional military education to qualify themselves for promotion, will be selected for promotion before [the Soldiers] that have not completed their professional military education," he said.

Difficult times call for prayer

God desires for hungry infants to be fed, for example, but His design for human beings is such that the act of another human being is required for this good to occur.

Jones suggests that the spiritual

realm is analogous to the physical realm. There are many good things God wills to do, even miraculous things. But, God has made them contingent upon our prayers.

We do not exert any control over God. God remains totally sovereign. Yet, we can make a difference even in

> the epistle of James, the writer reminds us, "The effective, fervent prayer of a righteous man avails much. Elijah was a man with a nature like ours, and he prayed earnestly that it would not rain; and it did not rain on the land for three years and

en gave rain, and the earth produced its fruit."

I share these thoughts as our country faces a crises unlike anything most of us have ever experienced. I have heard a few folks speculating about the Coronavirus as some kind of divine punishment. I see it a bit differently.

What if God is perfectly willing to supply the solution to the COVID-19 problem, but has made it contingent upon our humbling ourselves to honor Him as the Sovereign Lord of the universe and seek His favor? We will never know unless we pray.
