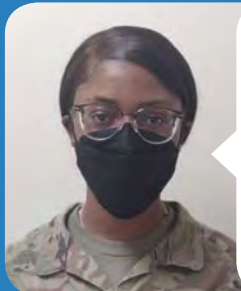

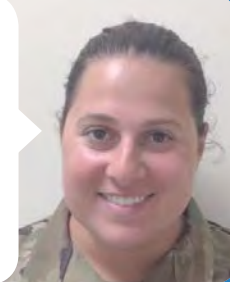

Maintain Battalion keeps deactivated unit Soldiers' ultimate sacrifice alive

The “Maintain Battalion,” 703rd Brigade Support Battalion, 2nd Armored Brigade Combat Team, 3rd Infantry Division, held a dedication for the tree memorials at Warriors Walk representing and memorializing the fallen Soldiers of the 703rd and 26th BSB on May 26 at Fort Stewart. The 26th BSB was deactivated in 2014 with the restructuring of the Army. The 703rd BSB has taken the mantle as caretaker of the 26th BSB’s memorials at Warriors Walk.

“These Soldiers come from two units, one of which is deactivated,” said Lt. Col. Harley Jennings, commander of the 703rd BSB, 2nd ABCT, 3rd ID. “It is up to us to maintain the memories of ours and their fallen to ensure their sacrifice is not forgotten.”

Warriors Walk is dedicated to the 469 3rd ID Soldiers who sacrificed their lives since 9/11. A total of eight Soldiers between the two BSBs are among them and range from the rank of private to captain.

Two Soldiers and a noncommissioned officer from the 703rd BSB were selected to dedicate each tree with a unit crest.

“I was beyond honored to be a part of the team to honor our fallen brothers and sisters in arms,” said Cpl. Kristian Evans, an NCO assigned to the 703rd BSB, 2nd ABCT, 3rd ID. “I take great pleasure bringing recognition to those who gave the ultimate sacrifice for our country.”

The unit will continue to maintain these trees moving forwards, ensuring that the memories of these eight 3rd ID Soldiers live on.

“I have been a member of both of these units and personally know the Soldiers associated with 10 of the trees in Warriors Walk.” Maj. Jeffrey Teplis, executive officer of the 703rd BSB, 2nd ABCT, 3rd ID. “The memories of these Soldiers must be carried forward to honor the sacrifice that comes with service to our country. The families need to know that their Soldier is not forgotten, and they are not alone.”

Trusted Traveler reinstated

Trusted Traveler resumed today at Fort Stewart and Hunter Army Airfield. Trusted Traveler allows all DOD ID card holders to vouch for all occupants in their vehicle. The DOD ID card holder must be the driver unless observed medical conditions prevents vehicle operation. Trusted Traveler hours are 6 a.m. to 9 p.m. daily, Monday through Sunday at all gates. After 9 p.m. all occupants of the vehicle will

be subject to 100% ID card check at open gates except Rio gate at Hunter. After 9 p.m. use Montgomery Gate at Hunter. Contractors and AIE card holders are not authorized Trusted Traveler. Visitor Control Center hours remain 6 a.m. to 6 p.m. at Stewart and Hunter.

State carry act does not apply on post

The recently passed Georgia Constitutional Carry Act does not apply to Fort Stewart-Hunter Army Airfield or any Army installation in Georgia. Per Army Regulation 190-11, the carrying of privately owned weapons and ammunition is prohibited on post unless authorized by the Senior Commander. Also, the carrying of a concealed weapon on the installation is prohibited regardless of whether a state or county permit has been obtained. 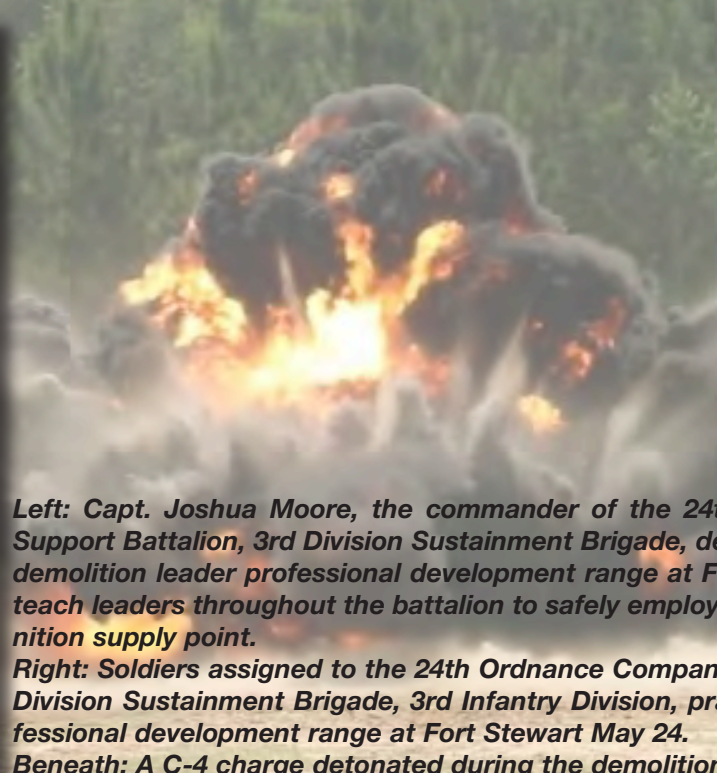

‘Game-changing’ SmartVoucher pays PCSing Soldiers faster

SmartVoucher is a wave of the future, putting money into the pockets of Soldiers and their families faster than ever before.

Across the Army and around the globe, the U.S. Army Financial Management Command's Army Military Pay Offices are helping deploy the Defense Finance and Accounting Service's SmartVoucher program to automate the Army's permanent-change-of-station travel voucher claim process.

"The future is here with SmartVoucher, which is the new and improved way of completing a PCS travel claim," said William French, Fort Leavenworth, Kansas, AMPO director. "Soldiers can complete their voucher on any device anywhere in the world by simply filling out their itinerary, uploading their documents, and submitting their claim for review."

The SmartVoucher system can be accessed anywhere in the world with internet access and either a common access card or myPay login and password at <https://smartvoucher.dfas.mil/>.

"With SmartVoucher's easy three-step process, Soldiers can get paid in a handful of days instead of the 15 or 20 it used to take," explained French.

"This was the first time I used SmartVoucher, and I am a big fan of it because it was extremely easy to use and took maybe ten minutes to complete," said 1st Sgt. Elvis Puente Gonzalez, Mission Command Training Program senior battle staff observer, coach and trainer. "I got paid in three days, the fastest I've ever been paid for a PCS in eight moves."

Not only does SmartVoucher pay up to 50 percent faster, it's easier to use and eliminates many of the mistakes that plagued travel claim processes for years.

"It works just like commercial tax-filing software that many of us use to fill out our taxes each year," said Butch Boris, DFAS Rome finance director. "It's a multi-question, multi-decision-point program that walks you through the process of filling out your PCS travel claim using plain language and easy-to-understand questions."

The electronically-submitted travel voucher is then automatically transferred either directly to DFAS Rome for processing or through an AMPO for review before heading to DFAS. With either route, information doesn't have to be reentered from a scanned PDF by DFAS like it used to with the manual system.

"We're eliminating up to 50 percent of the travel voucher claim returns through SmartVoucher," Boris elaborated. "That means we aren't touching things we don't need to touch, speeding up the process and saving time and resources."

The fully-automated SmartVoucher also provides another advantage to Soldiers – visibility. As claims go through the process, Soldiers can receive text and email alerts to follow them along the way.

Looking back, Boris said SmartVoucher's beginnings

can be traced back nearly eleven years as DFAS worked to improve and automate their temporary duty voucher process with automated form filing.

However, the initiative really gained steam almost five years ago at Fort Sill, Oklahoma.

"When the DFAS director was visiting Fort Sill, the deputy to the commanding general there at the time asked her what she could do to make the military PCS voucher process easier and faster," recalled Susan Gillison, USAFMCOM Military Pay Operations director. "We talked about a bunch of different things, and we ended up modifying the tool DFAS had for TDY."

From there, SmartVoucher was born.

"It's a game changer. For decades, we used to have dozens or more Soldiers all in a single classroom with one or two Defense Military Pay Office employees, now AMPO employees, walking them through filling out their DD Form 1351-2, block by block," said Gillison. "The Soldiers didn't really have to know or understand a lot about the process or travel pay."

"The old method of bringing in the masses and having the group go line by line was awful and painful," recalled Puente Gonzalez, who just moved from Fort Rucker, Alabama, to Fort Leavenworth. "It always took more than an hour, depending on the number of service members in-processing."

"Now we're not only not spending all that time and coordination getting everyone in a classroom at the same time, but the Soldiers are also much more aware of their travel voucher claim process," French added. "Before, a lot of that education and information was lost each time a Soldier PCSed, but now they understand it better and can help one another as Soldiers rotate through their units."

While SmartVoucher allows Soldiers to file their own PCS travel vouchers on their own time thanks to ease of access and use, it becomes all the more important they file in a timely manner.

"While it's easier on them, they sometimes push it off and don't file their claim right away," explained French. "That can cause the military pay system to pay wrong allowance amounts, create debts and even suspend a Soldier's pay if it goes long enough. That's why we tell in-processing Soldiers that it's very important for them to file their claim using SmartVoucher as soon as possible."

Despite the tremendous advantages SmartVoucher provides Soldier's, Boris said SmartVoucher isn't perfect yet, and there are some big upgrades in the near future that will make it even better.

"In August, DFAS is adding responsive design to SmartVoucher, which will make it easier to use on personal devices," he explained. "You can definitely file on a tablet, but phones are still a bit clunky. And, later this fall, we have tons of recommendations from the field we're planning on implementing."

One of those changes will be increasing the character count from 250 to 1,000 in explanation blocks on returned

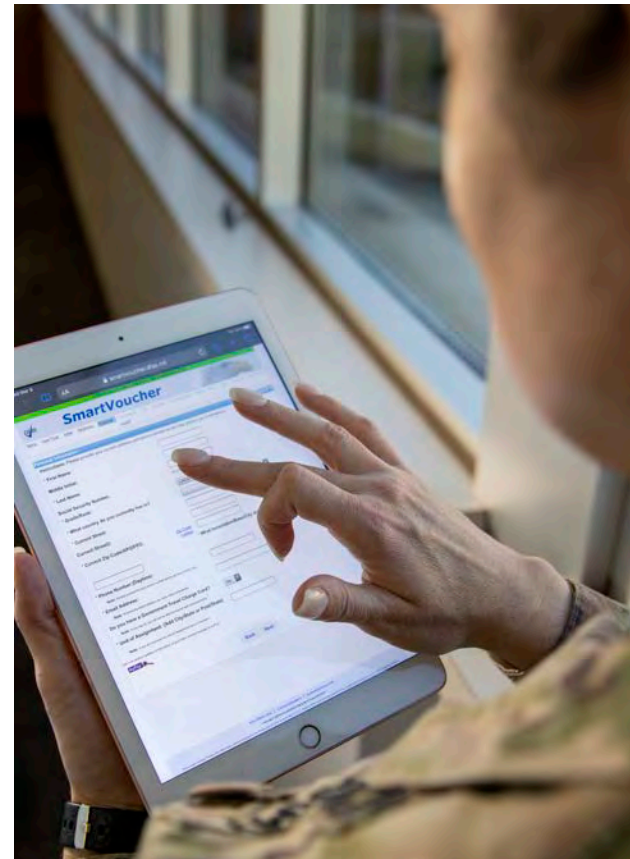

vouchers so military pay technicians can better communicate what a Soldier needs to fix.

Gillison said the improvement process will continue throughout the life of SmartVoucher as DFAS and USAFMCOM work together to provide better service.

"We're embracing technology in order to serve our Soldiers and their families better, and we want their feedback on how we're doing," she explained. "If there's something about it that they don't like, we want them to tell us so we can try to fix it."

While SmartVoucher will be optional for most PCSing Soldiers, it will be mandatory at certain locations.

"We went 100 percent SmartVoucher in Japan in December, and starting in June, we will fully mandate its use in Europe," said Boris. "We mandated SmartVoucher in those locations because their unique situations meant that SmartVoucher was the best way for us to provide the best service to our Soldiers."

"In the end, even though this is a Department of Defense-level program owned by DFAS, it's really about the Army and taking care of our Soldiers and their families," he concluded.

3RD ID HOSTS BEST SQUAD COMPETITION

The 3rd Infantry Division hosted a Best Squad Competition on Fort Stewart, Georgia, May 24-26, 2022, to identify the squad that will represent 3rd ID during XVIII Airborne Corps' Best Squad Competition, which will take place this July at Fort Stewart.

The winning team for 3rd ID came from 703rd Brigade Support Battalion, 2nd Armored Brigade Combat Team, 3ID.

"We are the support battalion, so we support everybody else, but we are out here being straight beasts and grinding," Sgt. 1st Class Mk-Ada-Quet Genereaux, a combat medic assigned to 703rd Brigade Support Battalion, 2nd Armored Brigade Combat, 3rd ID. "I am proud of the effort my team has put in and that they have shown everyone else what the best squad truly looks like."

The Best Squad Competition assessed each squad on its technical and tactical proficiency, as well as its ability to work as a cohesive team.

Squads consisted of five Soldiers: the squad leader, a sergeant first class or staff sergeant; a team leader, a sergeant or corporal; and three squad members in the ranks of specialist or below.

The three-day competition included various warrior tasks and battle drills, an Army Combat Fitness Test, a land navigation course, marksmanship events, and a foot march.

"Winning matters," said Sgt. Maj. Jerry Manzanares, the senior enlisted advisor for operations and training for 3rd ID. "Our goal is to foster physical and mental toughness by creating competitions like this that bring out the best in our Soldiers. We are also cultivating a sense of cohesion not only within a squad, but within a unit and beyond. When a group experiences hardships and challenges, like those in the Best Squad Competition, the Soldiers grow closer and learn about the strengths and weaknesses each Soldier brings to the table. The more a squad or a unit is united in its goal, the stronger it is and the more successful it becomes."

Competition events are a fundamental part of the Division's method of building lethal, cohesive teams and expert leaders.

"It's named the Best Squad competition for a reason," said Genereaux. "Not only is it testing a squad's physical and mental capabilities, but also a squad's ability to encourage one another and push through the challenge as a cohesive unit. This squad has a wheeled mechanic, three medics, and an ammunition specialist, and even though we are diverse, we still come together and are there for one another. Despite the diversity, at this moment we are all experiencing the same challenge. If someone has to take off their ruck and take a knee, we are going to put that on our back because we understand what our fellow Soldier is experiencing. We have that family mentality that allows us to overcome and move forward as a team."

The 3rd ID trains diligently and deliberately to create cohesive teams prepared to win on future battlefields, and events like the Best Squad Competition allow leaders to test those teams. They also showcase the culture of care, pride and ownership that junior leaders within those squads cultivate on a day-to-day basis.

"I would describe this squad as resilient," said Spc. Matthew Martin, a combat medic assigned to 703rd BSB. "We only had about a week together to prepare, but came together immediately and worked hard as a team. I am a medic and there are two other medics on the team, but we also have a mechanic and an ammo guy. They taught us a lot that we don't normally get to utilize as medics, and I'm sure we taught them a few things too. Being a diverse team allowed us to share our knowledge and build each other up."

XVIII Airborne Corps' Best Squad Competition is slated to take place in July and will pit squads from across the Corps in direct competition to see which Division can lay claim to the title of having the "Best Squad."

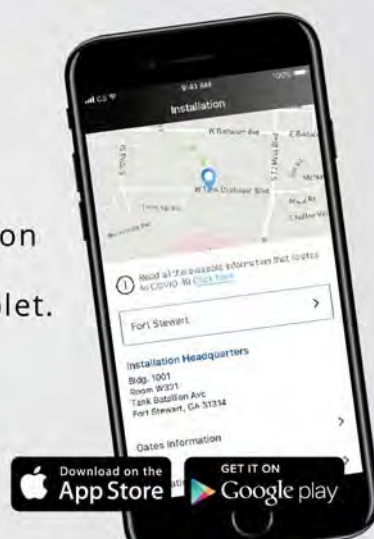

No one else knew how else to fill the overwhelming silence of that space no one wanted or ever expected to be. And so we listened to the almost song-like mantra, “the hills and the valleys.”

Life changes quickly. It is so fragile. We often forget that hard truth. It is easy to get caught in the endless tasks, meetings and preparations for the next “important” thing. We convince ourselves that our bodies are invincible, that relationships last forever, and that we have all the time in the world. And then life happens in unexpected and tragic ways.

All at once, we are confronted by the reality that from ashes we were created and to ashes one day we all return. It is one of the earliest lessons within our sacred Christian scriptures. Our time is but a simple breath within God’s creation.


We can almost be forgiven then when life forces us to stare our hubris in the eye. Tragedy and loss leaves us unprepared. Raw. Without words. Small. To where will our eyes turn then? That is what the Psalmist asked too when faced with a similar situation. At the heart of

the question is a simple plea: where can I find assurance of hope and the presence of God’s steadfast love.

We can almost be forgiven then when life forces us to stare our hubris in the eye. Tragedy and loss leaves us unprepared. Raw. Without words. Small. To where will our eyes turn then? That is what the Psalmist asked too when faced with a similar situation. At the heart of

the question is a simple plea: where can I find assurance of hope and the presence of God’s steadfast love.

“The hills and the valleys,” the woman sang to herself. The words aren’t her song. They are the refrain from another great Psalm, a powerful reminder that God is our shepherd no matter the circumstance. As I sat there, I don’t even know if she knew the entirety of Psalm 23, but God filled her heart with the part that matter most. The truth that God walks with us in every moment of our life, including the challenging ones that leave us filled overwhelmed.

I remind Soldiers frequently that faith is not a portal into an existence free of suffering. It is a hard lesson. We long to think that our faith gives us access to the HOV lane in life, but it is not how it works. It is not how it worked for Jesus. It is not how it works for us either. The human condition bound by free will and the effects of collateral choices leaves the world and lives broken. However, like Jesus, we know that God never leaves us in the suck alone.

God is with us over the hills and down the valleys of whatever may come. It is the truth more powerful than the fundamental reality of ashes to ashes. It is the love that fills a cold, tear-filled space with an eternal warmth that doesn’t rely on a lot of words as long as we can all hear the familiar echo of a sacred song.
