# Marne Focus begins: Beware Soldiers, tanks, traffic

Georgia highways 119 and 144 east on Fort Stewart will have significant military vehicle traffic March 10-15 due to a large tactical exercise, Marne Focus.

Drivers are advised to find alternate routes and not use the highways on Fort Stewart those six days. Based on military vehicle movements, delays could take up to 30 minutes.

If using highways 119 and 144 east, drivers are asked to proceed with extreme caution at all times, day or night.

The greatest concern to drivers will be military vehicles crossing highways--including 70-ton main battle tanks--at any time, day or night, at designated locations. Seventy tons is roughly the weight of 10 African elephants.

The speed limit at military vehicle crossings will be 35 mph. Military vehicle crossings are clearly marked with signs and flashing amber warning lights. Soldiers wearing reflective vests and holding flashlights will man crossings. The Soldiers will use hand and arm signals to stop traffic. Military vehicles will cross once traffic is stopped. After the military vehicles cross, the Soldiers will remove dirt and debris from the road. Even with debris removal, roads may remain slippery, so drivers should proceed slowly. Drivers should drive with caution

at all times due to dirt and debris on the highways.

Marne Focus will test the 3rd Infantry Division's readiness and lethality as it prepares a brigade combat team for a National Training Center rotation.

**Fort Stewart-Hunter Army Airfield**

There will be an increase in military traffic on installation highways as the 3rd Infantry Division tests its readiness during Marne Focus, a large tactical exercise.

**MARCH 10-15**

Military vehicles will be crossing Georgia highways 119 and 144 east at any time, day or night.

**DRIVE WITH CAUTION!**

Drivers are advised to find alternate routes. If you choose to drive on highways 119 and 144, proceed with extreme caution and expect delays up to 30 minutes. Be alert for military vehicles and dirt on roadways.

**CROSSING SIGNS**

Crossings are marked with signs and flashing amber warning lights. Soldiers wearing reflective vests and holding flashlights will man crossings. The Soldiers will use hand and arm signals to stop traffic.

**ROAD HAZARDS**

After military vehicles cross, Soldiers will remove excess debris from roads. Even with debris removal, roads may remain slippery, so drivers should proceed cautiously.

# "Can Do" battalion's fire support teams train for NTC

Bradley fire support teams assigned to the 3rd Battalion, 15th Infantry Regiment, 2nd Armored Brigade Combat Team, 3rd Infantry Division, began training to certify as fire support team Soldiers on Feb. 28 on Fort Stewart.

To certify, they used the call for fire trainer and a virtual battlespace simulator. Both simulators are used to train fire support teams, or FiSTers, before live firing. The evaluators from 3-15 Inf. train and certify first, then the evaluators train the rest of the fire support team Soldiers.

The first step to certification is individual training on the technical skills required to fire safely and accurately. Artillery table I includes a position-specific written test and a hands-on artillery skills proficiency test, administered under the supervision of the bat-

talion master gunner/digital master gunner/fire support master gunner.

"A couple of months prior to certifying, we train to call for fire and study general FiSTer knowledge," said Pfc. Brady Misencik, a fire support team Soldier assigned to 3-15 Inf. "We study joint fire observation, munitions platforms, basic call for fire, and radio etiquette."

After individual FiST Soldiers are well versed in general knowledge and tasks, they move to the virtual simulators. There are several different skill level tests a Soldier must complete in order to certify. Skill level one Soldiers are tested on 12 simulations, skill level two Soldiers require 18 to certify, and 20 are required for advanced-level Soldiers.


"The simulations use populated targets to test Soldiers on their ability to accurately call for fire in a grid location," said Sgt. Casey Martin, an evaluator for 3-15 Inf. "After each Soldier passes their skill level tests,

they are certified as a team and operate as a crew on the BFiST, just like any infantry crew."

Once all Soldiers and senior leaders on the fire support teams pass, they are considered certified as a company. Fire support team senior leaders then come together to create a plan for the battalion call-for-fire plan.

"After certifying on the simulators, the leadership come together as a company to plan for a call-for-fire event," said 2nd Lt. Johanna Forbes, a fire support officer assigned to 3-15 Inf. "At this point, the companies are all certified as fire support teams and crews. They are ready and able to execute any mission."


Spartan Brigade's BFiST teams are certified through execution of simulated training, Spartan Focus, and the brigade's rotation at the National Training Center in May. This qualifies each Battalions' BFiST team to support the Spartan Brigade while deployed.

## Raider Soldiers head to Fort Polk to support light infantry rotations

The “Desert Rogues” of 1st Battalion, 64th Armor Regiment, 1st Armored Brigade Combat Team, 3rd Infantry Division, are trading in the mountains of Korea for the swamps of Louisiana where two of their companies supported light infantry rotations at the Joint Readiness Training Center, Fort Polk, Louisiana.

Soldiers from Charlie Company, completed gunnery,

and partner units from 2ABCT, departed for Fort Polk over the weekend. They will support the 3rd Brigade, 101st Airborne Division during their rotation. Alpha Company will follow behind in support of 3rd Brigade, 10th Mountain Division.

Capt. Ben Novak took command of Company A, 1-64 Armor in January after serving as the battalion's assistant operations officer during the rotation in Korea.

“Our operational focus is preparing for the dismounted fight as opposed to the heavy tank engagements we trained for in Korea,” said Novak. “Specifically training for survivability against enemy air and artillery assets that will be targeting us as the only armored element in the brigade.”

It is quite a change from the mission in Korea. While the battalion was headquartered south of Seoul at Camp Humphreys, most training and all gunnery was conducted at Rodriguez Live Fire Complex near the Demilitarized Zone.

The companies from 1-64 Armor will also include additional enablers from the 3rd Brigade Support Battalion and the 1st Battalion, 41st Field Artillery Regiment. Together they will make up the mechanized element for the light infantry brigade combat teams.

“Adding an armored/mechanized company increases the brigade's lethality, speed, and ability to employ a striking force capable of destroy-

ing an enemy counterattack,” said Maj. Levi Thompson, operations officer, 3rd Infantry Brigade Combat Team, 101st Airborne Division. “The ability to employ mechanized and light forces together at the Joint Readiness Training Center increases our ability to effectively fight as a combined arms team, building lessons learned, exploiting capabilities, and increasing a shared understanding before executing in actual combat.”

Part of the JRTC rotation is a live-fire portion which requires crews to be qualified before they arrive at Fort Polk. The 1ABCT tank and Bradley crews were able to qualify during 2ABCT's gunnery. “Spartan Brigade” Soldiers completed their qualification tables in preparation for an April rotation at the National Training Center at Fort Irwin, California. They were also able to facilitate the individual and collective gunnery tables for 1ABCT Soldiers.

“The biggest challenge was working the details between the two brigades to slot our crews into their gun line in a short amount of time,” said Sgt. 1st Class Jason Gamble, 1ABCT Bradley Master Gunner. “The senior leaders, planners, and master gunners from the Spartan Brigade made it easy to integrate our 14 tank crews and 17 Bradley crews into their training plan.”

Raider Brigade Soldiers will support additional rotations at both Fort Polk and the National Training Center throughout the year augmenting rotational units, providing opposing forces, and mentoring rotational units in observer, coach, trainer roles.

# Severe weather warnings announced: stay tuned, ready

The Fort Stewart-Hunter Army Airfield Emergency Operations Center initiated the installation's Emergency Warning System, March 3, following a tornado warning from the 26th Operational Weather Squadron.

Emergency operations officer, Eric Waters, said Fort Stewart initiated the EWS immediately after the notice, which included the Big Voice public address system, the AtHoc (text, email, and phone notification). Moments later, the warning was also sent out by via social media and the website's electronic notification.

While the tornado did not touch down on the installation, emergency manager, Randall McPherson, said early warning via local warning apps (e.g. AtHoc, Alert Liberty, Code Red, Red Cross, GEMA) and tuning to local weather channels, can greatly impact family preparedness to mitigate the threat of severe weather and be prepared before it arrives.

Fort Stewart and Hunter Army Airfield encourages community members to learn about severe weather preparedness and remain attentive to not only the installation's communication efforts, throughout the spring and through hurricane season, (June 1 through Nov. 30).

Last year, the National Oceanic and Atmospheric Administration, at <http://www.nhc.noaa.gov>, predicted 9-13 named storms with four to seven hurricanes would affect the Atlantic region. The season ended with ten named storms, five developed into hur-

ricanes. This season's prediction should be released not later than late March to early April.

While the NOAA prediction isn't yet available for 2019, the installation EOC reminds people to remain vigilant and learn about making an Ready Kit. The Fort Stewart website at <https://home.army.mil/stewart/index.php/my-fort/community/hurricane-center>, provides readiness information for a variety of weather and other events.

The installation also uses social media platforms such as [www.facebook.com/FortStewartHunterArmyAirfield](http://www.facebook.com/FortStewartHunterArmyAirfield). Community members can tune in to those sites for warnings, road conditions, and threat awareness tips.

Waters said it was a good idea for Soldiers and their Families to keep their information updated on the Army Disaster Personnel Accountability and Assessment System at <https://adpaas.army.mil>.

The ADPAAS system provides a standardized method for the Army to account, assess, manage, and monitor accountability and recovery process for personnel and their Families affected and/or scattered by a wide-spread catastrophic event. It is designed to help Soldiers, Family Members, and leaders maintain accountability for personnel away from their home station; provides a system to track Soldier and Family Member locations; helps evaluate their needs; coordinate assistance, and provide reference information. So stay prepared, remain vigilant, and stay tuned to the installations' communication platforms for updates.

# Army FY20 budget proposal realigns \$30 billion

**WASHINGTON** -- The Army is slated to release its fiscal year 2020 budget request on March 12, which will include the realignment of nearly \$30 billion over the next five years to improve readiness and better support the Army's six modernization priorities.

"We've been very consistent about where we're trying to take the Army ... by 2028," said Under Secretary of the Army Ryan D. McCarthy. "We are trying to enable the National Defense Strategy, and we have taken some pretty dramatic steps to get there."

The under secretary discussed the Army's upcoming budget request during the Association of the U.S. Army's Institute of Land Warfare breakfast series in Arlington, Virginia, Tuesday morning.

While McCarthy didn't go into a line-by-line detail about the upcoming budget, he shared that the FY20 request will include, "\$8 billion in cost avoidance, and about \$22 billion in cuts or terminations."

Further, a portion of the request will help fund the science and technology community, supporting the "31 signature priorities" outlined in the FY18 and FY19 budgets.

Freeing up \$30 billion was no easy task. Last year, Secretary of the Army Mark T. Esper and Chief of Staff Gen. Mark A. Milley ordered a comprehensive review of the entire budget. Army senior leaders, staff officers, and major commanders from all three components participated in the process, he said.

"We ran through every program in the budget," McCarthy said. "They branded it 'night court,' because it had that shark tank (feel). You went in there and you'd try to explain your program to the leadership. If it didn't survive -- it was out."

"We need to be better with every dollar that taxpayers give us," he said, adding Esper and Milley are trying to change the "fundamental behavior of the Army."

After the budget proposal is released, Army leaders will engage with Congressional leaders to justify the request. However, with this year's shortened approval timeline, McCarthy acknowledges the challenge Congress will face in passing the FY20 budget.

Failing to pass a budget could result in a series of continuing resolutions and alter the Army's agenda.

"Continuing resolutions breed mediocrity," he said. "You can't have predictability in an environment where you're getting an installment every three or six months. How (will) companies know if they're going to get paid

or not? How can you get the system primed to hit at optimal levels?"

The Army will need to work very hard with Congress during the posture hearings to get them the information they need, McCarthy said, so they can pass both the authorization and appropriation bills by Oct. 1.



# Town hall illuminates issues, initiates repair process at Stewart, Hunter

More than 250 community members attended the Fort Stewart Housing town hall meeting, Feb. 27 on Fort Stewart held at the Main Post Chapel.

Maj. Gen. Lee Quintas, as the installation senior commander and 3rd Infantry Division commanding general, opened the event, and explained the town hall was held to answer an Army-wide concern regarding on-post housing and barracks living conditions.

Desiring transparency, the command led off the event with a CBS Evening News story with Chip Reid, who interviewed Secretary of the Army Mark Esper and Sergeant Major of the Army Daniel Dailey, about Army housing conditions. During that interview, Esper apologized about the condition of thousands of military houses, which are maintained by private contractors. Esper also said he desired a clear Bill of Rights for housing residents that they can bring to their chain of command.

Quintas brought subject matter experts from the garrison staff, the chain of command and representatives from the private contractor who manages Fort Stewart-Hunter Army Airfield housing - Balfour Beatty Communities. He explained they could help answer questions and help initiate work-orders following the meeting.

The commander said his intent for the meeting was first to gain consent so the chain of command could conduct assessments of Fort Stewart housing. Second, to explain the inspection process and to explain what they were looking for to help ensure the health and safety of residents. And lastly, to arm community members with knowledge of the work order process and encourage attendees to be part of the feedback process.

The 3rd ID senior enlisted leader, Command Sgt. Maj. Michael J. Coffey, an on-post resident himself, said company commanders and first sergeants would help with the health and safety inspections, but they needed help, noting no Soldier should live in conditions that are unhealthy or unsafe.

“We need you as tenants of Fort Stewart and Hunter Army Airfield, to get involved in the process,” Coffey said.

To help community members understand what an assessment looked like, Balfour Beatty Communities produced a what-to-look for video, conducting a walk-through of a house on Stewart.

## Health and safety tips:

- Drinking water. Check the color.
- Cabinets and pantries. Check for ventilation.
- Doors to rooms, closets, cabinets and pantries. Make sure doors open easily.
- Lighting. Ensure they work and provide adequate visibility.
- Bathrooms. Check for discolored walls due to water

damage or mold; and ventilation.

- Walls throughout the house. Look for paint cracking, chipping, or peeling. For houses constructed prior to 1978 this issues elevates to urgent level, as lead based paint was commonly used then.

- Smoke detectors and firestop. Make sure they are present and functional. (The video noted the firestops are normally founder under the stove's ventilation fan/hood.

- Child fall sticker. Make sure the stickers are present for two story dwellings.

- Pest indicators. Normally found in corners or tight spaces.

The garrison commander, Col. Jason Wolter, then walked attendees through the reporting process. He noted access to reporting could be found using the installation's social media platforms, website and included a hotline, 767-5770. He said there are dedicated response times, depending on the severity of the issue. Wolter explained how and where to submit a work order, the time standards for the work order and how to engage quality control.

## Housing response standards:

- Emergencies during duty days, 30 minutes or less; one-hour for non-duty days.
- Urgent, four hours.
- Routine, 48 hours.

For Barracks, he noted three ways for reporting issues, the Demand Maintenance Order (767-2883) online at <https://home.army.mil/stewart/index.php/contact/service-order-request>; the Area Barracks Management

Team; and the chain of command.

## Barracks response standards:

- Emergency, 1 hours
- Urgent, 7 days
- Routine, 30 days

Balfour Beatty Communities has a three-step process for reporting issue, illustrated on the Fort Stewart website at <https://home.army.mil/stewart/index.php/housing>. First, contact the local management or maintenance team; second, if you are not satisfied or your request is incomplete, contact management. Third, if the issue remains unresolved, contact Army housing.

Following the briefing, the command opened the town hall up to questions and concerns. One major concern was older housing, especially those built prior to 1978 which may have lead based paint.

Balfour Beatty Communities' Regional Director, Bo Letnaunchyn, said they were aware of concerns, but noted while about 40 percent of the on-post houses were newer homes, encapsulating lead based paint mitigates the threat. He said if community members saw indicators of paint cracking, chipping or peeling, the work order would be escalated to address the issue.

Many questions revolved around a lack of responsiveness or sense of urgency. To address the concerns BBC established on-site stations at the back of the town hall to immediately record and follow-up on concerns.

Another town hall was held earlier, Feb. 27, on Hunter Army Airfield at the Hunter Chapel with about 75 community members in attendance. They expressed similar concerns to those heard at Fort Stewart.

# CHAPLAIN'S CORNER: SNAKE-LIKE, JESUS

One of my family's favorite games to play when we get together is "Apples to Apples." It's a word association game. The object is to play a card with a noun or name that most closely connects with the adjective on the card atop the center pile.

Let's imagine, today, the face-up card says "snake-like". None of us would even think about playing the Jesus card, if we held it. But, strangely enough, according to John's Gospel, Jesus himself just might.

*"Just as Moses lifted up the serpent in the wilderness, so must the Son of Man be lifted up."* **John 3:14**

The reference is a fairly obscure story from **Numbers** which fits that book's unfortunate recurring pattern. The people of Israel sin, God punishes them, Moses intercedes, and after a several casualties are tallied, God saves the people as a whole. In earlier examples within the pattern, we find God sometimes requiring a visual sign to be set as a reminder of the failure. Something a bit different occurs in the story of the snake-bitten rebels. The people complain again about food and water and suggest they'd have been better off staying put in Egypt. God punishes them by sending venomous snakes, many deaths prompt those still alive to repent. Moses prays, and God offers a means of healing, a bronze snake for those bitten to look upon. This time, however, visible sign are given during the event, rather than as a reminder afterwards.

The brevity of the account has led some people to read between the lines on the part of interpreters. The most compelling hypothesis is this rebellion, the final such story in **Numbers**, represented an even more serious insult to God than previous examples.

Key to this view is the last part of **Numbers 21:5**, when the people cry *"we loathe this miserable food."* In other words, they are calling worthless, what God had graciously provided. I believe the reason the visible sign comes earlier in the story is God wanted them to look fully upon their sin before they received healing.

Some scholars suggest a bronze serpent would have been a particularly offensive symbol.

Similarly, historians tell us that the cross didn't become a symbol among Christians until those old enough to have actually witnessed a crucifixion had died. In both cases, God is saying the same thing to His rebellious children. "Take a good look; this is how ugly your sin really is."

The scriptures remind us of something that is true in any relationship in which a serious rift has occurred. Reconciliation requires both offended and offender honestly look at the offense. Only then is forgiveness and restoration possible. We also learn, sometimes the injured person needs to take the initiative and let the hurtful person know, "This is what your action looked like from my perspective."

God certainly did that with humanity. In the cross, Jesus simultaneously reveals the unforgivable offensiveness of humanity's rebellion and the unbelievable love and forgiveness of a Holy God.

Lent is the season to look painfully and thankfully upon the cross. Just as God saved those ungrateful, disobedient, and impatient Hebrews by means of a really painful experience, we can be confident that God is patient and willing to forgive us.

Let us be open to whatever is needed in our lives to grow our faith, to draw us into the light, and to help us live by His truth. But please, God, don't let it involve snakes!

## Be careful what you flush

The water treatment plant on Fort Stewart quickly cleaned up a recent minor sanitary spill that did not reach drains or waterways.

The spill was contained to the facility's parking lot. Upon investigation, a blockage of disposable wipes in the sanitary collection system caused the spill.

Grease, oil, and fat also clog pipes and sewer lines and are common causes for overflows. Flushing baby wipes, makeup remover wipes, plastic bags, and other objects down toilets causes the same problem. These items become stuck within the sewer system, restricting the flow before blocking the system completely.

Any solid matter that is put down the toilet has the potential to cause blockages in the drainage system. Flushing foreign objects such as baby wipes, makeup remover wipes, sanitary napkins, and other objects--even if they claim to be flushable--can be disastrous.

Clogged toilets can overflow into homes resulting in huge cleanup efforts and destruction of property. Furthermore, blockages within the sanitary collection system can result in gallons of wastewater overflowing into homes, parks, yards, streets, ditches, streams, and other waterways.

The only things you should ever flush down a toilet are human waste and toilet paper. Even though some products such as wipes and baby diapers claim to be flushable, they do not break down easily or quickly enough, clogging sewage treatment systems and causing sewage spills.

Do not flush any type of wipe down the toilet. Other items not to flush include diapers, feminine products, paper towels, cotton balls and swabs, condoms, bandages, rags, plastic bags, or even flushable cat litter.

With your assistance, we can minimize the probability of unpleasant smells, annoyances, and inconveniences associated with sanitary spills.

# Marne Air Safety Guardian to Guardian Angels

Marne Air Soldiers from 3rd Squadron, 17th Cavalry Regiment, 3rd Combat Aviation Brigade, 3rd Infantry Division honored two Safety Guardian recipients Feb. 28 on Hunter Army Airfield for their reaction to an emergency car accident Nov. 5, in Tucson, Arizona.

The Safety Guardian award is awarded to an individual who has performed with extraordinary action or skill to an emergency event which eliminated or minimized loss such as damage to Army property or injury to Army personnel.

"This award is for reacting to a car accident while in support of the Defense Support of Civil authorities and Defense chemical, biological, radiological and nuclear response force mission in Tucson, Arizona," said Staff Sgt. Joseph O'Donnell, a supply noncommissioned officer for 3rd CAB. "My counterpart and I was coming up to a stoplight when we noticed a sports utility vehicle on its side smoking."

O'Donnell is a North Carolina native with a wife and three sons, he took no reservation to help the owner of the SUV to get to safety.

"It looked like a really bad accident, I told the Soldier who was driving to stop the car so I could asses the accident said O'Donnell. "At this time, when we both got eyes on the civilian woman in the SUV, we knew we had

to get her out soon."

The SUV had a sunroof, it is also were O'Donnell and Chief Warrant Officer Two Phillip Bogard, a maintenance technician for 3-17 Cav., were able to get the civilian woman out of the SUV.

"We got a blanket from the back of our car to cover the opening of the sunroof to prevent her from being cut while trying to extract her from the vehicle," said Phillip. "After the extraction, a police officer was on scene to assess and direct in which he thanked us and released us from the scene."

Phillip is an Alabama native with a wife and two children and within the moments he hopped out of his car there was no hesitation in going to the car accident. Phillip was a Marne Air Soldier on a mission.

"There were no medical personnel there to help the woman, so both O'Donnell and I felt obligated to help and make sure she was okay and out of her SUV," said Phillip. "We were both concern about the SUV catching on fire, everything was pure adrenaline and reaction."

As Marne Air Soldiers continue their dedication to their mission and readiness one constant that will never change is their dedication to the people of the United States.

"I believe any Soldier would do this, It is built in us since day one to help others, it is what we do," said Phillips. "I would do it again for any family and person it was never about an award."

# Army CID warns of internet sextortion scams

QUANTICO, VA. – As part of a continuing campaign to help prevent Soldiers and other members of the Army community from becoming victims of crime, Special Agents from the U.S. Army Criminal Investigation Command are cautioning the Army community about ongoing Internet based “sextortion” scams.

Sexual extortion, or “sextortion,” is a cybercrime perpetrated against unwitting victims who are often approached in casual conversation via social media platforms and then seduced into engaging in online sexual activities. After participating in the sexual request, which are most often recorded without the victim’s knowledge or consent, the victim is then threatened by the criminals with public exposure and embarrassment if the victim does not pay money to the extortionist.

According to military officials, more than 450 known military members from all services have fallen victim to the scam and have been blackmailed for more than \$560,000 dollars, and those numbers do not include the number of victims who have not come forward.

With the criminals threatening to send compromising video or photographs to the victim’s commanders or families, victimized military members often pay out of fear that their careers will be jeopardized by the false claims. In another version of the scam, the criminals contacts the victim and poses as police or parents of who they claim is an “underage victim”

and threaten to ruin the service member’s career or have them arrested if they do not pay the ransom.

Another method the criminals use to attempt to extort money is to claim that they are a lawyer working on behalf of the alleged victim. The scammer will request payments for things such as counseling for the alleged victim or to replace electronic devices that now contain alleged “child pornography.” If these demands are not met, the person claiming to be the lawyer threatens to report the incident to law enforcement.

“Legitimate organizations will not contact you and ask for money in lieu of reporting you to law enforcement,” said Special Agent Edward LaBarge, the head of Army CID’s highly specialized Computer Crime Investigative Unit. “Typically law enforcement will not attempt to make contact with you over the phone. If you are contacted via telephone, always request validating information such as an agency email address and offer to meet in person at a law enforcement facility before proceeding with giving out your personal information.”

Army CID officials stress that if an individual is being blackmailed and comes forward, they want to help that individual.

“It is important to also keep in mind that law enforcement, to include Army CID, will never agree not take legal action against you if you have agreed to pay [ransom] money to the alleged victim or to the alleged victim’s family,” LaBarge said.

# Army takes down Marines to win Armed Forces wrestling

**FORT BLISS, Texas** -- The Army won seven of 10 matches Saturday against the Marine Corps to capture the Greco-Roman title and came back Sunday to beat the Marines in free-style wrestling to win the Armed Forces title in both disciplines for the 18th consecutive year.

## Greco-Roman

Both the Army and Marine Corps began the tournament by winning every single match of their first two dual meets against the Air Force and Navy, setting up a show-down for the title.

Fueled by a strong start in the light-weights, Army won its first four matches against the Marines, all with bonus-point victories.

The Army's Staff Sgt. Max Nowry, a double champion at the 2018 Armed Forces, came out with a strong 8-0 technical fall at 55 kg over Sgt. Jamone Carter. He was followed by 2017 World Team member Ildar Hafizov, who got the Army team fired up with a pin over Lance Cpl. German Diaz in 1:24.

The next bout proved to be huge. The Marine Corps sent out 2018 Armed Forces champion Sgt. Xavier Johnson, a National Team member who is coming off a big second-place finish at the Grand Prix Zagreb Open. The Army sent out Pvt. Hayden Tuma, an athlete with extensive World Championships experience.

Tuma shut the door on the Marines desire to change the momentum, tossing Johnson on the way to an 8-0 technical fall. One of the matches the Marines needed, if they hoped to win this year, went to the Army in a big way.

The Army run continued at 67 kg, as 2008 Olympian and two-time World Team member Ellis Coleman kept up the pressure with a 9-0 technical fall over 2nd Lt. Jamel Johnson. The team score after four matches was 17-0, with only six more bouts for the Marines to change the narrative.

Sgt Raymond Bunker of the Marines, who had been a silver medalist in this event a number of times, scored the first Marine Corps win, stopping Army 2nd Lt. Michael Hooker in a 3-3 criteria decision.

At 77kg/169.7 lbs., Sgt. Vladyslav Dombrovskiy got the Army back on track in an intense battle with 1st Lt. Payton

Walsh, who has been a National Team member. Dombrovskiy won some key positions and emerged with a 17-7 technical fall.

At 82kg, in another aggressive match between two warriors, Sgt. John Stefanowicz of the Marines beat Maj. Jon Anderson of the Army, 4-1. Both were past Armed Forces Greco-Roman champions.

Spc. James Souza, who won an Armed Forces title in 2015 when he competed with the U.S. Navy, claimed his first Armed Forces gold as a member of the Army with a powerful 10-0 technical fall over Sgt Vaughn Monreal Berner.

In a battle of National Team members, Capt. Daniel Miller of the Marines edged SGT Lucas Sheridan, 2-1. Miller is ranked No. 2 in the nation and Sheridan is No. 3 on the ladder.

Army big man, 2nd Lt. Toby Erickson was dominant on top, turning Sgt. Trent Osnes multiple times in an 8-0 technical fall to close out the win.

The Army had seven champions and three runners-up.

## Free-Style Match

For the Army to win the free-style competition for the 18th straight year was anything but easy with a talented and motivated Marine Corps team across from them on the mat.

Army started off with confidence, as Staff Sgt. Max Nowry defeated Sgt Christian Martin, 7-4 at 57 kg, and Spc. Leslie Fuenffinger pinned 1stLt Colton Rasche in 4:35 at 61 kg.

The 65 kg match gave the Marines their first victory. Lt. Jamel Johnson defeated Hayden Tuma in an 11-0 technical fall. Tuma suffered an injury in his bout and continued regardless, but could not keep up with Johnson, who secured the bonus-point victory. Army led 8-5 at that point, and the Marines were looking to start a rally of their own.

As has been the case in years past, after the Army suffered a setback, the next Soldiers on the mat raised the stakes even higher to keep the Marines at bay. In this case, the Army response to Tuma's defeat was to reel off a pair of technical fall wins.

At 70 kg, Spc. Isaac Dukes, a Div. III national champion for Case Reserve in Ohio, lit up the scoreboard to beat 2019 Armed Forces Greco-Roman champion

Sgt. Raymond Bunker, 10-0. It was Duke's fourth straight Armed Forces freestyle title.

Not to be outdone, 2nd Lt. Michael Hooker added an 11-0 technical fall over Lance Cpl. Ali Marciano at 74 kg. On Saturday, Hooker's streak of four straight Greco-Roman Armed Forces titles got snapped with a loss to Bunker, and he came back with extra fire in the freestyle tournament. This gave the Army a 16-5 lead halfway through the dual meet.

The Marine Corps never quits, and that was the case in this dual meet. In a classic battle which saw the lead change and had some fierce action, 1st Lt. Payton Walsh of the Marines edged Sgt. Vladyslav Dombrovskiy of the Army, 9-8. Walsh was an EIWA champion and three-time NCAA qualifier for the U.S. Naval Academy, and Dombrovskiy has been a multiple All-American at the U.S. Open in freestyle. Walsh's win lifted the spirits of the Marine faithful, which still had hopes for a late rally.

It was not going to happen. Maj. Jon Anderson of the Army avenged a loss in the Greco-Roman finals to Sgt. Jon Stefanowicz on Saturday, with an inspiring 9-1 win over Stefanowicz on Sunday. At 34

years old, Anderson is the grandpa on the Army team, and is a walking definition of the word "grit." Anderson's win made a Marine Corps comeback highly unlikely.

The Army victory was sealed mathematically when powerful Spc. James Souza of the Army pinned 2nd Lt. Terrence Zaleski of the Marines in 1:50 at 92 kg.

The Army, however, was not done showing its skill and character. In a battle of former Div. I talents, Sgt. Lucas Sheridan avenged his loss to Capt. Daniel Miller from Saturday's Greco-Roman finals dual. Sheridan was able to hit one of his patented headlocks in the first period and went on to defeat Miller, 5-0.

With the title already mathematically Army's, the Marines did not send out their heavyweight, and Spc. Jacob Mitchell received a forfeit to end the match.

There were only two double champions this year, with Nowry and Souza the only wrestlers to claim gold medals in both freestyle and Greco-Roman this weekend. Nowry, Fuenffinger, Dukes and Mitchell defended their 2018 freestyle titles.
