# Marne 6 sends: Providing an update to G01

We appreciate all our Soldiers' and Families' patience and continued efforts to reduce the spread of COVID-19 within our formations. Your dedication to maintaining our mission readiness is a balancing act of smart training and minimization of opportunities for COVID-19 transmission.

We have a responsibility to our Army and as members of our immediate communities to get this right. I'd like to eliminate any ambiguity about the updated restrictions and keep our most valuable resources - Soldiers and Families - healthy and safe.

Of course, we can only maintain forward progress if all of us continue to follow the required guidelines and social distancing to reduce the impact of COVID-19.

On Sept. 11, we published an update to General Order 1, which included additions to permitted business and activities, such as bowling alleys, off-post gyms, and indoor dining at restaurants, providing that establishment is adhering to social distancing and mask wear by their employees.

Things that remain off limits includes: indoor movie theaters, amusement parks, bars (including those in restaurants), night clubs and tattoo parlors.

The local leave and pass radius is 200 miles surrounding Fort Stewart, and if you will be away from home more than 24 hours, you must have a signed leave or pass form.

There has been no change to the approval authorities for leaves and passes but the areas considered high risk

now include: Houston, Atlanta, and the states of Mississippi Alabama, North and South Dakota and Florida.

Travel to these locations requires battalion commander approval and quarantine upon return. All OCONUS travel requires a negative COVID test or medical clearance no sooner than seven days prior to departure. PCS moves still require ETPs based on the COVID-19 transmission rates and facilities available in the areas traveling to, and areas traveling through.

Please remember that it is a collaborative effort to minimize transmission rates and ensure continued forward progress toward reducing restrictions.

Continue to follow 3rd ID on social media for our future town hall meetings and updates. If you have questions about your PCS moves or other travel, bring those to your chain of command.

Stay safe, stay strong, take care of yourselves, take care of each other.

We are all Dogfaced Soldiers.

# Dogface Soldier returns as division's top enlisted advisor

Command Sgt. Maj. Quentin Fenderson assumed responsibility as the 3rd Infantry Division's top enlisted advisor in a ceremony Sept. 23, at the Marne Garden on Fort Stewart.

Maj. Gen. Tony Aguto, 3rd ID commanding general and the ceremony's reviewing officer, reminded guests of how 3rd ID earned its reputation as "The Rock of Marne" during WWI, when Division Soldiers defended the Marne River in France from advancing German troops.

"Our Dogface Soldiers stood their ground like a rock along their positions on the Marne," Aguto said. "Fenderson is no stranger to this Division. No one represents our Rock of the Marne better. There is no better trainer, leader, or rock, and we are honored to have him here."

During Fenderson's previous stint with 3rd ID, he deployed four times in support of Operation Iraqi Freedom. During OIF I and III, he served as a platoon sergeant and battalion master gunner assigned to 1st Battalion, 30th Infantry Regiment, 3rd Armored Brigade Combat Team. He deployed again for OIF V and VII, served in the latter as a company first sergeant in 2nd Bn., 69th Armored Regiment, 2ABCT. In addition to his four deployments to Iraq, Fenderson's career has taken him to Bosnia, Macedonia, Egypt and Afghanistan.

"It was the people around me from this Division who always supported me and who always encouraged me," Fenderson said. "So, to be able to come back, and be able to give from this position is amazing to me."

Fenderson believes his greatest responsibility as the division's senior enlisted advisor is to develop an environment in which Soldiers, Family members, and civilian employees throughout the organization are supported and treated fairly and equally. Fenderson added that he appreciates the standards set by his predecessors: Command Sgts. Maj. Michael Coffey, James McGuffy, and Jesse Andrews. He said he is proud to follow in their footsteps.

"We have a small-town feel here in that we all take care of one another," Fenderson said. "By making sure our people are taken care of, we can better focus on serving our nation."

Fenderson was born and raised in Demopolis, a small town at the confluence of the Black Warrior and Tombigbee rivers in western Alabama. According to Fenderson, growing up in his neighborhood was like

being raised by a village.

"You could do something wrong down the street and get a big whooping, and then by the time you get home, you might get another whooping," Fenderson said. "That's how close the community was."

Fenderson participated in sports throughout his childhood, and following high school he played baseball at the collegiate level. Becoming an Army division command sergeant major never crossed his mind until after he arrived to 3rd ID as an infantryman. Fenderson would serve 12 years in the 3rd ID and it was during this time that he realized becoming a command sergeant major was a goal he had the ability and drive to achieve. He said there is no other division in which he would rather serve as the senior enlisted advisor than the 3rd ID.

Fenderson thanked those in attendance, including his family and more than a dozen former and current sergeants major.

"Throughout my career I've been given what I consider the most important thing one can ever receive: an opportunity," said Fenderson. "Each of you in some form or another have given me the opportunity to lead, to learn, and to mentor. I know I wouldn't be here without you."

# Blackjack Soldiers receive latest UAVs

The “Blackjack” Soldiers from Troop B, 3rd Squadron, 17th Cavalry Regiment, 3rd Infantry Division, received the latest model of the RQ-7Bv2 Shadow unmanned aircraft systems, Sept. 22 at Evans Army Airfield.

The Shadow is capable of assisting ground and aviation units with surveillance and reconnaissance: spotting threats, monitoring vehicle movements, or providing grid locations with its video technology. This information allows the units to conduct missions more efficiently and effectively.

The upgraded version of the UAS is visually similar to the pre-

vious model, but with several improvements.

“Our flight endurance has gone up significantly with this newer model,” said Spc. Edward Clark, an unmanned aircraft systems operator with Troop B, 3rd Sqn., 17th Cav. Rgmt.

Larger fuel storages means longer flight time. In addition to the increased range, the new version of the Shadow meets increased requirements for higher levels of communications security.

“Operating the Shadow is a team effort,” Clark said. “From the maintainers performing equipment safety checks, to the operators ensuring the electronics systems are operational, we rely on each other pretty heavily to accomplish the mission.”

# Leaders seek feedback to improve inclusion in Army

**WASHINGTON**— Army senior leaders continue to prioritize efforts to advance diversity, equality, and inclusion across the ranks, including a series of national listening sessions and finding ways to better select leaders.

In June, Army Secretary Ryan D. McCarthy and Army Chief of Staff Gen. James C. McConville announced “Project Inclusion,” the operational arm of the Army People Strategy’s five-year plan for DEI.

The Army is determined to put systems in place to create a positive work environment and understand the needs of all personnel, said E. Casey Wardynski, assistant secretary of the Army for manpower and reserve affairs.

“Our goal is to bring them together to build a strong common culture that supports the development of cohesive teams” to accomplish the Army’s mission, Wardynski said during a media event Thursday.

## Listening sessions

To do this, Army leaders have participated in an ongoing series of listening sessions, with the most recent event taking place at the Pentagon in Washington, D.C., earlier this month.

Each session allows Soldiers and

civilians to openly discuss issues that impact readiness and inclusiveness, said Anselm Beach, the deputy assistant secretary of the Army for equity and inclusion.

“Soldiers and civilians need [the opportunity] to invest in these policies,” Beach said. “We want to make a full investment and get it as close to ‘right,’ as possible.”

Although COVID-19 has kept many leaders from meeting and interacting in person, Army personnel still have shown their willingness to participate in each listening session, he added.

Personnel at Fort Belvoir, Virginia, will be able to participate in the next virtual listening session on Sept. 29, G-1 officials said. Army leaders have also scheduled online or in-person visits to Fort Bragg, North Carolina; and Joint Base San Antonio, Texas, in October; and sessions at Fort Benning, Georgia; and Fort Stewart, Georgia, in November. Sessions in South Korea; Hawaii; and Fort Irwin, California, are being planned for December.

Additional sessions are slated to take place at many other Army locations in 2021.

“There have been a lot of people who are engaged in these listening sessions,” Beach added. “Not only are they sharing their life experiences, but they are also forward-thinking. Their ideas are not focused on

what is going on right now.” They are also centered “on where the Army should be heading” in the future.

The Army continues to be at the forefront of change as the force shifts the conversation around the construct of DEI, Beach said.

“We are moving beyond a [one-dimensional] description about diversity,” said Beach, adding that the term “diversity” is more than just a visual representation of the force.

“If people feel as though they need to have one of each [person] to ensure there is diversity, that will create tokenism,” he added. In turn, the Army looks to leverage “diversity by ensuring that we bring the skills and talents” of all Soldiers and civilians to bear.

## Talent management

Part of the Army People Strategy also includes efforts to improve talent management and processes on how the force acquires, employs, and retains personnel.

The Army is developing a 21st-century approach to talent management, starting with the officer corps, said Lt. Gen. Gary Brito, the Army’s deputy chief of staff, G-1. Leaders now have the option to evaluate and assign officers based on their knowledge, skills, behaviors, and preferences.

It is important to “create an environment where every single Soldier

[and civilian], regardless of their race, gender, religion, or background, has opportunities to excel -- warranted off their proven and demonstrated talents,” Brito said.

Some of the changes for officers include the Battalion Commander and Colonels Command Assessment Programs, or BCAP and CCAP respectively, which now ensure the best leaders step into critical leadership roles after going through multiple assessments.

The Army has also launched the Talent-Based Branching program, or TBB, a market approach that addresses a cadet’s branch preference, Wardynski said. Previously, the Army would review an officer’s overall class performance to match their career path to the force’s needs. Under TBB, future leaders will now have a choice of branch predetermined by their talents and interest.

To bolster diversity and talent across the force, the Army will also engage with science, technology, engineering and math high school students through the Junior Reserve Officer Training Corps, Wardynski said.

“One of the goals of JROTC is to inspire young adults into service,” he added. “We are in 10% of the high schools in America. We are creating a STEM JROTC curriculum focused initially on cybersecurity and coding, to build interest in those fields.”

# Army cleanups support installation readiness

**SAN ANTONIO**— The Army's Environmental Restoration Program, more commonly known as the Army Cleanup Program, addresses a variety of hazardous contaminants and military munitions on Army installations across the globe to bolster readiness. The initiative stemmed from the Defense Environmental Restoration Program, established in 1986 by the Department of Defense.

The mission is to ensure compliance with applicable federal and state environmental regulations, protect human health and the environment, and enable readiness by returning Army lands to usable condition. By performing cost-effective remediation on contaminated sites, cleanup efforts have enabled installations to expand and carry out critical missions.

"We deliver cost-effective environmental services globally to enable Army readiness by providing expertise, program management and project management in compliance, conservation, restoration and pollution prevention," explained Hopeton Brown, Chief of Program and Liabilities Branch.

Under DERP guidance, the Army

Cleanup Program prioritizes remediation sites into high, medium and low priority categories primarily based on relative risk. The Army evaluates relative risk by the type of contaminant hazard, migration of contaminants, and the potential exposure to humans or plants and animals.

The Army creates an Installation Action Plan for each site with an active environmental restoration project. The IAP is often based on a multi-year approach; however, with Fort Huachuca in southeastern Arizona, the planned construction of a new electronic proving ground facility on a former landmine training site propelled it into a time critical removal action.

Fort Huachuca, a product of the Indian Wars of the 1870s and 1880s, sits at the base of the Huachuca Mountains and offered protection to settlers in southern Arizona. Today it integrates and delivers base support, including training, testing, communications and intelligence, to enable Army readiness. The new EPG includes a much-needed maintenance facility to test and repair unmanned aerial vehicles, more commonly known as drones.

The area designated for construction was undeveloped but located near existing buildings, making it more likely to contain

archaeological artifacts than environmental hazards. Therefore, the first priority was to conduct an archeological survey.

As the team of archaeologists were digging, they found a metal object identified as unexploded ordnance. The area was cordoned off and the project was suspended until an Explosive Ordnance Disposal team could respond, detonate the explosive, and determine if it was an isolated incident or if additional hazards remained.

The news was disheartening; the proposed construction site was an old landmine training site and still contained UXOs. The finding would delay the construction and potentially threaten the Army's ability to train Soldiers.

"In most cleanup projects, it takes years to get a site approved and funded and ready to begin work," said Roberto Rivera, U.S. Army Environmental Command environmental support manager. "But because this was a construction project that was critical to the readiness of the Army, we were able to get all the approvals, funding and boots on the ground much quicker."

The cleanup also paved the way for future construction. A campus with training facilities and administrative buildings is slated to be built within the next 10 years.

While the Fort Huachuca cleanup project was determined to be time-critical, many cleanup projects are deemed non-time-critical, meaning they are no less important but do not pose an immediate danger to Army readiness or personnel.

The multi-year, multi-phase process begins with site discovery, identifying installations with potential contaminants; followed by site inspection, determining if there has been a release to the environment; and finally, a remedial investigation, determining the extent of the contamination. The next phase includes the feasibility study, proposed plan, record of decision and finally, the cleanup. For some installations, this process is long term and could be ongoing for 20 or more years.

The Army continues to achieve its goal by providing technical expertise to enable Soldier readiness and sustainable military communities; however, as Roberto Rivera said, "These efforts will be ongoing throughout our lifetime. New methods and strategies will make the process easier, but at the heart of the mission is dedicated staff with the U.S. Army Environmental Command who act as liaisons between installations and other agencies, making the process more effective and efficient."

# Veteran couple brews up successful business through military program

A brewing hobby bubbled over into full-time jobs for two Fort Stewart veterans.

Kristen Boucher and retired Army Chief Warrant Officer 3 Jeremy Boucher opened the doors to Split Fin Brewing in Midway, Georgia, in June and both attribute their business' early success to the skills they gained while serving.

Jeremy, a native of Springfield, Massachusetts, most recently served as a maintenance technician with the 3rd Infantry Division on Fort Stewart and retired earlier this year after 22 years of service. Kristen, a native of Syracuse, New York, served as a chemical officer for four years before leaving the military in 2017. She now works as a Department of the Army civilian at Hunter Army Airfield.

The couple married in 2016 and said a brewery was definitely not in the plans at the time.

"I actually never drank beer until I met my wife," Jeremy said.

Fatefully, Kristen's aunt sent a winemaking kit years before. The next Christmas, the couple moved from winemaking to beer brewing and their hobby just kept growing.

As Jeremy neared the end of his career and began to prepare to transition to civilian life, the couple knew they needed a plan. Their beer-making hobby was blossoming and the couple joked that maybe they should start a brewery. Their jokes soon turned into reality.

"It just seemed like a logical thing to do: to open up a brewery, because we both loved home brewing so much," Kristen said.

With the support of his leadership at 3rd ID, Jeremy took part in an internship at a local brewery coordinated through the Army's Career Skills Program.

The internship program is designed to offer Service members no-cost training in specific industries.

The internship provided Jeremy vital insight into the workings of a brewery. It also helped ease his transition out of the military by providing him the chance to work in a civilian business for the first time in 22 years.

"I was scared to get out and be in the civilian workforce again," Jeremy said. "I felt more secure knowing that the Army had my back."

Both Kristen and Jeremy took part in Fort Stewart's Soldier for Life-Transition Assistance Program. SFL-TAP provides a number of classes to transitioning

Service members such as a Military Occupational Code Crosswalk to help define and translate military skills, financial planning classes and resiliency classes.

SFL-TAP also provides workshops to help Soldiers compare their current salary, benefits, and opportunities with those they might be able to attain in the private sector, as well as identify gaps in their military skills that may assist with civilian employment.

Jeremy and Kristen also used their GI Bill benefits to pursue master's degrees at Syracuse University's Martin J. Whitman School of Management. Kristen earned her master's in business administration and Jeremy earned his master's in emerging enterprise entrepreneurship.

The knowledge gained from the internship, SFL-TAP, and from their GI Bill-funded degrees helped the couple come up with a plan. They purchased brewing equipment, found a spot in their town and opened their doors.

Although their military service is complete, the couple said that the values they learned in the Army continue to play a huge role in their lives.

For Jeremy, the Army mantra of "never quit" is a cornerstone of his business outlook. No matter the challenge, Jeremy said the Army taught him to continue to push forward and overcome obstacles.

"Coming from the Army Values standpoint, I consider myself a Soldier for life," Jeremy said.

For Kristen, military service provided a mindset that she continues to use in civilian life.

"I think that being in the military, you have a different perspective on things," Kristen said. "I feel like we are able to operate efficiently and effectively, get the job done better, be a little more efficient."

Since their opening, Kristen and Jeremy said the coastal Georgia community, including a large number of local veterans, have embraced their business.

"Community support has been amazing," Jeremy said.

Although Fort Stewart Soldiers are currently unable to frequent the brewery due to COVID-19 restrictions, Jeremy is excited to see them when the restrictions lift.

While still new to the world of business ownership, Jeremy has advice for other Soldiers looking to start their own business.

"Do not be the one who always talks first; sit back and listen," Jeremy said. "No matter how good you are at something, there is someone out there that knows how to do it a better way. Learn to be humble."

He also encouraged transitioning Service mem-

bers to find their niche.

"Find your passion and give everything you can to make that passion or dream a reality," Jeremy said.

Finally, Jeremy said Soldiers need to understand that there is life outside of the uniform.

"You are a Soldier, but there is more," he said. "Slow things down when at home. Pick up a hobby and become passionate about it. A hobby can be what gets you through even the toughest deployment."

The couple sees big things for their brewery in the coming years, but said that Midway and the Fort Stewart area will always be its home.

# Children, volunteers honor past by cleaning headstones for National Public Lands Day

“Give this lady a grave to be proud of,” said Adrien Dorsin, 12, as he and six of his classmates scrubbed down a headstone Sept. 25 at Taylors Creek Cemetery on Fort Stewart, honoring National Public Lands Day.

Children of Kessler, Murray and Diamond elementary schools and other volunteers cleaned historic headstones and learned proper care and cleaning of various grave markers, said Brian Greer, an archaeologist with the Directorate of Public Works, Environmental Division, Prevention and Compliance Branch.

“These are really the only visual reminders of the history of what Fort Stewart was before it was Fort Stewart,” Greer said. “Even before we say anything, we see [the children] recognize the importance of proper care and respect for the resources.”

National Public Lands Day is observed each year on the last Saturday in September. The day is the nation’s largest single-day volunteer event for public lands and brings together hundreds of thousands of volunteers nationwide to help restore America’s

public lands.

“It’s a day of volunteer work to get people out of their houses and out into the public lands,” Greer said.

Throughout the day, the children helped clean approximately 100-150 headstones. The remainder of the nearly 450 headstones in the cemetery were either deemed too fragile for cleaning or were completed during another cleanup held in July.

The initial cleanup stemmed from a request from Col. Bryan Logan, Fort Stewart garrison commander, to provide more outdoor activities for Marine Families during the pandemic. The July event was such a success that both DFMWR and DPW Environmental decided to do it again for National Public Lands Day, Greer said.

Greer told the children, the most important part of headstone cleaning is, “... to do no harm.”

Nick Moise, Fort Stewart School-Age Center facility director, said the children were given a history of the town and how things were before it was a military installation.

“We want to give them a picture of history and how the world changes,” Moise said.

The children bounced from headstone to head-

stone in groups or on their own to perform the duties. Some would occasionally discuss among themselves the possible stories of the people who laid below their feet.

“They’ve done a great job,” Greer said. “One thing we see them take away is respect - respect for their community and respect for the past.”


“Taylors Creek was a small village that stood at the junction of Canoochee and Taylors creeks, the area now occupied by Fort Stewart and Hunter Army Air Field,” Greer said. “Each fall, Taylors Creek’s heritage returns to Fort Stewart when former residents and their descendants visit the cemeteries to hold annual meetings and religious services.”

Darcy Flowers, president of the board of directors of the Taylors Creek Cemetery Association, said the event will segue nicely into the upcoming self-guided tour of the cemeteries this year, as the usual gathering cannot be held due to the pandemic.

“We’ve always appreciated how Fort Stewart takes care of [the cemetery] and honors what we honor,” Flowers said. “The reason we carry on getting together once a year is to remember the town that was here. Some of our members grew up here. Just to be involved in this makes it that much more special.”

# Schools to resume in-person learning

As a result of Fort Stewart's Health Protection Condition having changed from C to B, effective Sept. 25, in coordination with military leadership and keeping the health and safety of our students and staff in mind, Department of Defense Education Activity schools will begin in-person learning on post beginning Oct. 13, due to Oct. 12 being a holiday.

During this transition, students will continue with remote learning. Additionally, DoDEA schools are working with the District Office to ensure that they have logistics functions set up to be able to activate the bus transportation and the normal Student Meal Program. The school principal will be sending detailed information over the next two weeks regarding the children's' return to their respective school.

One of the important tasks to complete prior to the first day of classroom instruction is the Prescreening

Protocol and Acknowledgement for Students. Parents can download a copy of it at [dodea.edu/upload/prescreeningadultsacknowledgment\\_08192020.pdf](https://dodea.edu/upload/prescreeningadultsacknowledgment_08192020.pdf) or check [dodea.edu/returnto-school.cfm](https://dodea.edu/returnto-school.cfm) under the Health and Safety Tab. Parents are asked to be sure to send it with their student on their first day back and continue to check for any signs or symptoms of illness before sending them to school - support and involvement will be critical to a smooth and safe transition back to the classroom.

Things might look a little different this year due to the risk reduction and mitigation strategies put into place to maintain a safe and healthy environment for staff and students. Wearing cloth face coverings, maintaining social distancing, bringing an individual water bottle to school - all of these are part of the new normal as school communities work together during this unprecedented time. Restoring teaching and learning to the familiar environments of the classrooms provides students with stability and continuity so a return to in-person learning was important as soon as it was safe to do so.

As a reminder, students enrolled in DoDEA's Virtual School are not impacted by this change.

DoDEA continues to work closely with installation partners to monitor and assess health and safety conditions and provide updates as necessary. The well-being of the students and staff remains a top priority.

# 2ABCT Soldiers answer call at Combined Resolve XIV

**HOHENFELS, Germany**—“Send Me” is the motto of the 2nd Armored Brigade Combat Team, 3rd Infantry Division, a motto that they lived up to in April of this year when top U.S. Army officials selected the brigade for assessment and evaluation during Combined Resolve XIV in September at the Joint Multinational Readiness Center’s Hohenfels Training Area.

The 2nd ABCT is headquartered at Fort Stewart, Georgia. Their Spartan brigade includes a combat arms branch maneuver brigade, as well as all essential combat support and combat services. Nearly 3,500 participants from eight NATO allies and partner nations are participating in the exercise.

The 2nd ABCT has a broad arsenal available to combat mock opposition forces during Combined Resolve XIV while in Germany, including 43 M1A1 Abrams tanks, 75 M2A2 Bradley fighting vehicles, and eight Apache AH-64 helicopters (in the brigade’s subordinate 101st Combat Aviation Brigade.)

Combined Resolve XIV is an Army-directed exercise designed to test U.S. forces while simultaneously training a multinational brigade and enhancing interoperability with allies and partner nations.

The exercise emphasized unified land operations against a complex threat while concurrently improving the combat readiness of all participants. Now in its 14th iteration, the Combined Resolve series of exercises has paired the U.S. Army's Regionally Aligned Force with European allies and partners.

Six days into the exercise, Lt. Col. Greg McLean, an armor officer and Observer Coach/Trainer for the Joint Multinational Readiness Center, said he was impressed with the effort from the 2nd ABCT Soldiers.
