

# Spartans bid farewell to senior enlisted leader

Aristotle famously said, “The whole is greater than the sum of its parts.” Many leaders strive to instill this philosophy in their own organizations. For Command Sgt. Maj. Jabari Williams, the senior enlisted advisor of the 2nd Armored Brigade Combat Team, 3rd Infantry Division, his focus invariably has been on taking care of his Soldiers and ensuring they are combat ready as a whole.

“Being able to spend time with Soldiers and solve their problems is something that I’ve always enjoyed,” Williams said. “I always wanted to be a part of something bigger than myself, and the Army is exactly that.”

Williams, who has seen many professional changes of responsibility over his 26 years of service, is about to experience one more. He is set to become the senior enlisted advisor for the 174th Combined Arms Training Brigade in February at Fort Dix, New Jersey, under the First Army Division East.

Williams is a native of Charleston, S.C., where he graduated from R. B. Stall High School in 1995. He entered the Army as an M1 armored vehicle crew member after he saw a “supercool video of a tank going airborne.” He joined at a time when Army recruiting focused heavily on the educational opportunities service provides.

“They were allowing Soldiers an exemption from duty if they competed in and won a board,” Williams said. “So I would do my military duty as a tank driver, then get boarded and go to school at night.”

Williams leveraged the Army’s value of higher education to earn his bachelor’s and master’s degrees in business administration with a concentration in leadership from Excelsior College, and he is currently working on his doctorate with Walden University in corporate finance.

Degrees are not his only distinguishing achievements. To a cavalryman, earning spurs indicates having earned one’s spot among the ranks. Williams earned five sets of cavalry spurs throughout his career while serving in the 3rd Battalion, 37th Armor Regiment; 1st Battalion, 13th Armor Regiment; 4th Squadron, 7th Cavalry Regiment; 3rd Battalion, 15th Infantry Regiment; and 3rd Squadron, 89th Cavalry Regiment.

Armor crewmembers work in teams of four and are required to operate fluidly together. Syncopation in their minds and movements is imperative for efficiency. During training, armor crewmembers perform a 45-minute exercise to assess its teams’ skills in precision driving and accurate targeting. Williams holds the distinction of achieving a “perfect” 1000 point run while serving as an armor crewman.

Williams has also served in every level of professional leadership as an enlisted Soldier, from team leader through brigade command sergeant major.

Notable as well amongst his Army experiences is the recent 2nd ABCT deployment to Europe in support of Operation Atlantic Resolve. The OAR mission is to provide

a lethal joint force to defend the security of the nation and sustain American influence abroad. The 2nd ABCT provided heavy armor capability.

“To take a brigade and deploy them from Fort Stewart, putting them on a port and execute operations in Europe, and going back to the unit history where they started in Germany, was just one of those things that was truly amazing to me,” he said. “I really want our Spartan Soldiers to know that they are part of a great history, and the efforts that they put in every day are going to continue that legacy.”

Williams is most proud of deploying 3,483 Soldiers and bringing them safely back home to their Families nine months later. He attributes that success to the hard work and dedication of his great leaders and Soldiers. His commander states that Williams was instrumental to that mission accomplishment.

“Command Sgt. Maj. Williams helped this brigade exceed all expectations and outperform at every level,” said Col. Terry R. Tillis, 2ABCT commander.

“His leadership helped the brigade operate within the European Command area of responsibility, successfully assuring our European partners and allies while aiding the deterrence of regional aggression.”

His leadership garnered praise from the senior-most leaders of the 3rd ID.

“I want to thank him for his service, the support of his wife Lynette, and their dedication to our Soldiers,” said Maj. Gen. Antonio Aguto, “He took a brigade through a very challenging mission which changed during its process of execution because of COVID-19. He quickly adapt-

ed, helped his leaders and his Soldiers throughout the original mission, the changed mission, and brought them home safely. His personal leadership ensured that through this experience they all returned better prepared for the challenges ahead.”

Williams lists many moments of his time as the brigade’s command sergeant major as personally meaningful. One poignant moment for him was arranging to have his Soldier’s family physically in attendance, despite the current global pandemic, while Sgt. Mary Cloninger received recognition as the brigade’s noncommissioned officer of the year. Another was establishing his unit’s quality of life council, where Soldiers’ concerns were heard during a time of civil unrest.

Williams offered advice for the Soldiers of his former brigade.

“Take the challenge, make the change, take care of your Spartan buddy, leave no Spartan behind, supervisors are issued, and mentors are requested,” he said. “Enjoy what you’re doing every day, because there’s nothing better than being an American Soldier.”

Williams’ new responsibilities will test his ability to lead as he takes charge of Army National Guard and Reserve Soldiers sprawled across seven different states and 11 battalions.

“I’m excited about the opportunity to continue to serve, protect, and care for our most precious resource—the American Soldiers and their Families,” he said.

## New senior enlisted leader to focus on Soldier readiness

Command Sgt. Maj. Jaime Lopez's brows furled as his eyes focused on the staff being passed amongst the three men. Attached at the top hung a crimson and blue flag with yellow fringe. Called the brigade's "colors," the flag stands as a physical representation of the 2nd Armored Brigade Combat Team's identity and affiliation. In a two-step energetic motion, outgoing Command Sgt. Maj. Jabari Williams passed the staff to Col. Terry Tillis. Tillis then snapped his arms in, turned his body, and thrust his arms out again, offering the staff to the waiting hands of Lopez, the incoming command sergeant major and his new senior-most enlisted advisor. For Williams, this relinquishment of the colors signified his walk into the sunset. For Lopez, it was acceptance of the burden of responsibility and authority.

In the sparsely populated gymnasium on Fort Stewart, close friends and Family in masks sat six-feet apart, but witnessed the significant moment. Much like the heavy clouds surrounding the building on Jan. 22, COVID-19 restrictions hung over this milestone and forced all other viewers to watch online. However, in spite of the rain and pandemic protocols, no one seemed heavy-hearted. The 2nd ABCT, 3rd Infantry Division Spartans farewelled Williams and welcomed Lopez as its senior enlisted advisor the way they always had before, with the ceremonial passing of the colors.

"Command Sgt. Maj. Lopez has a tremendous reputation that precedes him, and we know he is the right senior noncommissioned officer to serve as Spartan 7," said Tillis. "I'm excited to serve with him and trust

he will execute the duties of the brigade Command Sgt. Maj. as we navigate our way through re-arming the formation, modernization, and preparing the brigade to achieve a high level of operational readiness preparing the brigade to deploy to answer our nation's call."

Lopez, a native of Las Vegas, Nevada, graduated from Moapa Valley High School in 1999. He enlisted in the Army as a construction engineer, a decision heavily influenced by his father-in-law, Alan Marshall. Marshall owned a construction company and employed Lopez throughout his adolescence. Lopez planned to gain some experience from the Army, then return to the construction company after a couple of years, but as time went on, his plans changed.

Lopez completed initial entry training at Fort Leonard Wood, Missouri, as an engineer Soldier. He served with the 84th Engineer Battalion, at Schofield Barracks, Hawaii, where he was a team and squad leader.

From there, he went on to the Operations Group at the National Training Center in Irwin, California, where he honed his abilities as a trainer of Soldiers. The National Training Center trains rotational training units, joint, inter-agency and multinational partners to build and sustain readiness to fight and win, while simultaneously caring for Soldiers, civilians, and Family members. After working for the combat training center, Lopez returned to Fort Leonard Wood after being selected to be a drill sergeant and trained more than 7,000 Soldiers in a span of two years.

As a platoon sergeant, Lopez deployed for 15 months in support of Operation Iraqi Freedom VII in 2007. As a first sergeant, he deployed to Northern

Afghanistan in support of Operation Enduring Freedom in 2013. Finally, as a command sergeant major, he deployed to Kuwait in support of Operation Spartan Shield in 2017 to build partner capacity in the Middle East, promote security, enhance readiness, and strengthen the ability to rapidly respond.

The 3rd Infantry Division command team welcomed Lopez's arrival with high hopes for his impact on the organization and lives of his Soldiers.

"His valuable experience and the energy Command Sgt. Maj. Lopez brings to his duties will be embraced in the organization," said Command Sgt. Maj. Quentin Fenderson, the division senior enlisted advisor.

Lopez said he's eager to serve in such a prestigious brigade and encourages his Spartan Soldiers to use him as a resource. He said his goal is to help Soldiers have a plan for their futures no matter the circumstances or background. He said he believes that by taking care of Soldiers and their Families they will increase the unit's ability to succeed as a whole.

"I first want to congratulate the Spartan brigade on a job well-done throughout its deployment to Europe," Lopez said. "I look forward to helping Soldiers and their Families reintegrate back into their daily duties and garrison operations at Fort Stewart. That's my main priority."

Lopez also said he wanted his Soldiers to know he's an advocate for them, that he lives by the Army values every day, treats everyone with dignity and respect, and that he and his Family are here to support them.

"I'm most looking forward to just being a Dog Face Soldier. Rock of the Marne!"

## Routine COVID-19 testing

Routine COVID-19 testing for ADSMs provided by civilian off post providers are NOT covered by TRICARE without an Approved Authorization therefore making you liable for the bill. ADSMs using Urgent Care Clinics are NOT covered by TRICARE without an Approved Authorization on file with TRICARE. All COVID-19 testing and Urgent Care should be provided by the Military Healthcare System management and tracking. For Emergencies (Loss of Life, Limb, or Vision) stop at the nearest Emergency Room and provide your TRICARE insurance information. ADSMs on leave or when in the absence of an MTF they attain an Approved Urgent Care Referral from their duty station Primary Care Manager at their Healthcare Clinic or contact the Nurse Advise Line at 800-874-2273 Option 1 24/7 hours. Note: The rules for Non-Active Duty beneficiaries are different for ADSMs covered by TRI-Prime.

# Hunter Army Airfield opens temporary dining facility

Hunter Army Airfield leadership welcomed the arrival of a new temporary dining facility while the permanent facility undergoes a remodel, Jan. 21.

The temporary structures are adjacent to the dining facility and consist of a large tent and three trailers that offer all the necessary equipment and adequate space to provide Soldiers their meals and dining services. While there will be some minor changes, food service and quality will remain consistent with the brick and mortar facility.

“We had to make a few sacrifices to be within code such as discontinuing the omelet bar because we couldn’t meet the fire suppression requirements in this temporary facility,” said Sgt. 1st Class Alechia Riley, dining facility manager with 3rd Infantry Division. “As far as the food quality and preparation, we are still able to make to everything we had before. There are just

more time and preparation requirements now because of the confined space we have to work in.”

While the kitchen space is cramped, the tent for dining Soldiers is spacious and offers the same comforts as the permanent facilities, according to Riley. Soldiers at the grand opening mirrored this sentiment.

“There’s really no difference from before other than it being in a tent,” said Spc. Israel Meadows, utilities equipment repairer with 3rd Infantry Division. “I don’t think people will mind this change at all, it’s roomy and nicely set up.”

“I did not know they were opening up a tent but they have everything here that was in the original DFAC.” Pfc. Alexander Haag, black hawk mechanic with 3rd Combat Aviation Brigade. “The first thing I noticed was the hardwood floors, which is pretty crazy to see in a tent.”

The grand opening was also attended by 3rd Infantry Division and Hunter

Army Airfield Garrison leadership.

“These updates will provide Soldiers with more convenient, quick food service options as well as traditional dining,” said Lt. Col. Stephan Bolton, Hunter Army Airfield garrison commander. “While you can expect the exterior to remain the same, the interior will undergo a complete modernization to better serve the high operational tempo of Soldiers on the go.”

The modernization concept includes kiosk/app ordering, exhibition cooking stations, improved serving equipment, seating with integrated power, all-day dining options and more.

Renovations of the DFAC are estimated to be completed early 2022.

The temporary DFAC will be closed one weekend a month where meal options will be provided by food trucks on site during normal brunch and dinner hours. Closures will be posted on the temporary DFAC’s doors. The next closure is Feb. 20 and 21.







# Adaptive reconditioning fosters creativity

**ARLINGTON, Va.**— What do famed painter Vincent Van Gogh and a Soldier in Georgia have in common? They've both completed a painting named "The Starry Night." Van Gogh is responsible for the original artwork while Chief Warrant Officer 4 Efrain Hernandez Torres completed his version more recently. He finished it while participating in the Fort Stewart Soldier Recovery Unit's art program last year.

Hernandez Torres painted before he was assigned to the SRU where he currently attends virtual art instruction. He explained that during the weekly classes, the Soldiers follow along with the instructor to create art.

Lt. Col. Edward Ziembinski, commander of the Fort Stewart SRU, said that the virtual art program has become an essential part of the adaptive reconditioning program and is "exceptionally beneficial for recovering Soldiers" in myriad ways.

"Each virtual art session fosters creativity, social interaction, and deliberate focus in our Soldiers," he said. "They cultivate their fine motor skills and engage their imaginations through a relaxing and exceedingly pleasant activity."

One of the paintings that Hernandez Torres completed with the art program was modeled after a landscape by Georgia O'Keeffe. In addition, he has painted landscapes, castles and an old colonial town from his homeland of Puerto Rico. He loves all of his artwork, but said that his painting of the Golden Gate Bridge was the most challenging to complete.

It can take up to three hourlong classes to finish a painting, but it depends on its level of complexity, Hernandez Torres said. The first class is for drafting, the second is for painting and last is for completing the artwork. They practice a number of COVID-19 precautionary measures, to include spacing easels six feet apart, providing Soldiers with their own tools, cleaning surfaces before and after instruction and wearing masks, said Dr. Yvonne Laroche, physical therapist at the Fort Stewart SRU.

Hernandez Torres said that painting is one of the most relaxing things he can do and it's helped him change his mindset

and cope with feelings of anger. When he returned from deployment, he sought an activity that would help him relax, and he found painting. He described painting a landscape with a mountain, valley or river and feeling like he'd transported himself to the place he was creating. When he feels depressed, he will spend time painting without interruption and it brings him happiness.

After he transitions from the SRU, Hernandez Torres wants to grow his skills and continue painting. He plans to look into art school to learn more about mixing paint, and oil or watercolor painting.

The Fort Stewart SRU's art program also includes crafts. Soldiers make wallets, bird-houses, clocks or magazine racks. On Fridays, they discuss how working on the projects made them feel, Laroche said. There are plans to expand the program with more offerings in 2021, she added.

Hernandez Torres tried one project in which Soldiers built wagons. It was his first craft and he's completed several more since then. He said that he enjoyed assembling the wagons because they had to be put together piece-by-piece.

"I loved that one too," he said.

Laroche said that the art program offers quite a few benefits, such as creating opportunities to practice fine motor skills or to adapt a workstation to focus on endurance or balance. In this way, art becomes more physical and functional, she said. It also provides a way for Soldiers to express their feelings using color and brushstrokes on paper, she said.

Soldiers have told Laroche that the art program was calming and provided peace and purpose during the week. Those who stayed with the program have created beautiful artwork, she said.

Ziembinski said that once Soldiers attend a virtual art session, they want to return because it's fun and the instructor is engaging. It's also a therapeutic and accessible addition to their schedules that helps them learn a skill, he said.

The Army Warrior Care and Transition Program is now the Army Recovery Care Program. Although the name has changed, the mission remains the same: to provide quality complex case management to the Army's wounded, ill and injured Soldiers.

# Vaccine phases open for beneficiaries 65 and up

Twenty-nine days after Winn Army Community Hospital distributed its first coronavirus vaccination on the installation, it began providing the second dose on Jan. 22 to emergency responders, healthcare providers, and critical workforce. Personnel planning to deploy, other essential workers, and beneficiaries aged 75 and older were invited to take the vaccine as Winn ACH moved into Phase 1b.

Three days later, on Jan. 25, Winn ACH invited its beneficiaries 65 to 74 years old to call for COVID-19 vaccine appointments at 435-6633, Option 3, from 7 a.m. to 4 p.m. Mon. through Fri. When the remaining TRICARE populations are eligible, it will be announced locally on the Winn ACH social media platform [facebook.com/winncares](https://www.facebook.com/winncares).

“We are excited to move to the next phases of COVID-19 vaccination. We plan to offer COVID-19 vaccine to all of our eligible beneficiaries according Department of Defense phases. It will take some time as our vaccine supply is limited currently. We’ll be providing information as soon as it becomes available.” Col Julie Freeman stated. Winn Army Community Hospital currently distributes the Moderna Vaccine. It is provided in two-doses, scheduled at least 28 days apart.

“The Moderna vaccine is a messenger RNA (Ribonucleic acid) based vaccine that essentially tells your immune cells to make a harmless protein - called a spike protein,” said Col. Nia Middleton, Deputy Commander for Clinical Services at Winn Army Community Hospital. “The protein is similar to the protein on the outside of the COVID-19 virus. Your body recognizes the protein as foreign and builds an immune

response of antibodies, and it will then break down this mRNA, and gets rid of it.

Middleton said there is no live virus and no virus particles – adding it cannot give you COVID-19.

But Middleton said the vaccine is not for all individuals. If you have a severe allergy to the Moderna vaccine or any of the vaccine components, you should not take it. If a person has a history of immediate reaction, of any severity, to a previous vaccines— such as hives, face or lip swelling, or breathing difficulty within 4 hours of vaccination—they should let us know when they make the appointment. Individuals with a history of allergies should take their COVID-19 vaccine at Winn and not at the drive-through service when it becomes available.

Middleton said if you take the Moderna vaccine, the second dose must also be Moderna – you cannot mix vaccines. The vaccine will also restrict flight duty for pilots for at least 12 hours.

“We thank community members for their patience and support as we continue to distribute the vaccines in accordance with DOD and CDC guidelines,” said Winn Army Community Hospital Commander, Col. Julie Freeman. She also noted in the future, when additional vaccines become available, we are planning to open a drive-through COVID-19 vaccination clinic.

Freeman encourages community members to follow the Winn ACH Facebook page to learn more and to learn when the various phases become open; but to continue using mitigation measures – even after taking the first vaccine – such as washing hands, wearing a mask, avoiding large crowds and maintaining a distance of about 6 feet from others. We are in this fight against COVID-19 together.



# Virtual UMO training keeps the Rock rolling

Have you ever wondered how a heavy armor unit such as the 3rd Infantry Division is able to move hundreds of thousands of pounds of equipment from one place to another when they are traveling to a training site or going on a deployment? How does all the weaponry, tactical gear, vehicles weighing over 10 tons and their personnel get from their point of origin to their destination and back? It is all thanks to the efforts put forth by two appointed members of the deploying unit.

The role of a Unit Movement Officer can be a challenging but rewarding role. They are the start point for a unit attending training, deployments and redeployments.

“A UMO is that unit’s subject matter expert when it comes to all things movement related,” said Chief Warrant Officer 3 Jay Turner, the 3rd ID mobility officer. “They are in charge of moving your containers, moving vehicles and rolling stock from your point of origin to your point of destination and back.”

The UMO’s are an integral part of the unit as they get ready to move forward. They are the ones who coordinate all movement, whether it be by land, air, sea or rail systems.

There are several requirements to obtain the UMO identifier. The Soldier must be in the rank of staff sergeant or second lieutenant and above, they must possess a security clearance and attend a specialized training course.

Traditionally, the course was taught over a two-week period as a residential course, meaning Soldiers had to physically attend the course.

Years ago, Fort Stewart was one of the training sites available to teach the United States Army Forces Command-approved residential course along with a few others. However, due to the recent Covid-19 pandemic, Fort Stewart implemented a new way to teach the course to its Soldiers.



“You always want to do a resident course,” said Maj. Joshua Petrus, the 3rd ID transportation officer. “But what we’ve found through the virtual means is it’s quicker access and it’s easier to get the students the training and help they may need.”

Turner said Fort Stewart is the first installation to set up a virtual training class for the UMO course.

With the help of a virtual meetings application as well as the Blackboard site, students are now able to attend the course at home, maintaining safe social distancing. This also safely manages the demands for mission readiness, according to Petrus.

The instructors worked closely with the subject matter experts at the U.S. Army Transportation School in Virginia in order to establish a sustainable virtual working environment.

“We have reached back to Fort Lee to actually attend our class and see how we’re conducting school and provide feedback and supply expertise to the students currently in attendance,” Petrus said.

One of the top priorities for the 3rd ID is maintaining and keeping highly-trained Soldiers, no matter the environment present. This is the first class being taught with a second class promised for March.

“I would say that 3rd ID is pretty much setting the standard for everyone else,” said Turner. “We’ve had transportation offices from all around call and ask us ‘how did you all do this and can you help us get something established at our base?’ We are setting the standard.”

Fort Stewart will continue to lead the effort in implementing the Army’s vision by executing the priorities that will define success in making America’s forces more lethal, capable and efficient.
