

Fort Stewart hosts law enforcement symposium

Officials from 3rd Infantry Division, Fort Stewart and Hunter Army Airfield hosted a law enforcement symposium, Feb 18-19 on Fort Stewart. The event was a collaboration with law enforcement partners from across the region to include Liberty County Sheriff, Hinesville Police Department, Bryan County Sheriff, Richmond Hill Police Department, Garden City Police Department, Statesboro Police Department, U.S. Marshals Office and members of the FBI, Georgia State Patrol, Long County Sheriff, Chatham County, and the Savannah Police Department were also invited. Command teams from across 3rd ID and garrison also attended.

The 385th Military Police Battalion and the Fort Stewart Directorate of Emergency Services organized the event. Maj. Gen. Antonio Aguto, the commanding general of the 3rd ID, Fort Stewart and Hunter Army Airfield, wanted the event to be both educational and relationship-building.

“The safety of our force and community is a team effort,” said Aguto. “Collaboration events like this are not just about what we can do better for our Fort Stewart and Hunter Army Airfield Community, but what we can help with for the greater law enforcement enterprise in the area. It’s important to ask what we can be doing better in their eyes, while keeping them informed of where we might need more of their expertise or assistance.”

The two-day event included briefings from several different agencies to address issues and educate each other on their challenges, capabilities, and best practices. It also included a briefing by Bonnie Sharp, an analyst for the National Counterterrorism Center.

“The law enforcement symposium was an event created to highlight our regional law enforcement and ensure commanders were aware of the law enforcement capabilities both on and off the installation,” said Maj. Erin Peterson, the Fort Stewart and Hunter Army Airfield Directorate of Emergency Services operations officer and lead planner for the symposium.

Since the Fort Hood Independent Review was published in December 2020, the Army has outlined an updated framework of recommended actions, considerations, and activities to commanders and Army law enforcement to assist in determining whether a Soldier’s absence is voluntary or involuntary.

The symposium helped ensure commanders were informed of crimes and procedures both on and off installation. It also outlined further responsibilities that commanders and law enforcement personnel must execute for involuntary missing persons’ cases and desertion cases.

It’s important for civilian law enforcement to understand because the changes in Army policy may lead to an increase in attempt to locate requests for the Soldiers and family members that reside off post.

“A secondary objective of this event was for commanders to become acquainted with the local law enforcement agencies and build ‘connective tissue’ to enhance our relationships with them in order to address corrosive behaviors that Soldiers may be participating in both on and off the installation,” Peterson said.

As a precursor to the Secretary of Defense-ordered stand down on the topic, the symposium also included a brief about “Extremism in our Ranks,” by Supervisory Special Agent Robert Payne, a U.S. Army War College research fellow from the Atlanta FBI Office.

The Army is committed to working closely with the FBI and local law enforcement on any accusations to charges pertaining to extremist behavior.

“Events like this are important for ensuring we are being proactive with information sharing to reduce crime in areas like drug suppression and increase joint law enforcement operations on the installations,” said Lt. Col. Craig Giancaterino, commander of the 385th Military Police Battalion and provost marshal and director of emergency services for Fort Stewart and Hunter Army Airfield. “It’s also important as policies change to contin-

uously inform our law enforcement partners and commanders on how the military law enforcement operates and educate ourselves on the crime areas off-post so we can assist in getting the information out to our community.”

Organizers said the symposium, the first of its kind for the Fort Stewart and Hunter Army Airfield community, opened dialogue and increased awareness of off-post hot spots and future partnership and networking opportunities to prevent and solve crime. The goal is for this to become reoccurring event.

“We are excited for the future law enforcement engagements beyond this symposium as we work together to provide analysis, feedback, and general situation awareness to the commander toward facilitating and enabling this posture and work rapidly toward crime incident reduction,” said Giancaterino.

“This symposium was a great start to future endeavors. I look forward to working with the Fort Stewart and Hunter Army Airfield leadership in caring for and protecting America’s greatest asset, our servicemen and women,” said Liberty County Sheriff William Bowman.

Army IG to Soldiers: ‘celebrate the differences that make us stronger’

WASHINGTON—The Army’s inspector general preaches building trust when he meets with Soldiers and civilians at Army installations throughout the country.

Lt. Gen. Leslie Smith demonstrates that in the way he listens to Soldiers as they tell their life stories or talk about their backgrounds. With Southern charm and a humility that comes from a blue-collar upbringing, the Atlanta native speaks to Army members the way he speaks to his family or old friends.

He and his wife of more than 30 years, Vanedra, have also instilled trust and respect for others in their two daughters, Taylor and Tori. Tori, the youngest, is an Army officer attending medical school at Howard University and plans to become an Army doctor.

The couple taught their children that building trust comes from treating others equally.

“We always fall back on things that our parents taught us,” Vanedra Smith said. “My mom always said, ‘It’s important to treat people the way that you want to be treated.’ And that’s one of the things that I’ve always instilled in my daughters, and I also let them know that there’s one race: the human race.”

Leslie Smith also believes that a more diverse force will make the Army stronger. Smith also joined acting Secretary of the Army John E. Whitley to speak virtually with cadets at Alabama A&M and Alabama State universities Feb. 18 and 19, as part of the Army’s wider effort to recruit more African-Americans into its ranks.

“We want to make sure that we focus on a diverse group of people coming into our Army and into our armed forces, because we are representative of the nation,” Smith said by video conference on Feb. 9. “So we need to fight for that talent.”

Smith also recorded a special Black History Month message for the NBA’s Washington Wizards to air during the team’s historically black college and university night on Feb. 27. Later this year, Smith will visit Army installations as part of the Project Inclusion listening tour.

Smith praised the efforts of Project Inclusion, an initiative that includes listening sessions that are scheduled to continue on Feb. 23-25 at Fort Irwin, California. The program collects data from the sessions to identify social issues related to diversity and inclusion that can be brought up to Army leadership.

To mold the Army into a welcoming, inclusive place for all backgrounds, Smith understands Army units must be united from the ground up.

Sergeant Major of the Army Michael A. Grinston strives to foster trust at the squad level through the “This is My Squad” initiative to build greater team unity, similar to

the bonds formed in special forces units. Other Army leaders, including Smith, have taken it upon themselves to spread that message throughout the force.

As the Army’s inspector general, Smith doesn’t take his position of influence lightly.

“If I say one thing and I do something else, that’s a problem,” Smith said. “So I have to make sure ... I demonstrate what I expect [Soldiers] to be. So if I expect someone to be in good physical shape, I have to be in good physical shape. If I expect people to treat everyone with dignity and respect, I have to do the same.”

“All of it comes back down to trust at the individual level, the team level, the organization level and then on the Army level.”

After recent events at Fort Hood, Texas, which included the deaths of missing Soldiers, the focus on race relations and accountability within the Army’s ranks has been pushed to the forefront.

Last summer, then-Secretary of the Army Ryan D. McCarthy ordered an independent review that revealed significant improvements must be made to the Army’s Sexual Harassment/Assault Response and Prevention

program as well as Soldier accountability procedures.

“There are areas that we need to work on,” Smith said. “I think the Fort Hood independent review showed us some things that we need to continue to highlight. But for me, it comes down to how we’re building trust. And the only way you build trust is getting to know the people that are around you.”

Smith spoke at a Martin Luther King Jr. celebration at Fort Lee, Virginia, last month and has participated in similar events over the years. He said he encourages Soldiers to honor King’s legacy by acting against incidents of sexual harassment/assault, racism, extremism and bullying, and reporting occurrences to their chain of command.

Vanedra Smith supports the Army in any way that she can, as a member of the Army Spouses’ Club of the Greater Washington Area and by attending events that promote diversity. General Smith said that Soldiers must not only know their peers better, but should also encourage their families to become involved.

“The atmosphere of a place, or the success or the failure of it, starts at the top,” Vanedra said. “So in order for an organization or person or people to succeed, we need everybody involved.”

Smith said understanding the nation’s diverse history will help foster that trust. At speaking engagements, he talks about Black pioneers such as Benjamin Banneker, a surveyor who helped Andrew Ellicott map the initial layout of Washington, D.C., in the late 18th century.

The Atlanta native also frequently speaks about his summer visits to Mound Bayou, Mississippi, a farming community where his family originated. Mound Bayou became a prosperous Black community amid racial segregation in the Deep South. Smith spent time learning from his uncles and cousins about his background and what was expected from him.

“To this day, my relatives still have high expectations of me as a leader, not only in the Army but in my family and community,” Leslie Smith said.

He also spoke of Secretary of Defense Lloyd J. Austin III, a close friend of the Smiths who became the nation’s first African-American to hold the position on Jan. 22.

Austin broke several barriers in his military career, becoming the first Black operations officer of the 82nd Airborne Division at Fort Bragg, North Carolina. A native of Thomasville, Georgia, Austin also became the first Black commander of U.S. Central Command and the first Black vice chief of staff of the Army. He retired from active duty after 40 years in the Army.

“He’s been blazing a trail for a long time,” Smith said. “We have to talk about those things.”

Smith said that the Army must continue to honor not only Black History Month, but other months that celebrate diversity including Asian Pacific American Heritage Month in May and Hispanic Heritage Month during September and October.

“We celebrate the differences that make us stronger,” Smith said.

Army plans smart barracks pilot on Fort Benning

FORT BENNING— Imagine a barracks room having USB ports and working thermostats. That's what is slated for the \$4.4 million Smart Barracks Initiative on Kelley Hill.

A modernization project for Building 9164 kicks off in April. This is an Army pilot program, said Geoff Ray, a mechanical engineer with Fort Benning's Directorate of Public Works' Operations and Maintenance Division. The agencies working with Army Materiel Command on this pilot include Installation Management Command and the U.S. Army Corps of Engineers.

Maj. Gen. Jeffrey Milhorn, USACE deputy commanding general for Military and International Operations, visited the Maneuver Center of Excellence Jan. 21 for a briefing on the project and ongoing construction here.

Brandon Cockrell, chief of Plans, Analysis and Integration Office, said the smart barracks initiative is a key part of the Installations

of the Future.

It is divided into two phases, the first phase starts in April on Kelley Hill. The location of the second phase, scheduled for FY22-23, has yet to be determined, Ray said.

During the first phase, the barracks will be fitted with a state-of-the-art utility monitoring and control system, improved heating ventilation and air conditioning equipment, electrical retrofits and smart fire detection and protection devices.

The Army wants to modernize its housing and permanent party barracks. Ray said they hope to improve security, quality of life, facility maintenance, improve energy and water efficiency along with capturing data to analyze to provide better user comfort.

Phase 1 includes increased filtration and ultraviolet lights, increasing air quality in the building, improving the controls for the building — the building automation system, to tie all the wiring, HVAC, electrical together so you can see it and program it better, he said.

"The point of this is to give Soldiers more control over their environment and provide better quality of life," Ray said.

COVID-19 vaccination opportunities offered

Are you and your Family looking to get a COVID-19 vaccine near you? If so, you'll soon have more options for where you can go to get it. As part of the ongoing response to COVID-19, the federal government has launched the Federal Retail Pharmacy Program for COVID-19 Vaccination. This new program is a collaboration between the federal government, states, territories, and 21 national pharmacies and independent pharmacy networks to increase access to the COVID-19 vaccine in the U.S.

"Vaccination is a critical step in protecting your health and slowing the spread of COVID-19," said Colonel Markus Gmehlin, acting chief of the Pharmacy Operations Division at the Defense Health Agency. "This program will provide TRICARE beneficiaries with more opportunities to get vaccinated at a location near them."

Here are some details about distribution and how you can get the vaccine with your TRICARE benefit.

How does the program work?

The Federal Retail Pharmacy Program will supply COVID-19 vaccines to retail pharmacies in phases. As part of the initial phase, 1 million doses of the COVID-19 vaccine will be sent to a select group of pharmacies. These pharmacies will then administer vaccinations to those who are eligible. Some pharmacies have already begun offering a limited amount of the vaccine through this program. Other pharmacies are set to begin offering doses soon. As stated by the Centers for Disease Control and Prevention, "As vaccine supply increases, more retail locations will be added."

Will my local pharmacy offer the COVID-19 vaccine?

Pharmacies that are part of the Federal Retail Pharmacy Program may vary by state and territory. Pharmacies participating in the program may include TRICARE network pharmacies (<https://militaryrx.express-scripts.com/find-pharmacy>) and non-network pharmacies (<https://www.tricare.mil/nonnetworkpharmacy>). You can find a list of pharmacies that are currently participating in your area on the CDC website.

The availability of the vaccine may vary by location. If you're a TRICARE beneficiary, you'll eventually be able to get the COVID-19 vaccine at:

- Your local military hospital or clinic

- Local or state health department COVID-19 vaccination sites
- Your civilian provider
- Pharmacies participating in the Federal Retail Pharmacy Program

"At this stage of the program, the vaccine supply is limited," said Gmehlin. "So, it's important to make sure you contact your local pharmacy in advance to see if the vaccine is available and if you can schedule an appointment to receive it."

There is no cost-shareA percentage of the total cost of a covered health care service that you pay. if you get the COVID-19 vaccine at a TRICARE network pharmacy.

Planning to get the vaccine at a non-network pharmacy? There's no cost for the COVID-19 vaccine itself. Keep in mind, TRICARE doesn't cover other vaccines and most prescription drugs at non-network pharmacies.

Remember, there may be a cost based on your health plan for an office visit with a provider, or if you need follow-on care. If you have questions, you can contact your TRICARE contractor.

Do you prefer to get the vaccine at a military hospital or clinic? If you're eligible for TRICARE, you can get the COVID-19 vaccine at any military hospital or clinic that offers it. This is true even if you don't get your routine care there. Phase 1A of the Department of Defense (DoD) COVID-19 vaccination plan is currently underway at many military hospitals, clinics, and DoD installations. This phase includes vaccinating health care workers, first responders, and residents of Armed Forces Retirement Homes. Keep in mind, some military hospitals and clinics may be in different phases of the vaccination plan. So, make sure you check first to see if the vaccine is available at your location.

TRICARE is committed to supporting you and your health. Stay up to date on vaccine guidance through the TRICARE and Military Health System websites. You can also check with your local health department and talk to your health care provider about when you may qualify to receive the vaccine as well as where you can go to get vaccinated. The Federal Retail Pharmacy Program for COVID-19 Vaccination is the latest of several resources introduced to help you and your Family.



‘We go together, Katchi Kapshida’: Raiders team with Korean counterparts

CAMP HOVEY, REPUBLIC OF KOREA— Soldiers across the 1st Armored Brigade Combat Team, 3rd Infantry Division conduct their daily activities and training with Korean Augmentation to the United States Army, or KATUSA counterparts. Ever since their establishment in July, 1950, KATUSAs have served in many military occupational specialties, from human resources specialist to infantry. They have been the cornerstone of the RoK-U.S. alliance and still play an important role to this day within the 2nd Infantry Division and rotational units.

The KATUSA soldiers are an elite group who go through a comprehensive selection process including an English proficiency test. Most Korean soldiers who are selected for the KATUSA program are enrolled into college or have already graduated. They are required to follow not only the Korean Army regulations, but U.S. Army regulations as well. KATUSA troops stand side by side with their U.S. counterparts during daily activities such as physical training, Soldier tasks and battle drills, and field training exercises.

During his 18 months of service, KSgt. Jin Ho Kwon, a KATUSA with the 1st Armored Brigade Combat Team “Raider”, 3rd Infantry Division, has been to multiple gunnery exercises, ranges, ceremonies and field training. Rain or shine, hot or cold, he was always there to complete his mission alongside his U.S. brother and sisters.

“Working as a KATUSA was definitely an honorable experience. I served in public affairs which gave me an opportunity to learn many helpful techniques in life, such as how to conduct an interview, how to

effectively communicate with people, how to shoot and edit a video, how to write articles etc.,” said Kwon. “Finally, I feel fulfilled since I learned a lot about leadership by seeing good examples of it, and practicing it myself as a senior KATUSA in the shop.”

On Feb. 10, 2021, Kwon was both congratulated and a farewellled won, and thanked for his outstanding service to his country, the RoK-U.S. alliance, and his fellow Soldiers.

KATUSA soldiers also bring more to the table than training with the U.S. Army troops. For many U.S. Soldiers, KATUSAs teach them things like customs, culture, and even the language. They also show them many different parts of the peninsula other than the typical tourist attractions, as COVID-19 mitigations allow of course.

“Serving alongside Sgt. Kwon was an excellent experience,” said Staff Sgt. Daniel Guerrero, Raider Brigade’s public affairs noncommissioned officer in charge. “This is my first time to the Republic of Korea, and my first time integrating my team with one from a host ally nation. I learned a lot from him, both culturally and professionally. I am sad to see him go, but I am also proud of him and happy to see him start his next chapter.”

Kwon impressed his U.S. counterparts with his great leadership, and has been a role model for his fellow KATUSAs and U.S. Soldiers. His future plans include graduate school and a successful career in bio-fluid mechanics.

The KATUSA program was originally designed to strengthen the U.S. Army during the outbreak of the Korean War. Today the KATUSA program also stands as a symbol of the ROK/U.S. alliance and resolve to deter war.



Soldiers compete for elite Sergeant Audie Murphy Award

With the recent changes made to the promotion system, where promotions will be based off of merit instead of time served, noncommissioned officers need to set themselves apart from their peers now more than ever in order to achieve that next rank.

Two Soldiers, Sgt. 1st Class Ronald Roden and Staff Sgt. Zachary Comstock within the 188th Infantry Brigade, First Army Division East, decided to do just that by participating in First Army's second quarter Sergeant Audie Murphy Board.

"I've wanted to participate in this board for a very long time but never made the time," said Comstock, a Military Police Investigator, assigned to 4-306 Brigade Engineer Battalion, 188th Infantry Brigade, First Army Division East. "However being here at Fort Stewart, and having leadership like Lt. Col. Morrow, Command Sgt. Maj. Kelly, and Sgt. 1st Class Hutton encourage me to participate really set me on the path to accomplish what I've wanted for so long."

Sgt. Audie Murphy was a NCO who, as a squad leader, consistently demonstrated the highest qualities of leadership, professionalism, and regard for the welfare of his Soldiers. The

FORSCOM Sgt. Audie Murphy Award (SAMA) is an elite award for NCOs whose leadership achievements and performance merit special recognition.

"It says that the club is reserved for NCOs who have demonstrated exceptionally high standards. When I saw that, I said to myself, that's where I belong." Said Roden, an infantryman assigned to 3rd Battalion, 395th Regiment, 188th Infantry Brigade, First Army Division East.

The entire board spanned over three days and included an Army physical fitness test, where the candidates had to score 90 percent in each event; a written exam, used to assess their knowledge using current Army doctrine; a written essay, on current events; and an oral board where they had to demonstrate critical thinking and problem solving skills.

Roden said, this was the hardest board he had ever competed in.

"Knowing that the questions were going to be situational, and not a typical Q&A format made it almost impossible to know what to expect," he said. "The questions that the command sergeants major presented definitely challenged your ability to think quickly in regards to leadership, and what you would do given different scenarios."

Comstock agreed with Roden on the level of

difficulty this board presented.

"In other boards you're typically competing against other competitors for an overall winner; however, with this board you are competing against yourself," he said. "Having the division command sergeant major as the president of the board as well as the brigade and battalion CSMs as board members also made the environment that much more stressful."

After spending a grueling 45-60 minutes each being grilled heavily by the board members, each candidate was successfully recommended for both the Sergeant Audie Murphy Award (SAMA) and induction into the club (SAMC).

"It feels great," Roden said. "I proved to myself that I can overcome my weaknesses through hard work and dedication to whatever it is I aspire to do."

Cornstock kept himself under pressure and believed he was lucky.

"Even after the board was over and they said I was being recommended; I was just surprised," he said.

First Army Division East Command Sgt. Maj. David Bass, who sat as the president of the board said, "I am very proud for what those non-commissioned officers represented not only for themselves but also for the unit."
