Firefighter exceeds call of duty, helps Family in need

A Fort Stewart military firefighter went beyond her duty when she cared for a father and child injured in a car accident on the installation March 24.

Spc. Tyeisha Jones, part of Fort Stewart Fire Department's Engine 3 crew, responded to the accident on 6th Street and Gulick Avenue. A man and infant were in one of the vehicles. Jones assisted by caring for the infant while emergency medical technicians aided the father. Both were transported to Winn Army Community Hospital for further care.

Jones went to the hospital after her shift ended at 8 a.m. to check on the fam-

ily. She learned the family was cleared to go home but didn't have a car seat anymore because the family's only car seat was left in the wreaked car.

Harnessing the power of social media, Jones canvassed spouses' page. She explained the situation and asked if anyone had a car seat to donate. A car seat was found and brought to the hospital, allowing the infant to travel home safely.

"Spc. Jones dedication to duty and quick thinking, not only helped out with the life of the child, but also showed great compassion and just how far she is willing to go to protect and save lives," said Fort Stewart firefighter Travon Sanders

Coastal Georgia named 2021 Great American Defense Community

Coastal Georgia was recently named a Great American Defense Community for 2021. The honor is bestowed by the Association of Defense Communities.

The recognition celebrates communities with an exceptional commitment to improving the lives of service members, veterans and their families, according to the ADC.

"We are extremely honored to be selected as a 2021 Great American Defense Community," said Hinesville Mayor Allen Brown, chair of the Coastal Georgia Military Affairs Committee. "The whole region works tirelessly through programs, initiatives and partnerships to improve the quality of life and mission effectiveness for over 56,645 military professionals, civilians and family members and the 19,214 retirees who make up coastal Georgia's military family."

Partnerships and initiatives are core functions of defense communities. They provided direct financial investment in infrastructure that supports the base. Defense communities also provide important services our military families depend upon, including schools,

housing, healthcare and other social services that promote a high quality of life.

"The strength of our military starts at home, in America's defense communities," ADC President Joe Driskill said. "We selected Coastal Georgia to be part of the 2021 class because they are a region that consistently goes above and beyond to support service members, veterans, and military families living in their community."

The mission of the ADC is to build resilient communities that support America's military.

"We are the connection point for leaders from communities, states, the military and industry on community-military issues by enhancing knowledge, information sharing, and best practices," according to the ADC. "With nearly 300 communities, states, regions, and affiliated industry organizations, ADC represents every major defense community/state in the nation."

Coastal Georgia is home to Fort Stewart-Hunter Army Airfield and is one of five communities across the country named to the 2021 Class of Great American Defense Communities. The other are Altus, Oklahoma: Everett. Washington; Great Falls, Montana; and the NAS Pensacola

& NAS Whiting Field Community. Coastal Georgia is the only Army presence recognized, said Fort Stewart Garrison Commander Bryan Logan.

"It is humbling to be the only Army installation recognized this year as a Great American Defense Community," Logan said. "Fort Stewart-Hunter Army Airfield would not be a seven-time Army Community of Excellence without the existing partnerships we have established throughout Coastal Georgia. This recognition reinforces our outstanding relationship with our communities outside the gate and we look forward to continuing to build upon those relationships at every opportunity."

The installation and the neighboring communities are woven together, said Leah Poole, CEO Liberty County Chamber/CVB. The recognition as an ADC proves those bonds.

"Fort Stewart-Hunter Army Airfield is ingrained in the fabric that is coastal Georgia," said Poole. "We couldn't be more pleased with this award, which honors the efforts of the communities surrounding our installations, as well as the huge job that our Army does every day, and our tireless efforts to work together always."

Team of teams takes top honors in cultural resources

WASHINGTON —Fort Stewart/Hunter Army Airfield is located southwest of Savannah, Ga. and is home to the 3rd Infantry Division.

This combined arms division is the largest Army installation east of the Mississippi River and has a distinguished history, dating back to World War I.

Their Cultural Resources Management program has long been successful in supporting and complementing the military mission by reducing training land restrictions, elevating conservation efforts, advancing archaeological surveys, and reinforcing the Army's commitment to the history and cultural resources abundant in the community.

They were recently awarded the 2020 Secretary of the Army Environmental Award for Cultural Resource Management for the Team/Individual category.

When a breached tide gate was discovered, installation officials knew they needed to pull together a team of experts to address the unique combination of engineering and regulatory issues related to the age and location of the structures. The location of the breach was in proximity to two 19th century water control structures that were causing erosion to and around the structures; the structures affected included an 18th century Ranger Outpost listed on the National Register of Historic Places and an upstream railway causeway and trestle.

Through early coordinated efforts with the State Historic Preservation Office, the team was able to develop an archaeological avoidance plan to preserve the two water control structures.

This effort included encapsulation of the exposed historic structure back to its original pre-tide gate breach condition. They also monitored the construction activities to ensure no adverse impacts would occur.

To prevent erosion and sedimentation at the site, the team placed fill and riprap in the marsh to stabilize and protect the historic causeway and wharf structure. Those measures will help prevent future flooding at the "Sleepy Hollow" Training Area, reduce continued erosion of the upstream rail assets used for deployment, and protect the natural and cultural resources that have been entrusted to Fort Stewart-Hunter Army Airfield.

CRM staff also used the opportunity to

conduct archaeological surveys on 265,911 acres of the installation's 266,862 acres that are accessible and completed building surveys on all structures built up to 1990. They identified eligible properties for the NRHP designation and added them to the Cultural Resource Action Plan for long-term protection and monitoring.

These efforts also reduced the number of encumbered areas, allowing for unrestricted access to more training grounds and land management activities. This level of access supports the Installation Strategic Plan through active participation in the Sustainability Management System's Training Lands Process Action Team and the Integrated Management Prescription Team.

"While this project was unique, this type of project coordination with multiple partner agencies is not unique. Our team's ongoing relationships with important stakeholders has served us well. While we regularly review all real property, range, maintenance, engineering projects, and non-routine training events, this project has set us up for future success and will provide cost savings and installation readiness in the future," said Thomas Fry, Environmental/Natural Resources Division chief.

Throughout the process, the team reinforced community relations through a comprehensive public outreach program that included archaeology discussion panels at Georgia Southern University, Historic Communities and Cemeteries Council meetings, hands-on historic cemetery preservation events with local schoolchildren, and presentations, briefings, and training for Fort Stewart-Hunter Army Airfield personnel and military Families. They also participated in Earth Day and Native American Heritage Day celebrations.

The team was led by DA Civilian CRM Program Manager, Brian Greer. The Hunter Tide Gate Project Team included Kyle Daniels, Fort Stewart-Hunter Army Airfield Engineering; Dena Thompson and Mark Puhalla, U.S. Army Corps of Engineers project managers; Melissa Kendrick, Fort Stewart-Hunter Army Airfield National Environmental Policy Act program manager; Larry Carlile, Fort Stewart-Hunter Army Airfield Fish & Wildlife Branch chief; and contract staff provided by Aerostar SES, Ashley Moss, archaeological field technician; Jessie Larson, archaeological and curations specialist; and George Harris, wetlands/water resources specialist.



Natural resources conservation efforts receive top honor

WASHINGTON —Fort Stewart/Hunter Army Airfield recently received the 2020 Secretary of the Army Environmental Award for Natural Resources Conservation for a Large Installation.

Fort Stewart's 284,000 acres in southeast Georgia provide unrivaled training opportunities for Soldiers in a diverse environment.

The lands contain some of the most biologically and ecologically diverse areas of Georgia, made up of pine forest, wetlands, blackwater rivers, hardwood management areas, forest clearings, and the largest tract of longleaf pine ecosystem in Georgia.

Its wildlife habitat includes seven species protected by the Endangered Species Act and more than 20 species of concern. Additionally, Fort Stewart-Hunter Army Airfield's diverse landscape has 948 different plant species. Through the management strategies developed in the Integrated Natural Resources Management Plan, natural resource managers have formulated a masterful balance between military training needs and the responsible stewardship of natural resources.

To achieve the goals of the INRMP, a team made up of representatives from the environment, cultural resources, and training and security branches developed detailed Integrated Management Prescriptions for each of the installation's 120 training areas.

Those prescriptions dealt with habitat restoration, threatened/endangered species, forestry, cultural resource sites and surveys, wetlands, and training facilities. They also worked with federal and state agencies, universities, research institutions, and non-governmental organizations to ensure that environmental activities were backed by the best science available.

Some of the most notable achievements included protecting 17,003 additional acres under the Army Compatible Use Buffer Program. The ACUB program aids in preventing encroachment from incompatible



development adjacent to installation boundaries. The result increased the total acreage protected under ACUB to 94,597 acres, guaranteeing superior training opportunities for both current and future generations of Soldiers.

Another long-lasting accomplishment was accomplished through land use and forest management with support from external partners, including the U.S. Fish and Wildlife Service, Georgia Department of Natural Resources, U.S. Forest Service, Georgia Forestry Commission, and the Natural Resources Conservation Service. Together, they were able to restore the native longleaf pine/wiregrass ecosystem by planting 134 acres of wiregrass and 438 acres of longleaf pine and by conducting timber thinning on 5,531 acres.

The thinnings and future prescribed management actions will serve as an effort to reduce the threat of wildfire related damages to people and property both on and off the installation.

"The prescribed burn program not only sustains the longleaf pine-wiregrass ecosystem, it opens up the landscape, creating better training grounds with less restrictions," said Jamie Heidle, director of public works.

Additionally, the Forestry Branch maintains an extensive timber harvest program, conducting timber sales that totaled \$5.3 million in support of the Army's Conservation Reimbursable and Fee Collection Program.

The combination of these actions led to improved habitat for the eastern indigo snake, gopher tortoise, and the red-cockaded woodpecker. In fact, continued protection of the red-cockaded woodpecker has resulted in a 63 percent increase in its population since the woodpeckers reached recovery in 2012.

Fort Stewart-Hunter Army Airfield receives more than 148,000 visitors each year who recreate, hunt, and fish on the installation. Providing ample, well-maintained hunting and fishing areas bolstered participation in the recreation program and enhances the community outreach program.

From 2019 to 2020, the team held 287 public outreach events that reached more than 45,000 area residents. School programs, both on- and off-post, included Earth Day events, community showcases, community safety days, and back to school fairs. These educational events increased conservation awareness, which is instrumental in successfully conducting natural resource management to audiences that reach beyond the borders of the installation.

"The lands on Fort Stewart and Hunter Army Airfield have been used to serve our nation's defense for well over half a century and this legacy is not taken lightly by those who use them today. The natural resource team is dedicated to future generations who will use these lands and their resources," said Col. Bryan Logan, Fort Stewart/Hunter Army Airfield garrison commander.

Female battalion commander stands out among the ranks

Women are an integral part of the military, and Women's History Month recognizes their contributions.

"Women's History Month means recognizing those women before us whose shoulders we now stand on," said Lt. Col. Erin Frazier, commander of the 5-306th Brigade Support Battalion, 188th Infantry Brigade, First Army Division East. "The groundbreaking women who've made service possible for all of us, needs to be recognized and remembered today, tomorrow, and always."

"I was raised by a strong woman and I want to do my part to live up to that legacy and continue to provide honest, strong, caring leadership for the Soldiers that I'm privileged to lead, past, present, and future," said Frazier.

Frazier, a native of Norfolk, Virginia, joined the Army after graduating college, said she earned an Army ROTC scholarship to help pay for school.

"I was daughter number three to go to college, so by the time it was my turn to go to school, there just wasn't any money left. I had to find a way to stay in school and earning the ROTC scholarship my sophomore year was the solution to my financial woes."

Frazier, who is the third child of four, said her parents supported her decision to join the military.

"They were proud of me and relieved that there was a way to finish my degree and serve my country," she said.

Frazier is an ordnance officer and holds a bachelor's of science degree in communications, and a master's degree in public administration. She loves serving her country and continues to serve despite obstacles she has faced during her time in service.

"The biggest obstacle I have faced serving as a female in today's Army, is the balance of being tough and not being labeled a certain way for holding up the standard," she said. "Often times as women we are labeled either a "pushover" or the "b" word, there is very little in between."

Staying true to self is how she over-

came those obstacles.

"I let my actions and personality stand on their own," said Frazier. "Eventually, subordinates, superiors, and peers knew and understood that my toughness was to either make them or the organization better and it was never personal."

Frazier, who is fast approaching her 20 year time in service anniversary, said her first duty assignment was the most influential in her career.

"My first company command team was all male and they showed me what it meant to be tough and fair," said Frazier. "Six short months later my entire chain of command was female and they taught me what it meant to be tough, empathetic, kind, and resilient.

"[Retired] Command Sgt. Maj. Vickie Hopson, [retired] Lt. Col. Karen Saravia, and [retired] Chief Warrant Officer 4 Marsha Kelly-Evans, are still impactful women in my life. I count myself blessed to have been molded by such amazing women as a young lieutenant.""

Frazier, who is currently the only female battalion commander serving alongside her male counterparts in the Ready Brigade had this to say about her role in the unit.

"It feels empowering and awesome to stand shoulder to shoulder with my male counterparts and know that I deserve to be here just as much as they do. Being a battalion commander has been my dream since I left company command all those years ago," she said. "Having it realized has been so amazing. I hope that I can be a good example for those inside my battalion and across the brigade as a strong female leader who cares about the individuals, the organization, and the mission of this unit."

Though most Service Members choose to retire at the 20 year mark, Frazier, who has been assigned to 11 duty locations, including Fort Stewart, has no plans of doing that anytime soon. She said she will serve until she is no longer having fun.

"So far, being in command has absolutely been the highlight of my career and I'm loving it every day," said Frazier.

For example, it gave everyone knowledge on how to properly assign sponsors that would prepare incoming Solders to the gaining installation. We must do more of it," says Capt. Gabrielle Wheat, the human resource officer in charge of subordinate unit 1st Battalion, 9th Field Artillery Regiment.

"There's always going to be a comment about being a female and questioning whether or not you can accomplish the same things the guys can do, but oddly enough, I'm super thankful for it because for as many people who have those sorts of opinions, there are twice as many people who know we can do it. I'm fortunate to have the NCOs (noncommissioned officers) and Soldiers that I do because they trust me and

I know I'm able to trust them."

Washa added that although there may have been those who doubted her along the way, the key is determination

"I'd say just keep doing it," said Washa. "There were male leaders along the way who doubted me and doubted that females could do it, but there's always someone out there who knows you can do it and it's been done before. There's females accomplishing all these amazing things, so there's nothing stopping you anymore; the door's open and we aren't going anywhere."

Washa works with another great leader, 1st Lt. Bethany Stuhlman, 5-7CAV's first female tank platoon leader. Washa said she was grateful for her because since she was in the squadron before Washa, Stuhlman helped set her up for success.

"Being the first female tank platoon leader was challenging at times, but very rewarding too," said Stuhlman. "I've had a lot of NCOs and Soldiers who helped me to get to where I am and be successful. I love my job, both when I was a platoon leader in a tank company and now (as a distribution leader).

Stuhlman served as 5-7 CAV's first female tank platoon leader of Darkhorse Troop, as well as the executive officer for that troop. Now she serves as a distribution platoon leader for Diesel Troop's forward support company.

"When I was shooting the tank, that was obviously a great thing to do, but still with my current role, I love working with Soldiers," said Stuhlman. " Every day they make it fun and different and working with all different types of people is what makes everyday fun."

These are just a few of our outstanding female Raiders who have played vital roles in the Raider Brigade. During March, we celebrate this month as Women's History Month.
