Installation practices “worst day” during annual Stewart Guardian exercise

Protestors chanted at the gate of Fort Stewart's Wright Army Airfield. At Hunter Army Airfield, explosions consumed the fuel storage area and spilled aircraft gas across a large swath of the installation. April 14 was a bad day for the installation.

It was designed to be. And it was all an exercise.

Fort Stewart-Hunter Army Airfield holds Stewart Guardian annually. It's the installation's chance to implement and validate emergency response to scenarios like the ones practiced this year.

Garrison exercise planner Beau Bradley was responsible for creating this year's exercise. He, along with others from the Directorate of Plans, Training, Mobilization and Security, as well as emergency services, human resources, public works, and other garrison offices came together to hash out the details to make the exercise rigorous and successful.

“I decided to leverage and trust organizations ‘trusted agents’ to communicate their directors’ intent to ensure we achieved success,” Bradley said. “Stewart Guardian 2021 exceeded my expectations as both Fort Stewart and Hunter Army Airfield demonstrated excellence in the core capabilities we selected to exercise. Of note, we exercised both Installations on the same day, something that has not been accomplished on several years.”

Planning for the exercise began months in advance.

“As the DPTMS exercise planner, I spent significant time reviewing existing after action reviews to identify areas to exercise and develop a solid plan,” Bradley said.

The exercise was designed to be challenging but not impossible. Overall, the intent was to identify areas of both success and improvement.

“As with any training event, we observed areas to improve on and these will be addressed on the corrective action plans,” Bradley said.

Garrison Commander Col. Bryan Logan called the exercise a success.

“Stewart Guardian was an excellent opportunity to stress our systems and teammates,” Logan said. “We always learn and grow from these training events. It's all about keeping our community safe.”

The exercise did result in some minor traffic impacts due to installation gates being closed. Fort Stewart exercise planners and leadership appreciate the patience of the community during the exercise. Planning is already underway for next year's Stewart Guardian.



Georgia Air National Guard teams with Spartans, administers vaccines

Airmen from the Georgia Air National Guard gave a shot in the arm to the active component by providing COVID-19 vaccines to U.S. Army Soldiers assigned to 2nd Armored Brigade Combat Team, 3rd Infantry Division, April 10 in Atlanta.

The Dogface Soldiers from Fort Stewart have been in Atlanta since March assisting the Federal Emergency Management Agency and Georgia Emergency Management and Homeland Security Agency operate a COVID-19 vaccination site at Mercedes-Benz Stadium.

“We have Soldiers mixing the vaccine, we have Soldiers vaccinating civilians, we have Soldiers waiting in the post area waiting 15 minutes to ensure their safety and to watch for adverse reactions,” said U.S. Army 2nd Lt. Angela Kammen, the medical officer for 3rd Battalion, 67th Armor Regiment, 2nd Armored Brigade Combat Team, 3rd Infantry Division. “We also have Soldiers that are not medics helping out with quality control, making sure people know where to go and doing the best they can to ensure a smooth process for everyone.”

Georgians have become accustomed to seeing

service members clad in camouflage fatigues out in public since the COVID-19 pandemic began in March 2020. The Georgia National Guard has employed Soldiers and Airmen across the state as disinfectant teams, hospital support teams, food bank workers and testing site operators.

Georgia National Guard medics have been giving vaccines to fellow Soldiers and Airmen since January. Georgia Guardsmen have also supported mass vaccination sites under supervision of GEMA and the Georgia Department of Public Health.

“We have developed a lot of best practices and lessons learned that we’ve shared not only with the active duty, but also the civilian sector too,” said U.S. Air Force Maj. Frances Burress, an aerospace medicine physician assistant with the Georgia Air National Guard’s 116th Medical Group, 116th Air Control Wing. “I was part of a team that went out to the civilian hospitals, and a lot of the stuff we learned there we brought back to the Guard and shared with the active-duty side of the house.”

Georgia National Guard and 3rd Infantry Division are no strangers when it comes to cooperation and supporting one another.

Along with being the home of the 3rd Infantry Division, Fort Stewart also hosts the Georgia Army National Guard’s Land Dominance Center. The LDC

is property on Fort Stewart designated to the Georgia National Guard for housing and training.

The Georgia Army National Guard’s 48th Infantry Brigade Combat Team wears the blue and white striped 3rd Infantry Division patch as part of the Total Force Partnership Program. This program facilitates more cooperative training between the active-duty and National Guard components by forming official partnerships.

Georgia Army National Guard Soldiers staff the 3rd Infantry Division Main Command Post Operational Detachment. The 3ID MCPOD is a Georgia Army National Guard unit whose mission is to provide additional personnel and support to the 3rd Infantry Division Headquarters. While the MCPOD is administratively assigned to the Georgia Army National Guard’s 648th Maneuver Enhancement Brigade, the 3rd Infantry Division has operational control over the unit during deployments.

Georgia Guardsmen vaccinating active-duty Soldiers is just one more addition to an established and proven relationship.

“They [3rd Infantry Division Soldiers] have welcomed us as brothers in arms; we’re sister services,” said Burress. “It seems like you would almost think we were family.”

TA funding exception to policy guidance

1. For classes that start April 23, 2021 and later, HQ ACCESS is reinstating exception to policy (ETP) Tuition Assistance (TA) funding. Soldiers should enroll in these classes directly with their Educational Institution.

2. To ensure that there is no gap in TA funding, Soldiers whose classes started on March 8, 2021 and later will be provided ETP TA funding if TA eligible (e.g., not Flagged, have TA remaining for FY). As such, no gap exists in a TA-eligible Soldier's ability to enroll in classes under this ETP.

3. When the TA program is back online in ArmyIgnitED, Soldiers should follow the guidance provided in previous messages from HQ ACCESS to request ETP TA for classes beginning March 8, 2021 and later.

4. Once the TA program is back online in ArmyIgnitED and Soldiers are able to submit TA Requests into the system, HQ ACCESS will suspend the ETP TA process. HQ ACCESS will message Soldiers when the TA program returns and when the ETP TA process has been discontinued.

5. Soldiers with questions about the ETP TA process should contact their Army Education Center/Office directly or submit an ArmyIgnitED helpdesk case AFTER the TA program comes back on line.

Serving on wheels

Culinary specialists with the 287th Field Feeding Company, Division Special Troops Battalion, 3rd Division Sustainment Brigade, began serving Soldiers from the recently renovated Outpost food truck, April 13 on Fort Stewart. The truck was renovated as part of an effort to better meet the needs of Soldiers by allowing them to get meals at distributed locations on Fort Stewart.

As part of the renovation, the truck is now equipped with a microwave, an air fryer, external hot water and coffee distribution systems, speakers to play music and a touch screen for Soldiers to order from. Investing in better equipment helps culinary specialists perform faster, with better methods for communication to provide smooth deliveries. When at capacity, the food truck can feed up to 200 Soldiers.

“We have a lot more room inside and we have the new kiosk option, where you can order from the outside,” said Spc. Alexis Robinson, a food service specialist with 287th FFC.

Investing in better technology for processing orders leads to less confusion and a better working environment.

“There’s no having to decipher, ‘Hey, what did you write here?’ That’s where the touch system comes into play,” said Master Sgt. Marques Myers, senior food service noncommissioned officer with Headquarters and Headquarters Company, 3rd DSB.

Having the upgraded food truck gives Soldiers options, especially during times where dining facilities can be closed due to deployments or renovations, to meet the new warrior restaurant model. The air fryer also provides culinary specialists the ability to serve healthier options, as opposed to frying everything in oil.

“The food truck gives the units the ability to move the meal cardholders source of chow every day to a specific location,” said Myers.

The speakers allow Soldiers to enjoy music and a better ambiance while eating.

“I think this new and updated food truck is definitely a morale booster,” said Robinson. “It’s an even better experience than being in the dining facility.”

Protecting your Water Source



The Directorate of Public Works (DPW) is pleased to present Fort Stewart and Hunter Army Airfield's Annual Water Quality Report (Water System Identification CG1790024 and CG0510107, respectively). Our water is SAFE to drink! This report provides you with a detailed account of all water monitoring and testing results gathered in 2020 confirming the

Installation's good water quality. As always, we've met our goal to provide our patrons with safe and dependable drinking water. Additional copies of this report are available at the Installation's Environmental Offices: Fort Stewart Building 1137 and Hunter Army Airfield Building 615.

The sources of drinking water (both tap and bottled) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the land or through the ground, it can dissolve naturally-occurring minerals. Therefore, water can pick up substances as by-products from both the presence of animals and human activities. Contaminants that may be present in source water include:



- Microbial contaminants, such as viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial and domestic wastewater discharges, oil and gas production, or mining and farming activities.
- Pesticides or herbicides, which may come from a variety of sources such as agriculture, urban runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals (VOCs), which are by-products of industrial processes and petroleum production, and they can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be either naturally-occurring or the result of oil and gas production and mining activities.


In order to ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which provide the same public health protection. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. 
Where does my water come from?

Fort Stewart's main water supply comes from six municipal groundwater wells that are no less than 500 feet deep, while Hunter Army Airfield residents are serviced by four 500-foot deep wells and one 1,100-foot deep well. Groundwater is stored in permeable rock layers called aquifers, which are like underground lakes. Our groundwater is supplied by the *Floridan Aquifer*. Before the water is distributed, the water is chlorinated to kill disease-causing organisms and fluoridated to promote dental health.



Georgia Water Restrictions

Georgia has received significant rainfall over the past year. However, the state still restricts outdoor water use to conserve our water resources. Homes and businesses with odd-numbered addresses may water on **Sundays, Tuesdays, & Thursdays** and even numbered or unnumbered addresses water on **Mondays, Wednesdays, & Saturdays** from 12 midnight to 10 a.m. and 4 p.m. to 12 midnight. All outdoor water use is prohibited on **Fridays**.



Source Water Assessment

A source water assessment has been performed on the source of your drinking water (the *Floridan Aquifer*). The Wellhead Protection Plans at Fort Stewart and Hunter Army Airfield were developed to determine the susceptibility of contaminants entering our drinking water supply and to better identify ways for protecting our water source. For further information, a copy of these Wellhead Protection Plans may be reviewed at the Fort Stewart Environmental Office, 1550 Veterans Parkway (Bldg. 1137), Fort Stewart, GA 31314. Vulnerability

Both MEDDAC's Preventive Medicine and the DPW continually monitor the drinking water for contaminants. **Our water is SAFE to drink;** however, some people may be more vulnerable to contaminants in drinking water than the general population. Immunocompromised persons such as those with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC (Center for Disease Control) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

Terms and Abbreviations:

Maximum Contaminant Level Goal (MCLG): Level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant Level (MCL): Highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Action Level (AL): The concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

ppm: Parts per million; a unit of measure equivalent to a single penny in \$10,000.

When it comes to conserving water, small changes can have a big impact. Here are some ways you can help conserve water.

- Turn water off while shaving and/or brushing your teeth.

Only EPA approved laboratory methods are used to analyze your drinking water. Our personnel take water samples from numerous locations throughout the distribution system and residential taps; samples are then delivered to an accredited laboratory where water quality analyses are performed. At a minimum, samples are analyzed as follows:

The Georgia Environmental Protection Division (EPD) issued Fort Stewart/Hunter Army Airfield an SOC monitoring waiver until DEC 2022 because EPD studies have shown that the drinking water is not vulnerable to contamination from SOCs at either installation.

Conserving our Water Supply

Everyday throughout the world, nations are facing water problems in terms of both quantity and quality. Between 1950 and 1970, global water demand tripled and is expected to double within 35 years. Although 75 percent of the earth is covered by water, only 1 percent is available as renewable fresh water, and only about one-third of all precipitation that falls on the land goes back to the oceans by rivers and runoff. We are a nation whose water needs are rapidly rising while available supplies are shrinking; regional water crises are becoming increasingly frequent as water tables are falling and stream flow is decreasing. We can no longer take our drinking water for granted. This means that individuals, municipalities, industries, and governments must be proactive in conserving and protecting our water supplies. The consequences of recurring long duration droughts are far-reaching, affecting wildlife, vegetation, and humans. Additionally, drought impacts on society are often exacerbated by the demand that people place on the water supply. Water is one of the most precious commodities we have on this planet; we ought not to treat it as if it were an unlimited resource. By shifting our priorities for water usage, we can prevent water scarcity. The well has run dry in many places—let's not make our community next!

Health Effects of Lead in Water



If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Water Systems are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. Winn ACH salutes lab professionals

U.S. Army Medical Department Activity-Fort Stewart and Hunter Army Airfield celebrates National Medical Laboratory Professional Week April 18-24 and salutes our lab staff who play an important role in healthcare.

Spc. Jose Robinson, a native of Augusta, Georgia, said he became a medical laboratory technician because the opportunities it offered him.

"It is a wonderful job with a lot of different disciplines" Robinson said, adding it encompasses specialty areas, such as chemistry, hematology, microbiology, research and more.

He said the training for the position was excellent and helped prepare him with valuable experience for the job and follow-on careers. Skills in the hospital laboratory translates well to other positions in the civilian sector. For him, Robinson hopes to pursue forensic science.

Although he enjoys the work, there can be challenges.

"Last year was definitely a struggle," Robinson said, alluding to the coronavirus. "Especially as far as testing for infectious diseases go."

He said the lab stepped up to the mission, adapting and expanding their capabilities.

Part of the solution was upgrading

equipment.

"We got the GeneXpert polymerase chain reaction analyzer and it helped us process a lot more tests, and get a lot more results - a lot faster," Robinson said.

He said another factor was staying positive and productive—something he did with the support of his co-workers.

He said the teamwork in the lab is amazing.

Robinson stated, "You could see everybody was going through the same struggle—the same fight. It helped us realize we're all in this together, we're going to get through this together."

Terry James, a civilian medical technologist at Winn ACH, came on board during that time. She helped fight COVID-19 while continuing traditional laboratory services too.

"People still have heart attacks and they're still having kidney problems and they're still having babies," James said. "Lab services touches all of those things."

She said lab work goes a long way to helping healthcare professionals make their diagnosis. She said it feels good to be part of the bigger team and help make a difference.

"Even though I don't have direct patient contact—every sample I get is a patient," James said. "I keep that in mind all the time. Even when it's four o'clock and I'm ready to go home...The last patient is just as important as the first patient of the day."





CHAPLAIN'S CORNER

Making the most out of silence

Our phones constantly ding, ring and vibrate. We are surrounded by screens with displays that can mimic the brightness of daytime. Our watches provide us minute-by-minute data. Social media, hashtags, and the latest viral sensations make claims on our attention.

All of these things are happening with each breath and yet I haven't even addressed all the demands our platoons, sections and Solider responsibilities.

We are mired in busyness and distracted by the myriad competing priorities that all seek to be the main priority. Then we wake up, drink coffee and do it all over again, and again, and again, praying that we have created a rhythm that brings out our strongest self.

The question I am left with is this; how do I make time for the things that deepen my soul, center my heart and focus my eyes to the steadfast presence of God alongside me? How do I find space for the things that steady the journey that God has placed before?

I suspect the answer to that question rests in something very few of us are truly comfortable experiencing: silence. No one particularly likes silence. It is one of the reasons we so easily surround ourselves with all the distractions and noises that I referenced earlier. I mean, let's be honest; you like noise. I hear you on the way to PT. You love the deep rumble of your mufflers. You love the booms of your weapons. There is a dearth of silence within the Army life, but we must be mindful of the deficiency this creates.

The challenge is that silence is essential for the development of the spiritual life and the development of the spiritual life is essential to the development, depth, insight and focus of our daily development, especially one centered in God.

Consider the words of the Psalmist in the 62nd psalm,

"For God alone my soul waits in silence; From him comes my salvation. He alone is my rock and my salvation, My fortress; I shall never be shaken." (Psalm 62:6)

I wonder what makes silence so challenging. Is it the absence of distraction? Is it a feeling of smallness? Is it an uncomfortable realization that we truly control so little? I don't know. We cannot know everything. I think it is important to make peace with the rawness that silence exposes so that we can find meaning in the opportunity that silence ushers into our souls. Thomas Merton, the great writer on spiritual identity, wrote "There is greater comfort in the substance of silence than in the answer to a question." I believe that. I have experienced that. I pray that you can experience the same too, because silence really is gift.

Silence is a moment that God gives us to bask in the very presence of God's steadfast being. That truth steadies us in every storm. That truth secures every moment of courage. That truth fundamentally transforms us to a closer proximity of the image of God within us as long as we can put down the phones for a minute and find refuge in the promises of God's salvation. It takes space and intention, though.

Admittedly, I have good weeks and bad weeks. Busy weeks and overwhelming weeks. I tell myself I just don't have time for silence as part of my prayer life. I convince myself of this, but then I notice how much time I spent on social media. As much as I love funny dog videos, they aren't going to deepen my soul, open my heart and direct my eyes. They are not going to steady my resolve. They are not going to bring out what God has created for me in the moment.

And so I get up a little be extra early to meet the God waiting to greet me within the new day. May you find time to do the same.





Fort Stewart's George P. Hays Library is now open for face-to-face services after nearly a year of primarily virtual services, which was implemented to mitigate the risk of COVID-19.

In addition to current mask and social distancing regulations, a new system for COVID-19 transmission mitigation includes taking visitors' temperatures, limiting the number of visitors to 25 at a time, and reducing operating hours to 10 a.m. to 3 p.m., Monday through Friday.

In 2020, the library was closed to almost all in-person services. The building underwent a deep cleaning and sanitizing, a full inventory, and a redecoration of the children's center.

Physically, the library has books, DVDs, and video games to check out. Online, there are ebooks, audiobooks and 40 databases, including ones used to learn new languages and research ancestry. All services are free and can be used with a

library account.

"The library has something for everyone; Soldiers, civilians, Families and veterans," said Jacqueline Chappell, the library director.

The library continues to provide virtual programs initiated early in the COVID-19 pandemic that can be found at stewardhunter.armymwr.com. and the Stewart Hunter MWR Facebook page. These programs include virtual story-time for kids, a summer reading program, and online mixology classes for adults.

The library's resources can be used to help get work done. Sgt. Branden Taylor, an investigator assigned to 30th Military Police Detachment, said he visits the library when he needs access to government websites that require a common access card.

"With the library being open, it gives me an opportunity to do what I have to do," said Taylor. "Without the library there's no way I'd be able to get [work] done on time."

Marne Air trains on new AH-64E Apache helicopter

The pilots of the 3rd Squadron, 17th Cavalry Regiment are undergoing AH-64E Apache helicopter familiarization training on Hunter Army Airfield as the 3rd Combat Aviation Brigade, 3rd Infantry Division, fields the aircraft. The first class ran March 24 through April 19.

Currently, the main Apache model used by the brigade is the AH-64D. "While the AH-64D and AH-64E look very similar, they are almost entirely different aircraft from a systems standpoint," said Lt. Col. Jeffery Paulus, the commander of 3rd Sqn., 17th Cav. Regt. "The training the squadron's pilots are currently undertaking is six weeks in length due to the myriad of new features and capabilities the AH-64E provides."

The AH-64E Apache helicopter has an improved transmission and rotor system allowing the turboshaft engine to run more efficiently, said Chief Warrant Officer 2 Bobby Triantos, the aviation mission serviceability officer of 3rd Sqn., 17th Cav. Regt.

For the pilots this means they can use less power to accomplish the same mission. These mechanical improvements increase the AH-64E's speed, travel distance and aircraft cargo load capabilities, Triantos continued.

The increase of efficiency in the drive system also means less wear on the mechanical components improving the aircraft's reliability.

For the pilots, the biggest upgrade are the new avionics inside of the cockpit. The aircraft has new radios and antennas allowing the aircraft to communicate with more advanced instrument systems, Triantos said.

One such function the AH-64E model is capable of performing is full instrument flight, Triantos continued. Full instrument flight is when the pilot uses the information from the instruments in the cockpit to control and maneuver the aircraft. This means pilots can fly through low visibility conditions such as clouds and adverse weather. A capability the older D model did not have.

The improved communication systems also increase the aircraft's ability to work in tandem with the unmanned aerial vehicles used by the brigade.

"Coupled with advancements in unmanned aerial systems and long-range precision weaponry, the AH-64E allows the squadron to locate, identify and engage enemy targets at ranges unheard of within previous generations, while remaining outside of the detection and engagement range of enemy air defense systems," Paulus said.

The unit will continue rotating pilots through this training through October.
