

Army announces implementation of mandatory vaccines for Soldiers

WASHINGTON — The Army outlined its plan today to fully comply with the Secretary of Defense's order requiring all Service members to be fully vaccinated against COVID-19.

The Army began implementing the Secretary of Defense's order on Aug. 24, following DoD and White House guidance. Before then, vaccines had been optional.

"This is quite literally a matter of life and death for our Soldiers, their families and the communities in which we live," said Lt. Gen. R. Scott Dingle, the U.S. Army Surgeon General. "Case counts and deaths continue to be concerning as the Delta variant spreads, which makes protecting the force through mandatory vaccination a health and readiness priority for the total Army."

While soldiers who refuse the vaccine will first be counseled by their chain of command and medical providers, continued failure to comply could result in administrative or non-judicial punishment – to include relief of duties or discharge. Soldiers have the ability to request an exemption from receiving the vaccine, if they have a legitimate medical, religious or administrative reason. Soldiers who are pending exemption requests will not be subject to adverse actions until the exemption is fully processed.

Commanders, command sergeants major, first

sergeants and officers in Command Select List (CSL) positions who refuse to be vaccinated - and are not pending an exemption request – face suspension and relief if they refuse to comply. Prior to any adverse action, each would be notified of the suspension and potential relief from their duties. They would then be counseled and provided the opportunity to be vaccinated before they would become subject to removal from their positions by a general officer.

Officers and noncommissioned officers who have been selected and are waiting to assume CSL command, key billet or nominative sergeant major positions – some of the most coveted assignments in the Army - will likewise be subject to removal from the list for those assignments should they refuse to be vaccinated without a pending or approved exemption.

Commanders will request a General Officer Memorandum of Reprimand be initiated for any Soldier who refuses to be vaccinated and does not have a pending or approved exemption request. Such reprimands can be career ending.

Active duty units are expected to be fully vaccinated by Dec. 15, 2021 and Reserve and National Guard units are expected to be fully vaccinated by June 30, 2022.

Soldiers may request administrative or medical exemptions as outlined in Army Regulation 600-20 and AR 40-562, as well as the new Army Directive

2021-33 that provides supplementary guidance on exemption requests.

Soldiers with previous COVID-19 infections are not automatically exempt from full vaccination and should consult their primary care managers. Soldiers pending exemption requests must continue to comply with all other applicable force health protection measures applicable to unvaccinated people.

Soldiers who have completed an FDA Emergency Use Authorization or World Health Organization-authorized series of vaccinations are fully vaccinated. Soldiers are only considered fully vaccinated two weeks post completion of a two-dose series vaccine or two weeks post completion of a single dose vaccine.

In addition to the COVID-19 vaccine mandate and following CDC and DoD guidance, Army commanders will continue to update health protection protocols consistent with the local conditions of the communities in which they serve. The health protection of our force is a top priority, and we will continue to ensure that our personnel have the most up-to-date information on appropriate safety measures to prevent potential spread of the virus.

Soldiers with questions about the safety, effectiveness and possible side effects of the COVID-19 vaccine should discuss them with their health care provider.

Face masks required in on-post facilities

Effective immediately, 3rd Infantry Division, Fort Stewart and Hunter Army Airfield GO1 requires ALL individuals to wear a mask inside ANY on-post facility at Fort Stewart or Hunter Army Airfield. Service members are also required to wear a mask inside off-post public buildings/ facilities (i.e. barber shops, religious services, grocery stores, etc.). Mask mandate exceptions

Exceptions to the mask mandate can be made if an individual is alone in a walled office; if an individual is eating and drinking and is socially distant from a co-worker; masks may be required to be lowered for identification or security purposes or as an annotated and approved reasonable accommodation. On Hunter Pfizer is offered at Tuttle Army Health Clinic, 9:30 a.m. to 11 a.m., each Wednesday at the Drive-Up clinic. The Moderna vaccine is offered each Tuesday 7:30 a.m. to 4 p.m. at Winn ACH. On Hunter, Moderna is offered at Tuttle AHC, 9:30 a.m. to 11 a.m. Tuesdays and Thursdays. The appointment line is 435-6633, Option 1.

Changes to speeding violations issued

The commanding general recently authorized the Fort Stewart Military Police to issue DD Form 1408 for traffic violations when a Soldier is pulled over for speeding 10mph or over above the speed limit. The DD 1408 is effectively a military speeding ticket that allows a Soldier's brigade commander to issue administrative reprimands, non-judicial punishment, suspension of on post driving privileges, corrective training, and/or other appropriate remedial measures. Master Sergeants and above caught driving 10 mph or over the posted speed limit will have their misconduct addressed by the commanding general in accordance Policy Letter #3.

New bicycle law now in effect

As of July 1, the operator of a motor vehicle approaching a bicycle shall approach the bicycle with due caution and shall proceed as follows. The new 3-Foot-Law is outlined in § 40-6-56.

- Make a lane change into a lane not adjacent to the bicycle if possible in the existing road and traffic conditions

If a lane change under paragraph (1) of this subsection would be impossible, prohibited by law, or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be at least ten miles per hour less than the posted speed limit or 25 miles per hour, whichever is more, and proceed around the bicycle with at least three feet between such vehicle and the bicycle at all times.

Raiders cement Warrior Ethos through hand-to-hand training

The mission of the U.S. Army Combatives Course is to train Leaders and Soldiers in close quarters combat, further cementing the Warrior Ethos to prepare Soldiers to defeat the enemy in hand to hand combat.

Sgt. 1st Class David Huerta, a senior combatives master trainer, assigned to the 1st Armored Brigade Combat Team, 3rd Infantry Division, hosted a Modern Army Combatives training session, Sept. 8 at the Combatives School House on Fort Stewart.

The Modern Army Combatives Program started in 1995 with the 2nd Ranger Battalion and has spread at the grass roots level around the Army. Basic Combatives is one of the Forty Warrior Core Tasks of the Warrior Ethos initiative.

“Combatives training is import-

ant for Soldiers to help instill warrior ethos and Army values,” Huerta said. “The only way to face fear is to face it directly. Many Soldiers have never been in a hand to hand situation so we like to put them in the situation to see how they react. It is just like any other combat training we as an army conduct.”

This type of training entails many lessons and techniques from multiple disciplines involving hand to hand combat. Huerta says a typical training session involves teaching, learning, and sharing about 5 or 6 techniques. He adds that the techniques can come from Brazilian jiu jitsu, boxing, muay thai, judo, and many other styles that the instructors have studied throughout their combined years of training. Each session usually culminates with a full-speed, practical application of lessons learned known as “rolling”.

Mixed martial arts training can

be extremely physically demanding, however it is just as much of a mental workout as it is a physical one.

“It may be difficult and uncomfortable, especially so when you first start, but you learn a lot about yourself,” said 1st Lt. Austin Drago, a Level 1 Combatives Instructor with 1st ABCT, 3rd ID. “Army combatives, as well as Brazilian Jiu Jitsu, is an active, physically demanding puzzle. Every time I learn something new, it’s like adding another piece to figure out and apply; it can be both the most brutal and rewarding thing you’ll ever do.”

There are many instances of Soldiers ending up in hand-to-hand combat throughout history. Drago adds that it is one of the most physically and mentally demanding things Soldiers can do, and there are many lessons to be learned with this type of training.

Army tests new EFMP system, targets assignment process for select Families

WASHINGTON —The Army is currently piloting a new Exceptional Family Member Program online enrollment process to improve the assignment research and selection process for EFMP participants, G-9 officials said Thursday.

Close to 300 Soldiers and family members are participating in the initial test of the integrated Army Enterprise EFMP system, or E-EFMP, from Aug. 27 through Sept. 30, said Paul Grossman, EFMP lead for Soldier and Family Readiness, Army G-9.

The new system should reduce the time Soldiers and families dedicate toward investigating care and support options during the permanent change of station process, Sgt. Maj. of the Army Michael A. Grinston said recently during the 2021 Fires conference, hosted by Fort Sill, Oklahoma.

Families often have to research a gaining installation and surrounding community to determine if they have the necessary services to meet their EFMP requirements, Grinston said. They then have to repeat the process if denied their initial assignment, resulting in undue stress.

“Why does a family member have to research [an assignment] all on their own?” Grinston said. “We are better than that in this day and age. I got that task

and working on it extremely hard.”

In June, Grossman said that the Army awarded a contract to develop the E-EFMP to support the service’s EFMP families by fiscal year 2022.


Under E-EFMP, Soldiers can access a range of medical and assignment information, along with an overview of installation and military treatment facility capabilities, he added. The program will also operate as the Army’s centralized EFMP case management system, allowing Soldiers to initiate a Department of Defense Form 2792, or Family Member Medical Summary, and manage their enrollment online.

Once the pilot is complete, G-9 officials plan to leverage user feedback to improve the program, Grossman said. The goal is to design a system that is both transparent and easy to use.

The E-EFMP will eventually link to the Active Duty Officer Assignment Interactive Module Version 2, or AIM 2.0, or the enlisted assignment process to streamline future PCS efforts, Grinston said.

The Department of Defense’s Office of Special Needs and Military OneSource have also supported EFMP families with the launch of the online tool EFMP & Me, Grinston mentioned during an interview in February.

Through EFMP & Me, Soldiers have access to medical and educational resources, along with step-by-step assistance during the EFMP enrollment process,


PCS preparation, deployments, and other military life events, according to the Military OneSource website.

On the EFMP & Me homepage, users answer a few questions to select the types of information they want to receive. The tool, available on computers or mobile devices, will also generate customizable checklists for users to follow. Lists include essential items to complete, along with tips and other resources.



Installation's first responders

Soldiers and civilians of the 3rd Infantry Division, alongside Fort Stewart police and fire emergency services personnel, held a 9/11 "Patriot Day" Remembrance Ceremony at the Alwyn Cashe Memorial Garden, Sept. 10 on Fort Stewart, to commemorate the 20th anniversary of the Sept. 11, 2001 terrorist attacks.

Hosted by 3rd ID's command team, Maj. Gen. Charles Costanza and Command Sgt. Maj. Quentin Fenderson, the event focused on encouraging Soldiers to take time to personally reflect on the service and sacrifices of the people lost, and to share in the response and resilience of the survivors and the United States.

"As I drove in this morning on the back road, I saw the pictures of the 2,977 people we lost on Sept. 11; 412 of them were first responders," said Costanza. "So as we talk about why tomorrow is Patriot Day, it is because of service. For all of our first responders that are here today, thank you for your service. Thank you for what you do.

Service is more than just this uniform," he said, pointing at his own Army uniform. "For a lot of it, it's about you."

Costanza encouraged attendees to reflect on the service members that lost their lives fighting in Iraq or Afghanistan after the events of 9/11.

Many Soldiers attribute the heroic efforts they witnessed on 9/11 and afterward as their inspiration for serving in the military. Costanza said young service members personally inspire him, emphasizing emergency services member, Pfc. Lucas Williams, age 19, who was not even born at the time of the terrorist attacks. Williams serves as a firefighter on Fort Stewart and assisted Fire Chief Steven Kelly during the ceremony in laying a wreath in honor of firefighters and emergency medical personnel.

Laying a wreath in honor of police officers was Lt. Col. Craig Giancaterino, the commander of the 385th Military Police Battalion and the Fort Stewart and Hunter Army Airfield Police Chief, Bart Knoch.

The 3rd ID command team laid the final wreath in honor of Soldiers and civilians lost in the

attacks.

Sept. 11, 2001, changed more than the skyline of New York City; the attacks changed a generation of Americans, the Army and the world.

At the time of the attacks, Fenderson was serving in Manhattan as an Army recruiter with the New York City Recruiting Battalion. He was in the city that day with another recruiter from the Air Force and their government vehicle was parked in one of the Twin Towers. He recounted running from the site and assisting others lost in the chaos as they made their way on foot to their own headquarters located miles away. Covered in dust and having worn through the Army dress shoes he was wearing, Fenderson remembers helping others while still trying to understand the scope of what was happening around them.

The ceremony included a firing party, moment of silence, the playing of taps, laying of wreaths and the ringing of a ceremonial bell from Fort Stewart Fire Station 1 in sequence with a reading of the timeline of tragic events of 9/11. Early Friday morning, participants of the Fort Stewart 9/11 Remembrance Run rang the bell as they completed the race.



Providers support Afghanistan evacuation efforts in Qatar

CAMP AS SAYLIYAH, QATAR—After a busy week of collecting and organizing donated clothes, hygiene items, toys, and other goods, the Qatar Red Crescent, an international volunteer charitable organization, distributed thousands of goods to Afghan evacuees, Aug. 26 at Camp Al Sayliyah, Qatar.

“We’re here to give support to refugees from Afghanistan,” a male volunteer from the Qatar Red Crescent said. “We’ve arranged everything into boxes based on age, male or female, boy or girl.”

The Qatar Red Crescent brought more than 50 volunteers to Camp Al Sayliyah to help hand out the donations.

“I’m here because I’m a human and because I want to support humans,” the volunteer said. “In Qatar Red Crescent we don’t care where they are from, their beliefs, their religions, their nationalities, or their colors. We care if they are human or not. If they are human, it is our job to support them.”

“A lot of the Afghans came here with just the clothes on their back,” Maj. Owen Chandler, a chaplain assigned to the 3rd Infantry Division Sustainment Brigade said. “So we’re trying to get them set up with some essentials and a few things to make their stay here a little more comfortable.”

Another volunteer with the Qatar Red Crescent said that he was appreciative of everything the U.S. military, the Qatar Red Crescent, and the Qatari public are doing in support of the Afghan refugees.

“Once they announced that there were refugees in Qatar, they started the donations,” he said.

“I’m proud that we are doing all of this and helping people,” said another volunteer.

“This piece of the mission is important because it helps restore the humanity of the people who are trapped in a situation that is completely overwhelming to them, and often they never imagined that this would be where they are,” Chandler said. “Nights like tonight truly are humbling and showcase the generosity of what’s possible with our neighbors.”

CHAPLAIN'S CORNER

Accepting God's unreserved love

How do you know that God loves you? How do you know that God has committed Himself to loving you forever?

If we took a poll of Christian believers and asked them what the most important word in the Bible was you would have a plethora of responses. Some would say the word love and some would say the word faith. Those answers are very good, but there may be an even more important word in Christian scripture and that word is "covenant."

The word "covenant" appears 300 times throughout scripture and it describes the very nature of our relationship with God. It demonstrates the deepest form of faithful love and commitment to the ones who enter into a covenant with each other.

The concept of a covenant is a relatively new and unfamiliar concept for people in the Western world, but for people who have lived in the Middle East, it is an ancient and still well-known phenomena.

A covenant, properly defined, is a legal, binding relationship with no exit clause. It is so much more than a legal contract where both parties can write stipulations into the contract to get out of the legal relationship. One cannot do that with a covenant relationship. In a biblical sense, to make a covenant is to literally "cut a covenant" because there was always blood shed when one made covenant with another.

The covenant ceremony between two people or a group was a rich and symbolic event showcasing total commitment and loving kindness. The two covenant representatives stood before their people and enacted many things. First, they would exchange their cloaks or robes with each other, symbolizing that "my personal covering is over you now, we wear each other's identities." Next would be an exchanging of weapons symbolizing "my physical protection now belongs to you."

The place where the ceremony took place would be marked by something that stood out, like a pile of rocks or a monument of some kind that would be

a reminder to succeeding generations of the sacred nature of the ground they were standing on. Finally a meal would take place celebrating the covenant treaty.

The most important part of the ceremony would see the covenant representatives sacrificing an animal and actually walking together between the two pieces of the animal calling death down upon themselves if either would ever violate the covenant. This may seem like a very grotesque thing to do with our twenty-first century sensibilities and sophistication, but it was very normal and real phenomena in those days and in that culture. Indeed, this was a very powerful symbol that this was no mere contract. Only the shedding of blood and death could make null and void the covenant contract.

For those who have read in Scripture God's covenant with Abraham in Genesis 15, what God and Abraham do in their covenant with each other now makes sense placed in the knowledge of covenant treaties. There is one difference however in the ceremony God makes with Abraham: it is God who walks through the bloody pieces of the animal while Abraham does nothing but stands on the side line. God calls death down upon Himself if He ever would violate his covenant treaty with Abraham and his seed, human kind. Abraham had no responsibility whatsoever. Abraham and humankind got off the hook.

God called himself into account for the violation of the covenant treaty made between humankind and Himself, not because He violated it but because humankind did. And in the fullness of time 2,000 years ago, Christians believed God paid the blood debt for our violation of our covenant with God by sending His Son Jesus Christ to pay that debt forever. Jesus Christ came to live as one of us and to die for us for a debt He did not owe.

How do we know God loves us, totally and with unreserved commitment? It was because of the covenant made with Abraham long ago and ultimately ratified with His Son on a cross for us. Out of His love for us, He paid the debt so we did not have to. That was an act of love that lasts forever.



Providers perfect proficiencies during demilitarization training

Soldiers from 24th Ordnance Company, 87th Division Sustainment Support Battalion, 3rd Division Sustainment Brigade, 3rd Infantry Division, conducted demilitarization training with quality assurance ammunition specialists from Fort Stewart, Sept. 9.

The purpose of the training was to ensure the company's magazine platoon was qualified on the requirements to identify, handle and store ammunition. Being proficient in these areas allows them to safely support 3rd Infantry Division units during training.

"Demilitarization is one of the tasks that my ammunition specialists and my ammunition stock control and accounting specialists need to be proficient at in order to accomplish their war time and peace time missions," said Capt. Joshua Moore, commander of 24th Ord. Co., 87th DSSB, 3rd ID.

To prepare his Soldiers for the training Moore reached out to ammunition subject matter experts.

"For the demilitarization training we checked out the training and evaluation outline as well as coordinated with the quality assurance ammunition specialists at the ammunition supply point for training," Moore said. The QASAS participated by hosting classes to train

the Soldiers.

"QASAS oversee anything ammunition related," said Kenneth Harwell the lead QASAS at the Fort Stewart ammunition supply point. "I received a call that some of the newer troops needed guidance on identifying ammo so I put together a presentation to give them the basics."

The presentation consisted of basic knowledge such as color-coding, but the biggest take back from the presentation was learning how to properly identify ammunition lots.

"The most critical, important takeaway during the training was learning how to identify ammo by lot numbers," Harwell said. "It's very specific to us so we can identify ammo in malfunctions so that we can make sure the troops don't get bad ammo."

The QASAS work with the Soldiers in to ensure that they learn from the training and are able to apply what they learned in real-life scenarios.

"I'm glad I can work with 24th to help them and try to get them to work out at ASP," Harwell said. "Hopefully when the Soldiers see a round loose on the ground they can identify what it is and properly handle it."

The training went more in-depth than the training the Soldiers received from Advanced Individual Training received from the ordnance school.

"This differs from advanced initial entry training because it specializes more on the color use," said Pfc. Alejandro Costas, an ammunition specialist assigned to 24th Ord. Co. "I learned more regulations towards ammunition."

Usually, demilitarization training needs to be accomplished annually, but 24th goes above the call of duty by training their Soldiers more than what is required.

"We try to knock it out bi-annually just so that they maintain proficiency in demilitarization of ammunition," Moore said.

Following the demilitarization training, leaders in the company are continuing to prepare their Soldiers for future ammunition oriented training.

"We're coordinating with the 38th Ordnance Company for further training," Moore said. "This is part of our training progression that's going to culminate with our live-fire demolition range in November. All our Soldiers will have the opportunity to prepare their own demolition charges to simulate the emergency destruction and demilitarization of war time stocks in the event that ammunition needs to be removed from the military surplus, or if there is fear of the ASP being overrun during the war time operation."
