# An expert early: Spartan Soldier excels

The Army Expert Infantry Badge, or EIB, is awarded to Soldiers who demonstrate proficiency in infantry skills and tactics over a two week train-up and one week of testing that ranges from first aid, to call for fire, to movement under fire, to map reading, and to a weapons proficiency. But for one soldier, earning his EIB was only the beginning of his journey to becoming an early expert.

Sgt. Caleb Zimmerman, a native from Wichita, Kansas, assigned to the "Hound Battalion," 3rd Battalion, 67th Armor Regiment, 2nd Armored Brigade Combat Team, 3rd Infantry Division, joined the Army on Nov. 7, 2017, as an infantryman and attended infantry one station unit training on Fort Benning.

While Zimmerman has a family history of serving in the military, he says his main inspiration for joining came from his dad, who he calls "pops."

"Growing up, I didn't have a father figure in my life, but I was introduced to him when I was 15 years old. Since then, he has been that missing piece that I've always wanted," Zimmerman explained. "He told me about his military experience and has given me so much advice that has helped me throughout my Army career and in life so far."

Zimmerman took his pop's advice to heart as he began his Army career. He received his EIB while stationed in Italy with the 173rd Airborne Brigade in Nov. 2020. Upon his return to Fort Stewart, Zimmerman passed the promotion board and attended professional military educational school for sergeants called Basic Leadership Course. Sooner after, he received a school slot for the Army Ranger School that would begin June 27, an opportunity he was eager to have.

"It took me a while to go to Ranger school because personally, I didn't think I was ready for that type of challenge," Zimmerman admitted. "I wanted to be more experienced in my craft because I knew being in the infantry would help a lot, especially because of the battle drills and other physical and mental aspects. I prepared myself and made it happen."

He credits his asking of questions, doing his job, constant battle drills and teamwork for his success. His experience at Ranger School was one of pride and determination.

"Ranger school was amazing and definitely lived up to its name of being the hardest school in the Army in my opinion. It was very challenging because you push yourself literally every day, but I would do it all again if I had to."

He said to get through the school, everyone had

to work together.

"It's all about teamwork because no tabbed Soldier got it by themselves; we did it together," said Zimmerman. "Teamwork is everything in the Army, you're always going to have someone there to help. It provides more opportunity for Soldiers to share ideas to help accomplish the mission."

Though Zimmerman reached goal of obtaining his Ranger tab, his journey is far from over.

"His drive for his military career is beyond ambitious," said Sgt. Damien Truesdale, a fellow Soldier also assigned to 3rd Bn., 67th AR, 2nd ABCT, 3rd ID. "Every goal he sets to accomplish, he creates a blueprint of the bigger picture. He puts in the extra work on his own time daily to get himself ready for any Soldier task at hand."

According to Truesdale, Zimmerman also uses that same drive with his Soldiers.

"As a noncommissioned officer, Zimmerman strives to take charge and lead appropriately in teaching, mentoring and guiding Soldiers to be better than himself," Truesdale said.

Zimmerman sets higher standards for himself and credits his mentors for much of his success. His advice to other Soldiers is to go after what you want.

"I live by the motto 'you'll always be what you've been if you always do what you've always done," he said. "To me, this means keep at it. Do your job to the best of your ability and take what you've learned from good and bad leadership, define that knowledge as your own and then apply it. If you want to make the Army better, then the only thing stopping that is you."

He leaves for his next duty station on Fort Campbell, Kentucky, in November and plans to pursue further challenges.

# EOD Soldiers pay tribute to fallen technicians

Explosive Ordnance Disposal Soldiers from the Fort Stewart-based 38th Ordnance Company paid tribute to fallen EOD technicians at cemeteries in eastern Gaeorgia, Sept. 18.

In one day, 1st Lt. Matthew Johnson, Capt. Jeremiah Worker, 1st Lt. Jill Bottarini and Sgt. 1st Class Eliot Bray placed flags at the gravesites for four different EOD technicians.

Johnson coordinated the visits to honor EOD technicians who served in the Army, Navy and Marine Corps during World War II, Vietnam and Iraq. Across eastern Georgia, they visited the Northside Cemetery in Pembroke, Bonaventure Cemetery in Thunderbolt, Oakland Cemetery in Waycross and Jesup City Cemetery in Jesup.

"Before attending school at the Virginia Military Institute, I had the privilege of meeting several Army EOD techs," Johnson said. "Their intelligence and confidence in their craft, along with the community that they fostered was a major driving factor. I was also driven by the desire to lead Soldiers whose primary mission is to protect personnel."

A four-year Army veteran from Chester, Virginia, Johnson is the operations officer for the 38th EOD Company, which is part of the 184th EOD Company, 52nd EOD Group and 20th Chemical, Biological, Radiological, Nuclear, Explosives Command.

The Aberdeen Proving Ground, Maryland-headquartered 20th CBRNE Command has Soldiers and civilians on 19 installations in 16 states who deploy to take on the world's most dangerous weapons and hazards.

Johnson also participated in the Sept. 10, 9/11 Memorial Run on Fort Stewart, where he ran 4.2 miles in 59 minutes in an 85-pound EOD bomb suit.

He was recently named the 52nd EOD Group Hero of the Week for his efforts.

According to Johnson, the EOD Memorial at the Naval EOD School on Elgin Air Force Base, Florida, inspired him every day when he was attending the school. He added that the memorial highlights the joint service nature of the EOD profession.

"The memorial has the names of EOD techs from all four service branches who have fallen in combat or performing their jobs as EOD techs," said Johnson. "The memorial not only stands to commemorate the fallen but also a reminder that even though we belong to different branches of the military we all share a bond and community that goes beyond our respective military branches."

#### Face masks required in on-post facilities

Effective immediately, 3rd Infantry Division, Fort Stewart and Hunter Army Airfield GO1 requires ALL individuals to wear a mask inside ANY on-post facility at Fort Stewart or Hunter Army Airfield. Service members are also required to wear a mask inside off-post public buildings/ facilities (i.e. barber shops, religious services, grocery stores, etc.). #### Mask mandate exceptions

Exceptions to the mask mandate can be made if an individual is alone in a walled office; if an individual is eating and drinking and is socially distant from a co-worker; masks may be required to be lowered for identification or security purposes or as an annotated and approved reasonable accommodation. #### Vehicle parking safety reminder

When parking a vehicle into a space, do not block the pedestrian walkway with your bumper or trailer hitch. If there is a sidewalk, or marked pedestrian pathway, ensure that it is not blocked by any portion of your vehicle when you park by it. A pedestrian walking past the vehicle may not notice a trailer hitch, and be severely injured by walking into it. #### Changes to speeding violations issued

The commanding general recently authorized the Fort Stewart Military Police to issue DD Form 1408 for traffic violations when a Soldier is pulled over for speeding 10mph or over above the speed limit. The DD 1408 is effectively a military speeding ticket that allows a Soldier's brigade commander to issue administrative reprimands, non-judicial punishment, suspension of on post driving privileges, corrective training, and/or other appropriate remedial measures. Master Sergeants and above caught driving 10 mph or over the posted speed limit will have their misconduct addressed by the commanding general in accordance Policy Letter #3.

To accomplish this, the Secretary of Defense directed the mandatory vaccination of service members against COVID-19 by signing the memorandum, "Mandatory Corona virus Disease 2019 Vaccination of Department of Defense Service Members," on Aug. 24.

On Sept. 9, the President of the United States directed Executive Branch agencies to implement a COVID-19 vaccination requirement for Federal employees to ensure the health and safety of the Federal workforce and members of the public with whom they interact by signing Executive Order 14043, "Requiring Coronavirus Disease 2019 Vaccination for Federal Employees."

All DOD civilian employees must be fully vaccinated by Nov. 22, subject to exemptions as required by law. Employees are considered fully vaccinated 2 weeks after completing the second dose of a two-dose COVID-19 vaccine or 2 weeks after receiving a single dose of a onedose COVID-19 vaccine.

New DOD civilian employees must be fully vaccinated by their entry on duty (start) date or Nov. 22, whichever is later. To meet this requirement, individuals must be vaccinated with vaccines that are either fully licensed or authorized for emergency use by the Food and Drug Administration (e.g., Comimaty/Pfizer-BioNTech, Modema, Johnson and Johnson/Janssen); listed for emergency use on the World Health Organization Emergency Use Listing (e.g., AstraZeneca/Oxford); or approved for use in a clinical trial vaccine for which vaccine efficacy has been independently confirmed (e.g., Novavax). Those with previous COVID-19 infection(s) or previous serology are not considered fully vaccinated on that basis for the purposes of this mandate.

Those who are not currently fully vaccinated must meet the following deadlines, if using vaccines that are fully licensed or authorized for emergency use by the FDA, in order to be fully vaccinated by Nov. 22:

- Oct. 11: first dose deadline (if receiving the Modema vaccine);
- **Oct. 18:** first dose deadline (if receiving the Comimaty/Pfizer-BioNTech vaccine);
- Nov. 8: second dose deadline (if receiving the Modema and Comimaty/PfizerBioNTech vaccines);
- Nov. 8: first (only) dose deadline (if receiving the Johnson and Johnson/Janssen vaccine).

In accordance with Deputy Secretary of Defense Memorandum, "Coronavirus Disease 2019 Vaccine Guidance," Dec. 7, 2020, DOD civilian employees are eligible to receive the COVID-19 vaccine at any DOD vaccination site, including military medical treatment facilities. They may also opt to receive the COVID-19 vaccine at locations other than DOD vaccination sites, including retail stores, private medical practices, and/or local and State public health department sites. Employees, including those who have already received COVID-19 vaccines, must be prepared to provide a copy of their COVID-19 vaccine record in order to meet forthcoming procedures for DOD COVID-19 vaccination verification.

Additional guidance, including procedures for processing vaccination exemption requests, will be published by the Under Secretary of Defense for Personnel and Readiness. The USD P&R is authorized to rescind this memorandum as necessary for purposes of providing updated guidance.

Vaccinating DOD civilian employees against COVID-19 will save lives and allow for the defense of our Nation. Thank you for your focus on this critical mission.

# Marne Air Soldiers earn Armed Forces Service Medal

Marne Air Soldiers assigned to Echo Company, 3rd Aviation Regiment, 3rd Combat Aviation Brigade, 3rd Infantry Division, received the Armed Forces Service Medal, Oct. 1 on Hunter Army Airfield.

Col. Eric Vanek, commander of the 3rd CAB, presented the Soldiers with the Armed Forces Service Medal for their outstanding actions while deployed to Fort Huachuca, Arizona, in support of the U.S. Customs and Border Protection security efforts, June-Sept.

"It doesn't matter where you are executing your mission, it's about the professionalism that we carry forward," Vanek said. "I was absolutely impressed by this team's dedication to accomplishing the mission, and their dedication to get after it every single day."

The company was tasked with the mission to conduct 24-hour reconnaissance along 340 miles of the Southwest border. To accomplish this, the company performed daily logistics, maintenance, and administrative support tasks required to conduct flight operations. Throughout the summer, the Soldiers of Echo Company flew six nights a week identifying potential threats and communicating with U.S. Customs and Border Protection agents to further investigate. "The experience of deploying to Arizona and contributing to a real-world mission set was an invaluable experience to the Soldiers," said Maj. Ross Skilling, the commander of Echo Company, 3rd Avn. Regt., 3rd CAB. "This mission was a close replica of what our Soldiers would experience on an operational deployment elsewhere in the world, preparing us for any future mission that comes our way."

The company had to think through real life challenges to mobilize Soldiers and equipment, facing a new mission with new challenges every day.

"All aspects of the company's operations, maintenance, logistics and leadership was challenged in ways that cannot be replicated at home station," Skilling said. "Leaders, maintainers, and operators alike had to manage relationships with our enabling partners and develop creative solutions to problems they faced."

Overall, the Soldiers of Echo Company, 3rd Avn. Regt. flew 874 hours and detected 904 non-U.S. citizens, which led to 449 apprehensions.

"I am extremely proud of the company for not only how well they accomplished the mission, but for their conduct," Skilling said. "The manner in which the Soldiers assumed ownership of the operation from the planning phase all the way to re-deployment was with the utmost professionalism."

# Combating suicide, domestic violence

#### ACS Victim Advocacy

Every 40 seconds a person dies by suicide worldwide; every nine seconds a woman becomes a victim of domestic violence.

Research has shown that ongoing exposure to violence can lead to an increased risk for suicidal behavior in women and children. However the victim may not be able to relate the suicidal thoughts with the domestic violence they are experiencing. It may also be difficult for others to connect the two unless the individual shares or presents some indicators. Ongoing exposure to psychical and psychological distress can lead to feelings of hopelessness, stress, and even depression.

The National Suicide Prevention Lifeline reports there are warning signs or red flags that can indicate someone is at high risk of attempting suicide.

- Conversations about death or wanting to kill themselves
- Looking for a way to kill themselves, such as searching online or purchasing a weapon
- Expression of feeling hopeless or having no reason to live
- Identifying themselves as feeling trapped or in pain that is \ unbearable
- Views themselves as a burden to others
- Consumption of alcohol or drugs intake is increased or has increased
- Behaving recklessly
- Excessive sleeping or not sleeping enough
- Withdrawing or even isolating themselves
- Extreme mood swings
- Having or showing signs of rage or talking about seeking revenge If you or someone you know has been exhibiting these indicators, the National Suicide Prevention Lifeline encourages you to
- Ask the individual questions (Are you thinking about killing yourself?)
- Link the individual to a support group and other community resources
- Encourage them to seek help
- Ask if they will let you hold onto things for safe keeping (i.e. weapons)

Listening without judgment and allowing them to talk is another effective way to assist. Provide regular check-ins to ensure they are okay, which also shows that you care.

## Financial management technicians certify for deployment support

Finance management technicians assigned to Alpha Detachment, 24th Financial Management Support Unit, Division Special Troops Battalion, 3rd Division Sustainment Brigade, 3rd Infantry Division, participated in an Operation Support Team certification throughout the month of September to prepare the unit to support the U.S. Central Command.

"Today marks the final day of our Army Financial Management Command OST evaluation," said Alpha Det. commander, 1st Lt. Elizabeth Christensen. "This is in preparation for our upcoming CENTCOM mission for the Commercial Vendor Services retrograde."

Similar to most military training, financial management technicians train in support of their mission. This mission is focused on contracting and paying for the contracts.

"Last year [the training] pertained to a theater vendor pay cells mission, disbursing mission, and a military pay mission," Christensen said. "This year, the mission is entirely focused on proofing contractual agreements and paying for the contracts that go through the entire CENTCOM area of responsibility."

The evaluation differs from finance's ordinary training operations due to its focus on the specific skills and knowledge they will need to support their upcoming deployment.

"We consistently train throughout the year in order to maintain our flexibility and agility as a unit with our military occupation specificity," Christensen said. "However, we only tend to do this level of intense training of evaluation right before we enter into a deployment or a significant mission. Essentially this type of training of evaluation is the finance version of heading out to the National Training Center on Fort Irwin, California."

Unlike most overseas deployments, the 24th FMSU will be providing support to CENTCOM units from the U.S.

"Most have not heard of that type of mission because it is pretty much unique to finance," Christensen said. "So, essentially when this mission kicks off and we have our transfer of authority we are going to adjust ourselves to the downrange CENTCOM time zones and we'll be operating seven days per week depending on mission requirements in support of the CENTCOM environment and ensuring that all their contracts are proofed and paid in a timely manner."

It's one thing to familiarize a Soldier with knowledge that they were previously trained on, but it an entirely different challenge when training that Soldier for a mission they are not acquainted with.

"We've actually never dealt with this level of contracts before, so us seeing contracts come in reviewing and processing all the way through is very beneficial for us because we don't have this day-to-day," said 2nd Lt. Morgan Fadel, the disbursing agent for Alpha Det. "It's not a task that we train and it's not something our Soldiers

have seen before unless they have previously done this mission."

The 24th FMSU Soldiers traditionally provide financial support to the installation. With the unit's upcoming in-place deployment, the Soldiers are expected to certify and understand how to conduct contracting and paying for the contracts.

"We don't handle a lot of contracts like the Mission Installation Contracting Command which is not 24th FMSU," Fadel said. "The MICC deals with a lot of contracts on Fort Stewart and the local area with U.S. contractors and money whereas we'll be dealing with everything downrange. Our mission involves liaising with multinational banking industries across the globe."

To prepare for the training, finance Soldiers were given multiple exercises to practice following proper procedures when dealing with contracting paperwork.

"We review all the different documents that OST comes here with and enforce repetition to ensure that the information is retained," said Sgt. 1st Class Jermaine Johnson, the senior noncommissioned officer for Alpha Det. "Repetition is key for this mission in order to get familiarized with the process and procedures. We would also read regulations to ensure that the Soldiers abide by proper protocols."

The finance management technicians faced several unfamiliar training obstacles to ensure they learned the processes to certify and become mission ready.

"It's is a learning curve, but we have an outstanding group of high-speed individuals that learn very fast and they take great notes" Johnson said. "At first it was a little difficult because it was like we were receiving information from a fire hose, but once the Soldiers got the hang of it and realized the process from start to finish they figured out why certain things are the way they are."

Some may think that those working behind the computer do not play a lethal role in the mission, but when it comes to financing a battle the funds have to come from somewhere.

"We actually change lives," Johnson said. "We shape the battle field, pay for the battle and any reconstructions downrange comes from us. So, we are just as important as a combat unit. The support units support the combat units and we make sure all the contracts are paid and the money is funded and allocated where it needs to be allocated to ensure that we achieve victory."
