# Army launches annual housing tenant satisfaction survey

The Army began its annual housing tenant satisfaction survey last week to gather feedback about living in Army housing. Survey results will guide the decisions the Army makes about future housing.

“As a team, the Fort Stewart-Hunter Army Airfield Housing Office and Balfour Beatty Communities have listened to our residents’ concerns and we’re committed to taking action,” said Col. Manny Ramirez, Fort Stewart-Hunter Army Airfield garrison commander. “By responding to the survey, our on-post residents have the opportunity to voice their concerns and help us continue to work together to keep their best interests at the forefront of all that we do.”

An online survey link was emailed from CEL & Associates, Inc. — an independent, third-party company — on Jan. 11 to more than 110,000 tenants living in privatized, government-owned and government-leased housing on Army installations across the globe. Completing the confidential survey takes about 10 minutes, and tenants have 45 days to do so.

“We are off to a great start with this year’s Tenant Satisfaction Survey,” said Doug Delzeith, housing manager for the Fort Stewart-Hunter Army Airfield Housing Branch. “Hunter Army Airfield is leading the way with



14.8% completion rate with Fort Stewart following at 6.8%. We cannot emphasize enough how important it is to take the survey for current and future residents alike. The Army takes your input at the end of the survey and works with Balfour Beatty to create an action plan to improve the quality of life here at Fort Stewart-Hunter Army Airfield.”

Army privatized, government-owned and government-leased housing tenants can rate their satisfaction

with services, property and the overall housing experience through the online survey. Feedback will be used by the Army to help maintain a high quality of life for service members and their Families.

The Army is investing billions of dollars into transforming barracks and on-post housing at installations across the globe to provide Soldiers and their Families with quality, safe and secure housing and a better quality of life. The Army has fully implemented the Tenant Bill of Rights, ensuring privatized housing tenants receive quality housing and fair treatment.

Housing tenants who do not receive the survey notice email from [ArmyHousingSurvey@celassociates.com](mailto:ArmyHousingSurvey@celassociates.com) should contact their local garrison housing offices.

Residents have until Feb. 24 to submit their surveys. “Each Resident that submits a survey will be entered to win fun and cool prizes, including Gift Cards,” said Melanie Cruz, housing manager for the Fort Stewart-Hunter Army Airfield Housing Branch. “Please take a few minutes to do the survey. Every voice deserves to be heard and we are listening. Completing the survey helps us help you make this a better place to live.”

# Soldiers recognized for saving 16-month-old Afghan evacuee

**CAMP AS SAYLIYAH, Qatar** — Two Military Police Soldiers tasked with protecting vulnerable Afghan travelers did more than just that when they saved an unresponsive 16-month-old Afghan in November.

For their actions, Spc. Samantha Gallardo and Spc. Shawn Miller of the Fort Stewart, Georgia-based 293rd Military Police Company, deployed here in support of the Afghan Evacuation Mission Support Element, were each awarded the Army Achievement Medal during a ceremony Jan. 1.

Nov. 17 was another typical day on Camp As Sayliyah, where the pair's daily routines include providing security and interacting with Afghan guests. That changed when they got word of an emergency. An Afghan mother and father had tried to wake their child up, but the child was unresponsive and not breathing.

"Another Soldier told us that a mother was in distress," said Miller, of Chesapeake, Virginia. "When we got [to the scene], there was a mother holding onto her child because he wasn't breathing."

The Soldiers immediately knew what to do. As Gallardo, of Fresno, Calif., took the child from his mother and put him on a table, while rubbing his back and sternum to determine if he was choking or having a seizure, Miller got on the radio to call for medical assistance.

Although they are MPs whose primary mission is to provide security for Afghan guests, this wasn't the first time the Soldiers had to provide medical attention. As

she assessed the situation and examined the child, Gallardo also had to keep the parents and herself calm.

"Adrenaline definitely kicks in," she said. "It hits you pretty hard, but it keeps you calm. So, I was performing the task while also telling the mother to keep calm and that everything was going to be okay."

Drawing on her training and experiences, Gallardo decided to do a finger sweep.

"I put my finger in his mouth and did a sweep," Gallardo said. "That was when he started to cry."

Medical personnel arrived shortly after that and took the family to the clinic to further evaluate the child. Since then, the family has left Camp As Sayliyah for movement to the United States.

Miller and Gallardo credit their training with helping them that day.

"Back home, our training includes first aid because the law-enforcement situation is constantly changing," Miller said. "We're trained on a multitude of tasks. These are the tasks we hope we never have to do, but they allow us to assist before medical personnel arrive."

The Soldiers said the incident was particularly meaningful because of the impact they have on those they were tasked to help.

"It's a rewarding experience because regardless of where they're from or where they're going, we are able to support and help our guests while they're here under our care," Miller said.

For Gallardo, saving a child also has personal meanings.

"I am married. I want kids one day, so it is a big relief to be able to help other families," she said. "Plus, this is the work I like doing — humanitarian work. It's humbling."

## Face masks required in on-post facilities

Effective immediately, 3rd Infantry Division, Fort Stewart and Hunter Army Airfield GO1 requires ALL individuals to wear a mask inside ANY on-post facility at Fort Stewart or Hunter Army Airfield. Service members are also required to wear a mask inside off-post public buildings/ facilities (i.e. barber shops, religious services, grocery stores, etc.). ## Mask mandate exceptions

Exceptions to the mask mandate can be made if an individual is alone in a walled office; if an individual is eating and drinking and is socially distant from a co-worker; masks may be required to be lowered for identification or security purposes or as an annotated and approved reasonable accommodation. ### Vehicle parking safety reminder

When parking a vehicle into a space, do not block the pedestrian walkway with your bumper or trailer hitch. If there is a sidewalk, or marked pedestrian pathway, ensure that it is not blocked by any portion of your vehicle when you park by it. A pedestrian walking past the vehicle may not notice a trailer hitch, and be severely injured by walking into it. ### Changes to speeding violations issued

The commanding general recently authorized the Fort Stewart Military Police to issue DD Form 1408 for traffic violations when a Soldier is pulled over for speeding 10mph or over above the speed limit. The DD 1408 is effectively a military speeding ticket that allows a Soldier's brigade commander to issue administrative reprimands, non-judicial punishment, suspension of on post driving privileges, corrective training, and/or other appropriate remedial measures. Master Sergeants and above caught driving 10 mph or over the posted speed limit will have their misconduct addressed by the commanding general in accordance Policy Letter #3.



# Maintain Battalion fields new system, supports modernization efforts

Soldiers assigned to the “Maintain Battalion,” 703rd Brigade Support Battalion, 2nd Armored Brigade Combat Team, 3rd Infantry Division, began fielding the new state-of-the-art shelters known as the Next Generation Automatic Test Set this past August and September on Fort Stewart. The NGATS replaces the legacy Direct Support Electrical Systems Test Sets platform and provides Integrated Test Equipment Operator and Maintainers, military occupational specialty 94Y, Soldiers quality maintenance and repair capability to support of Soldiers in combat and field operations.

According to Army Operational Test Command test officers, NGATS is designed to provide a general-purpose mobile and modular diagnostic test system to support testing digital and analog electronic hardware and software for a variety of Army weapon systems.

The fielding is in support of the 2nd ABCT’s modernization effort as the 2nd ABCT, 3rd ID, begins to receive modernized vehicle platforms, such as the 109A7 Paladin howitzer, M2 Bradley Fighting Vehicle and M1A2 Abrams tank that will make 3rd ID the most modernized division in the Army by summer 2023.

“It is not just the line units that must modernize; it is the whole force to include those of us that sustain the fight, and NGATS plays a major role in the modernization plan,” said Lt. Col Harley Jennings, commander of the 703rd BSB, 2nd ABCT, 3rd ID. “Building expertise and mastering the new system before the arrival of the new equipment will ensure that the brigade is ahead of the power curve for integrated test equipment maintenance.”

Warrant Officer 2 Aaron Jones, Warrant Officer 1 Stephen Crisp and 94Y Soldiers, assigned to Bravo Company, 703rd BSB, 2nd ABCT, went through four weeks of classroom instruction in September 2021 on the new NGATS systems led by subject matter experts from the Army Material Command and Picatinny Arsenal. Soldiers were trained to proficiency in operation, capabilities and maintenance of the new system. The two warrant officers and Soldiers also received cross training on the M1120 HEMTT Load Handling System and Container Handling Units to become entirely self-supporting and functional in both the operation and transportation of shelters.

“NGATS enables us to be streamlined and highly mobile, which improves our effectiveness across a broad range of mission sets,” Jones, the senior technician for the Missile Electronic Repair Section in Bravo Company, 703rd BSB, 2nd ABCT, said. “Besides a smaller footprint and increased mobility, new features such as climate-controlled interiors and built-in hoist systems are just a couple examples of improvements seen in this new generation of maintenance capability. With all the upgrades that have followed the legacy system, sustainment Soldiers are prepared to support the electronic diagnostic repair of modernized military vehicle platforms.”

# Nation observes anniversary of Operation Desert Storm

Operation Desert Storm began 31 years ago — on Jan. 16, 1991 — five months after Iraqi forces invaded and annexed Kuwait.

That operation to oust the Iraqis is also known as the Gulf War; it came about after Iraqi President Saddam Hussein refused to withdraw his forces from Kuwait.

In response, the United States and partner nations began a buildup of arms and forces in Saudi Arabia. That phase, leading up to Operation Desert Storm, was known as Operation Desert Shield.

Early on Jan. 16, 1991, the air campaign began with U.S. Army and Air Force helicopters knocking out Iraqi antiaircraft facilities and Hellfire missiles destroying Iraqi radar sites.

Then, fixed-wing aircraft from the Air Force, Navy, Marine Corps and coalition forces, augmented by cruise missiles, pounded Iraqi positions and supply lines for the next 42 days.

Iraqi forces were not idle. On Jan. 29, 1991, they attacked and occupied the city of Khafji, Saudi Arabia. Two days later, they were driven out of Saudi Arabia by U.S. Marines, Saudi and Qatari forces.

On Feb. 24, 1991, the ground war began with U.S. and allied forces penetrating deep into Kuwait and Iraq before the end of the day. The advance was so swift that masses of Iraqi troops began surrendering within hours.

By Feb. 28, 1991, U.S. and allied ground forces in Iraq and Kuwait decisively defeated a battle-hardened army — the fourth largest in the world — and liberated Kuwait.

During air and ground operations, U.S. and allied forces destroyed over 3,000 tanks, 1,400 armored personnel carriers, 2,200 artillery pieces, and countless other vehicles. Ninety-six service members were killed in action; an estimated 30,000 Iraqi troops were killed.

The war illustrated the importance of the 35 allies and partners that comprised the coalition to liberate Kuwait, which included several Arab nations.

#### **The war also included some notable firsts:**

- It was the first war in which TV news broadcasts were aired live from the frontlines.
- It featured the largest tank battle in U.S. history.
- The Patriot missile system was used in combat for the first time; it was used to intercept Iraqi It was the first time GPS and precision-guided munitions were used on a massive scale.

# The Battle of Anzio: Reflecting on the Division's World War II legacy

One of the bloodiest and most drawn-out battles experienced by the United States Army of the Second World War: The Battle of Anzio-Nettuno will forever live in infamy in the hearts of those that engaged in it. The 3rd Infantry Division was fully committed to this battle, from start to finish, for over four months.

During the second world war, the 3rd ID experienced more casualties than any other United States Army Division, as they had the most engagements against Axis forces.

After months of preparation in North Africa, the 3rd ID had developed into one of the finest fighting forces of the United States Army. The famed "Truscan Trott" was mandated by Division Commander, Major General Lucian King Truscott Jr., for all Soldiers serving in the division. The Truscan Trott consisted of marching at a pace in full kit at four miles per hour. This was heavily criticized by many leaders at the time, but the conditioning prepared the Soldiers for the

harsh conditions and ultimately to them being successful in their mission.

During the early morning hours on Jan. 22, 1944, 3rd ID was the spearhead for the landing on the Anzio

beachhead and was a central part of Operation Shingle. This operation was the allied plan to move in swiftly and capture Rome, however, the battle would drag on longer and cost more than anticipated. After initially not encountering resistance from the Nazi forces during the landings, 3rd ID would move further inland and initiate brutal fighting with the Nazi forces.

The initial landings did not involve heavy fighting, however, it was the first day of one of the war's most important battles. The 3ID experienced heavy casualties, but eventually emerged victorious in the annals of Military History. The Battle of Anzio is mostly overshadowed in history by the more famous Allied Normandy landings (Operation Overlord). On June 5th, 1944, the Allies had captured Rome which effectively ended the battle and further liberated the Italian peninsula from Axis oppression. The details of the bloody fighting in the Italian countryside during these months are some of the most brutal experienced in the Second World War.

## Charlie Dawgs improve readiness with new running method

Running is a recurring change of support from one foot to the other. This change begins as the runner's center of mass falls forward of the support foot that the runner then pulls from the ground. The foot is pulled up toward the hip by the hamstring muscles while the opposite foot moves to the ground to provide new support.

"Pose Method of Running is a combination of specific drills and exercises that applies to all runners that makes you more efficient," says Severin Romanov, military liaison of Pose Method of Running.

The Pose Method of Running courses have been used by the military since 2008. On Oct. 1, it became the method for the running skill program and drills published in updated Army doctrine.

Dr. Nicholas Romanov, founder of Pose Method of Running, and his team visited Fort Stewart, last week to host a two-day class for 40 Dogface Soldiers. Those service members will now be qualified to host running clinics for their units in an effort to continue the training of proper biomechanics, technique which will ultimately reduce injury and improve readiness. They will also be qualified to take the online certification course to add Certified Running Technique Specialist to their enlisted

record brief.

"Running starts with a philosophical approach called necessity," Romanov said. "[It] is one of those necessities. Once you understand this, your attitude will change to the way you approach running. Only when you have this in your mind will you devote yourself to this process. You have to think about your ability to run and live on a different level of wellbeing."

Running is one of the most injury-prone activities in the Army and is the most common training activity.

"I have been an avid runner for 25 years and I thought I was a great runner till they showed us this technique," said Sgt. 1st Class Timothy Naquin, platoon leader for Bravo Company, 1st Battalion, 41st Field Artillery Regiment, 1st Armored Brigade Combat Team, 3rd Infantry Division. "It is awesome that they are giving us a tool that will help Soldiers prevent injuries."

Participants in the program expressed excitement over the new techniques learned during the training.

"The Pose training class not only highlighted my mistakes with running but demonstrated how to correct them and others Soldiers with minimal to no equipment," said Capt. Veronica Lazar, 1st ABCT, 3rd ID Physical Therapist. "I am excited to see more installations support Pose Method of Running training and the positive outcomes that follow."

# COVID-19 home care can help, assistance is available

The latest outbreak of Omicron COVID-19 variant has impacts that have left many people sick and wondering how they can take care of themselves or their loved ones, while at home.

The Center for Disease Control and Prevention notes the Omicron variant is especially virulent, and can even affect those who have been vaccinated – thought to a lesser degree. The Omicron has spread rapidly Nationwide. We at Fort Stewart-Hunter Army Airfield have also seen a surge.

The various waves of infection may continue to impact medical services and hospital capabilities across the United States; but you can help by getting vaccinated and taking protective measures such as wearing a mask, maintaining a safe distance, self-monitoring, and continuing to wash your hands.

If you begin to feel sick— these measures become more important. The majority of people who get COVID, especially if they are vaccinated, exhibit mild symptoms. Depending on the severity, many people can recover by getting rest, staying hydrated, and using over the counter medication such as acetaminophen or ibuprofen

Proactive care may prevent the illness from growing worse, or spreading to others. Self-monitoring and isolation are key factors; if you start to get sick, stay away from others and notify your supervisor or chain of command.

The risk for severe disease from COVID-19 increases with medical conditions such as obesity, smoking, diminished immunity, diabetes, heart or lung disease or autoimmune deficiencies. People with higher levels of risk, should contact their healthcare provider when symptoms manifest.

Emergent symptoms to look for; where you would need to get immediate care include problems breathing, shortness of breath, chest pain or pressure, bluing of finger nail beds, toes, or face, changes in consciousness or if the person becomes confused. If these symptoms develop, call 911.

The CDC highly recommends booster vaccines for ages 12 and older, which can be received five months following your second dose of either Moderna or Pfizer vaccines, or two months after the single dose of Johnson and Johnson vaccine.

The higher percentage of people vaccinated, and boosted, following COVID-19 protection protocols can increase the communal protection and may decrease the impact of a future surge.

Winn Army Community Hospital offers COVID-19 testing and vaccination services. ### If you have possible or confirmed COVID-19

- 1. Stay home** except to get medical care.



- 6. Cover your cough and sneezes** with a tissue or use the inside of your elbow.



- 2. Monitor your symptoms** carefully. If your symptoms get worse, call your healthcare provider immediately.



- 7. Wash your hands often** with soap and water for at least 20 seconds or clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol.



- 3. Get rest and stay hydrated.**



- 8.** As much as possible, **stay** in a specific room and **away from other people** in your home. Also, you should use a separate bathroom, if available. If you need to be around other people in or outside of the home, wear a mask.



- 4.** If you have a medical appointment, **call the healthcare provider** ahead of time and tell them that you have or may have COVID-19.



- 9. Avoid sharing personal items** with other people in your household, like dishes, towels, and bedding.



- 5.** For medical emergencies, call 911 and **notify the dispatch personnel** that you have or may have COVID-19.



- 10. Clean all surfaces** that are touched often, like counters, tabletops, and doorknobs. Use household cleaning sprays or wipes according to the label instructions.

# Raider finds purpose during Task Force Pickett

Sgt. Ali Shakeri arrived at Fort Pickett, Virginia for the first time, Oct. 21, 2021. Exhausted after spending the day traveling from Fort Stewart, Shakeri had no idea that the mission he would soon take part in would change his life forever.

Shakeri, a native of Portland, Oregon, is among one of many service members who volunteered to aid as linguists in support of Task Force Pickett.

In support of Operation Allies Refuge, Task Force Pickett is one of many designated areas in the country that welcomes at-risk Afghan refugees to the country upon their initial entry to the United States. Through this operation, U.S. Northern Command and the Department of Defense provided a variety of services to Afghan refugees, particularly Afghan Special Immigrant Visa applicants, interpreters, U.S. embassy employees, and other individuals and families who have assisted the United States in various ways.

Afghan citizens brought to Task Force Pickett have access to a plethora of services, including temporary housing, medical screenings and care, transportation, religious services, recreational areas, and overall support. For thousands of Afghan citizens, this operation means another chance at safety, life, and freedom.

Service members assigned to Task Force Pickett, composed mostly of Army and Marine Corps personnel, ensure that all refugees have access to safety, security, and basic day-to-day necessities. Each day, linguists like Shakeri use their extensive language skills to translate for refugees as they interact and complete in-processing with different government

agencies and humanitarian organizations, such as the Department of Homeland Security, the State Department, and the International Rescue Committee. All service members assigned to Task Force Pickett, including Shakeri, are responsible for fulfilling America's commitment to helping Afghan citizens by initiating the settlement of refugees into new lives, cultures, and communities.

Outside of his basic duties at Task Force Pickett, Shakeri has been spending any available free time with refugees, using his language skills and past experiences to build bonds with individuals of all ages. While he allocates a substantial amount of time to teaching English and sports to children, he also dedicates considerable effort to support the needs and wants of the adults. One memory involving a refugee mother and her son stands out most to Shakeri.

"There was a situation where a woman was separated from her son and she was not able to see or even speak to him for a couple of months," Shakeri said. "I was able to assist in making arrangements with the Department of Homeland Security to get them back in touch. When they shared that first phone call, she was crying tears of joy, and I became overwhelmed with happiness knowing that I helped make that happen. Now, they can speak over the phone with one another weekly."

Though Shakeri was born in Oregon, he moved to Iran when he was just five years old and spent the following ten years there before returning to the United States. Inspired by his father, a military general who trained alongside the U.S. military, Shakeri decided to join the United States Army in 2017 as a Fire Control Specialist. While he excels in and enjoys his current job on Fort Stewart, he believes his assignment to Task Force Pickett is one of the most unique

and gratifying experiences he has endured in his military career thus far.

"I feel useful – like I have a purpose here," Shakeri said. "While it's sad that these individuals have to leave their home to seek asylum, I'm proud that we are here with open arms to provide them help and safety."

With many refugees to care for and a relatively small number of available linguists, Shakeri, along with Marines and his fellow Soldiers, typically find themselves working long, tiring hours. Because many Afghan citizens do not speak English natively and are entering an unfamiliar country for the first time, linguists are crucial to making this operation a success. As demanding as the job is, Shakeri wakes up in the morning excited to go to work.

"The hours are long, and we are always busy, but I'm making a lifelong impact on this group of people. They are in dire need of care, and I am here to ensure that they receive that," Shakeri said.

After growing up in both the United States and Iran, Shakeri is no stranger to blending two worlds into one – an undertaking that is critical to perform successfully as a linguist in this operation. "Task Force Pickett builds a bridge between the refugees' culture and the American way of life," Shakeri expressed. "I'm able to use our mutual language and experiences to help incorporate them into an entirely new and free lifestyle. It's my job to protect them and welcome them to their new lives in the United States of America."

Sgt. Shakeri, who was recently promoted, currently serves in Bravo Battery, 1st Battalion, 41st Field Artillery Regiment, 1st Armored Brigade Combat Team, 3rd Infantry Division, and is expected to return to Fort Stewart later this year.
