Fort Stewart Expresses introduce BP/Amoco fuel

TOP TIER[™]-certified branded fuel is rolling out to Fort Stewart's five Army & Air Force Exchange Service Express gas stations.

Drivers can now fill up with BP/Amoco fuel at the 6th Street Express, the first Fort Stewart Express gas station to receive updated signing and canopies identical to those at BP/Amoco's gas stations outside the gate. Pricing for the new, high-quality fuel follows the same process Exchange Expresses have long relied on to ensure competitive pricing for the Fort Stewart community.

"The Exchange is excited to bring branded fuel onto the installation," said Fort Stewart Exchange General Manager Hollie Morales. "Our remaining Express gas stations, including 4th BCT, Harmon, Bryan Village and Marne, will begin dispensing TOP TIERTM-certified branded fuel in the coming weeks. And our two fueling stations at Hunter Army Airfield will also offer BP/Amoco branding and fuel."

The Exchange is introducing branded fuel at more than 180 of its gas stations on Army and Air Force installations in CONUS. Branded fuel improves the Exchange's already-secure supply chain, enhancing the Exchange's support of the military communities it serves during emergencies and natural disasters.

The Exchange's fuel pricing policy—matching local competition for each fuel grade where the competition offers a similar service at the same terms and conditions—will remain unchanged.

Marne Tax Centers to open on Stewart, Hunter

The Fort Stewart-Hunter Army Airfield Tax Centers will open their doors on Feb. 7 to provide free tax assistance to active duty Soldiers, retirees, and their Families.

In 2021, the Tax Centers assisted over 2,000 clients receiving over \$3 million in refunds, saving about \$600,000 in preparation fees.

Due to COVID-19, walk-in services will not be provided this season and eligibility limitations have been placed on the taxpayers who are eligible for services.

If the answer to any of the below questions is yes, the Fort Stewart-Hunter Army Airfield tax centers will not be able to prepare your taxes this season. However, there are alternate resources available to you.

- Do you have more than one rental property?
- Is your gross income more than \$75K a year (single) or \$125K a year (joint)?
- Are you a single Soldier with no dependents?
- Do you own a business?
- Do you pay taxes to more than two states?
- Do you live more than 150 miles from Savannah?

Taxpayers are encouraged to self-prepare their returns from home. If assistance is needed, tax preparers from

the Fort Stewart-Hunter Army Airfield offices will be available virtually to answer any questions you may have and to review your return.

If you would like to be seen in-person, an appointment is needed. When making the appointment, you are encouraged to provide which office you prefer to visit and if you will be dropping off your tax paperwork beforehand or will be bringing it with you to the appointment.

The Fort Stewart Tax Center will be located in building 620 in the Legal Assistance Office within the Office of the Staff Judge Advocate building. The Hunter Army Airfield Tax Center will remain in building 1211 inside the Hunter Army Airfield Legal Assistance Office. Hours of operation for both locations are: Monday-Wednesday and Friday: 9 a.m. to noon, and 1-4 p.m.; Thursday: 9 a.m. to noon.

In order to maximize both the experience and the amount of returns, prospective clients are strongly encouraged to review the list of documents and tasks below to make sure they come to the Tax Center prepared.

- W2/1099misc/1099SSA
- 1098, Family mortgage interest statement
- Power of attorney, if necessary
- Prior year tax return

- Proof of dependent care expenses
- Interest income statement (e.g., 1099INT)
- Identity theft pin
- Dividend income statement (e.g., 1099DIV)
- 1099B, for stocks/bonds
- Statements reflecting capital gains/loss
- 1095, Proof of medical insurance Coverage
- Photo identification
- Social security card for self and all members on your return
- Student loan interest statement
- Divorce decree, if minor children
- Proof of educational expenses
- HUD 1 statement (if home purchased during the tax year)
- IRA/TSP contribution statements
- Proof of educator expenses
- Account and routing number for direct deposit/ debit (canceled check)

To make an appointment, call 767-2075. Leave a voicemail that includes: whether you would like to self-prepare your taxes or have a tax preparer meet with you in-person.

Military OneSource's MilTax forum opened for business today as the IRS began accepting tax returns, said an official with Defense Department Military Community and Family Policy.

Kelly Smith, program analyst with MC&FP, said the biggest factor DOD wants its service members and their families to know is that MilTax is an option for them when they're considering how to file for this tax season; the deadline is April 18.

"We know there are many other tax products out there, but MilTax is 100% free of charge [without] rank or pay restrictions," Smith said. Service members are entitled to the tax-filing benefit they've earned and can use MilTax's filing software and consult with a MilTax consultant even if they have just a question. The MilTax consultants are well-versed in military-specific tax situations, she said, noting that MilTax results are guaranteed.

For example, the Military Spouse Residency Relief Act is an issue that comes up quite often, Smith said. "There

are rules that military spouses need to know when it comes to filing their taxes, and there are some eligibility requirements [under the MSRRA], and it applies when a spouse lives in a state different from his or her residency state."

Because military Families move often, there are certain qualifying military moving expenses that can apply to filing taxes, she said. One qualifier involves moving household goods and personal effects, and the other is reasonable travel and lodging expenses, she added.

And particularly applicable to spouses is self-employment, otherwise known as working in the gig community, Smith said. Operating a small self-business requires a Schedule C tax form, she added.

The Child Tax Credit can also come into play for 2021 tax filing, Smith said. According to Military OneSource, the child tax credit maximum amount of credit is \$2,000 per qualifying child and is refundable up to \$1,400. The bill also includes a temporary \$500 nonrefundable credit for other qualifying dependents. As part of the American Rescue Plan to help Americans recover financially from the COVID-19 pandemic, the 2021 child tax credit was expanded to \$3,600 for children ages 5 and younger, and \$3,000 for children ages 6-17. Eligible taxpayers will receive monthly payments totaling half of their 2021 child tax credit from July 15, 2021 through the end of the

year. Taxpayers can claim the other half when they file their 2021 tax return. For more, visit *militaryonesource. mil/financial-legal/tax-resource-center/special-tax-considerations/advance-child-tax-credit-2021/.*

For those who are deployed overseas during the tax season and need an extension to file, Smith said DOD wants its service members to focus on their mission and not worry about filing tax forms. The IRS automatically extends tax deadlines for U.S. Armed Forces personnel deployed to a combat zone or in support of operations in a qualified hazardous duty area. Face masks required in on-post facilities

Effective immediately, 3rd Infantry Division, Fort Stewart and Hunter Army Airfield GO1 requires ALL individuals to wear a mask inside ANY on-post facility at Fort Stewart or Hunter Army Airfield. Service members are also required to wear a mask inside off-post public buildings/ facilities (i.e. barber shops, religious services, grocery stores, etc.). Mask mandate exceptions

Changes to speeding violations issued

Chemical engineer technicians combat Weapons of Mass Destruction

ABERDEEN PROVING GROUND, Maryland — Army civilian chemical engineering technicians from the Chemical, Biological, Radiological, Nuclear, Explosives Analytical and Remediation Activity (CARA) conduct critical missions around the world.

CARA is part of the Aberdeen Proving Ground, Maryland-headquartered 20th CBRNE Command, which is also home to 75 percent of the Active Duty U.S. Army's CBRN specialists and Explosive Ordnance Disposal technicians, as well as the 1st Area Medical Laboratory, five Weapons of Mass Destruction Coordination Teams and three Nuclear Disablement Teams.

From chemists to unexploded ordnance technicians, CARA brings together a wide variety of occupational specialists that confront and defeat CBRNE hazards around the world.

Engineering Technician (Chemical) is one of the many professions that keep the one-of-a-kind activity ready.

The highly trained Army civilian technicians conduct a wide array of missions supporting many of the 20th CBRNE Command's specialized missions.

The missions include supporting the remediation of Formerly Used Defense Sites, conducting Weapons of Mass Destruction characterization and assessment, supporting emergency response overseas and stateside missions for Recovered Chemical Warfare Material and providing technical escort of surety and non-surety chemical material.

"Chemical engineering technicians help to keep our nation's warfighters and citizens safe through quick response, assessment and remediation of potential and confirmed CBRNE material," said Jarrod M. Williams, a chemical engineering technician from CARA.

Originally from Somerset, Kentucky, Williams is also in the Air National Guard. He has been at CARA-West Redstone Arsenal, Alabama-based all Army civilian activity for less than a year.

After serving as a toxic material handler for Bluegrass Chemical Activity, he became a chemical engineering technician because he was looking for a new challenge.

Williams said it takes good communication skills and attention to detail to succeed in this high stakes profession.

Trevor V. Donnatien Jr., a supervisory chemical engineering technician from CARA-East on Aberdeen Proving Ground, Maryland, said technicians are required to be able to deploy anywhere on short notice. CARA personnel have recently conducted missions in the Pacific area of operations, Arizona, Delaware, Utah, Alabama, Kentucky, New Jersey and Colorado.

"Our typical day-to-day operations vary based on what's going on in the world," said Donnatien, a Felton, Delaware, native who has been at CARA for seven years. "There are many daily initiatives performed that ensure we are prepared and ready at all times. We may set up temporary



Weapons of Mass Destruction characterization and assessment sites in the public sector or other Department of Defense locations."

Donnatien said technicians qualify at the gun range and conduct use of force training to stay ready for armed and unarmed technical escort missions of surety and non-surety materials. In support of their escort missions, the technicians are part of the personal reliability program.

An Army veteran who served 10 years on active duty and three years in the Army Reserve, Donnatien said he was first exposed to the technical escort mission while serving with the 22nd Chemical Battalion (Technical Escort Unit) in 2005.

After leaving the Army, he worked in law enforcement for two years before coming to CARA. One of the reasons that Donnatien became an Army civilian at CARA was to combine his military service with his civil service for retirement purposes.

"During my time with TEU, I worked alongside CARA in two real-world missions," Donnatien said. "My time in TEU is how I learned of CARA's unique and specialized work."

Donnatien said a college degree and specialized experience are not required to become an entry-level technician. Military, law enforcement and Occupational Safety and Health Administration Personal Protective Gear experience is helpful but not required. "We will train the right candidate who possesses the right qualities," Donnatien said. "Some of the qualities that make a good candidate for the technician position are someone who is hard working, dependable, reliable, trustworthy, possesses the ability to work well in a team environment and works well under pressure."

Franz J. Amann, the director of CARA, said the chemical engineering technician position is ideal for U.S. Army Chemical Corps Soldiers who are retiring or completing uniformed service.

"They bring the critical skill sets that the Army has already invested in," said Amann, a retired Chemical Corps officer from Spartanburg, South Carolina. "As a Department of the Army civilian, CARA offers an opportunity for those interested to continue their careers or establishing a second career after a successful military career. The benefit is that individuals can grow in the position without reapplying for the next pay grade. In addition, there is a way for non-retiring Soldiers to apply their years of uniformed service towards their civilian service."

CARA routinely has open job announcements for chemical engineering technicians. You can find the announcements on *USAJobs.gov* by searching APG – Engineering Technician (Chemical), job series 0802. Grades can vary between GS-05 to GS-11 depending on the requirements and individual experience.

'Sustaining the fight': Providers develop NCO lethality

Soldiers assigned to the 87th Division Sustainment Support Battalion, 3rd Division Sustainment Brigade, hosted a Provider firing range as part of noncommissioned officer professional development, Jan. 18 on Fort Stewart. The training focused on how to properly prepare, plan and execute operations on a firing range.

"We want to ensure that our noncommissioned officers are trained and proficient" said Command Sgt. Maj. Ryan Stamos, the senior enlisted advisor of the 87th DSSB. "Our NCOs are responsible for training Soldiers, this training will give them the knowledge they will need to share with our Soldiers.'

The goal of NCOPD is to develop and strengthen the skills, knowledge and abilities to train, deploy and lead Soldiers in combat through battle focused training. According to a Training and Doctrine Command release on NCOPD, the NCOPD provides non-commissioned officers with progressive and sequential leader, technical and tactical training relevant to the duties, responsibilities and missions they will perform.

"Even though we are sustainers, we are ensuring that our Soldiers know how to defend a convoy and how to tactically employ their weapon systems," said Stamos. "We are ensuring that we are able and capable to support our team from the front in all aspects of sustaining the fight."

The NCOPD training was hosted as a two day training cycle to ensure that Soldiers were able to get classroom instruction and hands on instruction.

"Being able to teach and train alongside with my battle buddies was awesome," said Sgt. Alex Block, a motor transport operator assigned to Charlie Company, 87th DSSB. "It's always great to participate in a refresher course. The knowledge and skills that we learned from this NCOPD will help me go back to my company and train my Soldiers to the best of my ability."

The first day of the NCOPD training featured an overview of multiple weapon systems including the M240 machine gun, the Mk19 grenade launcher and more. During the second day, Soldiers were able to put their skills to the test at the range.

"It's been a while since I was able to fire some of these weapons," said Sgt. Springen Anderson, a tactical power generation specialist assigned to Bravo Company, 87th DSSB. "I feel more comfortable and confident to fully engage with my Soldiers now. I'm excited to show them what I've learned and how it can enhance our Soldier skills."

The end goal for the NCOPDs was to build an organizing framework to develop the next generation of competent and committed NCOs to thrive in chaos, adapt and win in a complex world.

"I hope that all NCOs can take away more than they came to the training with to go train their Soldiers and to help sustain the Brigade," Stamos said.

Army fielding looks towards cloud-enabled mission command

ABERDEEN PROVING GROUND, Md. — The latest iteration of the Army's converged suite of common operational picture capabilities is now fielding to Soldiers after reaching a critical milestone with the approval of Command Post Computing Environment, Increment 1 for a full deployment decision.

This milestone, reached December 15, marks the culmination of an integrated test strategy consisting of cyber security assessments; interoperability and developmental tests; Soldier touch points; and operational assessments throughout the last 15 months. The FDD also verifies training packages, affordability and sustainment for the CPCE, Inc 1 capability, and ultimately signals the start of fielding key enhancements to operational units.

"This [decision] is significant because Increment 1 provides several improvements over Increment 0 that the Soldiers have been asking for," said Col. Matt Paul, project manager Mission Command, assigned to the Program Executive Office for Command, Control, Communications-Tactical.

CPCE is the primary computing environment under Army Futures Command's Common Operating Environment modernization effort, supporting command posts and combat operations. Inc 1 marks the first significant convergence of warfighting functions into CPCE and incorporates improvements across a wide range of applications, including new mission planning and whiteboard tools, geospatial capabilities to converge some Intel functions, and security and general performance enhancements.

"Convergence into a simple, intuitive, single common operating picture is critical," said Col. Evert Hawk II, Mission Command lead for the Army Futures Command Network Cross-Functional Team. "For commanders to make rapid, informed decisions, they need to access and evaluate data from numerous sources across warfighting functions. The team has leveraged Soldier feedback to make sure we are bringing all that information together and presenting it in an integrated way."

An operational test conducted last year assessed the effectiveness, suitability and survivability of the enhanced Inc 1 capabilities, proving the ability for commanders and staff to share battlefield information and collaborate through a customizable COP from the battalion to the combatant command level.

To produce the COP, CPCE Increment 1 receives and processes data feeds from more than 25 other digital systems inside of the command post, including those from Joint and Coalition partners. The software's ability to produce a COP was successfully demonstrated as part of the OA during last year's Joint Warfighting Assessment 2021 (JWA21) with the 4th Infantry Division. JWA21 included Joint and Five Eyes partners all contributing to CPCE's COP using common data standards and interfaces.

"CPCE Increment 1 provided a foundational capability at PC21 to allow the Army to conduct experiments with promising new systems still in development," said Paul. PC21 observations indicated a need for established Joint interface standards to better prioritize data convergence and to integrate a data fabric onto the CPCE environment.

Two weeks ago, the 41st Field Artillery Brigade in Grafenwoehr, Germany became the first unit equipped with the new CPCE baseline when it received Inc 1 software. The unit — which is the only European-based fires brigade — provides strategic, operational, and tactical-level fires and support throughout the U.S. Army European Command.

Other units receiving Inc 1 software this month include the 2nd Infantry Brigade Combat Team and 4th Brigade Combat Team (Airborne), 25th Infantry Division, at Schofield Barracks, Hawaii.

The software's extensibility allows it to serve as a platform to integrate new or legacy 3rd party applications from industry and government sources. CPCE Increment 2 will build on Inc 1 and will converge additional warfighting functions, including sustainment and aviation applications.

Inc 2 will also add an initial data fabric capability to allow commanders and staffs to search and discover data they need more quickly and easily. Integrated data fabrics will stitch together different data formats to make relevant data visible and available throughout the ecosystem, facilitating sensor-to-shooter tasks, information advantage and decision dominance. Critically, CPCE Inc 2 will align the Army's data fabric implementation to the Department of Defense's Joint All-Domain Command and Control, known as JADC2, construct and will contribute to the department's new Joint Warfighting Concept.

Inc 2 also plans to leap into the cloud, supporting Army imperatives to migrate applications into a Cloud environment. PM Mission Command plans to leverage the cloud to provide a unit with redundant capability to maintain its COP and its critical mission data during large-scale combat operations. Specifically, the Army intends to optimize CPCE cloud deployment for units 'first in the fight', referred to as Joint Forcible Entry units.

PM Mission Command has also executed a number of unit driven pilot efforts concurrent to Inc 1 development and fielding to demonstrate CPCE in a cloud environment. These efforts include the XVIII Airborne Corps "DragonCloud" and similar initiatives that have provided the ability for units to use CPCE from cloud service providers where sufficient bandwidth is available. These proofs of concept are addressing cloud hosting and cyber accreditation challenges, and ongoing experimentation is generating valuable feedback to inform future cloud deployment.

Dental update

COVID-19 vaccine services offered

COVID-19 vaccines are available to TRICARE beneficiaries on Fort Stewart-Hunter Army Airfield. The Moderna Vaccine is offered on a walk-in basis, as a first, second or booster dose, to TRICARE beneficiaries 18 and older, 9 a.m. to 1 p.m. each Tuesday at the Patriot Auditorium. Pfizer Vaccine is available to active duty Soldiers (18 years and older), as a first or second dose; and to beneficiaries, age 12-17 years old, as a second dose, 2-5 p.m. each Wednesday at Winn's Patriot Auditorium. Winn ACH also offers the Pfizer pediatric dose to beneficiaries, age 5-11 years old, 2-5 p.m. Wednesday in the Patriot Auditorium. Vaccination's at Tuttle AHC on Hunter Army Airfield are by appointment only by calling 435-6633. The Influenza vaccine is offered at each of the COVID-19 vaccine sites for beneficiaries 6-months and older.

Booster doses highly recommended

The Moderna Vaccine is available on Fort Stewart and Hunter Army Airfield as a booster dose is available 9 a.m. to 1 p.m. each Tuesday at Winn Army Community Hospital on Fort Stewart, for beneficiaries, 18 and older, after 5 months from their second of either the Pfizer or Moderna vaccine; or after 2 months from receiving a single dose of Johnson and Johnson's Jansen Vaccine. Other Pfizer and Jansen vaccines/booster services are available through TRICARE Network Pharmacies.

TRICARE pharmacy copay update

As of Jan. 1, TRICARE pharmacy copayments changed for all beneficiaries, except Active Duty Service Members, dependent survivors of ADSMs, and medically retired service members and their dependents. Home Delivery is still an option for certain prescriptions. Please note that certain name brand maintenance medications (long-term medication) can only be filled twice at retail. After two refills, maintenance medications must be filled via home delivery or at a military pharmacy. Acute medications are available at retail pharmacies. CHAPLAIN'S CORNER The answer to suicide prevention: Seeking the eternal hope

Chaplains deal with a wide range of issues including stress, relationships, life transitions, suicide, sexual assault, grief and many others. One of the major issues that chaplains have to deal with on a frequent basis is suicidal thoughts and attempts.

Suicide is rampant in the Army today. A 2021 study by Brown University's Cost of War Project reported that suicides by active-duty personnel and veterans are reaching new peaks. The study found that while 7,057 members of the armed forces were killed in military action since 9/11, more than four times as many active-duty members and veterans — 30,177 — died by suicide. The report noted that the military suicide rates now exceed those for the general population.

These statistics are something that we need to pay attention to. Historically, military suicide rates have been lower than those rates found in the general population.

The Army is constantly working to mitigate the risk of suicide through programs, trainings and briefings. While we are trying so hard to fix this issue, it is true that we sometimes feel like we are getting nowhere.

I would say that the answer is hope. People turn to self-harm, self-injury and suicide when they feel hopeless, when they feel helpless losing hope, when they feel worthless losing hope and when they feel like they lack a sense of belonging, losing hope.

When I say "hope," it means the kind of hope that will last for eternity and will help

get you through the most difficult times in life. That real true hope will make it possible for you to deal successfully with the lonely and painful moments and the fearful experiences in life. But the question is, where can we find that kind of hope?

Many people search their whole lives for the real true hope but are looking in the wrong places. Some try to find it through their abilities, talents or material possessions, but what if they lose them? Others try to find it in their relationships, but what if they are broken? Such things are something that is not eternal but temporary. We can find the real true hope in something that is eternal.

Based on my own background religious tradition, I say that the real true hope can be found only in Jesus Christ. If He is your Savior, you can be ready for whatever life throws at you.

The point that I am trying to make here is that the best way to mitigate the risk of suicide is to find the real true hope in something that is eternal according to your religious background.

Whether you are Christian, Muslim, Hindu, Jewish or other, you can be never without hope in your own faith. Even in times of difficulty and despair, you can be still hopeful as long as you practice your own faith. Statistics show that people who attend religious services on a regular basis are significantly less likely to take their own lives.

I encourage all Dogface Soldiers to practice your own religious beliefs so that you may find the real true hope that is eternal even when you find yourself in a hopeless situation.

Spartans On-the-Move: Train to improve warfighter lethality

Soldiers assigned to the "Spartan Brigade," 2nd Armored Brigade Combat Team, 3rd Infantry Division, completed new equipment training for the Army's Armor Formation On-the-Move Network Pilot on Jan. 21-24 on Fort Stewart.

The unit will assess three different equipment sets composed of a wide range of commercial technologies at varying maturity levels from over 20 industry partners. The Army will use Soldier feedback from the field training pilot to inform design and fielding decisions to deliver a modernized mobile tactical network to armor formations as part of Capability Set 25 - the third installment in the Army's iterative two-year network modernization capability set acquisition and fielding process.

"The Spartan Brigade looks forward to providing feedback on the Army's latest communications pilot for armor formations," said Col. Terry R. Tillis, commander of the 2nd ABCT, 3rd ID. "Now that the new equipment training is complete, we're excited to get the pilot underway."

The Program Executive Office Command, Control, Communications-Tactical is one of the U.S. Army offices that delivers the Army's network modernization strategy. Fielders from the PEO-C3T's tactical network project office arrived to Fort Stewart in mid-November 2021 to receive the equipment by rail, inventory it and sign it over to the in the Spartan Brigade units executing the pilot. Engineers from General Dynamics, the industry lead integrator for the pilot, arrived in early December to begin internal network testing and network terminal and vehicle-server initialization in preparation for new equipment training.

"The new equipment training

conducted prior to the event is critical to the success of the pilot," said John Gillette, product manager for Mission Network, Project Manager Tactical Network, the PEO-C3T office leading the pilot. "Soldiers received in-depth training on the diverse commercial technologies that they will be operating for each of the equipment sets and will be afforded the opportunity to provide feedback on the systems and how they interact. This feedback, used in conjunction with technical data gathered throughout the field portion of the pilot, will inform future Army design decisions for armor formation OTM capability."

The Soldier new equipment training ran from Jan. 6-21, and consisted of seven different classes. The training included formal classroom instructions in the mornings leading to practical exercises with hands-on training in the afternoons.

The Army Test and Evaluation Command will operate as an independent evaluator during the pilot and will use direct Soldier feedback to develop a report to inform Army design decisions.

"There are obvious challenges integrating new and existing technologies into armor formations, but the effort is needed and necessary if we are to determine which technologies could best support the tactical commander's ability to make accurate and timely decisions," said Maj. Todd Klinzing-Donaldson, the top communications and network officer for the 2nd ABCT, 3rd ID. "Even with these challenges, the development team has done an incredible assimilating a diverse showcase of industry technology prototypes so we can find out how these technologies could potentially improve warfighter survivability and lethality."
