

Master gunners: A tank crew's key to success

Soldiers can hear the rumble of the M1A2 Abrams tanks cresting the hill of Bucierz Range, Drawsko Pomorskie, Poland. These tanks are loud, heavy machines that make their presence known when operated in combat.

Brandishing these impressive vehicles onto the battlefield are tank crews consisting of four Soldiers: a commander, a driver, a gunner and a loader. It takes training and experience to become proficient on the battlefield; it also requires guidance and determination to mold these Soldiers into experienced tanker crews.

The master gunner is the noncommissioned officer who holds the key to success for these tanker crews. They are the technical and tactical experts for their specific weapons and responsible for advising the commander on everything related to that particular vehicle. They also lead in developing training materials and conducting gunnery and live-fire exercises.

"The 'Mike Golf' is one of the most important NCOs in the battalion," said U.S. Army Lt. Col. Kenneth Selby, commander of 2nd Battalion, 34th Armor Regiment, 1st Armored Brigade Combat Team, 1st Infantry Division. "That person is your subject matter expert. They are the ones who put everything together based on the commander's intent." "Mike Golf" is a nickname commonly used to refer to master gunners — transcribing the initials of master gunner to the NATO phonetic alphabet.

Crews develop their skills with the experience of the master gunner, both on and off the range. "The master gunner plans and executes gunnery training, advises the commander on gunnery training courses of action and passes on knowledge to improve the lethality and capability of the unit as a whole," said U.S. Army Staff Sgt. Alexander Axford, master gunner, assigned to 2nd Battalion, 34th Armor Regiment.

The crews qualify at gunnery through training tables

that progress from gunnery tables I to VI and end with a live-fire exercise to fully qualify. These tables begin with learning primary weapons systems, training on the Abrams tank or Bradley Fighting Vehicle and performing simulations to ultimately qualify with live rounds while engaging moving and stationary targets on the range.

"I have the master gunners on speed dial; I talk to them all the time," Selby said. "They are my technical experts. They are the maintenance experts on the guns and the machine guns, and for all the gunnery ranges that we do here."

To earn the title of master gunner, a Soldier must be a noncommissioned officer and be specially selected by the commander to attend the master gunner course. The course is held at Fort Benning, Georgia. The master gunners assigned to 2nd Battalion, 34th Armor Regiment, 1st Armored Brigade Combat Team, 1st Infantry Division, are trained for the M1/M1A2 Tank and the M2 Bradley Infantry Fighting Vehicle.

"The master gunner is a subject matter expert on training, land and ammo management," said Command Sgt. Maj. Christopher Albanese, of 2nd Battalion, 34th Armor Regiment, "These are highly intelligent individuals sent to the Master Gunner Course," he said. "This course teaches machine guns, surface danger zones and training management."

During the Master Gunner Course, they also learn how to plan and execute range operations. They train to be experts on qualifying individual crews through brigade-size elements during live-fire exercises.

Once the Soldier is a qualified master gunner, they become that dedicated specialist a company commander relies upon.

"The master gunner is a subject matter expert who executes the commander's intent during gunnery training and ensures that all standards are being met," Axford explained.

Master gunners stay engaged throughout the gunnery. Observing from the tower or the vehicle, they have

many responsibilities to keep their eyes on. Their guidance extends from the movement of the vehicles, ammunition distribution and the weapons fire to make sure to run an after-action review for the benefit of the crews. The Soldiers are the ones who benefit from a committed master gunner who provides support, motivation and mentorship to shape them into experienced crews.

U.S. Army master gunners brought that same expertise and professionalism to train Polish soldiers in the role of the master gunner at Bruchierz Range, Drawsko Pomorskie, Poland, April 26-28.

In the 45 days leading up to the training event, master gunners assigned to 1st Infantry Division helped create and develop the training for what became known as the Abrams Operation Summit. The Abrams Operation Summit was a three-day training program designed to introduce the Polish army to U.S. Army systems and procedures that support successful Abrams operations at the company levels. The training consisted of leader panel discussions and roundtables, subject matter expert presentations, hands-on practical exercises and field demonstrations.

"The Dreadnaughts set the stage for the Polish Army to get familiarized with the M1 Abrams, how it fights, how we maintain the tank, how we sustain it. We have also given them some familiarization training on war-fighting, fighting function synchronization and fighting in a combined arms construct," Selby said. "So we gave them a three-day crash course on how to do this right."

The Abrams Operation Summit aims to support the Polish Tank Program by familiarizing key leaders with the systems and processes that produce lethal armored fighting formations.

"This training is important because it increases interoperability between the U.S. and NATO allies," Axford concluded, "It improves the understanding of different capabilities and limitations, which is critically important now that Poland is preparing to field their first Abrams tanks."

DRAGON MASTERS TAME ALL HAZARDS IN DCRF TRAINING

The 63rd CBRN Company is preparing to serve on the Defense CBRN Response Force in support of U.S. Northern Command’s Joint Task Force-Civil Support.

The Defense Chemical, Biological, Radiological, Nuclear Response Force (DCRF) saves lives, mitigates suffering and facilitates recovery operations in a CBRN environment to support civil authorities. The task force conducts defense support to civil authority response operations planning and preparedness to ensure mission readiness.

The 63rd CBRN Company is part of the 48th Chemical Brigade and 20th Chemical, Biological, Radiological, Nuclear, Explosives (CBRNE) Command, the U.S. military’s premier all hazards headquarters. The “Dragon Masters” tame CBRN hazards during military operations and domestic missions.

A hazardous response company, the Fort Campbell, Kentucky-based 63rd CBRN Company previously served on DCRF in 2019 – 2020 before deploying to South Korea for nine months to support rotational U.S. Army forces on the Korean Peninsula.

During their last tour on DCRF in 2019 - 2020, the “Dragon Masters” set three exercise records, including set up time for a mass casualty decontamination line, total number of patients processed in one hour and most consecutive hours meeting non-ambulatory and ambulatory through put requirements.

Capt. Matthew J. Maddox, the “Dragon Masters” commanding officer of the 63rd CBRN Company, said

the two-week exercise in April helped to prepare his Soldiers for a two-year DCRF rotation starting in June.

“The main focus of the training exercise at Fort Stewart was to prepare our task force for an upcoming major disaster response exercise,” said Maddox. “The training was unique due to the type of missions and scenarios, along with working with several different organizations while at Fort Stewart. This type of combined training has increased our readiness in the event our task force is activated.”

Maddox added that the task force includes more than 200 Soldiers from different companies, including the 561st Military Police Company and 581st Area Support Medical Company.

A native of Sandoval, Illinois, Maddox is a former 5th grade teacher and National Guardsman who was commissioned on Active Duty in the U.S. Army in 2014.

As a Chemical Corps officer, Maddox has served at

the company, battalion and brigade level. He also deployed with the 31st Air Defense Brigade Headquarters to the U.S. Central Command for Operation Spartan Shield and Operation Inherent Resolve in 2019.

Maddox said the Fort Stewart exercise was a great opportunity for his Soldiers to hone their mission-enabling and life-saving skills while forging new partnerships with other units.

“Networking is such an overlooked combat multiplier,” said Maddox. “Our teams did everything we could to get the wrinkles out early in the storming and forming phases of new group relationships.

“Seeing the vast improvement of the Soldiers from the first mission to the last mission (was a highlight),” said Maddox. “The entire team had a positive attitude, strong work ethic and made huge improvements leading up to the completion of our task force’s night mission.”

State carry act does not apply on post

The recently passed Georgia Constitutional Carry Act does not apply to Fort Stewart-Hunter Army Airfield or any Army installation in Georgia. Per Army Regulation 190-11, the carrying of privately owned weapons and ammunition is prohibited on post unless authorized by the Senior Commander. Also, the carrying of a concealed weapon on the installation is prohibited regardless of whether a state or county permit has been obtained. 

SPARTANS BRING HOME

An M2A3 Bradley Fighting Vehicle crew and M1A2 SEPv2 Abrams tank crew assigned to the “Spartan Brigade,” 2nd Armored Brigade Combat Team, 3rd Infantry Division, from Fort Stewart, Georgia competed in the 2022 Sullivan Cup against six other tank teams and four other Bradley teams from May 2-6 at Fort Benning. The Bradley crew won first place, bringing the Sullivan Cup back to the Marne Division after also winning the competition the last time it was held in 2018 due to the pandemic.

“We believe that winning matters and we believe in competition; competition breeds competence,” said Gen. Paul E. Funk II, the 17th Commanding General of U.S. Army Training and Doctrine Command, during the Sullivan Cup.

The competition embodies its namesake, retired Gen. Gordon R. Sullivan, who commanded numerous armored formations throughout his 36 years of service. The biennial Sullivan Cup brings together tank and Bradley crews from across the Army and the world and then rigorously and comprehensively tests their individual and crew level proficiencies.

“It shows what it takes to be an armor crew member in our Army,” said Capt. Matthew Meyer, an operations officer assigned to the 30th Adjutant General Battalion, 194th Armored Brigade, U.S. Armor School, and the officer in charge of the Starry Physical Proficiency Test. “Overall, it brings out the best in each crew and each competitor.”

Tank crews, and for the first time Bradley crews, from armored divisions across the Army competed in the competition. The tank and Bradley crews completed the same events but competed separately.

The “Spartan Brigade,” 2nd ABCT, 3rd ID fielded two teams to represent the Marne Division. The Bradley crew included Staff Sgt. Julian Gaitor, Spc. Tyler McGinnis and Pfc. Patrick Sullivan assigned to the “Hound Battalion,” 3rd

Battalion, 67th Armor Regiment, 2nd ABCT, 3rd ID, and the tank crew included Staff Sgt. Steven Shives, Staff Sgt. Colby Kuberski, Sgt. Grant Arnall and Spc. Alejandro Anguiano assigned to the “Panther Battalion,” 2nd Battalion, 69th Armor Regiment, 2nd ABCT, 3rd ID.

Before the main events, competitors participated in a week of preliminary rounds, which allowed them to familiarize themselves with the vehicles they would use for the competition and earn points towards their overall score.

The Sullivan Cup began after Operation Thunderstrike, a public live fire demonstration of the Army’s history and evolution of armored warfare and an opening ceremony that introduced the competitors. The following two days tested the crews’ gunnery skills with their respective armored vehicle with day and night live fire.

Sullivan, the Bradley crew’s driver, assigned to the 3rd Bn., 67th AR, 2nd ABCT, 3rd ID, said the most challenging thing about the Sullivan Cup was mentally pushing themselves to do their best and not make mistakes during each event.

The stress shoot and the Starry Physical Proficiency Test evaluated the crews’ physical fitness and team cohesion with back-to-back challenges in hot, humid weather.

The final challenge was Operation Thunder Run. Competitors ran two and a half miles to Brave Rifles Field to complete several tasks, such as assembling a single channel ground and airborne radio system and reacting to indirect fire.

After the five days of challenges, the Spartan Bradley crew came in first place, making them the first Bradley crew in the Army to win a Sullivan Cup.

“Our Bradley and Abrams crews fought hard the last two weeks, showing grit and stamina,” said Command Sgt. Maj. Jaime Lopez, the senior enlisted advisor for the 2nd ABCT, 3rd ID. “We’re very proud of both teams and excited for our Bradley crew who gets to take home the title as best Bradley crew in

the Army.”

The winning crews received a trophy and various gifts and Brig. Gen. Thomas M. Feltey, Armor School Commandant, U.S. Army Maneuver Center of Excellence, knighted them into the Order of St. George, recognizing their excellence in the U.S. Army Armor and Cavalry branches.

“The Sullivan Cup is a rigorous test of technical skill and physical will,” said Col. Terry R. Tillis, commander of the 2nd ABCT, 3rd ID. “We are extremely proud of our Bradley crew that exemplifies a cohesive, expert-

ly trained team who are true masters of their craft.”

The Sullivan Cup highlighted the competency of tank and Bradley crews that got their start at Fort Benning.

“Our crew cohesion and the bond we’ve been from the very beginning has always been strong, but I would definitely say that this competition has brought us a lot closer together,” said Gaitor, the Bradley crew commander from the 3rd Bn., 67th AR, 2nd ABCT, 3rd ID.

The 3rd Bn., 67th AR, 2nd ABCT, 3rd ID, is the same battalion that won the Sullivan Cup last time it was held in 2018.

Gila engineers represent at Best Sapper, place 9th

A two-man team of combat engineers assigned to the "Gila Battalion," 9th Engineer Battalion, 2nd Armored Combat Team, 3rd Infantry Division, tested their bodies and minds at the 15th Annual Lt. Gen. Robert B. Flowers Best Sapper Competition between April 23-25 at Fort Leonard Wood, Missouri. The 9th BEB team, Team 7, consisting of 1st Lt. Rafael Eirea Lamberto, a native of Cuba and Miami, Florida, who graduated from Florida International University in Miami, and 1st Lt. Drake Titus, a native of Bloomfield Hills, Michigan, who graduated from the United States Military Academy at West Point, New York, placed ninth overall out of the final 25 teams that completed the Best Sapper Competition.

Forty-eight sapper teams from across the country traveled to compete in the three-day competition at Fort Leonard Wood and each team consisted of at least one Sapper Leader Course graduate and who had military ranks ranging from specialists to captains.

The competition consisted of a non-standard physical fitness test, a river run, a round robin, sapper stakes, land navigation and many other challenges that tested their physical endurance, mental toughness and overall engineer skills to compete for top spot at the Best Sapper Competition.

Col. Daniel H. Hibner, the U.S. Army Engineer School Commandant, spoke about what it took for competitors to be successful.

"Through the challenges they were forced to rely on their training and their Sapper teammate to persevere and accomplish every mission," said Hibner. "I was inspired to watch these competitors give it all they had. It was their great and sheer determination that kept them going. I'm proud of you for taking on one of the toughest challenges the U.S. Army has to offer."

Eirea Lamberto says it was no easy task, despite three months of training

as much as they could. "The most challenging part was the lack of sleep and arduous activity day after day trying to stay alert and ahead of the other competitors to constantly outperform them," he said.

This the second year in a row that Eirea Lamberto's competed in the Best Sapper Competition, and he takes pride in learning from each one.

"I've learned more from failing than winning and won't stop until I take first place," he added. "The more I fail, the better I want to be. When competing you must go after it and want it more than anyone."

The 2022 Best Sapper Competition was the first for Titus and says his biggest takeaway was learning how far he could push himself. "I was able to accomplish tasks far beyond what I believed I was capable of," he said. "It was truly a test of mind over matter."

The competition teaches competitors how to operate under unfavorable conditions with little food or sleep and still accomplish the mission at hand.

"Physical fitness and attention to detail is a big separator within the competition, and those who could endure more and push harder through it are the ones who came out on top," Titus explained. "In contrast, those who lacked attention-to-detail fell behind or were dropped."

The competition demonstrates excellence within the Army engineer community and allowed competitors to hone their skills and perfect their craft.

"First Lt. Eirea Lamberto and Lt. Titus were the only armored brigade sapper team that completed the competition," said Lt. Col. Brian T. Looney, commander of the 9th BEB, 2nd ABCT, 3rd ID. "We talk every week about how winning matters and that's what these gentlemen did. They represented the Marne Division as Dogface sappers and crushed it."

Eirea Lamberto and Titus look forward to future challenges, including passing their knowledge onto their Soldiers and competing in next year's Best Sapper Competition.



Army advances new communications network baseline

From current support operations in Europe, to experimentation with emerging technologies at Project Convergence, leaders say it is clear that the Army must rely on an integrated, adaptive communications network to accomplish its missions.

“The network is the backbone of everything we do, and data is our new ammunition,” said Lt. Gen. James Richardson, Acting Commanding General of Army Futures Command, or AFC. “All of the experimentation we are doing today is informing where we are going for the future.”

On Tuesday, the Army took an important step forward in delivering that network with the completion of the critical design review for Capability Set 23, or CS23. CS23 aligns more than 40 systems — from Soldier radios and satellite terminals to mission command software and network operations tools — into a system of systems that increases network resiliency, capacity and convergence. Informed by test and experimentation, while balancing capabilities’ technical maturity, operational relevance and affordability, the critical design review is the acquisition event that finalizes the capability set design and authorizes limited production of CS23 systems.

“Capability Set 23 is not a singular, monolithic program — it is a compilation of many programs that come together to provide an operationally useful capability,” said Maj. Gen. Robert Collins, Program Executive Officer for Command, Control, and Communications — Tactical, or PEO C3T, the organization that leads the capability set process, along with AFC’s Network Cross-Functional Team. “It has been a tremendous collective team effort.”

The Army’s two-year network capability set delivery cycle is designed to enable consistent modernization driven by Soldier-led experimentation, commercial technology progress and overarching Army strategy — as well as Department of Defense initiatives such as Joint All-Domain Command and Control, or JADC2.

The Army is simultaneously fielding and developing several capability sets: CS21 is fielding, CS23 is in near-term development, CS25 is in technology maturation and prototyping, and CS27 design goals are being developed. While CS21 focused on Infantry formations at Brigade and below, Capability Sets 23 and 25 and beyond are increasingly targeting network modernization for mounted formations, as well as the Division level as the Army transitions to the Division as unit of action.

“From an operational perspective, what you’re really starting to see is how the Army wants to fight in the future be baked into each iteration of the Capability Sets,” said Lt. Gen. John Morrison Jr., Deputy Chief of Staff, G-6.

As the Army evolves to more data-centric, expeditionary and dispersed operations, Capability Set 23 will also deliver a foundational tactical data fabric that will provide commanders with relevant data at the point of need, as

well as Mission Partner Environment data exchange capability that increases interoperability with coalition partners.

“We need to create a data centric environment, a cloud environment, a backbone that we can reach to for our data and render that data to our commanders so they can make informed decisions,” said Brig. Gen. Jeth Rey, Director of the Network CFT.

Capability Set 23 also increases integration of electronic warfare, intelligence, fires and sustainment capabilities into the network. It introduces high-throughput, low-latency satellite communications through commercial services and non-traditional orbits to provide additional communications options for commanders.

For Stryker formations such as the 2nd Cavalry Regiment — which has participated throughout the CS23 design and assessment process and will be the first mounted unit equipped with CS23 — the new technology improves digital voice and data communications for mounted and dismounted operations.

“This allows Soldiers to maintain their communications while inside the vehicles, and as they dismount the vehicles, they maintain that connectivity throughout their mission,” said Mindy Gabbert, Deputy Project Manager for Capability Set Development at PEO C3T.

Capability Sets utilize synchronized Soldier touchpoints, developmental and operational tests, and exper-

iments such as Project Convergence and CyberQuest in order to fully vet and integrate systems so they are prepared for fielding. This ensures that input from the operational force, including lessons-learned from units supporting operations in Europe, is captured in the iterative design process.

“Tactical level Soldier/operator feedback more clearly informs and defines capability requirements,” said Maj. Todd M. Klinzing-Donaldson, head communications and network officer for the 2nd Armored Brigade Combat Team, 3rd Infantry Division, whose unit executed an Armor formation networking pilot earlier this year. “Our unit experimented with three unique equipment sets, focused on creating a more robust upper tactical internet capability that would build a better common operational picture for the unit commander.”

Feedback from the pilot event is already informing Capability Set 25, which will extend the network to Armor formations and continue to incorporate commercial solutions that enable the future network to be transport-agnostic, data-centric and underpinned by modernized security architecture and cyber resiliency. In parallel, the next step for Capability Set 23 will be a two-phase operational demo with the 2nd Cavalry Regiment that will take place starting in June, which will inform final CS23 fielding decisions to take place in Fiscal Year 2023.
