SJA, U.S. Attorney sign agreement

The Task Force Marne and the Fort Stewart Office of the Staff Judge Advocate held a Prosecution Partnership Agreement Signing Ceremony at the 3rd Infantry Division Museum on Fort Stewart, Georgia, March 22.

The agreement establishes the relationship and responsibilities

between the U. S. Attorney's Office and the OSJA in administering the federal misdemeanors and felony prosecution program for offenses committed by civilians and egregious offenses committed by service members here and Hunter Army Airfield, Georgia.

"Civilians are not subject to the Uniform Code of Military justice for crimes committed on the installation," said Lt. Col. Eric W.

Widmar, staff judge advocate, Task Force Marne and Fort Stewart/Hunter Army Airfield. "This can include anything from domestic violence situations - where you have civilian spouses - to drug and weapon offenses."

Widmar said the Department of Justice is responsible for prosecuting federal offenses in U.S. District Court before a district or magistrate judge. However, the U.S. Attorney may appoint an Army attorney as a Special Assistant U.S. Attorney with the authority to prosecute civilians in federal court under the supervision of the U.S. Attorney's office.

The memorandum of agreement establishes a felony prosecution program in, which the USAO provides resources in the form of training and supervision that enables uniformed attorneys the ability to prosecute these more serious offenses in the U.S. district courts.

"I think what you will see, as a result of this - especially with these serious crimes -- is a more rapid prosecution," said Widmar. "Additionally, since stiffer sentences usually accompany crimes tried in federal courts, it acts as an effective deterrent for criminal activities on the installations."

Widmar and the Honorable Bobby Christine, U.S. Attorney

for the Southern District of Georgia, solidified the agreement with their signatures - coalescing the long-standing relationship the two entities held.

Christine said the agreement also helps develop and strengthen litigation skills for both the Army judge advocates directly involved and the Assistant United States Attorneys with whom they will work with. Additionally, allowing prosecutors to focus more resources on crimes conducted both inside and outside of military installations increases the safety of our communities where many Marne Soldiers and their Families reside.

Christine was a staff judge advocate in the Army National Guard.

"Direct supervision of your peers will be with folks who understand - who get it," said Christine during a speech at the ceremony. "I pledge that we will return to you refined and amplified litigators. Anything we can do to make your mission successful, we will do that."

The 3rd ID OSJA has long had an agreement that allowed Army attorneys to prosecute misdemeanor crimes before a federal magistrate judge. Widmar said this is the first felony prosecution agreement the OSJA has established with the U.S. Attorney's Office in recent memory.

"This agreement provides another option to hold people accountable, deliver justice to victims and make Fort Stewart and Hunter a safer place for our Soldiers and Families to work and live in," Widmar added.

Educators learn about military life

Thirty-two school teachers and administrators from the Savannah-Chatham County Public School System visited Hunter Army Airfield March 21, to experience "A Day in the Life of a Soldier."

The event helped familiarize local educators with military life.

"The ability to gain first-hand knowledge of the great work of our service men and women, is so valuable to our staff who work day in and day out with military Families and students," said

Kurt Hetager, chief public affairs and administrative services officer, Savannah-Chatham County Public School System. "Events like this strengthen our connection."

The day included the educators getting off the Army bus and attempting to get properly aligned in an Army formation, marching to the obstacle course, negotiating obstacles, lunch with Soldiers in the dining facility and firing M4 rifles in the Engagement Skills Trainer under the instruction of Soldiers.

"We have a great relationship with our local school

systems and wanted to enhance their understanding of what those of us in the Armed Forces do on Hunter Army Airfield," said Lt. Col. Ken Dwyer, garrison commander, Hunter Army Airfield.

"I learned a lot about what the mission and units based on Hunter," said Candy Purdom, an early intervention program specialist with SCCPSS. "I also had a blast on the obstacle course and firing the weapon. Some of the obstacles required us to use teamwork to get over them ... that was a valuable example of the importance of working as a team."



Marne Division celebrates, honors women during observance

The 3rd Sustainment Brigade, 3rd Infantry Division hosted the Women's History Month observance at Club Stewart in Fort Stewart, Georgia, March 21.

The origins of Women's History Month began in 1978 in California as a week-long celebration of women's contributions to society and culture. In 1980, President Jimmy Carter issued the first proclamation declaring the 2nd week of March as National Women's History Week.

Six years later, the National Women's History Project petitioned the U.S. Congress to expand the commemoration to the entire month of March.

"Since America's founding, women have played an integral part in American innovation and productivity, while simultaneously raising generations of lively children and providing leadership in their local communities," said President Donald Trump during a speech officially proclaiming March 2018 as Women's History Month.

Club Stewart was adorned with displays highlighting various prominent female service members and the influential role they played in the armed forces.

While the incredible accomplishments of female Soldiers such as Capt. Kristen Griest – one of the first women to earn the coveted Ranger tab and the Army's first female infantry officer – are well known, women

have longed filled the ranks of formations in every major campaign throughout history.

Maj. Alicia L. Pruitt, deputy human resources officer of the 3rd Infantry Division and guest speaker for the observance, reveled in the endeavors of the service women who came before her and also recognized well-known female pioneers such as Rosa Parks, Marie Curie and Susan B. Anthony during her speech.

"Everything from the Women's Nurse Corps to the Women's Army Corps in support of the World Wars to even now," said Pruitt. "Women bring a dynamic of emotional intelligence, resiliency, adversity and a special talent of bringing together a team."

Pruitt attributes her success and accomplishments to her great-grandmother, Laurette Durand – who Pruitt says is her number one female role model.

As a photo was displayed of Durand on the projector at Club Stewart, Pruitt grew teary-eyed as she spoke of the struggles her great-grandmother endured while still managing to remain a stoic and resilient heroine to the women that followed her.

"I share my great-grandmother with you today, not because she was a change agent on a global scale," said Pruitt. "But because she was a change agent in my life and the life of the other women in my family."

Female Marne Soldiers from all ranks were in attendance for the observance.

Spc. Silken F. Little, a Decatur, Georgia native and signal support systems specialist assigned to the 87th

Combat Sustainment Support Battalion, 3rd STB, 3rd ID, said she was inspired to enlist and following the footsteps of her grandmother who was an internment/resettlement specialist in the Military Police Corps.

"I wanted to make her proud," said Little. "Female Soldiers like my grandmother played such a big role in the success of the Army. They have set milestones for younger women like myself."

Today, women have more opportunities than ever in the armed forces. Women make up more than 17 percent of the total Army force and are now able to serve in all position, to include, combat arms military occupational skills.

Spring Break - Discover Fort Pulaski, Tybee Island

Fort Stewart-Hunter Army community members considering spring break vacations do not have to look far to find scenic locations near the installation.

Approximately 70 miles from Fort Stewart and 20 miles from Hunter Army Airfield the Fort Pulaski National Park and monument with the off-shore batteries on Tybee Island, has historic military significance as well as scenic panoramas.

Conducting a professional development trip to Fort Pulaski, Soldiers and civilians with the 3rd Infantry Division and Fort Stewart public affairs office

visited the civil war landmark on March 23, and learned about the evolution of warfare.

While the rifled cannons used by the Union forces in the Civil War proved to be too much for the brick and mortar Fort Pulaski, the site remains an affordable Family friendly experience.

The on-shore batteries where the Union placed their rifled cannons to siege and batter the fort are located next to the Tybee Island lighthouse. The view from the same lighthouse provides a panoramic view of both the Fort and the nearby sand dunes and deep water beaches.

Reduced costs for certain drugs

TRICARE beneficiaries taking certain maintenance drugs for diabetes or high cholesterol are now paying lower or no copayments as part of a pilot program. The Medication Adherence Pilot Program, launched

on Feb. 1, will examine whether people are more likely to follow a medication treatment plan when those drugs are available at no-or-reduced cost.

TRICARE referrals, authorizations

If a necessary service is not available from the military hospitals and clinics, a referral will be required. Some procedures and services, including hospitalization, require prior authorization from Humana Military. This is the first time live rounds have been fired since the U.S. Army announced that 3rd ID's Spartan Brigade would convert from an infantry to an armored brigade combat team.

"The units are using gunnery tables to test their vehicles during the fielding process," said Sgt. 1st Class James Barboa, cavalry scout platoon sergeant with 6-8 Cav. "Table VI Gunnery will be the last requirement to complete the fielding process. That gunnery will be done by the end of the month."

Table VI is a live gunnery table that certifies each combat vehicle crew. Crew certification is a critical milestone that the three-person team must hit in order to progress onto larger and more complex gunnery tables.

Prior to firing live rounds down range, crews had to conduct hands-on and simulated modules of gunnery skills.

"The simulated exercises allowed our gunners to work on target acquisition," said Capt. Bryce East, commander of Troop C, 6-8 Cav. "The hands-on training included loading and downloading ammunition, identifying different vehicles and ammo types, and disassembling a 25 mm caliber cannon."

Barboa stated that his Troopers were anxious to begin gunnery and experience the adrenaline that comes from firing the main gun.

"We are going to set the bar high for the rest of the units going through gunnery," said East. "All that come after us, will know what to expect."

East said they will continue to make strides towards becoming the most lethal and fit ABCT in the Army and that this is just the beginning.

Seek strength in God this Easter

Sunday is Easter. That day evokes a wide range of emotions in peoples' hearts and minds. You may have memories of searching for dyed Easter eggs hidden in or around the house. You may have endured an especially thorough scrubbing Saturday night and been forced into starchy new clothes Sunday morning. Then you had to sit quietly through a church service.

My pastor had a cartoon on his desk showing a family in a car. The dad, who was driving, was saying, "I know the church is around here. I remember it from last Easter!" People sometimes only go to church on Easter and Christmas. Why is that?

Religion speaks to us of "ultimate" things which we consider beyond our control or somehow "above" us humans. Life, death, ethics, attitudes, motives, eternity, love and truth are heavy topics for our consideration, and faith speaks eloquently to these concerns.

Growing up in the 1960s, I saw a society that felt a need for religious teaching. Even non-churchgoers seemed to respect the value religion held for most of our nation. No one batted an eye when someone talked about God, even if they didn't believe

in God. When someone prayed, virtually everyone was silent and most closed their eyes.

Yes, some people – especially young people – rebelled. Sometimes their rebellion was shocking. But even some rebellious youth tended to be at church on Easter Sunday morning. It seemed to be important to them.

Why is religion so important that it forces its way into our thinking, even if we aren't religious? I suspect it's because humans recognize that there are things beyond our control, and we are somehow encouraged by a claim that a power outside of us and beyond us might help us. Passover, Easter and Laylat al-Qadr ("Night of Power") during Ramadan are all affirmations by people of faith that a good God will help us when we reach the end of our natural ability.

In the Passover, the Jews celebrate their deliverance from Egypt when the Angel of Death "passed over" the houses of the Hebrews while visiting death on the houses of their Egyptian taskmasters. That was the beginning of their freedom from centuries of slavery and their possession of the Promised Land.

Ramadan, begins May 15 this year.

It consists of a month of fasting and prayer, observed by Muslims all over the world. Toward the end of that month Muslims remember the revelation of the Holy Quran to the Prophet Muhammad. On the Night of Power they believe the power of Allah is available to them in a supernatural way, and may recite and study the Quran, make special requests from Allah, evaluate their own lives and make plans for the next year.

Easter is the commemoration of the resurrection of Jesus from the dead. Christians believe that this miracle makes forgiveness and a spiritually "right" life possible. It is central to the Christian faith and practice.

Each of these "holy days" speaks of a God who is greater than we. When we're feeling especially weak or helpless, it is natural to look to God, and comforting to believe that such a God is for us and will help us.

I believe that's why attendance goes up on these special days. I encourage you to think about those areas in your life where you don't feel you're strong enough to make it on your own and seek God's help. I believe you'll find the help you need. Please talk to your chaplain if you have any questions.



NCOPDS: How the Army is Develops its Leaders

BAGRAM AIRFIELD, Afghanistan - The Army is always changing and adapting to the challenges presented by current missions. To ensure Soldiers are ready to combat any threat, the Army has designed tiered training specific to each noncommissioned officer rank.

The NCO Professional Development System teaches leadership skills at all levels of the NCO from corporal through command sergeant major. Through both job-specific and broad leadership training, the NCOPDS molds Soldiers into competent leaders.

In the Basic Leader Course, future NCOs learn to adopt the role of a sergeant that their units expect of them. They will be in charge of training the junior Soldiers that they themselves were not long ago.

The Basic Leader Course teaches junior enlisted Soldiers basic warrior skills, such as land navigation and troop leading procedures. The point is not to re-teach what these Soldiers learned through initial entry training, but rather help them better understand it so that they can teach their own Soldiers one day.

As much as leadership courses can teach you, there is no substitute for good first line leaders. What a student can learn in three weeks an NCO utilizes every day. A key example would be the counseling

process. At BLC, the instructors show Soldiers how to properly fill out counseling forms and conduct a mock counseling session with a Soldier. While this is effective in helping junior leaders the correct way to fill out these forms and conduct these sessions, they should already be familiar with the process by going through it with the first line leaders.

Another key aspect of professional development happens at the unit level. Unit training with senior leadership will lay down expectations of NCOs for their future professional development. This can help disseminate information on changing Army policies and allows these leaders to ask the seniors questions.

A feature that all of these things have in

common: the leaders themselves. The quality of a leader can heavily influence a subordinate's morale and motivation. To develop junior Soldiers, leaders must be competent and provide purpose, direction and motivation to their subordinates.

Leaders must also develop themselves and demonstrate the drive to improve themselves while also being attentive to their Soldiers.

Through their professional development, Army leaders are able to meet any changes presented to them. While the education system may evolve, NCOs will remain the backbone of the Army. This will allow them to remain flexible to change and stay diligent in the development of future leaders.

DES CORNER: Move over law: Georgia code, Title 40-6-16

How many times have you been out driving and you see an emergency vehicle with flashing lights off the shoulder of the road?

Multiple times, I have witnessed vehicles driving in the lane adjacent to the shoulder of the road and outright ignore the lights of emergency and utility vehicles, stopped in an official capacity. Instead, the motorist continue driving in the lane adjacent to the shoulder; placing that emergency personnel in harm's way.

Georgia's move over law for emergency vehicles states the operator of a motor vehicle approaching a stationary authorized emergency vehicle that is displaying flashing yellow, amber, white, red or blue lights shall approach the authorized emergency vehicle with due caution and shall, absent any other direction by a peace officer, proceed as follows:

1. Make a lane change into a lane

not adjacent to the authorized emergency vehicle if possible in the existing safety and traffic conditions; or

2. If a lane change under paragraph (1) of this subsection would be impossible, prohibited by law or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be less than the posted speed limit and be prepared to stop.

The operator of a motor vehicle approaching a stationary towing or recovery vehicle or a stationary highway maintenance vehicle that is displaying flashing yellow, amber or red lights shall approach the vehicle with due caution and shall, absent any other direction by a peace officer, proceed as follows:

1. Make a lane change into a lane not adjacent to the towing, recovery, or highway maintenance vehicle if possible in the existing safety and traffic conditions; or

2. If a lane change under paragraph (1) of this subsection would

be impossible, prohibited by law, or unsafe, reduce the speed of the motor vehicle to a reasonable and proper speed for the existing road and traffic conditions, which speed shall be less than the posted speed limit and be prepared to stop.

Violation of subsection (a) or (b) of this code section shall be punished by a fine of not more than \$500.00.

Governor's Office of Highway Safety Director Harris Blackwood stressed that the purpose of Georgia's Move Over Law is to "reduce the number of injuries and fatalities to police officers, paramedics, firefighters, tow truck operators and highway maintenance workers."

Therefore, as motorists, not only must we not harm our emergency personnel, but we must also obey the law. You can find more information at www.gahighwaysafety.org

So the next time you see emergency vehicle on the shoulder of the road; do not think, simply move over safely.

Consider snake safety as weather warms approaches

Now that the weather is getting warmer with the approach of summer, there will be more people enjoying their favorite outdoor activities, such as hiking in our state parks. However, snakes are one of the outdoor dangers that we must be vigilant of as we move about since the warmer weather usually attracts snakes. While snakes are beneficial to our environment by helping keep the rodent population down, some snakes are very harmful to humans. These snakes are poisonous, and their venom can attack different organs in our bodies. In Georgia, we have several common snakes such as the

Eastern Garter, Brown Water, Scarlet King, Hognose, Eastern Ribbon, Crown, Queen, Earth, Black Swamp, Pine woods, Pine and Rainbow snakes. However, only the Crown and the Pine Woods snakes are mildly venomous, causing just a mild irritation to human. The rest are all venomous and can cause severe pain or death. The Eastern Diamond Back Rattlesnake, Cottonmouth (Water Moccasin), Coral Snake, Copperhead, Timber Rattlesnake and the Pigmy Rattlesnake are all great at camouflaging themselves with the surroundings and will strike without hesitation. Some snakes are more active than others in the evening when it is a little cooler outside, but enjoy sunbathing during the day. You can find them everywhere from the woods and under leaves, to rocky

hills and mountains. Some snakes spend most of their time in lakes and rivers catching frogs and lizards. So if you are going hiking, it is best to wear heavy leather or high-topped rubber boots and heavy gloves. Also, wear your trouser legs outside boots. Other tips are at <http://www.i4at.org/lib2/snakes.htm>

Be extremely careful around debris. Use rakes, pry bars, or other long-handled tools when removing debris. Never expose your hands, feet, or other parts of your body in a place where a snake might hide. Always be on the lookout and if you realize you are near a snake, avoid sudden movement, which may cause the snake to strike. If you remain still, the snake may leave. If the snake does not move away from you, back away from it, slowly.

If you kill a poisonous snake, use a stick, rake, or another long-handled tool to carry the snake away for disposal. Snakes may bite even when they appear dead.

These are just a few safety tips you can find more on the internet. It is best to know the basics about snakes before you find yourself or a family member in striking distance of a poisonous one.
