# Pilot takes final flight at Hunter

As the sun crept through the clouds, a bright energizing red-orange hue painted the sky Jan. 10. The day would prove to be a day to remember for an AH-64 Apache pilot as he soared through the sky.

Soldiers from 3rd Squadron, 17th Cavalry Regiment, 3rd Combat Aviation Brigade, 3rd Infantry Division, gathered to honor Chief Warrant Officer Ernest “Tommy” Barela as he made his final flight at Hunter Army Airfield.

The final flight is a tradition held by aviators to honor the pilots and crew chiefs, signifying the end of their Army careers. Barela made his flight after providing more than 20 years of service to the Army and the Soldiers he has mentored through the years.

Born and raised in Albuquerque, New Mexico, Barela knew at an early age that he wanted to be a pilot.

“I started my career as an aircraft power plant repairer,” said Barela. “As much as I liked my job

and taking care of Soldiers, I felt that if I could fix the aircraft, then I should be able to fly it, too.”

As he spoke of his career, he smiled. In 2008, the war in Afghanistan was still very much active but a 15-month deployment did not deter Barela from completing his dream.

“It was the success of the leaders around me at the time that really had a hand and influenced my career,” said Barela. “We were able to submit my packet while still in Afghanistan and when we came back it was approved.”

Barela then went to the warrant officer candidate school and the warrant officer flight training program where he trained to be the AH-64 Apache pilot.

“Warrant officer school was very demanding and it taught me etiquette and time management down to the second,” said Barela. “Flight school was just as demanding with hour-long bus rides and even longer academic schedule.”

After completing such demanding schools, Barela did not once falter because the desires of his heart were met with God’s plan for his life and in turn his Family maintained stability like ships

in port.

“After all the training, I was able to come to 3rd Combat Aviation Brigade and provided my family with the stability they needed to thrive and make it in today’s world,” said Barela.

Barela is supported by his wife Cathleen and his two children.

“We are best friends,” said Cathleen. “It is our faith in God and in each other that keeps us centered and together.”

Cathleen believed in Barela every step of the way and she noticed the same traits in their relationship.

“He is the most dedicated, driven and selfless individual,” said Cathleen. “He has a work ethic where he gives 100 percent to everything he does. He is sincere in his approach to help people.”

Barela has trained many junior Soldiers and officer in his career and as he walked away from the Apache for the last time, he said there was one thing he would change in his Army career.

“Keeping track of my flight hours,” said Barela. “Not trying to scrounge looking for .1 and .2 hours to log in the flight log.”

### Construction notice



## New graphic novellas to educate Soldiers, Families on future cyber threats

**FORT MEADE, Maryland** -- Since World War II, the Army has been using comic books to train Soldiers on specific duties and reduce casualties through improved situational awareness.

The trend continued through the Vietnam War. At that time, the Army discovered a training deficiency and produced a comic book to educate Soldiers about proper weapon maintenance.

Fast forward to today, the Army is facing a new challenge.

Advancements in cyber and smart technologies have the potential to alter the landscape of future military operations, according to Lt. Col. Robert Ross, threatcasting project lead at the Army Cyber Institute, West Point, New York.

The U.S. military, allied partners, and their adversaries are finding new ways to leverage networked devices on the battlefield, Ross said.

"The use of networked technology is ubiquitous throughout society and the leveraging of these devices on future battlefields will become more prevalent; there is just no escape from this trend. Technology is integrated at every level of our Army," he said.

Keeping with the Army's legacy of producing visual literature to improve readiness, the ACI has partnered with Arizona State University Threatcasting Lab to produce a series of graphic novellas, Ross said.

The lab brings together military, government, industry, and academia experts

to envision possible future threats.

Through their research, the workshop develops potential cyber threat scenarios, and then explores options to disrupt, mitigate, and recover from these future threats.

Each graphic novella considers what cyber threats are plausible in the next 10 years -- based on a combination of scientific fact and the imagination of those involved, Ross explained.

"This project is designed to deliver that understanding through visual narrative," he said. "Technical reports and research papers do not translate as well to the audiences we are looking to influence. Graphic novellas are more influential of a medium for conveying future threats to not only Army organizations at large, but down to the Soldier level."

The novella titled "1000 Cuts" depicts the psychological impact that a cyber-attack could have on Soldiers and their families. In the story, these attacks were enough to disrupt a deployed unit, leaving them open to an organized attack, Ross said.

"Given the exponential growth in Soldiers' use of [networked] devices ... 1000 Cuts presents an extremely plausible threat. It demonstrates how non-state actors can leverage technical vulnerabilities within the cyber domain to their advantage in the land domain," Ross said.

"The visual conveyance of a graphic novella enables leaders to not only envision these scenarios but retain the lessons that can be drawn from them as well," he added.



# SecArmy visits Stewart, Soldiers

The 23rd Secretary of the Army, The Honorable Dr. Mark T. Esper, visited the 3rd Infantry Division and tenant units on Fort Stewart and Hunter Army Airfield, Jan. 11.

The purpose of his visit was to observe the value of the 3rd ID and how their efforts are lined up with national defense efforts.

Fort Stewart-Hunter Army Airfield is the Army's premier power projection platform on the east coast – responsible for training, equipping, deploying and redeploying active and reserve component Army units.

"I had a wonderful day today at Fort Stewart and Hunter Army Airfield," said Esper. "The 3rd Infantry Division is a premier combat unit in the United States Army."

The Marne Division has a storied history of wartime operations. As the XVIII Corps' only heavy division, the 3rd ID adopts an expeditionary mindset and pos-

ture in order to maintain readiness. Maj. Gen. Leopoldo Quintas, the commanding general of 3rd ID, has Soldier lethality as a main priority of modernization – an attribute that resonates frequently throughout the Army Vision 2028, an initiative Esper announced in June.

"Today it's been our honor to host the Secretary of the Army for a visit today," said Quintas. "We have had the opportunity to show him how we are executing the Army's three priorities – building readiness, modernizing the force and executing reform."

His day started with observing a training event with an emphasis on breaching operations conducted by the engineers of the 9th Brigade Engineer Battalion, 2nd Armored Brigade Combat Team, 3rd ID.

Additionally, Esper was briefed on the brigade's recent transition from an infantry brigade to an armored brigade.

"This is the type of warfare that we need to prepare for that you all are rightly preparing for," said Esper. "I have enjoyed spending time with you all and watching this training today."

Esper then went on to observe the Joint Light Tactical Vehicle – the Department of Defense's newest combat vehicle – that is on track to replace the Humvee. The 1st Armored Brigade Combat Team, 3rd ID is the first unit in the Army to field the JLTV.

A town hall meeting was held at the Fort Stewart main chapel where Esper addressed questions pertaining to modernization, new weapon systems and training. The event was open to Soldiers, Families and civilians.

"As you think about modernization, our top six modernization priorities are long-range precision fires, next generation combat vehicles, future vertical lifts, network, air missile defense and Soldier lethality," said Esper. "All those new systems, all those programs that will better prepare our Army for the future fight will be integral to the readiness of the 3rd Infantry Division."

Accompanying Esper was his wife, Leah, who spent the day speaking with the spouses and Family Members of Fort Stewart. Leah also visited Pulaski Elementary School at Hunter Army Airfield.

# 2019 brings changes to military justice system

**FORT MEADE, Md.** -- A host of changes to the Uniform Code of Military Justice became effective Jan. 1, modernizing definitions for many offenses, adjusting maximum penalties, standardizing court-martial panels, creating new computer-crime laws, and much more.

The changes strike a balance between protecting the rights of the accused and empowering commanders to effect good order and discipline, said Col. Sara Root, chief of the Army's Military Justice Legislation Training Team.

"We're pretty excited," Root said. "It's a healthy growth of our military justice system."

Root and three members of her team spent the last year traveling to 48 installations to train 6,000 legal personnel and law-enforcement agents about the changes. Her two-day classes included everyone from judges to law clerks, and privates to generals, she said, and even 600 from other military services.

## Codifying Changes

Many of the changes came about after a review by the Military Justice Review Group, consisting of military and criminal justice experts whose report made recommendations to Congress.

"We've had a lot of changes to our system [over the years], but piecemeal," Root said. She explained that the Review Group convened to take a thorough and holistic look at the system to standardize military law and update the Manual for Courts Martial.

Many of the MJRG's changes were incorporated into the Military Justice Act of 2016, the 2017 National Defense Authorization Act, and then Executive Order 13825 signed by the president March 8. Additionally, Secretary of the Army Mark Esper signed a directive Dec. 20 that clarifies definitions for dozens of offenses taking effect this week.

"We've really needed that much time," Root said, from 2017 to now, in order to train all members of the Army Judge Advocate General's Corps. Those attending her classes then needed time to train commanders and others on the installations, she added.

## Adultery Changed

One of the changes replaces the offense of adultery with "extra-marital sexual conduct." The new offense broadens the definition of sexual intercourse, which now includes same-sex affairs. The amendments also now provide legal separation as a defense.

In the past, service members could be charged with adultery even if they had been legally separated for years but were not divorced. Now legal separation from a court of competent jurisdiction can be used as an affirmative defense, Root said.

Also in the past, prosecutors had to prove traditional intercourse to obtain a conviction for adultery, Root said. Now oral sex and other types of sexual intercourse are included.

## Protecting Junior Soldiers

UCMJ Article 93a provides stiffer penalties for recruiters, drill sergeants and others in "positions of special trust" convicted of abusing their authority over recruits or trainees.

The maximum sentence was increased from two years to five years of confinement for those in authority engaging in prohibited sexual activities with junior Soldiers. And it doesn't matter if the sex is consensual or not, Root said, it's still a crime.

Article 132 also protects victims and those reporting crimes from retaliation. An adverse personnel action -- such as a bad NCO Evaluation Report, if determined to be solely for reprisal --- can get the person in authority up to three years confinement without pay and a dishonorable discharge.

## Computer Crimes

Article 123 provides stiff penalties for Soldiers who wrongfully access unauthorized information on government computers. Distributing classified information can earn a maximum sentence of 10 years confinement, but even wrongfully accessing it can get up to five years in jail. Unauthorized access of personally identifiable information, or PII, is also a crime. Intentionally damaging government computers or installing a virus can also bring five years in the clinker.

Article 121a updates offenses involving

the fraudulent use of credit cards, debit cards or other access devices to acquire anything of value. The penalty for such crimes has been increased to a max of 15 years confinement if the theft is over \$1,000.

If the theft is under \$1,000 the maximum penalty was increased from five to 10 years confinement, and this crime also includes exceeding one's authorization to use the access device, for example, misusing a Government Travel Card.

Cyberstalking is also now included as a stalking offense under Article 130 of the UCMJ.

## Courts-Martial

A "bench trial" by a judge alone can now determine guilt or innocence for many offenses. Almost any charge can be referred to such a forum, except for rape and sexual assault, which requires referral to a general court-martial. However, if the offense has a sentence of more than two years, the accused has a right to object to such charges being referred to a bench trial and could request a special or general court-martial.

If found guilty at a bench trial, Root said a Soldier cannot be given a punitive discharge and the max sentence would be limited to no more than six months forfeiture of pay and no more than six months confinement. The judge can still adjudge a reduction in rank.

"It's a great tool that we're really excited to see how commanders use it out in the formations," Root said.

More than half of the cases in the Army actually are settled by plea agreements in lieu of a contested trial, Root said. Commanders have always had the authority to limit the max sentence with a plea agreement, but she said now they can agree to a minimum sentence as well. This

might result in a range for the judge to sentence within, for example, no less than one year confinement, but no more than five years confinement.

If a case goes to a non-capital general court-martial, the panel has now been standardized to eight members. In the past the size of the panel could vary from

five to an unlimited number, but often around 10-12 members. Now each general court-martial must begin with eight panel members, she said, but could continue if one panel member must leave due to an emergency during trial.

Special courts-martial will now be set at four panel members. A court-martial convening authority can also authorize alternate members to be on a special or a general court-martial, she said.

Capital offenses such as murder require a 12-member panel.

For a non-capital court-martial, three-fourths of the panel members must agree with the prosecution to convict the accused, she said. For instance, if only five members of an eight-member panel vote guilty, then the accused is acquitted. A conviction for a capital offense still requires a unanimous verdict.

## Expanded Authority

Congress expanded judges' authorities to issue investigative subpoenas earlier in the process, for example, to obtain a surveillance video from a store. One of the most significant changes is that now military judges can issue warrants and orders to service providers to obtain electronic communications such as email correspondence.

In the past, trial counsel had to wait until preferring charges to issue investigative subpoenas. Now, with the approval of the general court-martial convening authority, trial counsel can issue subpoenas earlier to help determine whether charges are necessary. For electronic communications, the government previously had to rely on federal counterparts to assist with obtaining electronic communications.

# Cervical cancer: capture, intervene, prevent

“Until completely evaluated, some women may be operating on bad information,” said Maj. Shannon Renfrow, concerning annual pap smears and cervical cancer. Renfrow, an obstetrician/gynecologist at Winn Army Community Hospital, U.S. Army Medical Department Activity-Fort Stewart, said “prevention is key to slow the growth of cervical cancer.

Cervical cancer grows in the part of the uterus that connects to the vagina called the cervix. This type of cancer, which is typically caused by sexually transmitted human papillomavirus, used to be one of the leading causes of cancer deaths in the world. But, thanks in part to the improvements in detection and treatment, survival rates have greatly improved.

“Cervical cancer doesn’t start as a raging, fast-growing, rapid-spreading cancer,” Renfrow said. “It starts as something called cervical dysplasia, which is a shift in those cervical cells, from stone-cold normal to abnormal.”

To detect the change in cervical cells, Renfrow suggests women have an annual well-woman exam and discuss what cervical cancer screening is recommended with their provider. Healthy young women, with a vigorous immune system, are typically able to fight low-grade cervical dysplasia and repair the cells them-

selves, Renfrow explained, but close surveillance is important.

Reproductive aged women are most at risk of contracting the virus. Early-stage cervical cancer rarely produces symptoms or signs. This type of cancer, in its advanced stage, can present with bleeding, or discharge from the vagina that is not normal, such as bleeding after sex, according to CDC experts.

The HPV vaccine is now offered to both males and females 9-26 years old, but recently has been approved for administration as late as 45-years-old.

“The goal is to give them the immunity before they are ever exposed to it,” Renfrow said. “Just like other childhood immunizations, our hope is that they are not exposed to for years to come, but because the HPV virus does cause cervical cancer we know that if we get them that immunity before they are ever exposed to it, that is the best way of them receiving the benefit.”

Capt. Brittany Brooks, a physician in the Ob/Gyn department at Winn ACH said an exam, which takes less than literal minutes a year, can prove to be life-saving.

“I know people hate speculum exams, you feel like it’s not that important and you can just bypass it, but pap smears are important,” Brooks said. “Just like I tell my girlfriends about any issues they feel like are going on ... ‘go see your doctor, don’t Google, don’t

ask your friends around you, go see your doctor,’ that’s what (we) are here for.”

Due to a constantly changing culture of sexual practices, there is now a significant increase in oral pharyngeal cancers. These cancers of the throat, head and neck are devastating. For men carrying the HPV virus, it is often silent, but the vaccine can protect against some of the most common and virulent strains and protect them while also preventing them from passing it on to other people.

“I tell parents that we literally have a vaccine that could prevent cancer,” Renfrow said. “That to me as a mother is a pretty powerful motivator. I can’t protect my children from everything, and no vaccine is 100 percent effective, but to be able to give my child that protection, I just feel like, when I have seen some of these devastating cases of cervical cancer in women who are in monogamous relationships ... it only takes one exposure and if that virus progresses and changes those cervical cells and it progresses to cancer before its caught, effects can be devastating to future fertility, quality of life and even life itself.”

Brooks recommends talking to your primary care provider about your particular problem, by asking questions, identifying the virus early, and to intervene before the small problem becomes a huge problem.

What would Dick Butkus say about the penalties called on Clay Matthews and other pass rushers this season? Has the respect shown to quarterbacks become disrespectful of other players?

It is interesting how the common usage of words changes over time. Take the word respect, for example. The Army defines respect as “treating other people as they should be treated.” Two ideas are implied by our third

core value. One is simply the dignity of persons. As the Declaration of Independence stated it, “We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness.” The second part of respect is the recognition of how every individual's effort contributes to the success of the team.

“Respect”, however, has not always been a positive term. In the King James Version of the Bible we find verses such as James 2:9 which reads, “But if ye have respect to persons, ye commit sin, and are convinced of the law as transgressors.” A more modern translation (New International Version) renders the same verse, “But if you show favoritism, you sin and are convicted by the law as lawbreakers.” In other words, one of the most common uses of the term respect in the early seventeenth century was to denote showing partiality to one person over another, and the Bible calls this “sin.”

The irony I lay before you is this: “King James” respect is one of the greatest hindrances to practicing well our third core value. One of the most common work issues about which folks express frustration is the partiality a supervisor shows to other individuals. It is natural that all of us will like certain people more than others. But the fairness expected by the Army definition of respect requires that supervisors lay aside personal preference and give everyone as much of an equal opportunity as possible. Remember back in school how everyone knew who the teacher's pet was? The best teachers were the ones for whom it was hardest to identify their favorite student. So it is with other leaders. Favoring one is disrespecting the rest. St Paul said, “There is no respect of persons with God.” In the King James sense of the word, there should be no respect of persons with us either.


Perhaps the bottom line here is this – we need to be better than the NFL rule book currently is.

# Hydrotherapy tub offers soothing labor experience

Solas, a name which means comforting, illumination and enlightenment is what Family Member Tashaia, and Spc. Johnathan Thomas, 3rd Combat Aviation Brigade, 3rd Infantry Division, named their son. Solas' name is indicative of the nature of his birth.

The Thomas Family was the third in 2019 to use the new hydrotherapy tub at Winn Army Community Hospital. When the Family arrived at Winn ACH, Tashaia was in labor, and was assigned the hydrotherapy tub room. When asked if she would like to use the tub as she labored, Tashaia jumped at the opportunity.

The hydrotherapy tub is equipped with comfortable

head rests and seating, a shower sprayer and temperature control. Although the hydrotherapy tub is not a viable option for all moms giving birth, Tashaia fit the guidelines, said Maj. Shannon Renfrow, an obstetrician/gynecologist at Winn Army Community Hospital, U.S. Army Medical Department Activity-Fort Stewart.

Renfrow said certain guidelines are in place for patient safety. Moms who meet the qualifications to labor in the tub have to have had a healthy pregnancy. Patients who go into labor spontaneously, with no drug inducement or epidural; patients who do not have complications in their pregnancy like hypertension, diabetes, pre-eclampsia, or a patient who has never had a c-section or uterine surgery, are good candidates for the hydrotherapy-tub.

"We have the research to support it," Renfrow said.

"We have effective pain control ... the research to show that it can decrease the duration of physiologic labor."

Tashaia agrees and said being in the hydrotherapy tub helped her labor to progress at a rate of comfort and timeliness that left her and Thomas enlightened. Previously, Tashaia had an epidural with their first child and

she labored for 16 hours, but with Solas, she dilated from five to eight centimeters in 30 minutes.

"It progressed really fast in the tub," Tashaia said. "The temperature control, helped a lot with contractions. The contractions would come, but because the water was so warm ... I really didn't notice having many contractions."

Tashaia suggests moms in labor walk as much as possible before coming to the hospital. While this natural delivery, meaning no pain management drugs, was more intense than her first, she would take having a baby naturally over receiving an epidural to manage the pain.

When she got to eight centimeters, Tashaia was moved from the tub to the bed to give birth, and an hour later Solas was born.

Thomas' advice to the support team is to have patience and be available to offer comfort.

"If you don't have much to say, then don't say nothing at all," Thomas said, "because you might say something that might make your wife mad."

In the end the Thomas Family is happy they chose to have their baby at Winn.

"I recommend Winn," they said in unison.

"I first I heard tons of horror stories making me want to actually pay to have labor outside (at another hospital)," Tashaia explained, "Which I could have paid for it, had an epidural and wouldn't have been satisfied. Instead of me taking a risk, because it is a risk either way, in coming, and having the best experience."

# New email survey aims to gauge Army housing

**WASHINGTON** -- Residents of Family housing owned and leased by the Army can again rate the quality of their housing and housing services.

Administered by CEL & Associates Inc., the survey was emailed to approximately 10,000 residents living in Army-owned and Army-leased housing worldwide on Jan. 15, from *ArmyHousingSurvey@celassociates.com*.

The survey's purpose is to receive firsthand accounts of what Soldiers and Families find important when living in Army-owned on-post and leased Family housing.

The housing survey is used to identify areas in housing operations that are successful or need improvement, where funding could have the most effect and are identified as top priorities to residents, and ascertain areas of success for the garrison housing office, according to Lt. Gen. Gwen Bingham, Army Assistant Chief of Staff for Installation Management.

"Your feedback about your experiences while residing in Army-owned or leased housing is critical to shaping the future housing and services provided by the Army," Bingham said.

CEL & Associates emailed an initial

housing survey in 2018 to 9,957 residents living in Army Family housing, with 2,025 residents responding (a rate of 20.3 percent). Army housing officials want to increase participation in the 2019 survey.

A higher response rate will give Army officials a more accurate depiction of Soldiers' and their Families' satisfaction with Army Family housing and the services offered by garrison housing offices, housing officials said.

"All surveys are confidential. Your frank feedback about your experiences in Army Family Housing may help to shape future housing programs and services and help guide future decisions that could impact generations of Soldiers and Families," said Lt. Gen. Bradley A. Becker, Installation Management Command commander.

The Army wants maximum outreach and participation to measure residents' satisfaction with housing accommodations, as well as the services they received from the Army Housing Office.

Residents who have not received an email with the survey link by Jan. 18 should contact their local housing offices.

The survey is open through Feb. 14. Residents of privatized Residential Communities Initiative housing will be surveyed in March.

"Being able to have these tools available earlier in the process is going to be helpful for overall justice," Root said.

The changes also call for more robust Article 32 hearings to help the commander determine if an accused should go to trial, she said. For instance, a preliminary hearing officer must now issue a more detailed report immediately after an Article 32 hearing's conclusion. In addition, both the accused and the victim now have the right to submit anything they deem relevant to the preliminary hearing officer within 24 hours after the hearing specifically for the court-martial convening authority to consider.

Aimed at speeding up the post-trial process, immediately following a court-martial, audio can now be provided to the accused, the victim, and the convening authority in lieu of a verbatim transcript which will be typed and provided later, but prior to appeal.

A number of other procedural changes are aimed at making the military justice system even more efficient, Root said.

### More Changes

More changes to punitive offenses also take effect this week. For instance, the definition of burglary

has changed to include breaking and entering any building or structure of another, anytime, with the intent to commit any offense under the UCMJ. In the past, burglary was limited to breaking and entering the dwelling house of another in the nighttime.

The penalty for wearing unauthorized medals of valor has increased from six months to a max of one-year confinement along with forfeiture of pay and a bad-conduct discharge. This includes wearing an unauthorized Medal of Honor, Distinguished Service Cross, Silver Star, Purple Heart, or valor device. The maximum penalty for wearing any other unauthorized medal is still only six months.

Regarding misconduct that occurred prior to Jan. 1, the changes to the punitive articles are not retroactive, Root said. However, some of the procedural changes will apply to cases that were not referred to trial before Jan. 1.

All members of the JAG Corps are trained in the changes and ready to go, Root said.

"We're pretty proud that our commanders are really at the center of this," she said, "and it just gives them some more tools for good order and discipline."




