# Fort Stewart NCO selected as winner of Dragon's Lair 7

**AUSTIN, Texas**— Army Sgt. Roger Litton, an allied trade specialist with the 92nd Engineer Battalion, 20th Engineer Brigade on Fort Stewart was selected as the winner of the Department of Defense's premiere innovation competition, Dragon's Lair 7, Aug. 16 in Austin, Texas.

During this event, Litton went up against four other contestants and came out as a champion. Dragon's Lair is a competition where innovators across the DOD have a chance to present their ideas to a panel of civilian tech leaders and senior military officials. Each of the finalists created their innovation to improve their profession of arms.

As a noncommissioned officer, one of Litton's responsibilities is taking care of his soldiers.

While searching for ways to improve efficiency, he discovered that the process of building bridges for combat engineers was labor intensive and time consuming.

To fix these deficiencies, Litton used his training as an allied trade specialist to fabricate an attachment for a hydraulic excavator. The attachment is a post pile driver that will increase


efficiency in building docks and bridges by 25%. This innovation ultimately impressed the panelists and won Litton the competition.

"After winning the award, I feel ecstatic right now," said Litton, "I think the other innovators had some really great ideas, and I am just very proud to be here."

As the winner of Dragon's Lair 7, this innovator received an Army Meritorious Service Medal, a military school of his choice and the opportunity for the DOD to implement his idea.

Moving forward, Litton wants to build a second version of his attachment that's lighter and more secure; he will distribute a build plan so that other highly skilled welders can reproduce his invention.

"When we started this journey about 24 months ago, the commander told us he wants to see tangible innovations," said Canadian Brig. Gen. Bob Ritchie, former Assistant Commanding General for Operations for the XVIII Airborne Corps. "We saw that today from these five champions — tangible innovations. And that is the one invariant with the Dragon's Lair. We are on number seven and what hasn't changed is why we do this thing. It's to unlock ideas."

# 3rd ID supports interoperability with partner nations at Bold Quest

The 3rd Infantry Division supported Bold Quest 2022, a premier coalition demonstration event that aims at improving digital interoperability and building trust between the U.S. and partner nations to increase lethality through joint and combined fires in multi-domain operations, between July 25 and Aug. 18 on Fort Stewart. Bold Quest, sponsored by the Joint Staff J6 Directorate for Command, Control, Communications and Computer (C4)/Cyber, is a joint and multinational demonstration and assessment helping to develop and deliver Joint All-Domain Command and Control, or JADC2, capabilities at the tactical level.

“The modern battlefield does not allow us the luxury of working interoperability issues during conflict,” said U.S. Air Force Lt. Gen. Mary F. O’Brien, Director for Command, Control, Communications and Computer (C4)/Cyber, and Chief Information Officer, J6, Joint Staff. “We’ve proven warfighter demonstrations such as Bold Quest provide opportunities to address C2 interoperability challenges between U.S. military services and our Partner Nations. By putting theory and technology into practice during these events, we learn the advantages and potential shortcomings of new tools and approaches while honing doctrine and tactics, techniques, and procedures. The result is a more capable, responsive joint and combined force to support our combatant commanders.”

Since Bold Quest’s inception in 2003 with six total nations participating, this “coalition of the willing” event has grown to 23 participants that range from NATO Allies to Middle Eastern partners to soon-to-be NATO members, such as Sweden and Finland.

“[Interoperability] is really, really important for us because we want to have the possibility to help others ... or if we do missions together,” said Swedish Sgt. Maj. Robert Andersson, Sergeant Major of Research and Development

at the Swedish Artillery School. “It’s really important that we can use the fire support from other countries and that we can support other countries with fire support.”

Air assets from the 3rd Combat Aviation Brigade at Hunter Army Airfield in Savannah, and the U.S. Marines at Marine Corps Air Station Beaufort in Beaufort, South Carolina, were used as sensors to identify and detect targets throughout the event. The “BattleKings Battalion,” 1st Battalion, 9th Field Artillery Regiment, 2nd Armored Brigade Combat Team, 3rd ID, executed the call for fire missions for the Bold Quest demonstration on Aug. 16 in real-time as part of the sensor-to-shooter kill chain.

“Bold Quest 2022 is a small but meaningful step toward building a coalition that will deter threats,” said Lt. Col. Benjamin Maher, commander of the 1st Bn., 9th FAR, 2nd ABCT, 3rd ID. “For true interoperability, you need to move beyond the technical means and build an authentic human connection. We have a lot to learn from our NATO Allies

and Partner Nations, and with each exercise we do together, we move closer to building experts in all our formations.”

According to the Joint Staff J6 office, Bold Quest provides a large, live C2 testing environment across air, land and sea for the U.S. and Partner Nations to experiment with interoperability in an operational context.

“The Joint Fire Support Joint Mission Thread in Bold Quest is the only venue in the world that I know of that allows national and military service program offices, agencies and organizations to bench test their systems with other national fire support command and control systems in a lab environment,” said Michael Shifflett, operation manager for the Joint Fire Support Joint Mission Thread. “This ability cannot be understated in that cross national system deficiencies are identified prior to deployment and in turn resolved to enhance multinational all-domain interoperability before needed in combat.”

Additional Bold Quest events are planned for the future.

### Trusted Traveler reinstated

Trusted Traveler resumed today at Fort Stewart and Hunter Army Airfield. Trusted Traveler allows all DOD ID card holders to vouch for all occupants in their vehicle. The DOD ID card holder must be the driver unless observed medical conditions prevents vehicle operation. Trusted Traveler hours are 6 a.m. to 9 p.m. daily, Monday through Sunday at all gates. After 9 p.m. all occupants of the vehicle will be subject to 100% ID card check at open gates except Rio gate at Hunter. After 9 p.m. use Montgomery Gate at Hunter. Contractors and AIE card holders are not authorized Trusted Traveler. Visitor Control Center hours remain 6 a.m. to 6 p.m. at Stewart and Hunter.

### State carry act does not apply on post

The recently passed Georgia Constitutional Carry Act does not apply to Fort Stewart-Hunter Army Airfield or any Army installation in Georgia. Per Army Regulation 190-11, the carrying of privately owned weapons and ammunition is prohibited on post unless authorized by the Senior Commander. Also, the carrying of a concealed weapon on the installation is prohibited regardless of whether a state or county permit has been obtained. 

# Training helps maintainers keep cool

Soldiers assigned to the 287th Field Feeding Company, Division Sustainment Troops Battalion, 3rd Division Sustainment Brigade, 3rd Infantry Division, hosted a Multi-Temperature Refrigerated Container System training, Aug. 15 on Fort Stewart.

The MTRCS is a mobile, multi-temperature refrigeration system designed to transport and store frozen, chilled, or semi-perishable food items in adverse locations. The container is built with an interior portion which allows the container to be divided into separate frozen and chilled compartments.

MTRCS training educates Soldiers on how to maintain and operate the piece of machinery in preparation for field missions. The Soldiers who attended were culinary specialists, utility equipment repairers, power generation specialists and wheeled vehicle mechanics.

“If we didn’t do the training we will have the same instances that we are having now, lack of knowledge on the system and how to use it and then the lack of knowledge on maintaining the system for the mechanics,” said Chief Warrant Officer 3 Kashauna Kynard, an automotive maintenance warrant officer assigned to the Support Operations Section Material Readiness Branch, 3rd DSB.

The ability to repair and operate the MTRCS allows 3DSB to support the 3rd ID Soldiers who may be in the field. This allows Soldiers to get fresh meals almost any-

where and not rely so heavily on meals ready to eat.

“If they didn’t receive this training then we would have more MTRCSs deadlined, we would have more MTRCSs in the motor pool waiting to be fixed,” said Master Sgt. Jennifer Felix, the senior food services NCO for 3rd DSB. “Giving Soldiers the tools to be able to fix them themselves and possessing the knowledge to troubleshoot themselves will help the mechanics be able to get the MTRCS back up and running faster.”

The 287th FFC receives requests about three times a week, to either support mermites, MREs or a Field Feeding Team. When supporting the requests and feeding hundreds at a time and using the MTRCS makes feeding Soldiers an easier task. The MTRCS can be loaded and transported with a load handling system or a palletized load system.

“It is very important to the Division because currently the Division is hurting on MTRCS, every time a unit requests MTRCS support we have to either outsource a refrigerated truck or borrow a MTRCS from another unit. For them to receive this training and be able to fix or troubleshoot their own is essential to the team,” Felix said.

The 3rd DSB is taking action and ensuring all qualified Soldiers receive this training to support modernization, deployment/redeployment, and total Army integration.

“We are looking to make it every quarter, to make it a focus and raise awareness in the division on how important the MTRCS is for field feeding and Soldier support,” Kynard said.

## MARNE HISTORY

### The history of Operation Dragoon

**On Aug. 15, 1944, the Allied Invasion of Southern France, Operation Dragoon, began.**

**On this day, the 3rd Infantry Division landed on the beach near Cavalaire-sur-Mer on beach Alpha. The landings were overwhelmingly successful but represented a strategic divergence between the allied planners.**

**The U.S. planners advised the opening of a second front in France shortly after the Normandy Invasion. Operation Dragoon took place nine weeks after Overlord, which was critical to a swift and decisive German defeat. During this time, British planners maintained the stance that the completion of the Italian campaign, with a subsequent invasion in the Balkans, was pivotal to maintaining a balance of power with the**

**Soviets.**

**Significantly, the First Free French Army, under the command of General Jean de Lattre de Tassigny, landed shortly after the American divisions. The 1st Free French, 1st Armored (France), and 3rd Algerian Infantry Divisions were all experienced units that had extensive combat experience in the Italian campaign.**

**Operation Dragoon was especially important for the French as it was the first full French Army to participate in the liberation of France.**

**Additionally, two 3rd Infantry Division Soldiers, Sgt. James Connor and Staff Sgt. Stanley Bender, earned the Medal of Honor for their actions during the operation.**



# Magnet fishing doesn't attract common sense

Three magnet fishermen hauled in more than they bargained for on Fort Stewart recently.

The haul included 86 small rockets and other ordnance found at the bottom of a river and they reeled in about \$340 in fines, according to The Macon Telegraph.

They posted the experience to their YouTube Channel, Outdoors Weekly.

The video has over 3.7 million views.

Finding unexploded ordnance isn't uncommon on Redstone Arsenal either. According to Garrison Safety Director Mike Moore, from 5-10 UXOs are found on post each year.

That's why hunters, contractors and anyone else who will be working in the soil on post is given UXO training.

"Never touch, disturb or pick up suspect items. When in doubt call 911 and state you are calling from Redstone Arsenal," Moore said. "Let emergency responders and trained UXO personnel make an assessment. UXO injures and kills people every year worldwide. Don't take a chance on

hurting yourself or others."

Since Fort Stewart is federal property, the group was fined for "recreating without a permit, entering a restricted area and unauthorized magnet detection," according to The Telegraph.

Conservation Law Enforcement Officer Kelly

Smith says magnet fishing on post is a bad idea.

"A few years back I had a guy ask about magnet fishing," Smith said. "Since it's not really fishing in the sense they're trying to catch an actual fish, it's actually a search for metal objects.

"It is really not much different than getting a metal detector and a shovel. I advised the guy, no, predominantly for the reason occurring in Georgia. UXO would be attracted to magnets and that alone makes it unsavory. If someone said their hobby was hitting lumps with a ball peen hammer in impact ranges, I'd also have to be the killjoy on that too.

"Also, since this is federal property, it's unlawful to remove items from the installation without expressed written permission from authorized officials which is rarely given. There are also archaeological resources that come into play with this activity and those type resources are also very much protected by several federal laws.

"So, I don't see it getting any traction out here."

# DOD releases first departmentwide social media policy

**WASHINGTON** — The Defense Department today released a policy that for the first time spells out, from the highest levels of the defense community, how DOD military and civilian personnel should use official social media accounts to best advance the mission of the U.S. military and further instill trust in the credibility of the DOD.

DOD Instruction 5400.17, titled “Official Use of Social Media for Public Affairs Purposes,” provides principles for social media use within DOD, direction regarding records management procedures for social media accounts, and guidance to ensure personal social media accounts are not misrepresented or misinterpreted as official accounts.

While some of the military services and other agencies published social media policies years ago, DODI 5400.17 is the department’s first instruction that provided Pentagon-level, departmentwide guidance that specifically addresses the use of social media. The DOD chief information officer previously issued DODI 8170.01, “Online Information Management and Electronic Messaging,” to provide broad policy guidance on the secure and appropriate use of social media. The new policy specifically addresses public affairs uses and responsibilities.

“It’s long overdue,” Andy Oare, director of digital media for the Office of the Secretary of Defense, said. “There have been efforts in the past to do this, but in an organization of this size and magnitude, you

need to fully coordinate and ensure all viewpoints are heard and represented. We wanted to make sure the services were collaborators from the very beginning.”

Because social media changes rapidly, Oare said policies that the department may have started developing in the past but had never finalized would quickly show their age. That won’t happen with the newly published instruction, and he stressed that this policy will be continually refined and updated based on the evolving social media landscape.

“We’ll work across the department to be agile and responsive in our day-to-day operations as we implement this policy and update it where and when we should,” Oare said.

“Social media has an effect on every one of our service members, civilians, contractors and their families — whether they run an official account or have never heard of Twitter,” Oare said. “We owe it to all of them to have one central policy that provides a clearly articulated standard of operation and accountability.”

The DOD social media policy applies to Office of the Secretary of Defense personnel, the military departments, the Office of the Chairman of the Joint Chiefs of Staff and the Joint Staff, the combatant commands, and other DOD offices and agencies. In some cases, this means the new policy will supersede preexisting social media policies, but close coordination throughout its development ensured that all perspectives were considered and integrated.

“We deliberately wrote it in a collaborative manner,

and it encourages component heads to continue establishing component-specific social media regulations,” Oare said. “Our aim is not to be prescriptive or restrictive, but rather to lay out some common-sense rules that simply have not been formally articulated at this level.”

In addition to detailing the roles and responsibilities of DOD leadership in enforcing responsible social media practices, the new policy offers guidance to department personnel who generate content on official social media platforms to ensure responsible use of the medium, key elements to consider when establishing a new presence or expanding into new platforms, and on the authority to close unused accounts.

“If social media is mismanaged or mishandled, the U.S. government’s reputation with the American public; relationships with interagency, international, state, local and tribal entities; military operations; and reputation for a high ethical and professional standard may be compromised,” the policy warns social media practitioners.

The guidance in DODI 5400.17 is meant to ensure DOD’s credibility and avoid controversy, while using social media to share its missions with the public, Oare said.

“In a digital world where lines of truth and authenticity are so often blurred, it’s important that institutions like us have trusted, verifiable and reliable presences,” Oare said. “We have a duty to the American people to show the work we’re doing, to tell the story of our service members, and to present that information through channels they use in their daily lives.”

"He has always been there for us," Marshall said.

She said her dad and mom, Madelyn Riley Brewton, were married for more than 67 years. She said they had seven children and 23 grandchildren.

One of those grandchildren, Jerome Crawford, was on-hand after Costanza visited Brewton, and spoke regarding Brewton's character.

"He has always been an upright and industrious person," Crawford said. "He always strives to do his best and inspires others to do the same."

Crawford said after Brewton retired from the Army, he returned to the Fort Stewart and Hinesville area and accepted a position with the Liberty County Department of Public Works; retiring after more than 20 years of service to the community.

But Crawford said Brewton never stopped working noting he even after he retired a second time, he remains active in the community and with his family.

Brewton's daughter, Marshall said, last year, she was able to surprise her father with a family visit that included a reunion of 5 generations of Brewtons. The visit included a visit by his daughter Marshall, her daughter Keisha Williams; great grand-daughters AJeh and Zaneh Williams and his newest great-great grand-daughter Azora; who was then 3 months old.

# Rest, a crucial element to help reduce daily stress

Stress is something that everyone will grapple with at one time or the other.

One may define stress as change that triggers emotional, physical, or physiological tension. As the body comes in contact with any situation that demands action or attention, the brain will quickly recognize the situation and activate the sympathetic nervous system in response to the stress. The sympathetic nervous system assesses how the body will react to the perceived danger. How one responds to stress is what makes the difference to the overall well-being of an individual.

**The various signs of stress can be identified as any of the following:**

- **Psychological:** These signs of stress include poor concentration, anxiety, and difficulty remembering things.
- **Emotional:** These include anger, irritation, mood swing, and feeling of frustration.
- **Behavioral:** These signs include poor self-care (unkempt hair unkempt, unwashed or wrinkled clothing, less interest or time for things one would usually enjoy, or dependence on drugs and alcohol to cope).
- **Physical:** These include elevated blood pressure, weight gain or loss, frequent colds or infections, and more.

In the Scripture, even Jesus recognizes the tendency for the body to experience some stress. In the book of Mark (4:35), Jesus tells his audience that the Master beck-

oned his disciples to go over to the other side.

The study of the verses that precede portrays the Master as being full of activities ranging from healing the man whose one side of the body was paralyzed to calming the storm and so forth. All these miraculous activities compelled the crowd to follow him. By the end of the day, He recognized that He and His disciples were already worn out, and their bodies were prone to stress. Consequently, He beckoned His disciples to go over to the other side of the lake.

I am convinced that He asked His disciples to move over to the other side of the lake not to continue doing ministry; rather, to provide the opportunity to engage in some form of self-care.

While reading this, you may be wondering, "How do you know?" My answer is simply because the Scripture tells us that while they were in the boat heading to the other side of the lake, the Master was busy taking a nap (Mark 4:38).

Given the above scenario, I like to consider the act of resting rest as one of the ways to mitigate stress.

The act of resting is the Creator's solution to stress. God emphasizes the importance of rest by resting on the seventh day; having worked for six days (Genesis 2:2). The subject of rest is so crucial that the Creator made it a requirement for His people to observe the Sabbath (Exodus 20:10).

There are lots of benefits of resting, such as reduced blood pressure, stronger cardiovascular system, improved mood, improved immune health and more. Having seen the importance of rest, I invite you to practice including rest as part of your daily and weekly routine.

# Transition Assistance Program hosts job fair

The Fort Stewart-Hunter Army Airfield Transition Assistance Program hosted a National Job Fair, Aug. 18 at Club Stewart on Fort Stewart. The fair featured 94 exhibitors from across the country and was attended by over 400 individuals to include transitioning service members, military spouses, veterans and spouses of veterans.

"I was surprised with the number of employers that were here and the scale of the event," said Sgt. 1st Class Christopher Welch, "I spoke with a few veteran employers who were friendly and very knowledgeable."

The fair featured career opportunities that are currently available both across the country and overseas with positions in a various amount of career fields such as logistics, maintenance, construction and restoration, IT and cybersecurity, manufacturing, human resources, sales, customer service, law enforcement and security, healthcare, education, food service and many more.

In addition to learning about available positions, several attendees were able to apply for certain positions on-site with the potential of receiving on-the-spot interviews and job offers within the same day. For other companies, their resume review and interview process is underway.

"I plan to interview two new associates and an electrician," said Tiera Johnson, Army and Air Force Exchange Service recruiting manager.

The Army Transition Assistance Program promotes retention through career exploration, information and examining a personalized gap analysis in support of one's individual goals.

"Events such as these are important to our military family

but especially our transitioning service members. It lets them know that although you are transitioning to the civilian sector, we still care about what's next for you and we want you to be successful," said Christine Abram, transition readiness liaison with Division Retention, Reserve Component, Air National Guard and Public Private Partnership. "The Job Fair allowed me to partner with local and national employers offering careers that will ensure our Army Reserve Soldiers are neither unemployed nor underemployed."

Military spouse employment options can often be a factor in family decision making.

"Most of our employees are military spouses or dependents," Johnson said. "[Through AAFES] spouses can take their careers to any base they go to."

In addition to job hunting, attendees had the opportunity to visit with Career Skills Programs representatives and Garrison support agencies to learn about how they can better prepare themselves to compete in the job market through various trainings and apprenticeships.

The Transition Assistance Program is available to help Soldiers make informed career decisions through counseling and employment assistance. Whether seeking a new a job or career, pursuing higher education or considering starting your own business, TAP has the classes and instructor expertise to start off on a successful path.




