GENERAL INFORMATION

Notification is required by the Georgia Underground Storage Tank Act, O.C.G.A. 12-12, as amended for all underground tanks that have been used to store regulated substances since January 1, 1974, that are in the ground as of May 6, 1984, or that are brought into use after May 6, 1984.

The primary purpose of this notification is to locate and evaluate underground tanks that store or have stored petroleum or hazardous substances. The information you provide must be based on reasonably available records, or in the absence of such records, your knowledge, belief, or recollection.

Who Must Notify? The GUST Act, as amended, requires that, unless exempted, owners of underground tanks that store regulated substances must notify the Georgia Environmental Protection Division of the existence of their tanks.

Owner Means:

a) In the case of an underground storage tank in use on November 6, 1984, or brought into use after that date, any person who owns an underground tank used for the storage, use, or dispensing of regulated substances; and

b) In the case of any underground storage tank in use before November 6, 1984, but no longer in use on that date, any person who owned such tank immediately before the discontinuation of its use.

Note: Any facility that has undergone any change to facility information or tank system is also required to submit updated tank information.

What Tanks Are Included? Underground storage tank is defined as any one or combination of tanks that (1) is used to contain an accumulation of "regulated substances," and (2) whose volume (including connected underground piping) is 10% or more beneath the ground. Some examples are underground tanks storing: 1. Gasoline, used oil, or diesel fuel; and 2. Industrial solvents, pesticides, herbicides or fungicides.

What Tanks Are Excluded? Tanks removed from the ground are not subject to notification. Other tanks excluded from notification are:

1. Tank or reservoir tanks of 1,100 gallons or less capacity used for storing motor fuel for noncommercial purposes;
2. Tanks used for storing heating oil for domestic use on the premises where stored;
3. Inert tanks;

4. Inactive facilities (including gathering lines) regulated under the Natural Gas Pipeline Safety Act of 1968, or the Hazardous Liquid Pipeline Safety Act of 1970, or which is an inactive electric facility regulated under other State laws;

5. Surface infrastructures, pits, ponds, or lagoons;

6. Storm water or waste water collection systems;

7. Non-underground process tanks;

8. Liquid lines or associated gathering lines directly related to oil or gas production and gathering operations;

9. Storage tanks situated in an underground area (such as a basement, cellar, mine, tunnel, shaft, or tunnel) if the storage tank is situated below or upon the surface of the floor.

What Substances Are Covered? The notification requirements apply to underground storage tanks that contain regulated substances. This includes any substance defined as hazardous in section 101 (14) of the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (CERCLA), with the exception of those substances regulated as hazardous waste under Subtitle C of RCRA. It also includes petroleum, e.g., crude oil or any fraction thereof which is found at standard conditions of temperature and pressure 100 degrees Fahrenheit and 14.7 pounds per square inch absolute.

When To Notify? 1. Owners of underground storage tanks in use or that have been taken out of operation after January 1, 1974, but still in the ground, must have notified by May 6, 1984. 2. Owners who bring underground storage tanks into use after May 6, 1984, must notify within 30 days of bringing the tanks into use. 3. Any modification to facility name requires immediate notification.

Penalties: Under the GUST Act, O.C.G.A. 12-12-18, any owner who knowingly fails to notify or submits false information shall be subject to a civil penalty not to exceed \$10,000 for each tank for which notification is not given or for which false information is submitted.
