SUBJECT: Commanding General (CG) Policy Letter #8: Driving Under the Influence (DUI) Free Award

- 1. References. Army Regulation (AR) 600-85, Army Substance Abuse Program, 28 November 2016.
- 2. Applicability. All 3d Infantry Division units at Fort Stewart and Hunter Army Airfield.
- 3. Purpose. This policy recognizes those units that support and enforce the Army Substance Abuse Program (ASAP) mission and vision.
- 4. Policy. The use of alcohol, while socially and legally acceptable under some circumstances, is not acceptable when it endangers the user or innocent bystanders, or when it affects combat readiness.
- 5. Procedures. The Senior Commander/Commanding General presents the DUI Free Award quarterly to qualifying Companies. To qualify for the DUI Free Award, the Company must have an active Company-level Designated Driver Program. Companies qualify for the DUI Free Award following ninety (90) consecutive DUI-free days. Once earned, units display the DUI Free award streamer on their guidon.
- a. The company retains its streamer as long as the Company remains DUI-free and maintains a Designated Driver Program.
- b. If a DUI occurs, the company removes the streamer and returns it to ASAP within five (5) days of notification of an incident.
- c. The Senior Commander/Commanding General or his designated representative will award streamers at a quarterly division award ceremony.
- d. Command will award a three (3) day pass to a Company for each period of 90 days for which the company qualifies for the DUI Free Award.
- 6. Responsibilities.

SUBJECT: CG Policy Letter #8: DUI Free Award

- a. The Company Commander, First Sergeant, S-1, or Unit Prevention Leader (UPL) will request the streamer and three (3) day pass via e-mail, or in person to the servicing ASAP office. The request will include the Company's contact information.
 - b. The ASAP office will.
 - (1) Verify eligibility.
 - (2) Verify requirements are met through the Division Operations Center.
 - (3) Coordinate and provide streamers and/or award.
 - (4) Provide assistance as requested or required.
