There have been several questions since the regional V-Teams have been implemented related to what V-Teams exist, what permissions they have, who are on the V-Teams, how to request membership on a team, etc.

A quick reference guide of sorts has been created to help answer some of these questions.

Please keep in mind this is NOT intended to be the official source of information. If an existing V-Team is disbanded or new members added to an existing V-Team, for example, that information will be updated on the list on the applicable SharePoint Online site that serves as the official source of that information. The same is true for all other information in this guide. This is only intended to be a quick reference guide as of this point in time and to assist with pointing users to the official locations for some of the information contained in it in order to help with some of the questions that have come up recently.

Cyber Operational Readiness Assessment!

How can you help with the upcoming inspection?

- Do NOT leave your CAC unattended, especially in a SIPR environment!
- Leave your machine online!
- Ensure access rosters are up to date!
- Do NOT disable CAC-enforcement without approval of Account Management V-Team and ISSM!


### RNEC WARRIORS WALK




